#### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Directs Oregon Government Standards and Practices Commission to charge public bodies, special government bodies, local governments and local service districts proportionate amounts for purposes of funding activities of commission.

Increases amount of reportable lobbying expenditures. Requires, on January 1, 2010, quarterly online filing of expenditure statements by lobbyists and persons on whose behalf lobbyist was registered. Directs commission to allow public access to statements using Internet. **Modifies other lobbying laws.**

Increases amount of civil penalties that may be imposed for violation of lobbying or government ethics law from \$1,000 to \$5,000. Prohibits candidate from using political contributions to pay criminal or civil penalties or legal expenses. Exempts civil penalties related to certain election law violations.

Prohibits former member of Legislative Assembly from being compensated lobbyist during period beginning on date person ceases being member and ending on date of adjournment sine die of next regular legislative session.

Prohibits public official from receiving in calendar year gifts with value exceeding [~~\$50~~] **\$100** from source with legislative or administrative interest. **Exempts certain items from definition of "gift." Allows food, lodging or travel expenses when attending official event. Allows food or beverage in presence of purchaser.**

Allows public official to receive items exempted from definition of "gift" from person with legislative or administrative interest. Allows public official to receive gift from source that does not have legislative or administrative interest in governmental agency in which official has official position.

*[Exempts judges or public officials serving judicial department from gift limits.]*

Modifies required contents of statement of economic interest.

Requires public officials and candidates to file quarterly statements with commission listing expenses received when participating in an official meeting, **gifts with value exceeding \$15**, honoraria exceeding \$15 and each source of income exceeding aggregate amount of \$1,000 from source that does business with or has legislative or administrative interest in governmental agency served by public official or candidate. **Requires certain persons who give gifts to file statements.**

Requires person with legislative or administrative interest who pays expenses of official meeting or provides *[honoraria to report to commission and to notify recipient of value]* **gift with value exceeding \$15**. Sets schedule for filing reports. Prescribes content of reports.

Prohibits public officials and candidates for public office from receiving honoraria in connection with official duties. Exempts honoraria or other items with value of \$50 or less.

Authorizes public official to establish legal expense trust fund to defray legal expenses incurred by public official in **maintaining action related to protective order or** defending public official in legal proceeding relating to or arising from status of person as public official. **Allows use of trust fund for collateral proceedings related to defending public official.** Requires approval by Oregon Government Standards and Practices Commission.

Prohibits personal use of legal expense trust fund proceeds. Prohibits public official from soliciting contributions to trust fund. Directs trustee of trust fund to file with commission quarterly reports of contributions received and expenditures made.

Declares emergency, effective on passage.

**A BILL FOR AN ACT**

Relating to government ethics; creating new provisions; amending ORS 171.725, 171.730, 171.735, 171.740, 171.745, 171.750, 171.772, 171.992, 244.020, 244.040, 244.045, 244.050, 244.060, 244.070, 244.100, 244.110, 244.280, 244.290, 244.350, 244.360, 244.390, 260.407, 293.708, 351.067 and 353.270 and sections 5, 14, 15 and 40b, chapter \_\_\_, Oregon Laws 2007 (Enrolled House Bill 2595); and declaring an emergency.

**Be It Enacted by the People of the State of Oregon:**

**NOTE:** Sections 1 through 3 were deleted by amendment. Subsequent sections were not re-numbered.

**REPORTING REQUIREMENTS**

**SECTION 4.** Section 5 of this 2007 Act is added to and made a part of ORS 171.725 to 171.785.

**SECTION 5.** Statements required to be filed with the Oregon Government Standards and Practices Commission under ORS 171.745 and 171.750 shall be filed in each calendar year:

(1) Not later than April 15, for the accounting period beginning January 1 and ending March 31;

(2) Not later than July 15, for the accounting period beginning April 1 and ending June 30;

(3) Not later than October 15, for the accounting period beginning July 1 and ending September 30; and

(4) Not later than January 15 of the following calendar year, for the accounting period beginning October 1 and ending December 31.

**SECTION 6.** ORS 171.725 is amended to read:

171.725. As used in ORS 171.725 to 171.785, unless the context requires otherwise:

(1) "Compensation" has the meaning given that term in ORS 292.951.

(2) "Consideration" includes a gift, payment, distribution, loan, advance or deposit of money or anything of value, and includes a contract, promise or agreement, whether or not legally enforceable.

(3) "Executive agency" means a commission, board, agency or other body in the executive branch of state government that is not part of the legislative or judicial branch.

(4) "Executive official" means any member or member-elect of an executive agency and any member of the staff or an employee of an executive agency. A member of a state board or commission, other than a member who is employed in full-time public service, is not an executive official for purposes of ORS 171.725 to 171.785.

(5) "Judge" means an active judge serving on the Oregon Supreme Court, Court of Appeals, Oregon Tax Court, or an Oregon circuit court.

(6) "Legislative action" means introduction, sponsorship, testimony, debate, voting or any other official action on any measure, resolution, amendment, nomination, appointment, or report, or any matter that may be the subject of action by either house of the Legislative Assembly, or any committee of the Legislative Assembly, or the approval or veto thereof by the Governor.

(7) "Legislative official" means any member or member-elect of the Legislative Assembly, any member of an agency, board or committee that is part of the legislative branch, and any staff person,

1 assistant or employee thereof.

2 (8) "Lobbying" means influencing, or attempting to influence, legislative action through oral or  
3 written communication with legislative officials, solicitation of *[others]* **executive officials or other**  
4 **persons** to influence or attempt to influence legislative action or attempting to obtain the goodwill  
5 of legislative officials.

6 (9) "Lobbyist" means:

7 (a) Any individual who agrees to provide personal services for money or any other consideration  
8 for the purpose of lobbying.

9 (b) Any person not otherwise subject to paragraph (a) of this subsection who provides personal  
10 services as a representative of a corporation, association, organization or other group, for the pur-  
11 pose of lobbying.

12 (c) Any public official who lobbies.

13 (10) "Public agency" means a commission, board, agency or other governmental body.

14 (11) "Public official" means any member or member-elect of any public agency and any member  
15 of the staff or an employee of the public agency.

16 **SECTION 6a.** ORS 171.730 is amended to read:

17 171.730. The Legislative Assembly finds that, to preserve and maintain the integrity of the leg-  
18 islative process, persons who engage in efforts to *[persuade members of the Legislative Assembly or*  
19 *the executive branch to take specific actions]* **influence legislative action**, either by direct communi-  
20 cation with *[members or employees of the Legislative Assembly or the executive branch]* **legislative**  
21 **officials** or by solicitation of *[others]* **executive officials or other persons** to engage in those ef-  
22 forts, should regularly report their efforts to the public.

23 **SECTION 6b.** ORS 171.735 is amended to read:

24 171.735. ORS 171.740 and 171.745 do not apply to the following persons:

25 (1) News media, or their employees or agents, that in the ordinary course of business directly  
26 or indirectly urge legislative action but that engage in no other activities in connection with the  
27 legislative action.

28 (2) Any legislative official acting in an official capacity.

29 (3) Any individual who *[receives no]* **does not receive** compensation or reimbursement of ex-  
30 penses for lobbying, who limits lobbying activities solely to formal appearances to give testimony  
31 before public sessions of committees of the Legislative Assembly, or public hearings of state agen-  
32 cies, and who, when testifying, registers an appearance in the records of the committees or agencies.

33 (4) A person who *[spends not]* **does not spend** more than **an aggregate amount of** 24 hours

35 \$100 lobbying during any calendar quarter.

36 (5) The Governor, *[Executive Assistant to]* **chief of staff for** the Governor, *[Legal Counsel]*  
37 **deputy chief of staff for the Governor, legal counsel** to the Governor, **deputy legal counsel to**  
38 **the Governor**, Secretary of State, Deputy Secretary of State appointed pursuant to ORS 177.040,  
39 State Treasurer, Chief Deputy State Treasurer appointed pursuant to ORS 178.060, **chief of staff**  
40 **for the office of the State Treasurer**, Attorney General, Deputy Attorney General appointed

42 and Industries, **members and staff of the Oregon Law Commission who conduct the law re-**

44 **SECTION 6c.** ORS 171.740 is amended to read:

45 171.740. (1) Within three *[working]* **business** days after exceeding the limit of time or expendi-

1 ture specified in ORS 171.735 (4), a lobbyist shall register with the Oregon Government Standards  
2 and Practices Commission by filing with the commission a statement containing the following in-  
3 formation:

4 (a) The name, address and telephone number of the lobbyist.

5 (b) The name, address and telephone number of each person that employs the lobbyist or in  
6 whose interest the lobbyist appears or works.

7 (c) A general description of the trade, business, profession or area of endeavor of any person  
8 designated under paragraph (b) of this subsection, and a statement by the person that the lobbyist  
9 is officially authorized to lobby for the person.

10 (d) The name of any member of the Legislative Assembly employed, retained or otherwise com-  
11 pensated by:

12 (A) The lobbyist designated under paragraph (a) of this subsection; or

13 (B) A person designated under paragraph (b) of this subsection.

14 (e) The general subject or subjects of the legislative action of interest to the person for whom  
15 the lobbyist is registered.

16 (2) The designation of official authorization to lobby shall be signed by an official of each person  
17 that employs the lobbyist or in whose interest the lobbyist appears or works.

18 (3) **A lobbyist must file a separate registration statement under this section for each**  
19 **person that employs the lobbyist or in whose interest the lobbyist appears or works.** If a  
20 lobbyist appears **or works** for a person for whom the lobbyist has not registered, the lobbyist shall  
21 register with the commission [*within three working days of the lobbyist's appearance*] **not later than**  
22 **three business days after the day the lobbyist first appears or works for the person.**

23 (4) If any of the information submitted by a lobbyist in the statement required under subsection  
24 (1) of this section changes, the lobbyist shall revise the statement within 30 days of the change.

25 (5) A lobbyist registration expires December 31 of an odd-numbered year. If a lobbyist renews  
26 the registration before March 31 of the following even-numbered year, the commission shall consider  
27 the registration to have been effective as of December 31 of the odd-numbered year on which the  
28 registration expired.

34 171.745. (1) A lobbyist registered with the Oregon Government Standards and Practices Com-  
35 mission or required to register with the commission shall, [*on January 31 and July 31, of each*

37 **to the schedule described in section 5 of this 2007 Act,** file with the commission a statement  
38 showing **for the applicable reporting period:**

3 **(b) The name of any legislative or executive official to whom or for whose benefit, on any**  
4 **one occasion, an expenditure is made for the purposes of lobbying, and the date, name of**  
5 **payee, purpose and amount of that expenditure. This paragraph applies if the total amount**  
6 **expended on the occasion by one or more persons exceeds \$50.**

7 *[(2) Beginning on July 1, 1979, the dollar amount specified in subsection (1)(b) of this section shall*  
8 *be adjusted annually by the commission based upon the change in the Portland Consumer Price Index*  
9 *for All Urban Consumers for All Items as prepared by the Bureau of Labor Statistics of the United*  
10 *States Department of Labor or its successor during the preceding 12-month period. The amount deter-*

13 (3) This section does not prohibit:

14 (a) The solicitation or receipt of an honorarium or a certificate, plaque, commemorative  
15 token or other item with a value of \$50 or less; or

16 (b) The solicitation or receipt of an honorarium for services performed in relation to the  
17 private profession, occupation, avocation or expertise of the public official or candidate.

7 mission, may extend the 60-day deadline by one period not to exceed 60 days.

8 (3) Except as provided in this subsection, unless the commission advisory opinion is revised or  
9 revoked, the commission [*or a court*] may not impose a penalty under ORS 244.350 or 244.360 on a  
10 person for any good faith action the person takes in reliance on an advisory opinion issued under  
11 this section. The commission [*or a court*] may impose a penalty under ORS 244.350 or 244.360 on the  
12 person who requested the advisory opinion if the commission [*or court*] determines that the person  
13 omitted or misstated material facts in making the request.

## 27 LEGAL EXPENSE TRUST FUND

28  
29  
30 **SECTION 28.** Sections 29 to 37 of this 2007 Act are added to and made a part of ORS  
31 chapter 244.

32 **SECTION 29.** (1) Subject to the authorization of the Oregon Government Standards and  
33 Practices Commission as described in section 31 of this 2007 Act, a public official may es-  
34 tablish a legal expense trust fund if the public official incurs or reasonably expects to incur  
35 legal expenses described in subsection (2) of this section.

36 (2) Proceeds from the trust fund may be used by the public official to defray legal ex-  
37 penses incurred by the public official in any civil, criminal or other legal proceeding or in-  
38 vestigation that relates to or arises from the course and scope of duties of the person as a  
39 public official. The legal expenses must be incurred in connection with:

40 (a) The issuance of a court's stalking protective order under ORS 30.866 or 163.738;

41 (b) The issuance of a citation under ORS 163.735;

42 (c) A criminal prosecution under ORS 163.732;

43 (d) A civil action under ORS 30.866;

44 (e) Defending the public official in a proceeding or investigation brought or maintained  
45 by a public body as defined in ORS 174.109; or

1 (f) Seeking affirmative relief in a collateral proceeding related to a proceeding or inves-  
2 tigation threatened, brought or maintained against the public official by a public body as  
3 defined in ORS 174.109.

4 (3) Except as provided in subsection (2) of this section, a public official may not use  
5 proceeds from the trust fund for any personal use.

6 (4) A public official may not establish or maintain more than one legal expense trust fund  
7 at any one time.

8 (5) A public official who establishes a legal expense trust fund may not solicit, receive  
9 or handle any contributions to the fund.

10 (6) The provisions of ORS chapter 130 do not apply to a trust fund established under  
11 sections 29 to 37 of this 2007 Act.

12 **SECTION 30.** (1) The proceeds of a legal expense trust fund may be used to:

13 (a) Defray legal expenses described in section 29 of this 2007 Act;

14 (b) Defray costs reasonably incurred in administering the trust fund, including but not  
15 limited to costs incident to the solicitation of funds; and

16 (c) Discharge any tax liabilities incurred as a result of the creation, operation or admin-  
17 istration of the trust fund.

18 (2) The proceeds of a trust fund may also be used to defray or discharge expenses, costs  
19 or liabilities incurred before the fund was established if the expenses, costs or liabilities are  
20 related to the legal proceeding for which the fund was established.

21 **SECTION 31.** (1) A public official may apply to establish a legal expense trust fund by  
22 filing an application with the Oregon Government Standards and Practices Commission. The  
23 application must contain:

24 (a) A copy of an executed trust agreement described in subsection (2) of this section;

25 (b) A sworn affidavit described in subsection (3) of this section signed by the public offi-  
26 cial; and

27 (c) A sworn affidavit described in subsection (4) of this section signed by the trustee.

28 (2) The trust agreement must contain the following:

29 (a) A provision incorporating by reference the provisions of sections 29 to 37 of this 2007  
30 Act; and

31 (b) A designation of a trustee who meets the requirements of section 32 of this 2007 Act.

32 (3) The affidavit of the public official must state:

33 (a) The nature of the legal proceeding that requires establishment of the trust fund;

34 (b) That the public official will comply with the provisions of sections 29 to 37 of this 2007  
35 Act; and

36 (c) That the public official is responsible for the proper administration of the trust fund,  
37 even though a trustee of the fund has been designated.

38 (4) The affidavit of the trustee must state that the trustee:

39 (a) Has read and understands sections 29 to 37 of this 2007 Act; and

40 (b) Consents to administer the trust fund in compliance with sections 29 to 37 of this 2007  
41 Act.

42 (5) Upon receiving an application under this section, the commission shall review the  
43 trust agreement, the affidavits and any supporting documents or instruments filed to deter-  
44 mine whether the application meets the requirements of sections 29 to 37 of this 2007 Act.  
45 If the commission determines that the application meets the requirements of sections 29 to

1 37 of this 2007 Act, the commission shall grant written authorization to the public official to  
2 establish the trust fund.

3 (6) The commission shall review the quarterly statements required under section 35 of  
4 this 2007 Act and shall monitor the activities of each trust fund to ensure continued com-  
5 pliance with sections 29 to 37 of this 2007 Act.

6 (7) Unless subject to the attorney-client privilege, all documents required to be filed re-  
7 lating to the creation and administration of a trust fund are public records subject to dis-  
8 closure as provided in ORS 192.410 to 192.505.

9 (8) A public official may not establish a legal expense trust fund without receiving prior  
10 written authorization of the commission as described in this section.

11 (9) A public official may file an amendment to a trust agreement approved as part of a  
12 trust fund under this section. The commission shall approve the amendment if the commis-  
13 sion determines the amendment meets the requirements of sections 29 to 37 of this 2007 Act.

14 **SECTION 32.** (1) The trustee of a legal expense trust fund is responsible for:

- 15 (a) The receipt and deposit of contributions to the trust fund;
- 16 (b) The authorization of expenditures and disbursements from the trust fund;
- 17 (c) The filing of quarterly statements required under section 35 of this 2007 Act; and
- 18 (d) The performance of other tasks incident to the administration of the trust fund.

19 (2) The trustee may not:

20 (a) Be a public official who serves the same public body as the public official who estab-  
21 lishes the trust fund;

22 (b) Be a relative of the public official who establishes the trust fund;

23 (c) Be an attorney for the public official in the legal proceeding for which the trust fund  
24 is established, or a member, partner, associate or employee of the firm employing the at-  
25 torney; or

26 (d) Have a business or employment relationship with the public official who establishes  
27 the trust fund.

28 **SECTION 33.** (1) Except as provided in subsection (3) of this section, any person may  
29 contribute to a legal expense trust fund established under sections 29 to 37 of this 2007 Act.

30 (2) A person may make contributions of moneys to a legal expense trust fund in unlim-  
31 ited amounts. Pro bono legal assistance and other in-kind assistance may also be provided  
32 without limit and is considered a contribution subject to the reporting requirements of sec-  
33 tion 35 of this 2007 Act.

34 (3) A political committee as defined in ORS 260.005 that is a principal campaign commit-  
35 tee may not contribute to a legal expense trust fund.

36 **SECTION 34.** (1) A trustee of a legal expense trust fund shall establish a single exclusive  
37 account in a financial institution, as defined in ORS 706.008. The financial institution must  
38 be located in this state and must ordinarily conduct business with the general public in this  
39 state.

40 (2) The trustee shall maintain the account in the name of the trust fund.

41 (3) All expenditures made by the trustee shall be drawn from the account and:

42 (a) Issued on a check signed by the trustee; or

43 (b) Paid using a debit card or other form of electronic transaction.

44 (4) A contribution received by a trustee shall be deposited into the account not later than  
45 seven calendar days after the date the contribution is received. This subsection does not

1 apply to in-kind contributions received.

2 (5) This section does not prohibit the transfer of any amount deposited in the account  
3 into a certificate of deposit, stock fund or other investment instrument.

4 (6) The account may not include any public or private moneys or any moneys of any  
5 other person, other than contributions received by the trustee.

6 (7) A trustee shall retain a copy of each financial institution account statement from the  
7 account described in this section for not less than two years after the date the statement is  
8 issued by the financial institution.

9 **SECTION 35.** (1) The trustee of a legal expense trust fund shall, according to the schedule  
10 described in subsection (3) of this section, file with the Oregon Government Standards and  
11 Practices Commission a statement for the applicable reporting period showing contributions  
12 received by the trustee and expenditures made from the trust fund account established under  
13 section 34 of this 2007 Act.

14 (2) Each statement shall list:

15 (a) The name and address of each person who contributed an aggregate amount of more  
16 than \$75, and the total amount contributed by that person;

17 (b) The total amount of contributions not listed under paragraph (a) of this subsection

26 riod, the trustee shall file a statement indicating that no contributions were deposited and  
27 no expenditures were made.

28 (5) The trustee may amend a statement filed under this section without penalty if the  
29 amendment is filed with the commission not later than 30 days after the deadline for filing  
30 the statement.

31 **SECTION 36.** (1) A legal expense trust fund established under sections 29 to 37 of this  
32 2007 Act may be terminated by:

33 (a) The public official who established the trust fund;

34 (b) Subject to subsection (2) of this section, the terms of the trust agreement; or

35 (c) The Oregon Government Standards and Practices Commission following a determi-  
36 nation by the commission that a violation of any provision of ORS chapter 244 has occurred  
37 in connection with the trust fund.

38 (2) A trust agreement may provide that a legal expense trust fund is terminated not later  
39 than six months following the completion of the legal proceeding for which the fund was es-

2 (4) **Not later than 30 days after a trust fund is terminated, the trustee of the fund shall**  
3 **file with the commission a final report listing the totals of all contributions made to the fund**  
4 **and all expenditures made from the fund.**

5 **SECTION 37. (1) Not later than 30 days after a legal expense trust fund is terminated,**  
6 **the trustee of the fund shall return any moneys remaining in the fund to contributors to the**  
7 **fund on a pro rata basis.**

8 (2) **If the legal proceeding for which the trust fund was established results in an award**  
9 **of attorney fees, costs or any other money judgment award to or in favor of the public offi-**  
10 **cial, amounts awarded shall be distributed in the following order:**

11 (a) **To pay outstanding legal expenses;**

12 (b) **To contributors to the trust fund on a pro rata basis; and**

13 (c) **To the public official or, if required by the trust agreement, to an organization exempt**  
14 **from taxation under section 501(c)(3) of the Internal Revenue Code.**
