

SENATE AMENDMENTS TO SENATE BILL 936

15 **tions and powers transferred from the department to the Oregon Health Authority by section**
16 **19 (2), chapter _____, Oregon Laws 2009 (Enrolled House Bill 2009), amendments to statutes**
17 **by chapter _____, Oregon Laws 2009 (Enrolled House Bill 2009), and other laws, out of**
18 **moneys appropriated or made available to the department for the duties, functions and**
19 **powers transferred and subject to Acts authorizing or limiting expenditures by the depart-**
20 **ment for the duties, functions and powers transferred.**

21 **“SECTION 3. For the biennium beginning July 1, 2009, the Department of Consumer and**
22 **Business Services shall pay the costs of administration and enforcement of duties, functions**
23 **and powers transferred from the department to the Oregon Health Authority or established**
24 **in the Oregon Health Authority by section 19 (3), chapter _____, Oregon Laws 2009 (En-**
25 **rolled House Bill 2009), amendments to statutes by chapter _____, Oregon Laws 2009 (En-**
26 **rolled House Bill 2009), section 17, chapter _____, Oregon Laws 2009 (Enrolled House Bill**
27 **2009), and other laws, out of moneys appropriated or made available to the department for**
28 **the duties, functions and powers transferred or established and subject to Acts authorizing**
29 **or limiting expenditures by the department for the duties, functions and powers transferred**
30 **or established.**

31 **“SECTION 4. For the biennium beginning July 1, 2009, the Office of Private Health Part-**
32 **nerships shall pay the costs of administration and enforcement of duties, functions and**
33 **powers transferred from the office to the Oregon Health Authority by section 19 (4), chapter**
34 **_____, Oregon Laws 2009 (Enrolled House Bill 2009), amendments to statutes by chapter**
35 **_____, Oregon Laws 2009 (Enrolled House Bill 2009), and other laws, out of moneys appro-**

1 **priated or made available to the office for the duties, functions and powers transferred and**
2 **subject to Acts authorizing or limiting expenditures by the office for the duties, functions**
3 **and powers transferred.”.**

4 In line 15, delete “3” and insert “5”.
