

# House Bill 2069

Ordered printed by the Speaker pursuant to House Rule 12.00A (5). Pre-session filed (at the request of Governor John A. Kitzhaber for Oregon Business Development Department)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Extends terms of loans made from Special Public Works Fund.

## A BILL FOR AN ACT

1  
2 Relating to the Special Public Works Fund; amending ORS 285B.440.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 285B.440 is amended to read:

5 285B.440. (1)(a) The moneys in the Special Public Works Fund shall be used primarily to provide  
6 loans to municipalities for projects as defined in ORS 285B.410 to 295B.482. The Oregon  
7 Infrastructure Finance Authority may determine the level of grant or loan funding, if any, on a  
8 case-by-case basis.

9 (b) If the authority approves funding, the authority shall determine a maximum amount of the  
10 loan based upon a reasonable and prudent expectation of the ability of the municipality to repay the  
11 loan.

12 (c) The **initial** loan term may not exceed the usable life of the project or [25] **30** years from the  
13 year of project completion, whichever is less. **The term of a renegotiated loan may not exceed**  
14 **the remaining usable life of the project or 30 years, whichever is less.**

15 (d) Assistance from the fund for a marine facility project otherwise funded under ORS 777.267  
16 shall be limited to a loan. The loan may not exceed the amount of the required local matching funds.

17 (2) The Oregon Business Development Department shall by rule adopt standards for awarding  
18 grants from the Special Public Works Fund. The standards may include the award of grants as a  
19 financial incentive to accomplish the goals of the Special Public Works Fund, to address special  
20 circumstances of a project or to address the financial need of the applicant.

21 (3) The authority may make grants to a municipality not to exceed \$1 million per project or 85  
22 percent of the allowable project costs, whichever is less. For purposes of this subsection, allowable  
23 project costs do not include capitalized interest, if any.

24 (4) The authority may not expend more than one percent of the value of the Special Public  
25 Works Fund in any biennium for grants or direct assistance, if any, for planning projects and com-  
26 munity development projects to municipalities.

27 (5) The authority may not expend more than \$2.5 million in any biennium for emergency project  
28 grants. For purposes of this subsection, emergency project grants include grants for essential com-  
29 munity facilities, as defined by the department by rule after consultation with the League of Oregon  
30 Cities, the Association of Oregon Counties, the Oregon Ports Representation Group and the Special  
31 Districts Association of Oregon.

1           (6) Except as otherwise limited by this section, not more than 100 percent of the total cost of  
2 a project, including capitalized interest, shall be financed from the Special Public Works Fund.
