#### Possible Introduction of Committee Measures

##### Public Hearing and Possible Work Session

- SB 40  
CARRIED OVER FROM THE 4/9/2013 AGENDA - Reduces unlawful manufacture of marijuana to Class B felony.
- SB 694  
CARRIED OVER FROM THE 4/09/2013 AGENDA - Requires law enforcement agency to alter police vehicle so that it no longer resembles police vehicle before selling or transferring title.
- SJR 34  
Proposes amendment to Oregon Constitution to allow person serving as judge to be employed by Oregon National Guard for purpose of performing military service or by State Board of Higher Education or school board for purposes of teaching.
- SB 622  
Defines "record of the case" and "supplemental confidential file" in juvenile court proceedings.

##### Work Session

- SB 125 A  
Requires state agency to provide notice to parties in contested case hearing describing rights that active duty servicemembers have to stay proceedings under federal law and providing contact information for legal resources.
- SB 188  
Authorizes Oregon Youth Authority to establish work release program for persons in physical custody of youth authority but in legal custody of Department of Corrections.
- SB 281  
Adds post-traumatic stress disorder to definition of "debilitating medical condition" for purposes of statutes authorizing medical use of marijuana.
- SB 347  
Modifies crime applicable to possession of firearm, or instrument used as dangerous weapon, while in or on school grounds.

**AGENDA (Cont.)**  
**April 10, 2013**

- SB 699  
Modifies laws prohibiting possession of firearms in public buildings.
- SB 700  
Requires person to request criminal background check before transferring firearm to any other person outside the transferor's immediate family.
- SB 780  
Requires grand jury proceeding involving use of deadly force by police officer to be recorded, transcribed and made available to public.
- SB 796  
Requires person applying for concealed handgun license to pass firing range test.
