SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Extends sunset on collection of hospital assessment to September 30, 2015. Modifies payment methodology for reimbursement of specified hospitals by state medical assistance program. Authorizes quality improvement incentive payments to hospitals that meet standards adopted by Oregon Health Authority based on recommendations from hospital performance metrics advisory committee.

Establishes process for reducing excess long term care facility bed capacity statewide. Grants antitrust immunity to long term care facilities that participate in process. Modifies procedure for review of applications for certificates of need by long term care facilities.

Modifies long term care facility assessment and long term care facility reimbursement formula. Makes waived long term care facilities, including long term care facilities operated by continuing care retirement communities, subject to long term care facility assessment. Extends long term care facility assessment to July 1, 2020.

Takes effect on 91st day following adjournment sine die.

2 Relating to state medical assistance program funding; creating new provisions; amending ORS
3 414.746, 442.015 and 442.315 and sections 2, 3, 6, 7, 8, 9, 10, 12, 13, 18, 23, 24 and 31, chapter 736,
4 Oregon Laws 2003; repealing ORS 414.746; prescribing an effective date; and providing for re-

6 **Be It Enacted by the People of the State of Oregon:**

7 **SECTION 1. (1) As used in this section, "hospital" means a hospital that is subject to the**
8 **assessment imposed under section 2, chapter 736, Oregon Laws 2003.**

9 **(2) In consultation with the President of the Senate and the Speaker of the House of**
10 **Representatives, the Director of the Oregon Health Authority shall appoint a hospital per-**
11 **formance metrics advisory committee consisting of nine members, including:**

12 **(a) Four members who represent hospitals;**

13 **(b) Three members who have expertise in measuring health outcomes; and**

14 **(c) Two members who represent coordinated care organizations.**

15 **(3) The hospital performance metrics advisory committee shall recommend three to five**
16 **performance standards that are reasonably attainable by hospitals within the biennium be-**
17 **ginning July 1, 2013, and that are consistent with state and national quality standards.**

18 **(4) The Oregon Health Authority shall adopt by rule the procedures for distributing to**
19 **hospitals the moneys described in section 9 (2)(d), chapter 736, Oregon Laws 2003, to ensure**
20 **that such moneys are distributed as follows:**

21 **(a) The authority shall distribute 50 percent of the moneys based upon each hospital's**

1 **compliance with data submission requirements.**

2 **(b) The authority shall distribute the remainder of the moneys based upon each hospital's**
3 **achievement of the performance standards recommended by the hospital performance met-**
4 **rics advisory committee under subsection (3) of this section.**

5 **SECTION 2.** Section 2, chapter 736, Oregon Laws 2003, as amended by section 1, chapter 780,
6 Oregon Laws 2007, section 51, chapter 828, Oregon Laws 2009, and section 17, chapter 867, Oregon
7 Laws 2009, is amended to read:

8 **Sec. 2.** (1) An assessment is imposed on the net revenue of each hospital in this state that is
9 not a waived hospital. The assessment shall be imposed at a rate determined by the Director of
10 the Oregon Health Authority by rule that is the director's best estimate of the rate needed to fund
11 the services and costs identified in section 9, chapter 736, Oregon Laws 2003. The rate of assessment
12 shall be imposed on the net revenue of each hospital subject to assessment. The director shall con-
13 sult with representatives of hospitals before setting the assessment.

14 (2) The assessment shall be reported on a form prescribed by the Oregon Health Authority and
15 shall contain the information required to be reported by the authority. The assessment form shall
16 be filed with the authority on or before the 75th day following the end of the calendar quarter for
17 which the assessment is being reported. Except as provided in subsection (6) of this section, the
18 hospital shall pay the assessment at the time the hospital files the assessment report. The payment
19 shall accompany the report.

20 (3)(a) To the extent permitted by federal law, aggregate assessments imposed under this section
21 may not exceed the total of the following amounts received by the hospitals that are reimbursed by
22 Medicare based on diagnostic related groups:

23 [(A) *The adjustment to the capitation rate paid to Medicaid managed care organizations under*
24 *section 15, chapter 867, Oregon Laws 2009;*]

25 [(B)] **(A)** 30 percent of payments made to **the** hospitals on a fee-for-service basis by the authority
26 for inpatient hospital services; *[and]*

27 [(C)] **(B)** 41 percent of payments made to **the** hospitals on a fee-for-service basis by the authority
28 for outpatient hospital services[.]; **and**

29 **(C) Payments made to the hospitals using a payment methodology established by the**
30 **authority that advances the goals of the Oregon Integrated and Coordinated Health Care**
31 **Delivery System described in ORS 414.620 (3).**

32 (b) Notwithstanding paragraph (a) of this subsection, aggregate assessments imposed for the
33 biennium beginning July 1, [2009] **2013**, may exceed the total of the amounts described in paragraph
34 (a) of this subsection to the extent necessary to compensate for any reduction of funding in the
35 legislatively adopted budget for that biennium for hospital services under ORS [414.705 to 414.750]
36 **414.631, 414.651 and 414.688 to 414.750.**

37 (4) Notwithstanding subsection (3) of this section, a hospital is not guaranteed that any addi-
38 tional moneys paid to the hospital in the form of payments for services shall equal or exceed the
39 amount of the assessment paid by the hospital.

40 (5) Hospitals operated by the United States Department of Veterans Affairs and pediatric spe-
41 cialty hospitals providing care to children at no charge are exempt from the assessment imposed
42 under this section.

43 (6)(a) The authority shall develop a schedule for collection of the assessment for the calendar
44 quarter ending September 30, [2013] **2015**, that will result in the collection occurring between De-
45 cember 15, [2013] **2015**, and the time all Medicaid cost settlements are finalized for that calendar

1 quarter.

2 (b) The authority shall prescribe by rule criteria for late payment of assessments.

3 **SECTION 3.** Section 3, chapter 736, Oregon Laws 2003, is amended to read:

4 **Sec. 3.** (1) Notwithstanding section 2, [of this 2003 Act] **chapter 736, Oregon Laws 2003**, the
5 Director of [Human Services] **the Oregon Health Authority** shall reduce the rate of assessment
6 imposed under section 2, [of this 2003 Act] **chapter 736, Oregon Laws 2003**, to the maximum rate
7 allowed under federal law if the reduction is required to comply with federal law.

8 **(2) If federal law requires a reduction in the rate of assessments, the director shall, after**
9 **consulting with representatives of the hospitals that are subject to the assessments, first**
10 **reduce the distribution of moneys described in section 9 (2)(d), chapter 736, Oregon Laws**

5 **moneys equal to the federal financial participation received from one percentage point of the**
6 **rate assessed under section 2, chapter 736, Oregon Laws 2003; and**

7 **(e) Paying administrative costs incurred by the authority to administer section 1 of this 2013**
8 **Act and the assessments imposed under section 2, chapter 736, Oregon Laws 2003.**

33 **may** include provisions that ensure that the adjustment to the payments established under sub-
34 section (1) of this section is distributed by the coordinated care organizations to hospitals located

4 **SECTION 15. (1) The Legislative Assembly finds that:**

5 **(a) A significant amount of public and private funds are expended each year for long term**
6 **care services provided to Oregonians;**

7 **(b) Oregon has established itself as the national leader in providing a choice of noninsti-**
8 **tutional care to low income Oregonians in need of long term care services by developing an**
9 **extensive system of home health care and community-based care; and**

10 **(c) Long term care facilities continue to provide critical services to some of Oregon's**
11 **most frail and vulnerable residents with complex needs. Increasingly, long term care facili-**
12 **ties are filling a need for transitional care between hospitals and home settings in a cost-**
13 **effective manner, reducing the overall costs of long term care.**

14 **(2) The Legislative Assembly declares its support for collaboration among state agencies**
15 **that purchase health services and private health care providers in order to align financial**
16 **incentives with the goals of achieving better patient care and improved health status while**
17 **restraining growth in the per capita cost of health care.**

18 **(3) It is the goal of the Legislative Assembly that the long term care facility bed capacity**
19 **in Oregon be reduced by 1,500 beds by December 31, 2015, except for bed capacity in nursing**
20 **facilities operated by the Department of Veterans' Affairs and facilities that either applied**
21 **to the Oregon Health Authority for a certificate of need between August 1, 2011, and De-**
22 **cember 1, 2012, or submitted a letter of intent under ORS 442.315 (7) between January 15,**
23 **2013, and January 31, 2013.**

24 **(4) In order to reduce the long term care facility bed capacity statewide, the Department**
25 **of Human Services may permit an operator of a long term care facility to purchase another**
26 **long term care facility's entire bed capacity if:**

27 **(a) The long term care facility bed capacity being purchased is not in an essential long**
28 **term care facility; and**

29 **(b) The long term care facility's entire bed capacity is purchased and the seller agrees**
30 **to surrender the long term care facility's license on the earlier of the date that:**

31 **(A) The last resident is transferred from the facility; or**

32 **(B) Is 180 days after the date of purchase.**

33 **(5) If a long term care facility's entire bed capacity is purchased, the facility may not**
34 **admit new residents to the facility except in accordance with criteria adopted by the De-**
35 **partment of Human Services by rule.**

36 **(6) Long term care bed capacity purchased under this section may not be transferred to**
37 **another long term care facility.**

38 **(7) The Department of Human Services may convene meetings with representatives of**
39 **entities that include, but are not limited to, long term care providers, nonprofit trade asso-**
40 **ciations and state and local governments to collaborate in strategies to reduce long term**
41 **care facility bed capacity statewide. Participation shall be on a voluntary basis. Meetings**
42 **shall be held at a time and place that is convenient for the participants.**

43 **(8) The Department of Human Services may conduct surveys of entities and individuals**
44 **specified in subsection (7) of this section concerning current long term care facility bed ca-**
45 **capacity and strategies for increasing future capacity.**

1 **(9) Based on the findings in subsection (1) of this section and the declaration expressed**
2 **in subsection (2) of this section, the Legislative Assembly declares its intent to exempt from**
3 **state antitrust laws and provide immunity from federal antitrust laws through the state**
4 **action doctrine individuals and entities that engage in transactions, meetings or surveys de-**
5 **scribed in subsections (4), (7) and (8) of this section that might otherwise be constrained by**
6 **such laws.**

7 **(10) The Director of Human Services or the director's designee shall engage in appropri-**
8 **ate state supervision necessary to promote state action immunity under state and federal**
9 **antitrust laws, and may inspect or request additional documentation to verify that the indi-**
10 **viduals and entities acting pursuant to subsection (4), (7) or (8) of this section are acting in**
11 **accordance with the legislative intent expressed in this section.**

12 **(11) The Director of Human Services or the director's designee, in consultation with the**
13 **Long Term Care Ombudsman, shall engage in regional planning necessary to promote the**
14 **safety and dignity of residents living in a long term care facility that surrenders its license**
15 **under this section.**

16 **SECTION 16.** ORS 442.015 is amended to read:

17 442.015. As used in ORS chapter 441 and this chapter, unless the context requires otherwise:

18 (1) "Acquire" or "acquisition" means obtaining equipment, supplies, components or facilities by
19 any means, including purchase, capital or operating lease, rental or donation, with intention of using
20 such equipment, supplies, components or facilities to provide health services in Oregon. When
21 equipment or other materials are obtained outside of this state, acquisition is considered to occur
22 when the equipment or other materials begin to be used in Oregon for the provision of health ser-
23 vices or when such services are offered for use in Oregon.

24 (2) "Affected persons" has the same meaning as given to "party" in ORS 183.310.

25 (3)(a) "Ambulatory surgical center" means a facility or portion of a facility that operates ex-
26 clusively for the purpose of providing surgical services to patients who do not require
27 hospitalization and for whom the expected duration of services does not exceed 24 hours following
28 admission.

29 (b) "Ambulatory surgical center" does not mean:

30 (A) Individual or group practice offices of private physicians or dentists that do not contain a
31 distinct area used for outpatient surgical treatment on a regular and organized basis, or that only
32 provide surgery routinely provided in a physician's or dentist's office using local anesthesia or
33 conscious sedation; or

34 (B) A portion of a licensed hospital designated for outpatient surgical treatment.

35 [(4) "Budget" means the projections by the hospital for a specified future time period of expen-
36 ditures and revenues with supporting statistical indicators.]

37 [(5)] (4) "Develop" means to undertake those activities that on their completion will result in
38 the offer of a new institutional health service or the incurring of a financial obligation, as defined
39 under applicable state law, in relation to the offering of such a health service.

40 **(5) "Essential long term care facility" means an individual long term care facility that**
41 **serves predominantly rural and frontier communities, as designated by the Office of Rural**
42 **Health, and meets other criteria established by the Department of Human Services by rule.**

43 (6) "Expenditure" or "capital expenditure" means the actual expenditure, an obligation to an
44 expenditure, lease or similar arrangement in lieu of an expenditure, and the reasonable value of a
45 donation or grant in lieu of an expenditure but not including any interest thereon.

1 (7) "Freestanding birthing center" means a facility licensed for the primary purpose of per-
2 forming low risk deliveries.

3 (8) "Governmental unit" means the state, or any county, municipality or other political subdi-
4 vision, or any related department, division, board or other agency.

5 (9) "Gross revenue" means the sum of daily hospital service charges, ambulatory service
6 charges, ancillary service charges and other operating revenue. "Gross revenue" does not include
7 contributions, donations, legacies or bequests made to a hospital without restriction by the donors.

8 (10)(a) "Health care facility" means:

9 (A) A hospital;

10 (B) A long term care facility;

11 (C) An ambulatory surgical center;

12 (D) A freestanding birthing center; or

13 (E) An outpatient renal dialysis center.

14 (b) "Health care facility" does not mean:

15 (A) A residential facility licensed by the Department of Human Services or the Oregon Health
16 Authority under ORS 443.415;

17 (B) An establishment furnishing primarily domiciliary care as described in ORS 443.205;

18 (C) A residential facility licensed or approved under the rules of the Department of Corrections;

19 (D) Facilities established by ORS 430.335 for treatment of substance abuse disorders; or

20 (E) Community mental health programs or community developmental disabilities programs es-
21 tablished under ORS 430.620.

22 (11) "Health maintenance organization" or "HMO" means a public organization or a private
23 organization organized under the laws of any state that:

24 (a) Is a qualified HMO under section 1310 (d) of the U.S. Public Health Services Act; or

25 (b)(A) Provides or otherwise makes available to enrolled participants health care services, in-
26 cluding at least the following basic health care services:

27 (i) Usual physician services;

28 (ii) Hospitalization;

29 (iii) Laboratory;

30 (iv) X-ray;

31 (v) Emergency and preventive services; and

32 (vi) Out-of-area coverage;

33 (B) Is compensated, except for copayments, for the provision of the basic health care services
34 listed in subparagraph (A) of this paragraph to enrolled participants on a predetermined periodic
35 rate basis; and

36 (C) Provides physicians' services primarily directly through physicians who are either employees
37 or partners of such organization, or through arrangements with individual physicians or one or more
38 groups of physicians organized on a group practice or individual practice basis.

39 (12) "Health services" means clinically related diagnostic, treatment or rehabilitative services,
40 and includes alcohol, drug or controlled substance abuse and mental health services that may be
41 provided either directly or indirectly on an inpatient or ambulatory patient basis.

42 (13) "Hospital" means:

43 (a) A facility with an organized medical staff and a permanent building that is capable of pro-
44 viding 24-hour inpatient care to two or more individuals who have an illness or injury and that
45 provides at least the following health services:

- 1 (A) Medical;
- 2 (B) Nursing;
- 3 (C) Laboratory;
- 4 (D) Pharmacy; and
- 5 (E) Dietary; or

6 (b) A special inpatient care facility as that term is defined by the [*Oregon Health*] authority by
7 rule.

8 (14) “Institutional health services” means health services provided in or through health care
9 facilities and includes the entities in or through which such services are provided.

10 (15) “Intermediate care facility” means a facility that provides, on a regular basis, health-related
11 care and services to individuals who do not require the degree of care and treatment that a hospital
12 or skilled nursing facility is designed to provide, but who because of their mental or physical con-
13 dition require care and services above the level of room and board that can be made available to
14 them only through institutional facilities.

15 (16) “Long term care facility” means a facility with permanent facilities that include inpatient
16 beds, providing medical services, including nursing services but excluding surgical procedures ex-
17 cept as may be permitted by the rules of the Director of Human Services, to provide treatment for
18 two or more unrelated patients. “Long term care facility” includes skilled nursing facilities and
19 intermediate care facilities but may not be construed to include facilities licensed and operated
20 pursuant to ORS 443.400 to 443.455.

21 (17) “New hospital” means a facility that did not offer hospital services on a regular basis within
22 its service area within the prior 12-month period and is initiating or proposing to initiate such ser-
23 vices. “New hospital” also includes any replacement of an existing hospital that involves a sub-
24 stantial increase or change in the services offered.

25 (18) “New skilled nursing or intermediate care service or facility” means a service or facility
26 that did not offer long term care services on a regular basis by or through the facility within the
27 prior 12-month period and is initiating or proposing to initiate such services. “New skilled nursing
28 or intermediate care service or facility” also includes the rebuilding of a long term care facility, the
29 relocation of buildings that are a part of a long term care facility, the relocation of long term care
30 beds from one facility to another or an increase in the number of beds of more than 10 or 10 percent
31 of the bed capacity, whichever is the lesser, within a two-year period **in a facility that applied for
32 a certificate of need between August 1, 2011, and December 1, 2012, or submitted a letter of
33 intent under ORS 442.315 (7) between January 15, 2013, and January 31, 2013.**

35 [(6)(a)] **(5)(a)** The department shall reimburse costs using the methodology described in [sub-
36 sections (4) and (5)] **subsection (4)** of this section at a rate not lower than a percentile of allowable
37 costs for the period for which the reimbursement is made.

38 (b) For the period beginning July 1, 2013, and ending June 30, 2016, the department shall reim-
39 burse costs at a rate not lower than the 63rd percentile of rebased allowable costs for that period.

40 (c) For each three-month period beginning on or after July 1, 2016, in which the reduction in
41 bed capacity in Medicaid-certified long term care facilities is less than *[the goal established in section*
42 *15 of this 2013 Act]* **1,500 in bed capacity statewide that existed on the effective date of this**
43 **2013 Act**, the department shall reimburse costs at a rate not lower than the percentile of allowable
44 costs according to the following schedule:

- 45 (A) 62nd percentile for a reduction of 1,350 or more beds.

1 (B) 61st percentile for a reduction of 1,200 or more beds but less than 1,350 beds.

2 (C) 60th percentile for a reduction of 1,050 or more beds but less than 1,200 beds.

3 (D) 59th percentile for a reduction of 900 or more beds but less than 1,050 beds.

4 (E) 58th percentile for a reduction of 750 or more beds but less than 900 beds.

5 (F) 57th percentile for a reduction of 600 or more beds but less than 750 beds.

6 (G) 56th percentile for a reduction of 450 or more beds but less than 600 beds.

7 (H) 55th percentile for a reduction of 300 or more beds but less than 450 beds.

8 (I) 54th percentile for a reduction of 150 or more beds but less than 300 beds.

9 (J) 53rd percentile for a reduction of 1 to 149 beds.

10 [(7)] (6) A reduction in the percentile **ceiling** of allowable costs reimbursed under subsection
11 [(6)] (5) of this section is not subject to ORS 410.555.

12 **SECTION 25.** (1) **Section 1 of this 2013 Act and the amendments to ORS 414.746 and**
13 **sections 2, 3, 6, 7, 8, 9, 10, 12 and 13, chapter 736, Oregon Laws 2003, by sections 2 to 11 of**
14 **this 2013 Act become operative on the date that the Director of the Oregon Health Authority**
15 **notifies the Legislative Counsel that the director received federal approval as described in**
16 **section 13 of this 2013 Act.**

17 (2) **The repeal of ORS 414.746 by section 12 of this 2013 Act becomes operative April 1,**
18 **2014.**

19 **SECTION 26.** (1) **The amendments to section 18, chapter 736, Oregon Laws 2003, by sec-**
20 **tion 18 of this 2013 Act become operative January 1, 2014.**

21 (2) **The amendments to ORS 442.015 and 442.315 and section 24, chapter 736, Oregon Laws**
22 **2003, by sections 22, 23 and 24 of this 2013 Act become operative June 30, 2020.**

23 **SECTION 27.** **Section 15 of this 2013 Act is repealed June 30, 2020.**

24 **SECTION 28.** **This 2013 Act takes effect on the 91st day after the date on which the 2013**
25 **regular session of the Seventy-seventh Legislative Assembly adjourns sine die.**
