SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

[Directs State Board of Education and State Board of Higher Education to work with Governor and conduct study on improving education governance.]

[Requires boards to submit joint report to interim legislative committees no later than July 1, 2014.]

- Grants additional authorities to Higher Education Coordinating Commission.**
- Modifies membership requirements for Higher Education Coordinating Commission.**
- Creates Office of Student Access and Completion.**
- Abolishes Oregon Student Access Commission.**
- Transfers policy and dispute resolution authority of Oregon Student Access Commission to Higher Education Coordinating Commission.**
- Transfers administrative authority of Oregon Student Access Commission to Office of Student Access and Completion.**
- Transfers authority over community colleges from State Board of Education to Higher Education Coordinating Commission.**
- Declares emergency, effective on passage.

11 functions and powers transferred by section 19 of this 2013 Act are transferred to the Higher
12 Education Coordinating Commission. For the purpose of succession to these rights and obli-
13 gations, the commission is a continuation of the board and not a new authority.

14 **SECTION 23.** (1) Notwithstanding the transfer of duties, functions and powers by section
15 19 of this 2013 Act, the rules of the State Board of Education in effect on the operative date
16 of section 19 of this 2013 Act continue in effect until superseded or repealed by rules of the
17 Higher Education Coordinating Commission.

18 (2) References in rules of the State Board of Education to the board or an officer or
19 employee of the board are considered to be references to the Higher Education Coordinating
20 Commission or to an officer or employee of the commission.

21 **SECTION 24.** The State Board of Education and the Higher Education Coordinating
22 Commission may take any action before the operative date specified in section 201 of this
23 2013 Act that is necessary to enable the commission to exercise, on and after the operative
24 date specified in section 201 of this 2013 Act, all the duties, functions and powers conferred
25 on the Higher Education Coordinating Commission by section 19 of this 2013 Act.

36 (2) On or after the effective date of this 2013 Act, is employed by an agency or public
37 corporation in a capacity that was within the authority of the board before the effective date
38 of this 2013 Act.

39 **SECTION 26.** For purposes of Article XI-M, section 1, of the Oregon Constitution, a
40 building owned by the State Board of Higher Education includes a building owned by:

41 (1) The State Board of Higher Education on the date before the effective date of this 2013
42 Act that, as a result of sections 6 to 24 of this 2013 Act and the amendments to ORS 351.715
43 and 351.735 and section 2, chapter 637, Oregon Laws 2011, by sections 1 to 5 of this 2013 Act,
44 is on the effective date of this 2013 Act owned by another agency or public corporation of this
45 state and used for purposes within the authority of the board on the date before the effective

1 date of this 2013 Act.

2 (2) An agency or public corporation of this state on or after the effective date of this 2013
3 Act and used for purposes within the authority of the board before the effective date of this
4 2013 Act.

5 **SECTION 27.** (1) Nothing in sections 25 and 26 of this 2013 Act shall be construed in any
6 way to impair the obligations or agreements of the State of Oregon or the State Board of
7 Higher Education with respect to bonds, certificates of participation, financing agreements
8 or other agreements for the borrowing of money issued prior to the operative date specified
9 in section 201 of this 2013 Act by the State of Oregon on behalf of the State Board of Higher
10 Education. A public university and the Oregon University System shall take all actions nec-
11 essary to ensure full compliance with all indentures, resolutions, declarations, agreements
12 and other documents issued with respect to the bonds, certificates of participation, financing
13 agreements or other agreements for the borrowing of money issued prior to the operative
14 date specified in section 201 of this 2013 Act by the State of Oregon on behalf of the State
15 Board of Higher Education. The Oregon University System and a public university shall es-
16 tablish, in a written agreement that shall be subject to the approval of the State Treasurer,
17 the responsibility of the public university for the payment to the State Board of Higher Ed-
18 ucation of moneys sufficient to pay when due all principal, interest and any other charges
19 on bonds, certificates of participation, financing agreements or other agreements for the
20 borrowing of money issued prior to the operative date specified in section 201 of this 2013
21 Act by the State of Oregon on behalf of the State Board of Higher Education.

22 (2) Holders of obligations issued by a public university on or after the operative date
23 specified in section 201 of this 2013 Act may be paid *pari passu* with the obligations issued
24 by the State of Oregon on behalf of the State Board of Higher Education for the public uni-
25 versity prior to the operative date specified in section 201 of this 2013 Act from the tuition,
26 fees, rents, revenues, receipts, appropriations or other income of the public university, but
27 only to the extent that:

28 (a) The holders have no rights, liens or other interests with respect to the tuition, fees,
29 rents, revenues, receipts, appropriations or other income of the university that are senior
30 or superior to the rights granted to the holders of obligations issued prior to the operative
31 date specified in section 201 of this 2013 Act by the State of Oregon on behalf of the State
32 Board of Higher Education; and

33 (b) The State Board of Higher Education, the Oregon Department of Administrative
34 Services or the State of Oregon, acting for the benefit of such holders of obligations, is
35 granted a lien or other security interest in the tuition, fees, rents, revenues, receipts, ap-
36 propriations or other income of the public university that is not junior to and is at least *pari*
37 *passu* with any lien or other security interest granted to the holders of obligations issued
38 by the public university.

39 (3) Any expenses, including legal expenses, judgments, liabilities and federal arbitrage and
40 rebate penalties arising from the actions of the public university, if incurred with respect to
41 bonds, certificates of participation, financing agreements or other agreements for the bor-
42 rowing of money issued prior to the operative date specified in section 201 of this 2013 Act
43 by the State of Oregon on behalf of the State Board of Higher Education, shall be paid when
44 due by the public university, subject to the public university's right to reasonably contest the
45 charges, judgments, liabilities or penalties. The public university shall assist the Controller

1 of the Oregon University System in making any necessary calculations and filing any neces-
2 sary reports related to arbitrage and rebate on the indebtedness.

3 (4) Any amounts deposited with the State Treasurer, the Controller of the Oregon Uni-
4 versity System, the Oregon Department of Administrative Services or their designated
5 agents in any debt service in reserve accounts for the debt service associated with any
6 bonds, certificates of participation, financing agreements or other agreements for the bor-
7 rowing of money issued prior to the operative date specified in section 201 of this 2013 Act
8 by the State of Oregon on behalf of the State Board of Higher Education shall remain with
9 the State Treasurer, the Controller of the Oregon University System, the Oregon Depart-
10 ment of Administrative Services or their designated agents until the time that the bonds,
11 certificates of participation, financing agreements or other agreements for the borrowing of
12 money for which the reserve accounts have been established have been retired or defeased.
13 The public university shall be credited with the investment earnings on the reserve accounts.

14 **SECTION 28.** (1) Nothing in sections 19 to 21 of this 2013 Act shall be construed in any
15 way to impair the obligations or agreements of the State of Oregon or the State Board of
16 Education with respect to bonds, certificates of participation, financing agreements or other
17 agreements for the borrowing of money issued prior to the operative date specified in section
18 201 of this 2013 Act by the State of Oregon on behalf of community colleges. A community
19 college and the State Board of Education shall take all actions necessary to ensure full
20 compliance with all indentures, resolutions, declarations, agreements and other documents
21 issued with respect to the bonds, certificates of participation, financing agreements or other
22 agreements for the borrowing of money issued prior to the operative date specified in section
23 201 of this 2013 Act by the State of Oregon on behalf of the State Board of Education. The
24 State Board of Education and a community college shall establish, in a written agreement
25 that shall be subject to the approval of the State Treasurer, the responsibility of the com-
26 munity college for the payment to the State Board of Education of moneys sufficient to pay
27 when due all principal, interest and any other charges on bonds, certificates of participation,
28 financing agreements or other agreements for the borrowing of money issued prior to the
29 operative date specified in section 201 of this 2013 Act by the State of Oregon on behalf of
30 the State Board of Education.

31 (2) Holders of obligations issued by a community college on or after the operative date
32 specified in section 201 of this 2013 Act may be paid *pari passu* with the obligations issued
33 by the State of Oregon on behalf of the State Board of Education for the community college
34 prior to the operative date specified in section 201 of this 2013 Act from the tuition, fees,
35 rents, revenues, receipts, appropriations or other income of the community college, but only
36 to the extent that:

37 (a) The holders have no rights, liens or other interests with respect to the tuition, fees,
38 rents, revenues, receipts, appropriations or other income of the community college that are
39 senior or superior to the rights granted to the holders of obligations issued prior to the op-
40 erative date specified in section 201 of this 2013 Act by the State of Oregon on behalf of the
41 State Board of Education; and

42 (b) The State Board of Education, the Oregon Department of Administrative Services or
43 the State of Oregon, acting for the benefit of such holders of obligations, is granted a lien
44 or other security interest in the tuition, fees, rents, revenues, receipts, appropriations or
45 other income of the community college that is not junior to and is at least *pari passu* with

1 any lien or other security interest granted to the holders of obligations issued by the com-
2 munity college.

3 (3) Any expenses, including legal expenses, judgments, liabilities and federal arbitrage and
4 rebate penalties arising from the actions of the community college, if incurred with respect
5 to bonds, certificates of participation, financing agreements or other agreements for the
6 borrowing of money issued prior to the operative date specified in section 201 of this 2013
7 Act by the State of Oregon on behalf of the State Board of Education, shall be paid when due
8 by the community college, subject to the community college's right to reasonably contest the
9 charges, judgments, liabilities or penalties. The community college shall assist the Higher
10 Education Coordinating Commission and the Department of Education in making any neces-
11 sary calculations and filing any necessary reports related to arbitrage and rebate on the
12 indebtedness.

13 (4) Any amounts deposited with the State Treasurer, the Higher Education Coordinating
14 Commission, the Department of Education, the Oregon Department of Administrative Ser-
15 vices or their designated agents in any debt service in reserve accounts for the debt service
16 associated with any bonds, certificates of participation, financing agreements or other
17 agreements for the borrowing of money issued prior to the operative date specified in section
18 201 of this 2013 Act by the State of Oregon on behalf of the State Board of Education shall
19 remain with the State Treasurer, the Higher Education Coordinating Commission, the De-
20 partment of Education, the Oregon Department of Administrative Services or their desig-
21 nated agents until the time that the bonds, certificates of participation, financing
22 agreements or other agreements for the borrowing of money for which the reserve accounts
23 have been established have been retired or defeased. The community college shall be credited
24 with the investment earnings on the reserve accounts.

2 [(B) *The Chancellor of the Oregon University System.*]

3 [(C) *The executive director of the Oregon Student Access Commission.*]

4 [(D)] (A) The Early Childhood System Director.

5 [(E)] (B) The executive director of the Higher Education Coordinating Commission.

6 [(F)] (C) The Deputy Superintendent of Public Instruction.

7 (c) The authority of the Chief Education Officer granted under paragraph (a) of this subsection
8 does not include the authority to appoint or remove a person from a position identified in paragraph
9 (b) of this subsection.

10 (d) If a person in a position identified in paragraph (b) of this subsection is appointed by an
11 entity other than the Governor, the Governor shall resolve any dispute between the Chief Education
12 Officer and the appointing authority of the person. The Governor's decision is final.

13 **SECTION 30.** Section 14, chapter 36, Oregon Laws 2012, is amended to read:

14 **Sec. 14.** (1) For the purposes of this section:

15 (a) "Achievement compact" means an agreement entered into between the Oregon Education
16 Investment Board and the governing body of an education entity as described in this section.

34 Board of Directors.

35 (2)(a) Prior to the beginning of each fiscal year, the governing body of each education entity
36 must enter into an achievement compact with the Oregon Education Investment Board for the fiscal
37 year.

38 (b) Governing bodies of education entities identified in subsection (1)(b)(A) to (C) of this section
39 shall enter into achievement compacts as part of the budgeting process under ORS 294.305 to 294.565
40 and shall submit achievement compacts to the board prior to July 1 of each year.

41 (c) The board shall specify a process for adoption and a timeline for submission of achievement
42 compacts for education entities identified in subsection (1)(b)(D) to (F) of this section.

43 (d) The board shall provide to each school district a number quantifying the district's estimated
44 level of funding for the next fiscal year compared to the determination of funding needed to ensure
45 that the state's system of kindergarten through grade 12 public education meets the quality goals

1 specified under ORS 327.506.

2 (3)(a) The board shall establish the terms for achievement compacts.

3 (b) The terms of an achievement compact may include:

4 (A) A description of goals for outcomes that are consistent with the educational goals identified
5 in ORS 329.015, the findings described in ORS 351.003 and the mission of education provided in ORS
6 351.009.

7 (B) A description of the outcomes and measures of progress that will allow each education entity
8 to quantify:

9 (i) Completion rates for:

10 (I) Critical stages of learning and programs of study;

11 (II) The attainment of diplomas, certificates and degrees; and

12 (III) Achieving the high school and post-secondary education goals established in ORS 351.009
13 and a projection of the progress needed to achieve those goals by 2025;

14 (ii) Validations of the quality of knowledge and skills acquired by students of the education en-
15 tity; and

16 (iii) The relevance of the knowledge and skills acquired by the students of the education entity
17 and the means by which those skills and knowledge will contribute to the workforce, the economy
18 and society as described in state policy.

19 (C) Other information suggested by the governing body of an education entity and approved by
20 the board.

21 (c) Notwithstanding the terms described in paragraph (b) of this subsection, for an achievement
22 compact entered into by an education entity identified in subsection (1)(b)(F) of this section, the
23 terms of the achievement compact shall be limited to the enrollment of, and attainment of degrees
24 by, Oregon residents in programs for which the state provides funding.

25 (4)(a) The governing body of each education entity shall identify a target number and percentage
26 of students for achievement of the outcomes, measures of progress and goals specified in the
27 achievement compact for the fiscal year.

28 (b) The governing body of each education entity shall provide a target number and percentage
29 of students for the aggregate of all disadvantaged subgroups, as defined by federal law or specified
30 by rules adopted by the board. The target number and percentage of students must reflect the edu-
31 cation entity's goals of improving education outcomes for disadvantaged student groups and closing
32 any student achievement gaps between disadvantaged student groups and other student groups.

33 (5) As part of the process of entering into an achievement compact, the governing body of an
34 education entity shall ensure that open communications are provided to parents, students, teachers
35 or faculty, employees, exclusive bargaining representatives and community representatives for the
36 purposes of explaining and discussing the outcomes, measures of progress, goals and targets speci-
37 fied in the achievement compact for the fiscal year. The open communications must be provided
38 during each education entity's public budget process.

39 (6) The board shall specify the format of the achievement compacts and provide model achieve-
40 ment compacts to the governing body of each education entity.

41 (7) The board may adopt a timeline and method for governing bodies of education entities to
42 provide the board with a report at the end of a fiscal year that describes the achievements made
43 by the education entities during the fiscal year. The report:

44 (a) Must include disaggregated data for each disadvantaged student group specified by the

1 (b) May state achievements in numbers and percentages and in relation to the outcomes, meas-

4 336.590. (1) As used in this section, “Youth Corrections Education Program” means the program

6 (2) The Department of Education shall provide or cause to be provided appropriate education
7 for children enrolled in an educational program under the Youth Corrections Education Program.
8 The Superintendent of Public Instruction may contract with a school district or education service
9 district to provide or cause to be provided appropriate education to children enrolled in an educa-
10 tional program under the Youth Corrections Education Program.

11 (3) The superintendent shall pay the costs of providing education to children enrolled in an ed-

22 *[(e)]* (d) Participate in the beginning teacher and administrator mentorship program established
23 by ORS 329.788 to 329.820.

24 *[(f)]* (e) Receive funds under ORS chapter 329 as provided by ORS 329.875.

25 **SECTION 43.** ORS 341.005 is amended to read:

26 341.005. As used in this chapter, unless the context otherwise requires:

27 (1) “Academic year” means the year beginning July 1 of each year and ending June 30 of the
28 following year running concurrently with the fiscal year.

29 (2) “Board” means the board of education of a community college district.

30 (3) “Board member” means a member of the board of education of a community college district.

31 (4) “Commissioner” means the Commissioner for Community College Services appointed under

1 [(8) “Operating expenses” means the sum of the expenditures of a community college district for
2 administration, instruction, necessary student services, operation and maintenance of plant and fixed
3 charges, as determined in accordance with the rules of the State Board of Education.]

4 [(9) (8) “Paying agent and registrar” means the county treasurer or county fiscal officer of the
5 county in which the chief administrative officer of the community college district maintains the ad-
6 ministrative office.

7 [(10) (9) “Petitioning territory” means a community college district petitioning to have an area
8 outside the district included in the district or to have an area inside the district excluded from the
9 district, or an area outside the district petitioning to be included within the district.

10 [(11) (10) “Principal county” means the county in which the chief administrative officer of the
11 community college district maintains the administrative office.

12 [(12) “State board” means the State Board of Education.]

13 **SECTION 44.** ORS 341.009 is amended to read:

14 341.009. The Legislative Assembly finds that:

15 (1) The community college is an educational institution that is intended to fill the institutional
16 gap in education by offering broad, comprehensive programs in academic subjects and in career and
17 technical education subjects. It is primarily designed to provide associate or certificate degree pro-
18 grams for some, serve a transitional purpose for others who will continue baccalaureate or other
19 college work, provide the ability to enter the workforce immediately and serve to determine future
20 educational needs for other students. It can provide means for continuation of academic education,
21 career and technical education or the attainment of entirely new skills as demands for old skills and
22 old occupations are supplanted by new technologies. It may also provide the means to coordinate
23 courses and programs with high schools to accommodate successful transition to college degree
24 programs.

25 (2) Each community college should be so located as to be within commuting time of a substantial
26 majority of its students. As an economical method of providing education close to the student’s
27 home, the community college should remain a commuting institution.

28 (3) The community college should establish its organizational patterns to maintain a unique
29 quality of flexibility and the ability to change to meet changing needs.

30 (4) The community college is a post-high-school institution [*under the general supervision of the*
31 *State Board of Education*]. It should not be a “starter” institution intended to evolve into a four-
32 year baccalaureate institution. It should be concerned with programs terminating before reaching
33 the baccalaureate degree.

34 (5) The community college should continue to be prohibited by law from becoming a
35 baccalaureate degree granting institution.

36 (6) Admission to the community college should be open to high school graduates or to persons
37 who have not graduated from high school who can profit from the instruction offered.

38 (7) There should be close cooperation between those directing the community college program
39 and those responsible for [*higher education*] **public universities listed in ORS 352.002**, so that
40 lower-division college transfer programs of the community college will provide adequate preparation
41 for entering baccalaureate degree granting programs, and so that students will be able to transfer
42 with a minimum of difficulty.

43 (8) The community college should offer as comprehensive a program as the needs and resources
44 of the area that it serves dictate. Cost to student and quality of instruction in established private
45 institutions should be among the factors in determining necessary duplication of effort.

1 (9) It should be the policy of the community college to open its facilities and make available its
 2 resources to the high schools of its area on a sound contractual basis, for appropriate secondary
 3 or transitional courses, either academic or as part of career and technical education, when it is
 4 within its ability to provide facilities and it is determined that the high school cannot or does not
 5 offer them.

6 (10) Programs designed to meet the needs of the area served should be based on the actual ed-
 7 ucational and service needs of the district. Specific career and technical education courses should
 8 be related not only to the employment opportunities of the area but of the state and nation as well.
 9 Such determination should be made in consultation with representatives of labor, business, industry,
 10 agriculture and other interested groups.

11 *[(11) The State Board of Education should be responsible for coordinating the community college*
 12 *program of the state and should have general supervisory responsibilities for that program. With the*

16 *[(12)]* (11) The initiative for the establishment of new community colleges should come from the

20 *[(13)]* (12) The governing board of the community college should be charged with the policy-
 21 making function. With respect to educational programming, the governing board **shall** *[should in*

7 (d) In another state and licensed or approved by the appropriate agency in that state.

8 (3) "Fraud or misrepresentation" means knowingly giving misinformation or a false impression
9 through the intentional misstatement of, concealment of or failure to make known a material fact
10 or by other means.

11 (4) "Manual" means the use of the hands or the feet, or both, or any part of the body in the
12 performance of massage.

13 (5) "Massage" or "massage therapy" means the use on the human body of pressure, friction,
14 stroking, tapping or kneading, vibration or stretching by manual or mechanical means or gymnas-
15 tics, with or without appliances such as vibrators, infrared heat, sun lamps and external baths, and
16 with or without lubricants such as salts, powders, liquids or creams for the purpose of, but not
17 limited to, maintaining good health and establishing and maintaining good physical condition.

18 (6) "Massage therapist" means a person licensed under ORS 687.011 to 687.250, 687.895 and

32 quired. Notwithstanding any provision in this section, the department may require cosigners on the
33 loans.

34 (2) Loans granted under ORS 348.040 to 348.070 to eligible students by the department shall:

35 (a) Not exceed \$1,000 in a single academic year to an undergraduate student.

36 (b) Not exceed \$4,000 in a single academic year to a graduate or professional student.

37 (c) Not exceed \$16,000 for all loans made to a student under ORS 348.040 to 348.070.

38 (3) Payment of interest shall be as follows:

39 (a) Medical and dental student borrowers at the Oregon Health and Science University and
40 veterinary student borrowers at Oregon State University shall be assessed at least six percent in-
41 terest per annum on the unpaid balance from the date of the note. Interest payments by these
42 borrowers shall be deferred until they cease to be enrolled. During the interest deferment period,
43 the [*Oregon Student Access Commission*] **Office of Student Access and Completion** shall pay the
44 department the negotiated rate of interest on an annual basis. The borrower shall reimburse the
45 [*commission*] **office** for these interest payments as provided in subsection (4) of this section. These

1 borrowers shall commence direct payment of accruing interest to the department at the time they
2 cease to be enrolled.

3 (b) All other borrowers are required to pay at least seven percent interest per annum on the
4 unpaid balance from the date of the loan as provided in subsection (4) of this section.

5 (c) The [commission] **office** shall pay annually to the department a maximum of three percent
6 per annum on the unpaid balance of all medical, dental and veterinary student borrower loans. The
7 rate of this special payment may vary annually and will be negotiated by the [commission] **office**
8 and the department.

9 (d) The interest rates to be charged the borrower for the school year as stated in paragraphs
10 (a) and (b) of this subsection shall be negotiated by the department and the [commission] **office**.

11 (4)(a) Repayment of the principal and accruing and deferred interest on loans shall be com-
12 menced not later than 12 months after the student's graduation or other termination of the student's
13 education.

14 (b) Notwithstanding any other provision of this section, medical, dental and veterinary student
15 borrowers who enter approved post-graduate study programs shall commence repayment of the
16 principal and the accruing and deferred interest on loans no later than 12 months following the
17 completion of the post-graduate study program or 60 months from when the loan was originally
18 granted, whichever is sooner.

19 (c) Repayment shall be completed in a maximum of 120 months from the time repayment is
20 commenced. However, nothing in this section is intended to prevent repayment without penalty at
21 an earlier date than provided in this section or to prohibit the department, with the consent of the
22 [Oregon Student Access Commission] **Office of Student Access and Completion**, from extending the
23 repayment period to a date other than permitted by this subsection.

24 (5) Notwithstanding any other provision of this section, the department may loan an amount
25 from the Common School Fund to a student under guaranteed programs authorized by the Higher
26 Education Act of 1965, as amended, commonly known as the Guaranteed Student Loan Program and
27 the Parent's Loans for Undergraduate Students Program. Neither the limitations on amounts set
28 forth in subsection (2) of this section nor the subsidies authorized by subsection (3) of this section
29 apply to such loans. ORS 327.484 does not apply to such loans.

30 **SECTION 197.** ORS 348.095 is amended to read:

31 348.095. From funds available therefor, the [Oregon Student Access Commission] **Office of Stu-**
32 **dent Access and Completion** shall reimburse the Department of State Lands for any loss resulting
33 from default of a student loan under ORS 348.040 to 348.070. Funds appropriated under ORS 348.050
34 to pay interest to the department on loans to medical, dental and veterinary students shall also be
35 available to reimburse the department for any loss resulting from default of a student loan under
36 ORS 348.040 to 348.070.

37 **SECTION 198.** Section 3, chapter 94, Oregon Laws 2012, is amended to read:

38 **Sec. 3.** (1) The STEM Fund is established in the State Treasury, separate and distinct from the
39 General Fund. Interest earned by the STEM Fund shall be credited to the fund. Moneys in the
40 STEM Fund are continuously appropriated to the [Oregon Student Access Commission] **Higher Ed-**
41 **ucation Coordinating Commission** for the purpose of providing scholarships to students to en-
42 courage study in science, technology, engineering and mathematics.

43 (2) The [Oregon Student Access] commission may accept grants, donations, contributions or gifts
44 from any source for deposit in the STEM Fund.

45 **SECTION 199.** ORS 351.052, as amended by section 7, chapter 104, Oregon Laws 2012, is

1 amended to read:

2 351.052. [(1) For the purposes of this section, “performance compact” means an agreement between
3 the State Board of Higher Education and the State of Oregon to achieve certain performance targets
4 in order to enhance the success of Oregon University System students in exchange for consideration
5 of the appropriations sought in a funding request submitted by the State Board of Higher Education
6 to the Oregon Department of Administrative Services.]

7 [(2)] (1) On or before September 1 of each even-numbered year, the State Board of Higher Edu-
8 cation shall submit [the] a funding request [and performance compact] to the [Oregon Department of
9 Administrative Services] **Higher Education Coordinating Commission** for the Oregon University
10 System.

11 [(3)] (2) The Governor’s biennial budget submitted to the Legislative Assembly may include the
12 **Higher Education Coordinating Commission’s** [State Board of Higher Education’s] funding request
13 [submitted to the Oregon Department of Administrative Services for the Oregon University System].
14 Any funding request approved by the Legislative Assembly must specify that the moneys be appro-
15 priated to the [Oregon Department of Administrative Services] **commission** for allocation to the
16 [Oregon University System] **public universities listed in ORS 352.002**.

17 [(4) The funding request must include, in addition to the performance compact, a report on per-
18 formance from the previous biennium’s performance compact.]

19 [(5) The State Board of Higher Education shall, by rule, establish a framework for the development
20 of a performance compact that must accompany the funding request to the Oregon Department of Ad-
21 ministrative Services. The framework must address, among other issues, the issue of tuition
22 affordability for students.]
