SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Defines "record of the case" and "supplemental confidential file" in juvenile court proceedings. Clarifies when exhibit or judicially noticed fact or law becomes part of record of case. Clarifies when record and file are subject to inspection or disclosure, and who may obtain copies. **Permits persons allowed by court to inspect and obtain copies of record and file, operative July 1, 2014.** Requires court to furnish transcript of evidence or proceedings to certain persons who are without financial means to purchase transcript.

Provides that reports and other materials relating to child, ward, youth or youth offender's history and prognosis created or maintained by Oregon Youth Authority or juvenile department are privileged and not subject to public inspection without consent of child, ward, youth or youth offender. Prescribes when and to whom reports and other materials may be disclosed and copies provided. Requires summary sheet in guardianship report.

Authorizes court on appeal from judgment in juvenile court proceeding to consent to disclosure of audiotape or videotape of oral proceeding on appeal.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. As used in this section and ORS 419A.253, 419A.255 and 419A.256:**

6 (1) "Person" means an individual, a public body as defined in ORS 174.109 or a tribe that
7 has intervened in a juvenile court proceeding pursuant to the Indian Child Welfare Act (25
8 U.S.C. 1901 et seq.).

9 (2) "Prospective appellate attorney" means an attorney designated by the office of public
10 defense services established under ORS 151.216 to potentially represent a child, ward, youth,
11 youth offender, or a parent or guardian of a child, ward, youth or youth offender, in a juve-
12 nile case when the case has been referred to the office of public defense services for appeal.

13 (3) "Record of the case" or "record of each case":

14 (a) Includes but is not limited to:

15 (A) The summons and other process;

16 (B) Petitions;

17 (C) Papers in the nature of pleadings, answers, motions, affidavits and other papers that
18 are filed with the court, including supporting documentation;

19 (D) Local citizen review board findings and recommendations submitted under ORS
20 419A.118 or 419B.367;

21 (E) Guardianship report summaries filed with the court under ORS 419B.367;

1 (F) Orders and judgments of the court, including supporting documentation;

4 (I) Other documents that become part of the record of the case by operation of law.

5 (b) May include electronic records.

6 (4) "Supplemental confidential file":

7 (a) Includes reports and other material relating to the child, ward, youth or youth
8 offender's history and prognosis, including but not limited to reports filed under ORS
9 419B.440, that:

10 (A) Are not or do not become part of the record of the case; and

11 (B) Are not offered or received as evidence in the case.

12 (b) May include electronic records.

13 **SECTION 2.** ORS 419A.253 is amended to read:

14 419A.253. (1) When, for the purpose of a hearing or proceeding that will result in the entry of
15 an order or judgment, the juvenile court [*considers*] **intends to rely upon** information in [*a*] **any**
16 **report, [*or other material described in ORS 419A.255 (2)*] material or document, including infor-**
17 **mation in the supplemental confidential file,** and no party has offered the report, [*or*] material
18 **or document** as an exhibit or asked the court to take judicial notice of **a fact or law in** the in-
19 **formation pursuant to ORS 40.060 to 40.085 and 40.090,** the court shall:

20 (a) Identify on the record the report, [*or*] material **or document,** or [*the part of*] **information**
21 **in the report, [*or*] material or document, [*that the court has considered.*] upon which the court**

7 ing to the child, ward, youth or youth offender's history and prognosis] **a supplemental confidential**
8 **file for each case and a record of each case except as otherwise provided in ORS 7.120.**

10 the **following:**

11 **(A) The judge of the juvenile court and those acting under the judge's direction;**

12 **(B) The child[,];**

36 (2)(a) Reports and other material relating to the child, ward, youth or youth offender's history
37 and prognosis **in the supplemental confidential file or record of the case** are privileged and,
38 except at the request of the child, ward, youth or youth offender, [may not be disclosed directly or
39 indirectly to anyone other than] **shall be withheld from public inspection. Once offered as an**
40 **exhibit, reports and other material relating to the child, ward, youth or youth offender's**
41 **history and prognosis become part of the record of the case but are subject to paragraph (e)**
42 **of this subsection.**

43 **(b) A supplemental confidential file is open to inspection by the following:**

44 **(A) The judge of the juvenile court[,] and those acting under the judge's direction[,];**

45 **(B) The parent or guardian of the child or ward in a dependency case;**

2 **(D) The parent or guardian of the youth or youth offender in a delinquency case if the**

28 **and attorneys] are entitled to [examine and obtain] copies of [any reports or other material relating**
29 **to the child, ward, youth or youth offender's history and prognosis.] material maintained in the**

31 **(A) The judge of the juvenile court and those acting under the judge's direction;**
32 **(B) Service providers in the case;**
33 **(C) School superintendents and their designees in cases under ORS 419C.005;**

35 **(E) The district attorney or assistant attorney general representing a party in the case;**
36 **(F) The juvenile department;**
37 **(G) The Department of Human Services;**
38 **(H) The Oregon Youth Authority; and**
39 **(I) The court appointed special advocate and a representative of a CASA Volunteer Pro-**
40 **gram as defined in section 3, chapter 97, Oregon Laws 2012.**
41 **(e) [Any service provider in the case, school superintendent, superintendent's designee or attorney**
42 **who examines or] A person that obtains copies of [such reports or materials is] material in the**
43 **supplemental confidential file pursuant to paragraph (d) of this subsection is responsible for**
44 **preserving [their] the confidentiality of the material in the supplemental confidential file. A**
45 **service provider, school superintendent or superintendent's designee who obtains copies of such**

1 [reports or materials shall return the copies to the court] **material shall destroy the copies** upon the
2 conclusion of [*the service provider's, superintendent's or superintendent's designee's*] involvement in
3 the case.

4 (3) Except as otherwise provided in subsection [(7)] (5) of this section, no information appearing
5 in the record of the case or in [*reports or other material relating to the child, ward, youth or youth*
6 *offender's history or prognosis*] **the supplemental confidential file** may be disclosed to any person
7 not described in subsection (2) of this section without the consent of the court, except for purposes
8 of evaluating the child, ward, youth or youth offender's eligibility for special education as provided
9 in ORS chapter 343, and no such information may be used in evidence in any proceeding to establish
10 criminal or civil liability against the child, ward, youth or youth offender, whether such proceeding
11 occurs after the child, ward, youth or youth offender has reached 18 years of age or otherwise, ex-
12 cept for the following purposes:

13 (a) In connection with a presentence investigation after guilt has been admitted or established
14 in a criminal court.

15 (b) In connection with a proceeding in another juvenile court concerning the child, ward, youth
16 or youth offender or an appeal from the juvenile court.

17 [(4) *If the court finds that the child, ward, youth, youth offender or parent is without financial*
18 *means to purchase all or a necessary part of the transcript of the evidence or proceedings, the court*
19 *shall order upon motion the transcript or part thereof to be furnished. The transcript or part thereof*
20 *furnished under this subsection shall be paid for in the same manner as furnished transcripts are paid*
21 *for in criminal cases.*]

22 (4)(a) **When a person described in subsection (1)(b)(M), (N), (O) or (P) of this section in-**
23 **spects or obtains copies of reports, materials or documents under this subsection or under**
24 **subsection (1) or (2) of this section, the person may not use or disclose the reports, materials**
25 **or documents, except:**

26 (A) **As provided in this subsection or under subsection (1) or (2) of this section;**

27 (B) **In the juvenile court proceeding for which the reports, materials or documents were**
28 **sought or disclosed;**

29 (C) **With the consent of the court; or**

31 (b) **Nothing in this section prohibits the district attorney or assistant attorney general**
32 **representing a party in a juvenile court proceeding, the juvenile department, the Department**
33 **of Human Services, the Oregon Youth Authority or other parties in the proceeding or their**
34 **attorneys from disclosing to each other reports, materials or documents described in sub-**
35 **sections (1) and (2) of this section if the disclosure is reasonably necessary to perform official**
36 **duties related to the involvement of the child, ward, youth or youth offender with the juve-**
37 **nil court or the juvenile department. A person to whom reports, materials or documents**
38 **are disclosed under this subsection is subject to subsection (3) of this section.**

39 (5)(a) **Information contained in the supplemental confidential file that, in the professional**
40 **judgment of the juvenile counselor, caseworker, school superintendent or superintendent's**
41 **designee, teacher or detention worker to whom the information in the supplemental confi-**
42 **dential file has been provided, indicates a clear and immediate danger to another person or**
43 **to society shall be disclosed to the appropriate authority and the person who is in danger**
44 **from the child, ward, youth or youth offender.**

45 (b) **A person that discloses information under paragraph (a) of this subsection has im-**

1 **munity from any liability, civil or criminal, that might otherwise be incurred or imposed for**
2 **making the disclosure.**

3 **(c) Nothing in this subsection affects the provisions of ORS 146.750, 146.760, 419B.035,**
4 **419B.040 and 419B.045. The disclosure of information under this subsection does not make the**
5 **information admissible in any court or administrative proceeding if it is not otherwise ad-**
6 **missible.**

7 [(5)] **(6) Notwithstanding any other provision of law, and subject to subsection (8) of this**
8 **section,** the following are not confidential and not exempt from disclosure:

9 (a) The name and date of birth of the youth or youth offender;

10 (b) The basis for the juvenile court's jurisdiction over the youth or youth offender;

11 (c) The date, time and place of any juvenile court proceeding in which the youth or youth
12 offender is involved;

13 (d) The act alleged in the petition that if committed by an adult would constitute a crime if ju-
14 risdiction is based on ORS 419C.005;

15 (e) That portion of the juvenile court order providing for the legal disposition of the youth or
16 youth offender when jurisdiction is based on ORS 419C.005;

17 (f) The names and addresses of the youth or youth offender's parents or guardians; and

18 (g) The register described in ORS 7.020 when jurisdiction is based on ORS 419C.005.

19 [(6)] **(7) Notwithstanding any other provision of law, and subject to subsection (8) of this**
20 **section,** when a youth has been taken into custody under ORS 419C.080, the following information
21 shall be disclosed unless, and only for so long as, there is a clear need to delay disclosure in the
22 course of a specific investigation, including the need to protect the complaining party or the victim:

23 (a) The youth's name and age and whether the youth is employed or in school;

24 (b) The youth offense for which the youth was taken into custody;

25 (c) The name and age of the adult complaining party and the adult victim, unless the disclosure
26 of such information is otherwise prohibited or restricted;

27 (d) The identity of the investigating and arresting agency; and

28 (e) The time and place that the youth was taken into custody and whether there was resistance,
29 pursuit or a weapon used in taking the youth into custody.

30 [(7)(a) *Information contained in reports and other materials relating to a child, ward, youth or*
31 *youth offender's history and prognosis that, in the professional judgment of the juvenile counselor,*
32 *caseworker, school superintendent or superintendent's designee, teacher or detention worker to whom*
33 *the information for the reports or other materials has been provided, indicates a clear and immediate*
34 *danger to another person or to society shall be disclosed to the appropriate authority and the person*
35 *or entity who is in danger from the child, ward, youth or youth offender.]*

36 [(b) *An agency or a person who discloses information under paragraph (a) of this subsection has*
37 *immunity from any liability, civil or criminal, that might otherwise be incurred or imposed for making*
38 *the disclosure.]*

39 [(c) *Nothing in this subsection affects the provisions of ORS 146.750, 146.760, 419B.035, 419B.040*
40 *and 419B.045. The disclosure of information under this section does not make the information admis-*
41 *sible in any court or administrative proceeding if it is not otherwise admissible.]*

42 (8) [A county juvenile department is the agency responsible for disclosing youth and youth offender
43 records if the records are subject to disclosure.] **Except as provided in ORS 419A.300 and 420.048,**
44 **only the juvenile court and the county juvenile department may disclose the information**
45 **under subsections (6) and (7) of this section if the information is subject to disclosure, unless**

1 otherwise directed by the court.

2 **(9) Nothing in this section limits access to any juvenile court records by an appellate**
3 **court reviewing a juvenile court order or judgment. Appellate court rules may establish**
4 **procedures for appellate court access to juvenile records.**

5 [(9)] **(10)** A petition filed under ORS 419B.851 alleging that a child who is a foreign national is
6 within the jurisdiction of the court, or a motion requesting an implementation plan other than return
7 of a ward to the ward's parent, is subject to disclosure to the consulate for the child or ward's
8 country as provided under ORS 419B.851 (3).

9 [(10)] **(11)** Nothing in this section prohibits a guardian appointed under ORS 419B.365 or
10 419B.366 from disclosing or providing copies of letters of guardianship when so required to fulfill the
11 duties of a guardian.

12 [(11)] **(12)** The court shall cooperate in the sharing of information with a court in another state
13 to facilitate an interstate placement of a child or ward.

14 **SECTION 4.** ORS 419A.256 is amended to read:

15 419A.256. (1)(a) Once prepared and filed with the court, a transcript of a juvenile court pro-
16 ceeding is part of the record of the case maintained by the clerk of the court under ORS 419A.255
17 (1) and is subject to the provisions of ORS 419A.255 [(1) and (3)] governing access and disclosure.

18 (b) Notwithstanding ORS 419A.255, if a transcript, audiotape or videotape has been prepared in
19 any proceeding under ORS chapter 419C, the victim may obtain a copy by paying the actual cost
20 of preparation.

21 **(2) If the court finds that the child, ward, youth, youth offender or parent or guardian**
22 **of the child, ward, youth or youth offender is without financial means to purchase all or a**
23 **necessary part of the transcript of the evidence or proceedings, the court shall order, upon**
24 **motion, the transcript or part of the transcript to be furnished. The transcript or part of the**
25 **transcript furnished under this subsection must be paid for in the same manner as furnished**
26 **transcripts are paid for in criminal cases.**

27 [(2)] **(3)** The official audio, video or other recording of a juvenile court proceeding shall be
28 withheld from public inspection but is open to inspection by the [*child, ward, youth, youth offender,*
29 *parent, guardian, court appointed special advocate, surrogate or a person allowed to intervene in a*
30 *proceeding involving the child, ward, youth or youth offender, and their attorneys*] **persons described**
31 **in ORS 419A.255 (1)(b)(A) to (P).**

32 **SECTION 5.** ORS 419A.257 is amended to read:

33 419A.257. [(1) *The district attorney or assistant attorney general representing the state in a juvenile*
34 *court proceeding, the juvenile department, the Department of Human Services and the Oregon Youth*
35 *Authority may inspect and obtain from the court copies of the records, reports and other materials de-*
36 *scribed in ORS 419A.255 (1) and (2) to the same extent that attorneys for the other parties and the*
37 *other parties are authorized to inspect and obtain copies of the records, reports and other materials.*
38 *An agency or person that inspects or obtains records, reports or materials under this subsection is*
39 *subject to ORS 419A.255 (3).]*

40 [(2) *Nothing in ORS 419A.255 prohibits the district attorney or assistant attorney general repre-*

14 **ward, youth or youth offender or with the authorization of the court, shall be withheld from**
15 **public inspection.**

36 (8) Except as provided in ORS 419A.300 and 420.048, only the juvenile court and the county ju-
37 venile department may disclose the information under subsections (6) and (7) of this section if the
38 information is subject to disclosure, unless otherwise directed by the court.

39 (9) Nothing in this section limits access to any juvenile court records by an appellate court re-
40 viewing a juvenile court order or judgment. Appellate court rules may establish procedures for ap-
41 pellate court access to juvenile records.

42 (10) A petition filed under ORS 419B.851 alleging that a child who is a foreign national is within
43 the jurisdiction of the court, or a motion requesting an implementation plan other than return of a
44 ward to the ward's parent, is subject to disclosure to the consulate for the child or ward's country
45 as provided under ORS 419B.851 (3).

1 (11) Nothing in this section prohibits a guardian appointed under ORS 419B.365 or 419B.366 from
2 disclosing or providing copies of letters of guardianship when so required to fulfill the duties of a
3 guardian.

4 (12) The court shall cooperate in the sharing of information with a court in another state to
5 facilitate an interstate placement of a child or ward.

6 **SECTION 12. The amendments to ORS 419A.255 by section 11 of this 2013 Act:**

7 **(1) Become operative on July 1, 2014; and**

8 **(2) Apply to juvenile court proceedings commenced on or after the operative date speci-**
9 **fied in subsection (1) of this section.**

10 **SECTION 13. Section 1 of this 2013 Act and the amendments to ORS 419A.015, 419A.200,**
11 **419A.253, 419A.255, 419A.256, 419A.257, 419A.300, 419B.367 and 420.048 by sections 2 to 10 of**
12 **this 2013 Act apply to juvenile court proceedings commenced on or after the effective date**
13 **of this 2013 Act.**
