Dear Senator Gelser,

We would like to take the opportunity to write to you in support of Senate Bill 449. SB 449 is a legislative bill currently being introduced by Senator Laurie Monnes Anderson. This bill encourages the Department of Human Services (DHS) to provide mandated services for Deaf, DeafBlind, and Hard of Hearing Oregonians.

Currently, ORS 410.740 does not require the DHS to provide services, even if it is advised by its own advisory committee to implement such programs for Deaf, DeafBlind, and Hard of Hearing Oregonians. We think DHS should be required to provide those services.

We have a few personal reasons why we would like to see DHS provide services. We run a school for deaf and hard of hearing children in Portland called Tucker-Maxon. Linda has been a Teacher of the Deaf for over 28 years. As a Teacher of the Deaf she is aware of the specific needs of this community. These services are urgently needed by our students and your constituents. Please let us know if you would like to visit the school. We would be pleased to provide you a tour and discuss SB 449 further.
