

HOUSE AMENDMENTS TO HOUSE BILL 2150

1 On page 1 of the printed bill, delete lines 24 through 28 and insert:

2 “(c) For the purpose of determining the amounts to be distributed to a school district from the
3 State School Fund for a public charter school, the district extended ADMw described in ORS 327.013
4 shall be calculated:

5 “(A) Except as provided by subparagraph (B) of this paragraph, as though the students enrolled
6 at a public charter school are students enrolled at the public schools of the school district in which
7 the public charter school is located.

8 “(B) By including only five percent of the portion of the ADM attributable to the students who
9 had been enrolled during the previous school year at a public charter school that has ceased to
10 operate because of dissolution or closure or because of termination or nonrenewal of a charter.”.

11 On page 3, after line 3, insert:

12 **“SECTION 2. (1) In addition to amounts distributed to a public charter school as provided
13 by ORS 338.155 and for the 2015-2016 school year only, an additional amount shall be available
14 for distribution to a school district that had been the sponsor of a public charter school that
15 operated during the 2014-2015 school year and that ceased to operate following the 2014-2015
16 school year because of dissolution or closure or because of termination or nonrenewal of a
17 charter.**

18 **“(2) The additional amount provided under subsection (1) of this section shall be based
19 on the district extended ADMw, described in ORS 327.013, which shall be calculated by in-
20 cluding only three percent of the portion of the ADM attributable to the students who had
21 been enrolled during the previous school year at the public charter school.**

22 **“(3) The Department of Education shall set aside the additional amount provided under
23 subsection (1) of this section for distribution to the school district described in subsection
24 (1) of this section. The amount shall be distributed to the school district upon a showing by
25 the school district of expenses incurred related to the public charter school that ceased to
26 operate. The department shall prescribe any requirements related to a distribution under
27 this section.**

28 **“(4)(a) For the 2015-2016 school year, the school district described in subsection (1) of this
29 section shall file with the department quarterly reports that describe expenses incurred by
30 the school district related to a public charter school that ceased to operate.**

31 **“(b) For the 2016-2017, 2017-2018 and 2018-2019 school years, the school district described
32 in subsection (1) of this section shall file with the department annual reports that describe
33 expenses incurred by the school district related to a public charter school that ceased to
34 operate.**

35 **“(c) The department shall prescribe any requirements for reports filed under this sub-**

1 **section.**

2 **“SECTION 3. (1) Section 2 of this 2015 Act is repealed on July 1, 2019.**

3 **“(2) Any amounts not distributed as provided by section 2 of this 2015 Act by July 1, 2019,**
4 **shall be transferred to the General Fund.”.**

5 In line 4, delete “2” and insert “4”.

6 In lines 17 through 19, restore the bracketed material.

7 In line 18, delete “(1)(b)”.

8 On page 4, line 32, delete “3” and insert “5” and delete “2” and insert “4”.

9 Delete lines 34 through 43.

10 In line 44, delete “5” and insert “6”.

11 _____
