SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Defines "inhalant delivery system." Amends laws concerning sale of tobacco products to, and use of tobacco products by, minors so those laws equally apply to inhalant delivery systems. Provides for further regulation of inhalant delivery systems.

Expands scope of offense of endangering welfare of a minor from knowingly causing sale of tobacco products to minors to knowingly allowing sale of tobacco products to minors and adds distribution and sale of inhalant delivery systems.

For purposes of Oregon Indoor Clean Air Act, defines "inhalant." Makes prohibitions of Oregon Indoor Clean Air Act apply to inhalants. Makes certain other changes to Oregon Indoor Clean Air Act.

Repeals laws related to smoking in public that are duplicative or inconsistent with provisions of Oregon Indoor Clean Air Act.

Declares emergency, effective on passage.

10 **SECTION 1.** ORS 431.840, as amended by section 2, chapter 20, Oregon Laws 2014, is amended
11 to read:

12 431.840. *[(1) It shall be unlawful to do any of the following:]*

13 *[(a) To distribute free tobacco products to persons under 18 years of age as part of a marketing*
14 *strategy to encourage the use of tobacco products.]*

15 *[(b) To fail as a retailer to post a notice substantially similar to that set forth in subsection (3) of*
16 *this section in a location clearly visible to the seller and the purchaser that sale of tobacco products*
17 *to persons under 18 years of age is prohibited.]*

18 *[(c) To sell cigarettes in any form other than a sealed package.]*

19 *[(2) As used in this section "tobacco products" means bidis, cigars, cheroots, stogies, periques,*
20 *granulated, plug cut, crimp cut, ready rubbed and other smoking tobacco, snuff, snuff flour, cavendish,*

1 *plug and twist tobacco, fine-cut and other chewing tobaccos, shorts, refuse scraps, clippings, cuttings*
2 *and sweepings of tobacco and other kinds and forms of tobacco, prepared in such manner as to be*
3 *suitable for chewing or smoking in a pipe or otherwise, or both for chewing and smoking, and shall*
4 *include cigarettes as defined in ORS 323.010 (1).]*

5 **(1) As used in this section and ORS 431.853:**

6 **(a)(A) “Inhalant delivery system” means:**

7 **(i) A device that can be used to deliver nicotine or cannabinoids in the form of a vapor**
8 **or aerosol to a person inhaling from the device; or**

9 **(ii) A component of a device described in this subparagraph or a substance in any form**
10 **sold for the purpose of being vaporized or aerosolized by a device described in this subpara-**
11 **graph, whether the component or substance is sold separately or is not sold separately.**

12 **(B) “Inhalant delivery system” does not include:**

13 **(i) Any product that has been approved by the United States Food and Drug Adminis-**
14 **tration for sale as a tobacco cessation product or for any other therapeutic purpose, if the**
15 **product is marketed and sold solely for the approved purpose; and**

16 **(ii) Tobacco products.**

17 **(b) “Tobacco products” means:**

18 **(A) Bidis, cigars, cheroots, stogies, periques, granulated, plug cut, crimp cut, ready**
19 **rubbed and other smoking tobacco, snuff, snuff flour, cavendish, plug and twist tobacco,**
20 **fine-cut and other chewing tobaccos, shorts, refuse scraps, clippings, cuttings and sweepings**
21 **of tobacco and other forms of tobacco, prepared in a manner that makes the tobacco suitable**
22 **for chewing or smoking in a pipe or otherwise, or for both chewing and smoking; or**

23 **(B) Cigarettes as defined in ORS 323.010 (1).**

24 **(2) It is unlawful:**

25 **(a) To distribute, sell or allow to be sold tobacco products or an inhalant delivery system**
26 **to a person under 18 years of age.**

27 **(b) To fail as a retailer of tobacco products to post a notice substantially similar to the**
28 **notice described in subsection (3) of this section in a location that is clearly visible to the**
29 **seller and the purchaser of the tobacco products.**

30 **(c) To fail as a retailer of inhalant delivery systems to post a notice in a location that is**
31 **clearly visible to the seller and the purchaser of the inhalant delivery systems that it is un-**
32 **lawful to sell inhalant delivery systems to persons under 18 years of age. The Oregon Health**
33 **Authority shall adopt by rule the content of the notice required under this paragraph.**

34 **(d) To distribute, sell or allow to be sold an inhalant delivery system if the inhalant de-**
35 **livery system is not labeled in accordance with rules adopted by the authority.**

36 **(e) To distribute, sell or allow to be sold an inhalant delivery system if the inhalant de-**
37 **livery system is not packaged in child-resistant safety packaging, as required by the au-**
38 **thority by rule.**

39 **(f) To distribute, sell or allow to be sold an inhalant delivery system if the inhalant de-**
40 **livery system is packaged in a manner that is attractive to minors, as determined by the**
41 **authority by rule.**

42 **(g) To distribute, sell or allow to be sold cigarettes in any form other than a sealed**
43 **package.**

44 **(3) The notice [shall] required by subsection (2)(b) of this section must be substantially as**

NOTICE

The sale of tobacco in any form to persons under 18 years of age is prohibited by law. Any person who [*knowingly*] sells, or [*causes*] **allows** to be sold, tobacco to a person under 18 years of age [*commits the offense of endangering the welfare of a minor, pursuant to ORS 163.575*] **is in violation of Oregon law.**

(4) Rules adopted under subsection (2)(d), (e) and (f) of this section must be consistent with any regulation adopted by the United States Food and Drug Administration related to labeling or packaging requirements for inhalant delivery systems.

SECTION 2. ORS 431.845 is amended to read:

431.845. [(1) *The civil penalty for violation of any provision of ORS 431.840 shall not be less than \$100 nor exceed \$500.*]

(1) The Oregon Health Authority may impose a civil penalty for each violation of ORS 431.840. A civil penalty imposed under this section may not be less than \$250 or more than \$1,000.

(2)(a) [The] Amounts collected under subsection (1) of this section shall be deposited [to the credit of the General Fund.] in the Oregon Health Authority Fund established under ORS 413.101. Except as provided in paragraph (b) of this subsection, moneys deposited in the fund under this subsection are continuously appropriated to the authority for carrying out the duties, functions and powers of the authority under ORS 431.840 and 431.853.

(b) At the end of each biennium, the authority shall transfer the unobligated moneys collected under subsection (1) of this section remaining in the fund to the Tobacco Use Reduction Account established under ORS 431.832.

SECTION 3. ORS 431.853 is amended to read:

431.853. (1) The Oregon Health Authority shall:

(a) Coordinate with law enforcement agencies to conduct random, unannounced inspections of [*Oregon*] wholesalers and retailers of tobacco products **or inhalant delivery systems** to [*insure*] **ensure** compliance with [*Oregon*] **the laws of this state** designed to discourage the use of tobacco **products and inhalant delivery systems** by minors, including ORS 163.575, 163.580, 167.400, 167.402 and 431.840; and

(b) Submit a report describing:

(A) The activities carried out to enforce the laws listed in paragraph (a) of this subsection during the previous fiscal year;

(B) The extent of success achieved in reducing the availability of tobacco products **and inhalant delivery systems** to minors; and

(C) The strategies to be utilized for enforcing the laws listed in paragraph (a) of this subsection during the year following the report.

(2) The [*Oregon Health*] authority shall adopt rules concerning random inspections of places that **distribute or sell tobacco products or inhalant delivery systems that are consistent with [section 1921, Public Law 102-321, 1992] any federal law or regulation relating to the inspection of such places.** The rules shall provide that inspections may take place:

(a) Only in areas open to the public;

1 (b) Only during **the** hours that tobacco products **or inhalant delivery systems** are [*sold or*]
2 distributed **or sold**; and

3 (c) No more frequently than once a month in any single establishment unless a compliance
4 problem exists or is suspected.

5 **(3) The Oregon Liquor Control Commission, pursuant to an agreement or otherwise, may**
6 **assist the authority with the authority's duties under subsection (1)(a) of this section and**
7 **the enforcement of ORS 431.840.**

8 **SECTION 4. (1) Except as provided by subsection (2) of this section, the amendments to**
9 **ORS 431.840, 431.845 and 431.853 by sections 1 to 3 of this 2015 Act apply to conduct occurring**
10 **on or after the effective date of this 2015 Act.**

11 **(2) The amendments to ORS 431.840 (3) by section 1 of this 2015 Act apply to notices**
12 **posted on or after January 1, 2016.**

14 **ENDANGERING THE WELFARE OF A MINOR**

15
16 **SECTION 5.** ORS 163.575, as amended by section 1, chapter 20, Oregon Laws 2014, is amended
17 to read:

18 163.575. (1) A person commits the offense of endangering the welfare of a minor if the person
19 knowingly:

20 (a) Induces, causes or permits an unmarried person under 18 years of age to witness an act of
21 sexual conduct or sadomasochistic abuse as defined [*by*] **in** ORS 167.060;

22 (b) Permits a person under 18 years of age to enter or remain in a place where unlawful activity
23 involving controlled substances is maintained or conducted;

24 (c) Induces, causes or permits a person under 18 years of age to participate in gambling as de-
25 fined [*by*] **in** ORS 167.117;

26 (d) Distributes, sells[, *or causes*] **or allows** to be sold[,] tobacco in any form to a person under
27 18 years of age; [*or*]

28 **(e) Distributes, sells or allows to be sold an inhalant delivery system, as defined in ORS**
29 **431.840, to a person under 18 years of age; or**

30 [*e*] **(f) Sells to a person under 18 years of age any device in which tobacco, marijuana, cocaine**
31 **or any controlled substance, as defined in ORS 475.005, is burned and the principal design and use**
32 **of which is directly or indirectly to deliver tobacco smoke, marijuana smoke, cocaine smoke or**
33 **smoke from any controlled substance into the human body including but not limited to:**

34 (A) Pipes, water pipes, hookahs, wooden pipes, carburetor pipes, electric pipes, air driven pipes,
35 corncob pipes, meerschaum pipes and ceramic pipes, with or without screens, permanent screens,
36 hashish heads or punctured metal bowls;

37 (B) Carburetion tubes and devices, including carburetion masks;

38 (C) Bongs;

39 (D) Chillums;

40 (E) Ice pipes or chillers;

41 (F) Cigarette rolling papers and rolling machines; and

42 (G) Cocaine free basing kits.

43 (2) Endangering the welfare of a minor by violation of subsection (1)(a), (b) or (c) of this section,
44 **by violation of subsection (1)(e) of this section if the inhalant delivery system contains or is**
45 **a substance containing a cannabinoid** or by violation of subsection [*(1)(e)*] **(1)(f)** of this section

1 involving other than a device for smoking tobacco, is a Class A misdemeanor.

2 (3) Endangering the welfare of a minor by violation of subsection (1)(d) of this section is a Class
3 A violation.

4 **(4) Endangering the welfare of a minor by violation of subsection (1)(e) of this section if
5 the inhalant delivery system does not contain or is not a substance containing a cannabinoid
6 is a Class A violation.**

7 [(4)] (5) Endangering the welfare of a minor by violation of subsection [(1)(e)] (1)(f) of this sec-
8 tion involving a device for smoking tobacco is a Class A violation.

9 **SECTION 6. The amendments to ORS 163.575 by section 5 of this 2015 Act apply to con-
10 duct occurring on or after the effective date of this 2015 Act.**

12 **VIOLATIONS AND REGULATION**

13
14 **SECTION 7.** ORS 167.400 is amended to read:

15 167.400. (1) **As used in this section and ORS 167.401, 167.402, 167.404 and 167.407:**

16 (a) **“Inhalant delivery system” has the meaning given that term in ORS 431.840.**

17 (b) **“Tobacco products” has the meaning given that term in ORS 431.840.**

18 [(1)] (2) It is unlawful for [any] a person under 18 years of age to possess tobacco products[, as
19 defined in ORS 431.840] **or inhalant delivery systems.**

20 [(2)] (3) [Any] A person who violates [subsection (1) of] this section commits a Class D violation.

21 **SECTION 8.** ORS 167.401 is amended to read:

22 167.401. (1)(a) Except as provided in subsection (4) of this section, [no] a person under 18 years
23 of age [shall] **may not** purchase, attempt to purchase or acquire tobacco products [as defined in
24 ORS 431.840] **or inhalant delivery systems.** [Except when such minor is in a private residence ac-
25 companied by the parent or guardian of the minor and with the consent of such parent or guardian,
26 no person under 18 years of age shall have personal possession of tobacco products.]

27 (b) **A person under 18 years of age may not possess tobacco products or an inhalant de-
28 livery system unless the person is in a private residence accompanied by the parent or
29 guardian of the person and the parent or guardian has consented to the person possessing
30 tobacco products or the inhalant delivery system.**

31 (2) [Any] A person who violates subsection (1) of this section commits a Class B violation.

32 (3)(a) In lieu of any other penalty established by law, a person who is convicted for the first time
33 of a violation of subsection (1) of this section may be ordered to participate in [a tobacco] **an** edu-
34 cation program **about using tobacco products or inhalant delivery systems** or a [tobacco use]
35 cessation program **for users of tobacco products or inhalant delivery systems** or to perform
36 community service related to diseases associated with [consumption of tobacco products] **using to-
37 bacco products or inhalant delivery systems. Except as provided in paragraph (b) of this
38 subsection, a person may be ordered to participate in [such] a program described in this para-
39 graph only once.**

40 (b) In addition to and not in lieu of any other penalty established by law, a person who is con-
41 victed of a second violation of subsection (1) of this section through misrepresentation of age may
42 be required to participate in [a tobacco education or a tobacco use cessation program] **a program
43 described in paragraph (a) of this subsection** or to perform community service [related to diseases
44 associated with the consumption of tobacco products] **as described in paragraph (a) of this sub-
45 section, and the court shall order that the person’s driving privileges [and] or right to apply for**

1 driving privileges be suspended for a period not to exceed one year. If a court has issued an order
 2 suspending driving privileges under this [subsection] **paragraph**, the court, upon petition of the
 3 person, may withdraw the order at any time the court deems appropriate. The court notification
 4 to the Department of Transportation under this [subsection] **paragraph** may include a recommen-
 5 dation that the person be granted a hardship permit under ORS 807.240 if the person is otherwise
 6 eligible for the permit.

7 (4) A [minor] **person under 18 years of age who is** acting under the supervision of an adult
 8 may purchase, attempt to purchase or acquire tobacco products **or an inhalant delivery system** for
 9 the purpose of testing compliance with a federal law, state [statute] **law**, local law or retailer man-
 10 agement policy limiting or regulating the delivery of tobacco products **or inhalant delivery sys-**
 11 **tems** to minors.

12 **SECTION 9.** ORS 167.402 is amended to read:

13 167.402. (1) As used in this section, “vending machine” means a mechanical, electronic or similar
 14 device that, upon the insertion of tokens, money or another form of payment, dispenses tobacco
 15 products **or inhalant delivery systems**.

16 (2) A person may not sell or dispense tobacco products[, *as defined in ORS 431.840,*] **or inhalant**
 17 **delivery systems** from a vending machine, except in an establishment where the premises are
 18 [*posted as*] permanently and entirely off-limits to minors under rules adopted by the Oregon Liquor
 19 Control Commission.

20 (3) [*Violation of subsection (2) of this section is*] **A person who violates this section commits**
 21 a Class B violation. Each day [*of*] **that the person commits the** violation constitutes a separate
 22 offense.

23 **SECTION 10.** ORS 167.404 is amended to read:

24 167.404. Cities and counties by ordinance or resolution [*shall*] **may** not regulate vending ma-
 25 chines that dispense tobacco products[, *as defined in ORS 431.840, in any form*] **or inhalant delivery**
 26 **systems** and that are in any manner accessible to minors.

27 **SECTION 11.** ORS 167.407 is amended to read:

28 167.407. (1) A person having authority over the location of [*cigarettes and other*] tobacco pro-
 29 ducts **or inhalant delivery systems** in a retail store may not locate [*cigarettes or other*] **the** tobacco
 30 products **or inhalant delivery systems** in a location in the store where the [*cigarettes or other*]
 31 tobacco products **or inhalant delivery systems** are accessible by store customers without assist-
 32 ance by a store employee.

33 (2) Violation of [*subsection (1) of*] this section is a Class B violation. Each day [*of*] **that the**
 34 **person commits the** violation constitutes a separate offense.

35 (3) [*Subsections (1) and (2) of this section do*] **This section does** not apply to a person if the
 36 location at which the [*cigarettes or*] tobacco products **or inhalant delivery systems** are sold is a
 37 store or other establishment at which persons under 18 years of age are prohibited.

38 **SECTION 12.** ORS 811.193 is amended to read:

39 811.193. (1)(a) A person commits the offense of smoking, **aerosolizing or vaporizing** in a motor
 40 vehicle if the person smokes **or uses an inhalant delivery system** in a motor vehicle while a per-
 41 son under 18 years of age is in the motor vehicle.

42 (b) As used in this subsection[,]:

43 (A) “Smokes” means to inhale, exhale, burn or carry a lighted cigarette, cigar, pipe, weed, plant,
 44 regulated narcotic or other combustible substance[.]; **and**

45 (B) “Uses an inhalant delivery system” means to use an inhalant delivery system, as

1 **defined in ORS 431.840, in a manner that creates an aerosol or vapor.**

2 (2) Notwithstanding ORS 810.410, a police officer may enforce this section only if the police of-
3 ficer has already stopped and detained the driver operating the motor vehicle for a separate traffic
4 violation or other offense.

5 (3) Smoking, **aerosolizing or vaporizing** in a motor vehicle is a:

6 (a) Class D traffic violation for a first offense.

7 (b) Class C traffic violation for a second or subsequent offense.

8 **SECTION 13. The amendments to ORS 167.400, 167.401, 167.402, 167.404, 167.407 and 811.193**
9 **by sections 7 to 12 of this 2015 Act apply to conduct occurring on or after the effective date**
10 **of this 2015 Act.**

12 **OREGON INDOOR CLEAN AIR ACT**

13
14 **SECTION 14.** ORS 433.835 is amended to read:

15 433.835. As used in ORS 433.835 to 433.875:

16 (1) "Cigar bar" means a business that:

17 (a) Has on-site sales of cigars as defined in ORS 323.500;

18 (b) Has a humidor on the premises;

19 (c) Allows the smoking of cigars on the premises but prohibits the smoking *[of all other tobacco*
20 *products in any form including, but not limited to, loose tobacco, pipe tobacco, cigarettes as defined in*
21 *ORS 323.010 and cigarillos as defined by the Oregon Health Authority by rule]*, **aerosolizing or**
22 **vaporizing of other inhalants on the premises;**

23 (d) Has been issued and operates under a full on-premises sales license issued under ORS
24 471.175;

25 (e) Prohibits persons under 21 years of age from entering the premises and posts notice of the
26 prohibition;

27 (f) Does not offer video lottery games as authorized under ORS 461.217;

28 (g) Has a maximum seating capacity of 40 persons;

29 (h) Has a ventilation system that exhausts smoke from the business and is designed and termi-
30 nated in accordance with the state building code standards for the occupancy classification in use;
31 and

32 (i) Requires all employees to read and sign a document that explains the dangers of exposure
33 to secondhand smoke.

34 [(2) "Enclosed area" means all space between a floor and a ceiling that is enclosed on three or more
35 sides by permanent or temporary walls or windows, exclusive of doors or passageways, that extend
36 from the floor to the ceiling.]

37 (2) "Inhalant" means nicotine, a cannabinoid or any other substance that:

38 (a) Is in a form that allows the nicotine, cannabinoid or substance to be delivered into a
39 person's respiratory system;

40 (b) Is inhaled for the purpose of delivering the nicotine, cannabinoid or other substance
41 into a person's respiratory system; and

42 (c)(A) Is not approved by, or emitted by a device approved by, the United States Food and
43 Drug Administration for a therapeutic purpose; or

44 (B) If approved by, or emitted by a device approved by, the United States Food and Drug
45 Administration for a therapeutic purpose, is not marketed and sold solely for that purpose.

1 (3)(a) "Place of employment" means *[every]* **an** enclosed area under the control of a public or
2 private employer *[that employees frequent during the course of employment]*, including *[but not limited*
3 *to]* work areas, employee lounges, vehicles that are operated in the course of an employer's business
4 **and** that are not operated exclusively by one employee, rest rooms, conference rooms, classrooms,
5 cafeterias, hallways, meeting rooms, elevators and stairways.

6 (b) "Place of employment" does not include a private residence unless it is used as a child care
7 facility as defined in ORS 329A.250 or a facility providing adult day care as defined in ORS 410.490.

8 (4) "Public place" means *[any]* **an** enclosed area open to the public.

9 (5) "Smoke shop" means a business that is certified with the authority as a smoke shop pursuant
10 to the rules adopted under ORS 433.847.

11 (6) "Smoking instrument" means any cigar, cigarette, pipe or other *[smoking equipment]* **in-**
12 **strument used to smoke tobacco, marijuana or any other inhalant.**

13 **SECTION 15.** ORS 433.840 is amended to read:

14 433.840. The people of Oregon find that because exposure to secondhand smoke, **certain exhaled**
15 **small particulate matter or other exhaled toxins** is known to cause cancer and other chronic
16 diseases such as heart disease, asthma and bronchitis, it is necessary to reduce exposure to
17 *[tobacco]* **such** smoke, **matter or toxins** by prohibiting the smoking, **aerosolizing or vaporizing**
18 **of inhalants** in all public places and places of employment.

19 **SECTION 16.** ORS 433.845 is amended to read:

20 433.845. (1) A person may not smoke, **aerosolize or vaporize an inhalant** or carry *[any]* **a**
21 lighted smoking instrument in a public place or place of employment except *[in areas designated as*
22 *smoking areas pursuant to]* **as provided in** ORS 433.850.

23 (2) A person may not smoke, **aerosolize or vaporize an inhalant** or carry *[any]* **a** lighted
24 smoking instrument within 10 feet of the following parts of public places or places of employment:

- 25 (a) Entrances;
- 26 (b) Exits;
- 27 (c) Windows that open; and
- 28 (d) Ventilation intakes that serve an enclosed area.

29 (3) A person may not smoke, **aerosolize or vaporize an inhalant** or carry *[any]* **a** lighted
30 smoking instrument in a room during the time that jurors are required to use the room.

31 **SECTION 17.** ORS 433.847 is amended to read:

32 433.847. (1) The Oregon Health Authority shall adopt rules establishing a certification system
33 for smoke shops. **In adopting such rules, the authority shall prohibit the smoking, aerosolizing**
34 **or vaporizing of inhalants that are not tobacco products in smoke shops.**

35 (2) The authority shall issue a smoke shop certification to a business that:

36 (a)(A) Is primarily engaged in the sale, **for off-premises consumption or use**, of tobacco pro-
37 ducts and smoking instruments *[intended for off-premises consumption or use]* **used to smoke to-**
38 **bacco products**, with at least 75 percent of the gross revenues of the business resulting from such
39 sales;

40 (B) Prohibits persons under 18 years of age from entering the premises;

41 (C) Does not offer video lottery games as authorized under ORS 461.217, social gaming or betting
42 on the premises;

43 (D) Does not sell, offer or allow on-premises consumption of food or beverages, including alco-
44 holic beverages;
