

House Bill 2329

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of Governor Kate Brown for State Board of Psychologist Examiners)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Permits State Board of Psychologist Examiners to assess disciplinary costs against disciplined person.

A BILL FOR AN ACT

2 Relating to assessment of disciplinary costs by State Board of Psychologist Examiners; creating new
3 provisions; and amending ORS 675.110.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 675.110 is amended to read:

6 675.110. The State Board of Psychologist Examiners shall have the following powers, in addition
7 to the powers otherwise granted under ORS 675.010 to 675.150, and shall have all powers necessary
8 or proper to carry the granted powers into effect:

9 (1) To determine qualifications of applicants to practice psychology in this state[;] **and** to cause
10 to have examinations prepared, conducted and graded and to grant licensing to qualified applicants
11 upon their compliance with the provisions of ORS 675.010 to 675.150 and the rules of the board.

12 (2) To grant or deny renewal of licenses, and to renew licenses which have lapsed for nonpay-
13 ment of the renewal fee, subject to the provisions of ORS 675.010 to 675.150.

14 (3) To suspend or revoke licenses, subject to ORS 675.010 to 675.150.

15 (4) To issue letters of reprimand, to impose probationary periods with the authority to restrict
16 the scope of practice of a licensed psychologist or to require practice under supervision.

17 (5) To impose civil penalties as provided in ORS 675.070.

18 (6) To restore licenses which have been suspended or revoked or voided by nonpayment of the
19 renewal fee.

20 (7)(a) To collect fees for application, examination and licensing of applicants, for renewal of li-
21 censes, and for issuance of limited permits, such fees to be used to defray the expenses of the board
22 as provided in ORS 675.140.

23 (b) The board may collect a delinquent renewal fee for licenses renewed after the deadline for
24 renewal but before the grace period for renewal has expired.

25 (8) To investigate alleged violations of ORS 675.010 to 675.150.

26 (9) To issue subpoenas for the attendance of witnesses, take testimony, administer oaths or af-
27 firmations to witnesses, conduct hearings, require the production of relevant documents in all pro-
28 ceedings pertaining to the duties and powers of the board.

29 (10) To enforce ORS 675.010 to 675.150 and to exercise general supervision over the practice of
30 psychology in this state.

31 (11) To adopt a common seal.

NOTE: Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 (12) To formulate a code of professional conduct for the practice of psychology giving particular
2 consideration to the Ethical Standards of Psychologists promulgated by the American Psychological
3 Association.

4 (13) To establish standards of service and training and educational qualifications for the ren-
5 dering of ethical psychological services in this state, including the formulation of standards for the
6 issuance of licenses for areas of special competence.

7 (14) To formulate and enforce continuing education requirements for duly licensed psychologists
8 to ensure the highest quality of professional services to the public.

9 (15) To deny renewal of a license, or renewal of a license that has lapsed for nonpayment of the
10 renewal fee, unless the applicant completes, or provides documentation of previous completion of:

11 (a) A pain management education program approved by the board and developed in conjunction
12 with the Pain Management Commission established under ORS 413.570; or

13 (b) An equivalent pain management education program, as determined by the board.

14 **(16) If the board takes disciplinary action under this section, to assess against the person**
15 **disciplined costs associated with the disciplinary action. An assessment under this subsection**
16 **is in addition to, and not in lieu of, any other action taken by the board. Moneys collected**
17 **under this subsection shall be deposited in the State Board of Psychologist Examiners Ac-**
18 **count established under ORS 675.140.**

19 [(16)] (17) For the purpose of requesting a state or nationwide criminal records check under ORS
20 181A.195, to require the fingerprints of a person who is:

21 (a) Applying for a license that is issued by the board;

22 (b) Applying for renewal of a license that is issued by the board; or

23 (c) Under investigation by the board.

24 [(17)] (18) Subject to the applicable provisions of ORS chapter 183, to adopt reasonable rules to
25 carry out the provisions of ORS 675.010 to 675.150.

26 **SECTION 2. The amendments to ORS 675.110 by section 1 of this 2017 Act apply to dis-**
27 **ciplinary actions commenced on or after the effective date of this 2017 Act.**
