

# House Bill 3080

Corrected Sponsor

Sponsored by COMMITTEE ON HEALTH CARE

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Establishes Task Force on State Medical Assistance Funding. Specifies membership. Requires task force to investigate sources of funding for medical assistance, including potential changes to existing funding, and submit report to interim committees of Legislative Assembly related to health by September 15, 2018.

Sunset December 31, 2018.

Takes effect on 91st day following adjournment sine die.

## A BILL FOR AN ACT

2 Relating to state medical assistance program funding; and prescribing an effective date.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. (1) The Task Force on State Medical Assistance Funding is established.**

5 **(2) The members of the task force shall be appointed as follows:**

6 **(a) The President of the Senate shall appoint:**

7 **(A) One member from among members of the Senate.**

8 **(B) Three members, with one each representing:**

9 **(i) Health care providers who serve medical assistance recipients;**

10 **(ii) Hospitals; and**

11 **(iii) Medical assistance recipients.**

12 **(b) The Speaker of the House of Representatives shall appoint:**

13 **(A) One member from among members of the House of Representatives.**

14 **(B) Three members, with one each representing:**

15 **(i) Health care providers who serve medical assistance recipients;**

16 **(ii) Hospitals; and**

17 **(iii) Medical assistance recipients.**

18 **(3) The task force shall investigate sources of funding for the state medical assistance**  
19 **program and potential changes to existing funding sources.**

20 **(4) A majority of the members of the task force constitutes a quorum for the transaction**  
21 **of business.**

22 **(5) Official action by the task force requires the approval of a majority of the members**  
23 **of the task force.**

24 **(6) The task force shall elect one of its members to serve as chairperson.**

25 **(7) If there is a vacancy for any cause, the appointing authority shall make an appoint-**  
26 **ment to become immediately effective.**

27 **(8) The task force shall meet at times and places specified by the call of the chairperson**

2 (9) The task force may adopt rules necessary for the operation of the task force.

3 (10) The task force shall submit a report in the manner provided by ORS 192.245, and  
4 may include recommendations for legislation, to the interim committees of the Legislative  
5 Assembly related to health no later than September 15, 2018.

6 (11) The Legislative Policy and Research Office shall provide staff support to the task  
7 force.

8 (12) Members of the task force who are not members of the Legislative Assembly are not  
9 entitled to compensation or reimbursement for expenses and serve as volunteers on the task  
10 force.

11 (13) All agencies of state government, as defined in ORS 174.111, are directed to assist  
12 the task force in the performance of the task force's duties and, to the extent permitted by  
13 laws relating to confidentiality, to furnish information and advice the members of the task  
14 force consider necessary to perform their duties.

15 SECTION 2. Section 1 of this 2017 Act is repealed on December 31, 2018.

16 SECTION 3. This 2017 Act takes effect on the 91st day after the date on which the 2017  
17 regular session of the Seventy-ninth Legislative Assembly adjourns sine die.
