SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

[Directs Oregon Arts Commission to establish policies and procedures] **Requires Director of Oregon Business Development Department to adopt rules** that ensure Arts Program considers regional differences in public access to, or opportunities for engagement in, arts and cultural development when determining eligibility for grant awards **and that promote investment in communities where opportunities for engagement in arts and cultural development are limited.**

Directs Oregon Arts Commission to establish policies and procedures for grant programs administered by Arts Program that are consistent with rules adopted by director.

2 Relating to the Arts Program; creating new provisions; and amending ORS 359.010, 359.025, 359.030,
3 359.050, 359.135 and 359.142.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 359.010 is amended to read:

6 359.010. As used in ORS 359.010 to 359.137, unless the context requires otherwise:

7 *[(1) "Administrator" means the Administrator of the Arts Program of the Oregon Business Devel-*
8 *opment Department.]*

9 *[(2)]* **(1)** "Arts" includes, but is not limited to[,];

10 **(a)** Instrumental and vocal music;

11 **(b)** Dance, drama[,], **and** folk art[,];

12 **(c)** Creative writing and poetry;

13 **(d)** Architecture and landscaping design and the fields allied to them;

14 **(e) Museum-related activities including, but not limited to:**

15 **(A) Exhibitions;**

16 **(B) Curation and maintenance of art work collections; and**

17 **(C) Education relating to works of art, artists and art history;**

18 **(f)** Painting, sculpture[,], **and** photography;

19 **(g)** Graphic and craft arts;

20 **(h)** Industrial design;

21 **(i)** Costume and fashion design;

22 **(j)** Motion pictures, television[,], **and** radio;

23 **(k)** Tape and sound recording;

24 **(L)** The history, criticism, theory and practice of the arts; and

25 **(m)** The *[arts related to the]* presentation, performance, execution and exhibition of *[such]* art

2 [(3)] (2) "Association" means a nonprofit, private, incorporated or unincorporated institution,
3 foundation, museum, organization, society or group, whether local, state, regional or national, that
4 is operating, or doing business, in Oregon.

5 [(4) "Commission" means the Oregon Arts Commission.]

6 [(5) "Department" means the Oregon Business Development Department.]

7 [(6) "Director" means the Director of the Oregon Business Development Department.]

8 [(7) "Program" means the Arts Program of the Oregon Business Development Department.]

9 [(8)] (3) "Local agencies" includes cities, counties and other public corporations and their offi-
10 cers, boards and commissions.

11 [(9) "Public agencies" means state agencies and local agencies.]

12 [(10)] (4) "Private corporation" means a corporation organized for profit and authorized to do
13 business in this state.

14 (5) **"Public agencies" means state agencies and local agencies.**

15 [(11)] (6) "State agencies" includes state officers, departments, boards and commissions.

16 **SECTION 2.** ORS 359.025 is amended to read:

17 359.025. (1) The Oregon Arts Commission shall perform the following duties:

18 (a) Serve as a body to advise governmental bodies and agencies and private persons on the de-
19 velopment and implementation of state policies and programs relating to the arts, heritage, historic
20 preservation, humanities and culture, and to assist in the coordination of these activities.

21 (b) Advise the Governor, the Director of the Oregon Business Development Department and the
22 Oregon Business Development Commission on all matters relating to the arts that pertain to the
23 powers, duties and functions of the Arts Program of the Oregon Business Development Department.

24 (c) Develop a recommended biennial budget for the operation of the Arts Program that will be
25 submitted to the director and the Governor.

26 (d) Seek and receive the views of all levels of government and the private sector with respect
27 to state programs and policies for the promotion and assistance of the arts.

28 (e) Prepare and submit suggested administrative rules to the director that the Oregon Arts
29 Commission determines are necessary for the operation of the programs of the Arts Program.

30 (f) Establish [*policy*] **policies** and procedures for grant programs administered by the Arts Pro-
31 gram **consistent with rules adopted under ORS 359.142.**

32 (2)(a) In addition to the duties imposed by subsection (1) of this section, the Oregon Arts Com-
33 mission shall establish policies and provide management and operational staff support for the Trust
34 for Cultural Development Board.

35 (b) Notwithstanding paragraph (a) of this subsection, the Trust for Cultural Development Board
36 shall make any decisions relating to the investment and disbursement of moneys in the Trust for
37 Cultural Development Account.

38 **SECTION 3.** ORS 359.135 is amended to read:

39 359.135. (1) The Director of the Oregon Business Development Department, upon consultation
40 with and the approval of the Oregon Arts Commission, shall appoint [*an*] **the** Administrator of the
41 Arts Program who shall serve at the pleasure of the director.

42 (2) The administrator shall receive such salary as may be provided by law or as fixed by the
43 director.

44 (3) The administrator shall be the administrative head of the program.

45 (4) The administrator may suggest rules to the director for the government of the program, the

1 conduct of its employees and the assignment and performance of its business and the custody, use
2 and preservation of its records, papers and property.

3 **SECTION 4.** ORS 359.050 is amended to read:

4 359.050. (1) In performing its duties, the Arts Program of the Oregon Business Development
5 Department, within the limits of available funds, may:

6 (a) Conduct hearings and conferences to develop facts, to explain programs and activities, and
7 to obtain advice.

8 (b) Enter into agreements with other public agencies and with associations and individuals for
9 services that will assist the Oregon Arts Commission or the Trust for Cultural Development Board.

10 (c) Enter into agreements with other public agencies of Oregon or with agencies of other states
11 or the federal government, and with private corporations, associations and individuals in Oregon or
12 other states for cooperative endeavors which further the objectives and programs of the commission.

13 (d) Make grants to local agencies, to associations or to individuals for the development and
14 conservation of programs in the arts, such grants to be made in accordance with policies and pro-
15 cedures adopted by the commission **under ORS 359.025.**

16 (2) In carrying out the purposes of ORS 359.010 to 359.137, the Arts Program, in addition to the
17 other powers granted:

18 (a) Shall as needed appoint committees, consultants, artists and other persons expert in subjects
19 of concern to the program to advise and assist the commission.

20 (b) May obtain from any state agency necessary assistance and data.

21 (c) May perform other acts necessary to carry out its duties.

22 **SECTION 5. ORS 359.142 is added to and made a part of ORS 359.010 to 359.137.**

23 **SECTION 6.** ORS 359.142 is amended to read:

24 359.142. (1) The Director of the Oregon Business Development Department, in accordance with
25 ORS chapter 183, may adopt such rules for the operation of the Arts Program as the director de-
26 termines necessary or convenient for the program to perform its duties and functions.

27 **(2) The director shall adopt rules for grant programs administered by the Arts Program,**
28 **including rules that:**

29 **(a) Ensure that the criteria used to determine eligibility for grant awards are designed**
30 **to take into consideration the regional differences in public access to, or in opportunities for**
31 **engagement in, arts and cultural development in this state; and**

32 **(b) Promote investment in communities where opportunities for engagement in arts and**
33 **cultural development is limited.**

34 **SECTION 7.** ORS 359.030 is amended to read:

35 359.030. The objectives of the Arts Program of the Oregon Business Development Department
36 are:

37 (1) To complement, assist and strengthen existing or planned programs and activities of public
38 and private associations in the arts to promote the broadest **statewide** public benefit, while main-
39 taining high artistic and scholarly standards.

40 (2) To encourage and give greater opportunities and recognition to individual Oregon artists
41 whose work is, or gives promise of being, of high quality.

42 (3) To stimulate and encourage private and local initiative and financial support in connection
43 with programs and activities in the arts.
