SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Establishes Advance Directive Adoption Committee for purpose of adopting form of advance directive to be used in this state. [*Specifies that form may not take effect unless form is submitted and presented to certain committees of Legislative Assembly.*] Specifies that [*first*] form may not take effect unless form is ratified according to constitutional requirements for passage of legislative measures.

Requires Advance Directive Adoption Committee to submit form of advance directive to interim committee of Legislative Assembly related to judiciary. Directs interim committee, upon receiving form, to file proposed legislative measure with Legislative Counsel.

Repeals statute setting forth current form of advance directive used in this state. Sets forth alternative form of advance directive that may be used in this state. Sunsets alternative form on January 1, 2020.

Modifies means by which advance directive is executed.

Modifies law by which individual is selected to make health care decisions for another individual who becomes incapable of making health care decisions.

Makes certain other changes to provisions governing individuals who become incapable of making health care decisions.

Becomes operative January 1, 2018.

Takes effect on 91st day following adjournment sine die.

11 **SECTION 1. Sections 2 to 6 of this 2017 Act are added to and made a part of ORS 127.505**
12 **to 127.660.**

14 (Advance Directive Adoption Committee)

15
16 **SECTION 2. (1) The Advance Directive Adoption Committee is established within the di-**
17 **vision of the Oregon Health Authority that is charged with performing the public health**
18 **functions of the state.**

NOTE: Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

1 **(2)(a) The committee consists of 13 members.**

2 **(b) One member shall be the Long Term Care Ombudsman or the designee of the Long**
3 **Term Care Ombudsman.**

4 **(c) The other 12 members shall be appointed by the Governor as follows:**

5 **(A) One member who represents primary health care providers.**

6 **(B) One member who represents hospitals.**

7 **(C) One member who is a clinical ethicist affiliated with a health care facility located in**
8 **this state, or affiliated with a health care organization offering health care services in this**
9 **state.**

10 **(D) Two members who are health care providers with expertise in palliative or hospice**
11 **care, one of whom is not employed by a hospital or other health care facility, a health care**
12 **organization or an insurer.**

13 **(E) One member who represents individuals with disabilities.**

14 **(F) One member who represents consumers of health care services.**

15 **(G) One member who represents the long term care community.**

16 **(H) One member with expertise advising or assisting consumers with end-of-life deci-**
17 **sions.**

18 **(I) One member from among members proposed by the Oregon State Bar who has ex-**
19 **tensive experience in elder law and advising individuals on how to execute an advance di-**
20 **rective.**

21 **(J) One member from among members proposed by the Oregon State Bar who has ex-**
22 **tensive experience in estate planning and advising individuals on how to make end-of-life**
23 **decisions.**

24 **(K) One member from among members proposed by the Oregon State Bar who has ex-**
25 **tensive experience in health law.**

26 **(3) The term of office of each member of the committee is four years, but a member**
27 **serves at the pleasure of the appointing authority. Before the expiration of the term of a**
28 **member, the appointing authority shall appoint a successor whose term begins on January**
29 **1 next following. A member is eligible for reappointment. If there is a vacancy for any cause,**
30 **the appointing authority shall make an appointment to become immediately effective for the**
31 **unexpired term.**

32 **(4) A majority of the members of the committee constitutes a quorum for the transaction**
33 **of business.**

34 **(5) Official action by the committee requires the approval of a majority of the members**
35 **of the committee.**

36 **(6) The committee shall elect one of its members to serve as chairperson.**

37 **(7) The committee shall meet at times and places specified by the call of the chairperson**
38 **or of a majority of the members of the committee, provided that the committee meets at**
39 **least twice a year.**

40 **(8) The committee may adopt rules necessary for the operation of the committee.**

41 **(9) Members of the committee are not entitled to compensation, but may be reimbursed**
42 **for actual and necessary travel and other expenses incurred by them in the performance of**
43 **their official duties in the manner and amounts provided for in ORS 292.495. Claims for ex-**
44 **penses shall be paid out of funds appropriated to the Oregon Health Authority for purposes**
45 **of the committee.**

1 **SECTION 3. (1) In accordance with public notice and stakeholder participation require-**
2 **ments prescribed by the Oregon Health Authority and section 4 of this 2017 Act, the Advance**
3 **Directive Adoption Committee established under section 2 of this 2017 Act shall:**

4 **(a) Adopt the form of an advance directive to be used in this state; and**

5 **(b) Review the form not less than once every four years for the purpose of adopting**
6 **changes to the form that the committee determines are necessary.**

7 **(2) Except as otherwise provided by ORS 127.505 to 127.660, the form of an advance di-**
8 **rective adopted pursuant to this section is the only valid form of an advance directive in this**
9 **state.**

10 **(3) At a minimum, the form of an advance directive adopted under this section must**
11 **contain the following elements:**

12 **(a) A statement about the purposes of the advance directive, including:**

13 **(A) A statement about the purpose of the principal's appointment of a health care rep-**
14 **resentative to make health care decisions for the principal if the principal becomes incapable;**

15 **(B) A statement about the priority of health care representative appointment in ORS**
16 **127.655 in the event the principal becomes incapable and does not have a valid health care**
17 **representative appointment;**

18 **(C) A statement about the purpose of the principal's expression of the principal's values**
19 **and beliefs with respect to health care decisions and the principal's preferences for health**
20 **care;**

21 **(D) A statement about the purpose of the principal's expression of the principal's pref-**
22 **erences with respect to placement in a care home or a mental health facility; and**

23 **(E) A statement that advises the principal that the advance directive allows the principal**
24 **to document the principal's preferences, but is not a POLST, as defined in ORS 127.663.**

25 **(b) A statement explaining that to be effective the advance directive must be:**

26 **(A) Accepted by signature or other applicable means; and**

27 **(B) Either witnessed and signed by at least two adults or notarized.**

28 **(c) A statement explaining that to be effective the appointment of a health care repre-**
29 **sentative or an alternate health care representative must be accepted by the health care**
30 **representative or the alternate health care representative.**

31 **(d) A statement explaining that the advance directive, once executed, supersedes any**
32 **previously executed advance directive.**

33 **(e) The name, date of birth, address and other contact information of the principal.**

34 **(f) The name, address and other contact information of any health care representative**
35 **or any alternate health care representative appointed by the principal.**

36 **(g) A section providing the principal with an opportunity to state the principal's values**
37 **and beliefs with respect to health care decisions, including the opportunity to describe the**
38 **principal's preferences, by completing a checklist, by providing instruction through narrative**
39 **or other means, or by any combination of methods used to describe the principal's prefer-**
40 **ences, regarding:**

41 **(A) When the principal wants all reasonably available health care necessary to preserve**
42 **life and recover;**

43 **(B) When the principal wants all reasonably available health care necessary to treat**
44 **chronic conditions;**

45 **(C) When the principal wants to specifically limit health care necessary to preserve life**

1 and recover, including artificially administered nutrition and hydration, cardiopulmonary
2 resuscitation and transport to a hospital; and

3 (D) When the principal desires comfort care instead of health care necessary to preserve
4 life.

5 (h) A section where the principal and the witnesses or notary may accept by signature
6 or other means, including electronic or verbal means, the advance directive.

7 (i) A section where any health care representative or any alternate health care repre-
8 sentative appointed by the principal may accept the advance directive by signature or other
9 means, including electronic or verbal means.

10 (4)(a) In adopting the form of an advance directive under this section, the committee
11 shall use plain language, such as “tube feeding” and “life support.”

12 (b) As used in this subsection:

13 (A) “Life support” means life-sustaining procedures.

14 (B) “Tube feeding” means artificially administered nutrition and hydration.

15 (5) In adopting the form of an advance directive under this section, the committee shall
16 use the components of the form for appointing a health care representative or an alternate
17 health care representative set forth in section 5 of this 2017 Act.

18 (6) The principal may attach supplementary material to an advance directive. In addition
19 to the form of an advance directive adopted under this section, supplementary material at-
20 tached to an advance directive under this subsection is a part of the advance directive.

21 (7) The Oregon Health Authority shall post the form of an advance directive adopted
22 under this section on the authority’s website.

23 **SECTION 4.** (1) In addition to the requirements prescribed by the Oregon Health Au-
24 thority under section 3 (1) of this 2017 Act, the form of an advance directive adopted pursu-
25 ant to section 3 of this 2017 Act may not take effect until the form has been ratified by the
26 Legislative Assembly during an odd-numbered year regular session of the Legislative As-
27 sembly in the manner required for the passage of bills by Article IV, section 25 (1), of the
28 Oregon Constitution, and by the Governor in the manner required for the passage of bills
29 by Article V, section 15b, of the Oregon Constitution.

30 (2) For purposes of this section, the Advance Directive Adoption Committee established
31 under section 2 of this 2017 Act shall submit the form of an advance directive adopted under
32 section 3 of this 2017 Act to an interim committee of the Legislative Assembly related to the
33 judiciary on or before September 1 of an even-numbered year following the date on which the
34 committee adopts the form. Upon receiving the form, the interim committee shall file a
35 proposed legislative measure with the Legislative Counsel requesting a measure by which the
36 Legislative Assembly and the Governor may ratify the form.

• You must sign this form for it to be effective. You must also have it witnessed by two witnesses or a notary. Your appointment of a health care representative is not effective until the health care representative accepts the appointment.

• If you become too sick to speak for yourself and do not have an effective health care representative appointment, a health care representative will be appointed for you in the order of priority set forth in ORS 127.635 (2).

29 **APPOINTING HEALTH CARE REPRESENTATIVES**
30 **AND EXECUTING ADVANCE DIRECTIVES**

31
32 **SECTION 7.** ORS 127.510 is amended to read:

33 127.510. [(1) A capable adult may designate in writing a competent adult to serve as attorney-in-fact
34 for health care. A capable adult may also designate a competent adult to serve as alternative
35 attorney-in-fact if the original designee is unavailable, unable or unwilling to serve as attorney-in-fact
36 at any time after the power of attorney for health care is executed. The power of attorney for health
37 care is effective when it is signed, witnessed and accepted as required by ORS 127.505 to 127.660 and
38 127.995. The attorney-in-fact so appointed shall make health care decisions on behalf of the principal
39 if the principal becomes incapable.]

40 [(2) A capable adult may execute a health care instruction. The instruction shall be effective when
41 it is signed and witnessed as required by ORS 127.505 to 127.660 and 127.995.]

42 (1) **A capable adult may execute an advance directive. The advance directive is effective**
43 **when it is signed by the principal and witnessed or notarized as required by ORS 127.505 to**
44 **127.660.**

45 (2)(a) **A capable adult may use an advance directive or the form set forth in section 5 of**

1 **this 2017 Act to appoint a competent adult to serve as the health care representative for the**
2 **capable adult. A health care representative appointed under this paragraph shall make health**
3 **care decisions for the principal if the principal becomes incapable.**

4 **(b) A capable adult may use an advance directive or the form set forth in section 5 of this**
5 **2017 Act to appoint one or more competent adults to serve as alternate health care repre-**
6 **sentatives for the capable adult. For purposes of ORS 127.505 to 127.660, an alternate health**
7 **care representative has the rights and privileges of a health care representative appointed**
8 **under paragraph (a) of this subsection, including the rights described in ORS 127.535. An al-**
9 **ternate health care representative appointed under this paragraph shall make health care**
10 **decisions for the principal if:**

11 **(A) The principal becomes incapable; and**

12 **(B) The health care representative appointed under paragraph (a) of this subsection is**
13 **unable, unwilling or unavailable to make timely health care decisions for the principal.**

14 **(c) For purposes of paragraph (b) of this subsection, the health care representative ap-**
15 **pointed under paragraph (a) of this subsection is unavailable to make timely health care de-**
16 **cisions for the principal if the health care representative is not available to answer questions**
17 **for the health care provider in person, by telephone or by another means of direct commu-**
18 **nication.**

19 **(d) An appointment made under this section is effective when it is accepted by the health**
20 **care representative.**

21 **(3) Unless the period of time that an advance directive or a form appointing a health care**
22 **representative is [to be] effective is limited by the terms of the advance directive or the form**
23 **appointing a health care representative, the advance directive [shall continue] or the form ap-**
24 **pointing a health care representative continues in effect until:**

25 **(a) The principal dies; or**

26 **(b) The advance directive or the form appointing a health care representative is revoked,**
27 **suspended or superseded pursuant to ORS 127.545.**

28 **(4) Notwithstanding subsection (3) of this section, if the principal is incapable at the expiration**
29 **of the term of the advance directive or the form appointing a health care representative, the**
30 **advance directive or the form appointing a health care representative continues in effect until:**

31 **(a) The principal is no longer incapable;**

32 **(b) The principal dies; or**

33 **(c) The advance directive or the form appointing a health care representative is revoked,**
34 **suspended or superseded pursuant to the provisions of ORS 127.545.**

35 **(5) A health care provider shall make a copy of an advance directive, a copy of a form ap-**
36 **pointing a health care representative and a copy of any other instrument a part of the principal's**
37 **medical record when a copy of [that] the advance directive, form appointing a health care rep-**

39 **(6) Notwithstanding subsections (3)(a) and (4)(b) of this section, an advance directive remains**
40 **in effect with respect to an anatomical gift, as defined in ORS 97.953, [made on an advance direc-**
41 **tive is effective] after the principal dies.**

42 **SECTION 8.** ORS 127.515 is amended to read:

43 127.515. (1) An advance directive **or a form appointing a health care representative** may be
44 executed by a resident or nonresident adult of this state in the manner provided by ORS 127.505 to
45 127.660. [and 127.995.]

1 [(2) A power of attorney for health care must be in the form provided by Part B of the advance
2 directive form set forth in ORS 127.531, or must be in the form provided by ORS 127.530 (1991 Edi-
3 tion).]

4 [(3) A health care instruction must be in the form provided by Part C of the advance directive form
5 set forth in ORS 127.531, or must be in the form provided by ORS 127.610 (1991 Edition).]

6 [(4) An advance directive must reflect the date of the principal's signature. To be valid, an advance
7 directive must be witnessed by at least two adults as follows:]

8 [(a) Each witness shall witness either the signing of the instrument by the principal or the
9 principal's acknowledgment of the signature of the principal.]

10 [(b) Each witness shall make the written declaration as set forth in the form provided in ORS
11 127.531.]

12 [(c) One of the witnesses shall be a person who is not:]

13 [(A) A relative of the principal by blood, marriage or adoption;]

14 [(B) A person who at the time the advance directive is signed would be entitled to any portion of
15 the estate of the principal upon death under any will or by operation of law; or]

16 [(C) An owner, operator or employee of a health care facility where the principal is a patient or
17 resident.]

18 [(d) The attorney-in-fact for health care or alternative attorney-in-fact may not be a witness. The
19 principal's attending physician at the time the advance directive is signed may not be a witness.]

20 [(e) If the principal is a patient in a long term care facility at the time the advance directive is
21 executed, one of the witnesses must be an individual designated by the facility and having any quali-
22 fications that may be specified by the Department of Human Services by rule.]

23 **(2) An advance directive or a form appointing a health care representative must reflect**
24 **the date of the principal's signature or other method of accepting the advance directive or**
25 **the form appointing a health care representative. To be valid, an advance directive or a form**
26 **appointing a health care representative must be:**

27 **(a) Witnessed and signed by at least two adults; or**

28 **(b) Notarized by a notary public.**

29 **(3) If an advance directive or a form appointing a health care representative is validated**
30 **under subsection (2)(a) of this section, each witness must witness:**

31 **(a) The principal signing the advance directive or the form appointing a health care rep-**
32 **resentative; or**

33 **(b) The principal acknowledging the signature of the principal on the advance directive**
34 **or the form appointing a health care representative, or the principal acknowledging any**

37 **(4) For an advance directive or a form appointing a health care representative to be valid**

41 **(b) Be the principal's health care representative or alternate health care representative**

43 **(5) If an advance directive or a form appointing a health care representative is validated**
44 **under subsection (2)(a) of this section, and if the principal is a patient in a long term care**
45 **facility at the time the advance directive or the form appointing a health care representative**

1 **is executed, one of the witnesses must be an individual who is designated by the facility and**
2 **qualified as specified by the Department of Human Services by rule.**

3 [(5)] (6) Notwithstanding [subsections (2) to (4)] **subsection (2)** of this section, an advance di-
4 rective **or a form appointing a health care representative that is** executed by an adult who [at
5 *the time of execution resided in another state,*] **resides in another state at the time of execution**
6 **and that is executed** in compliance with [the formalities of execution required by] the laws of that
7 state, the laws of the state where the principal [was] **is** located at the time of **the** execution or the
8 laws of this state[,] is validly executed for the purposes of ORS 127.505 to 127.660 [and 127.995 and
9 *may be given effect in accordance with its provisions, subject to the laws of this state*].

12
13 **SECTION 9.** ORS 127.505 is amended to read:

14 127.505. As used in ORS 127.505 to 127.660 and 127.995:

15 (1) “Adult” means an individual who:

16 (a) Is 18 years of age or older[, *who*]; **or**

17 (b) Has been adjudicated an emancipated minor, or [*who*] is **a minor who is** married.

18 [(2) “Advance directive” means a document that contains a health care instruction or a power of
19 *attorney for health care.*]

20 (2)(a) “Advance directive” means a document executed by a principal that contains:

21 (A) **A form appointing a health care representative; and**

22 (B) **Instructions to the health care representative.**

23 (b) “Advanced directive” includes any supplementary document or writing attached by
24 **the principal to the document described in paragraph (a) of this subsection.**

25 (3) “Appointment” means [*a power of attorney for health care*] **the portion of the form adopted**
26 **under section 3 of this 2017 Act used to appoint a health care representative or an alternate**
27 **health care representative, the form set forth in section 5 of this 2017 Act,** letters of
28 guardianship or a court order appointing a health care representative.

29 (4)(a) “Artificially administered nutrition and hydration” means a medical intervention to pro-
30 vide food and water by tube, mechanical device or other medically assisted method.

31 (b) “Artificially administered nutrition and hydration” does not include the usual and typical
32 provision of nutrition and hydration, such as the provision of nutrition and hydration by cup, hand,
33 bottle, drinking straw or eating utensil.

34 (5) “Attending health care provider” means the health care provider who has primary
35 **responsibility for the care and treatment of the principal, provided that the powers and du-**
36 **ties conferred on the health care provider by ORS 127.505 to 127.660 are within the health**
37 **care provider’s scope of practice.**

38 [(5)] (6) “Attending physician” means the physician who has primary responsibility for the care
39 and treatment of the principal.

40 [(6) “Attorney-in-fact” means an adult appointed to make health care decisions for a principal under
41 a power of attorney for health care, and includes an alternative attorney-in-fact.]

42 [(7) “Dementia” means a degenerative condition that causes progressive deterioration of intellectual
43 functioning and other cognitive skills, including but not limited to aphasia, apraxia, memory, agnosia
44 and executive functioning, that leads to a significant impairment in social or occupational function and
45 that represents a significant decline from a previous level of functioning. Diagnosis is by history and

1 *physical examination.*]

2 (7) **“Capable” means not incapable.**

3 (8) **“Form appointing a health care representative” means the portion of the form**
4 **adopted under section 3 of this 2017 Act used to appoint a health care representative or an**
5 **alternate health care representative or the form set forth in section 5 of this 2017 Act.**

6 [(8)] (9) “Health care” means diagnosis, treatment or care of disease, injury and congenital or
7 degenerative conditions, including the use, maintenance, withdrawal or withholding of life-sustaining
8 procedures and the use, maintenance, withdrawal or withholding of artificially administered nutri-
9 tion and hydration.

10 [(9)] (10) “Health care decision” means consent, refusal of consent or withholding or withdrawal
11 of consent to health care, and includes decisions relating to admission to or discharge from a health
12 care facility.

13 [(10)] (11) “Health care facility” means a health care facility as defined in ORS 442.015, a
14 domiciliary care facility as defined in ORS 443.205, a residential facility as defined in ORS 443.400,
15 an adult foster home as defined in ORS 443.705 or a hospice program as defined in ORS 443.850.

16 [(11) *“Health care instruction” or “instruction” means a document executed by a principal to indi-*
17 *cate the principal’s instructions regarding health care decisions.*]

18 [(12)] (12)(a) “Health care provider” means a person licensed, certified or otherwise authorized
19 or permitted by the [law] laws of this state to administer health care in the ordinary course of
20 business or practice of a profession[, and includes a health care facility].

21 (b) **“Health care provider” includes a health care facility.**

22 (13) “Health care representative” means:

23 [(a) *An attorney-in-fact;*]

24 (a) **A competent adult appointed to be a health care representative or an alternate health**
25 **care representative under ORS 127.510.**

26 (b) A person who has authority to make health care decisions for a principal under the pro-
27 visions of ORS 127.635 (2) or (3); or].

28 (c) A guardian or other person, appointed by a court to make health care decisions for a prin-
29 cipal.

30 (14) “Incapable” means that in the opinion of the court in a proceeding to appoint or confirm
31 authority of a health care representative, or in the opinion of the principal’s attending physician
32 **or attending health care provider**, a principal lacks the ability to make and communicate health
33 care decisions to health care providers, including communication through persons familiar with the
34 principal’s manner of communicating if those persons are available. [*“Capable” means not*
35 *incapable.*]

36 (15) “Instrument” means an advance directive, [*acceptance,*] **form appointing a health care**
37 **representative**, disqualification, withdrawal, court order, court appointment or other document
38 governing health care decisions.

39 [(16) *“Life support” means life-sustaining procedures.*]

40 [(17)] (16)(a) “Life-sustaining procedure” means any medical procedure, pharmaceutical, medical
41 device or medical intervention that maintains life by sustaining, restoring or supplanting a vital
42 function.

43 (b) “Life-sustaining procedure” does not include routine care necessary to sustain patient
44 cleanliness and comfort.

45 [(18)] (17) “Medically confirmed” means the medical opinion of the attending physician **or at-**

1 **tending health care provider** has been confirmed by a second physician **or second health care**
2 **provider** who has examined the patient and who has clinical privileges or expertise with respect to
3 the condition to be confirmed.

4 [(19)] (18) “Permanently unconscious” means completely lacking an awareness of self and ex-
5 ternal environment, with no reasonable possibility of a return to a conscious state, and that condi-
6 tion has been medically confirmed by a neurological specialist who is an expert in the examination
7 of unresponsive individuals.

8 [(20)] (19) “Physician” means an individual licensed to practice medicine by the Oregon Medical
9 Board.

10 [(21) “Power of attorney for health care” means a power of attorney document that authorizes an
11 attorney-in-fact to make health care decisions for the principal when the principal is incapable.]

12 [(22)] (20) “Principal” means:

13 (a) An adult who has executed an advance directive;

14 (b) A person of any age who has a health care representative;

15 (c) A person for whom a health care representative is sought; or

16 (d) A person being evaluated for capability [*who will have*] **to whom** a health care represen-
17 tative **will be assigned** if the person is determined to be incapable.

18 [(23)] (21) “Terminal condition” means a health condition in which death is imminent irrespec-
19 tive of treatment, and where the application of life-sustaining procedures or the artificial adminis-
20 tration of nutrition and hydration serves only to postpone the moment of death of the principal.

21 [(24) “Tube feeding” means artificially administered nutrition and hydration.]

25 **SECTION 10.** ORS 127.005 is amended to read:

26 127.005. (1) When a principal designates another person as an agent by a power of attorney in
27 writing, and the power of attorney does not contain words that otherwise delay or limit the period
28 of time of its effectiveness:

29 (a) The power of attorney becomes effective when executed and remains in effect until the power
30 is revoked by the principal;

31 (b) The powers of the agent are unaffected by the passage of time; and

32 (c) The powers of the agent are exercisable by the agent on behalf of the principal even though
33 the principal becomes financially incapable.

34 (2) The terms of a power of attorney may provide that the power of attorney will become ef-
35 fective at a specified future time, or will become effective upon the occurrence of a specified future
36 event or contingency such as the principal becoming financially incapable. If a power of attorney
37 becomes effective upon the occurrence of a specified future event or contingency, the power of at-
38 torney may designate a person or persons to determine whether the specified event or contingency
39 has occurred, and the manner in which the determination must be made. A person designated by a
40 power of attorney to determine whether the principal is financially incapable is the principal’s per-
41 sonal representative for the purposes of ORS 192.553 to 192.581 and the federal Health Insurance
42 Portability and Accountability Act privacy regulations, 45 C.F.R. parts 160 and 164.

43 (3) If a power of attorney becomes effective upon the principal becoming financially incapable
44 and either the power of attorney does not designate a person or persons to make the determination
45 as to whether the principal is financially incapable or none of the designated persons is willing or

1 able to make the determination, a determination that the principal is financially incapable may be
2 made by any physician. The physician's determination must be made in writing.

3 (4) All acts done by an agent under a power of attorney during a period in which the principal
4 is financially incapable have the same effect, and inure to the benefit of and bind the principal, as
5 though the principal were not financially incapable.

6 (5) If a conservator is appointed for a principal, the agent shall account to the conservator,
7 rather than to the principal, for so long as the conservatorship lasts. The conservator has the same
8 power that the principal would have to revoke, suspend or terminate all or any part of the power
9 of attorney.

10 (6) This section does not apply to [*powers of attorney for health care executed under*] ORS 127.505
11 to 127.660 [*and 127.995*].

12 **SECTION 11.** ORS 127.520 is amended to read:

13 127.520. (1) Except as provided in ORS 127.635 or as may be allowed by court order, the fol-
14 lowing persons may not serve as health care representatives:

15 (a) If unrelated to the principal by blood, marriage or adoption:

16 (A) The attending physician **or attending health care provider of the principal**, or an em-
17 ployee of the attending physician **or attending health care provider of the principal**; or

18 (B) An owner, operator or employee of a health care facility in which the principal is a patient
19 or resident, unless the health care representative was appointed before the principal's admission to
20 the facility; or

21 (b) A person who is the principal's parent or former guardian [*and*] **if**:

22 (A) At any time while the principal was under the care, custody or control of the person, a court
23 entered an order:

24 (i) Taking the principal into protective custody under ORS 419B.150; or

25 (ii) Committing the principal to the legal custody of the Department of Human Services for care,
26 placement and supervision under ORS 419B.337; and

27 (B) The court entered a subsequent order that:

28 (i) The principal should be permanently removed from the person's home, or continued in sub-
29 stitute care, because it was not safe for the principal to be returned to the person's home, and no
30 subsequent order of the court was entered that permitted the principal to return to the person's
31 home before the principal's wardship was terminated under ORS 419B.328; or

32 (ii) Terminated the person's parental rights under ORS 419B.500 and 419B.502 to 419B.524.

33 (2) A principal, while not incapable, may petition the court to remove a prohibition [*contained*]
34 **described** in subsection (1)(b) of this section.

35 (3) A capable adult may disqualify any other person from making health care decisions for the
36 capable adult. The disqualification must be in writing and signed by the capable adult. The dis-
37 qualification must specifically designate those persons who are disqualified.

38 (4) A health care representative whose authority has been revoked by a court is disqualified.

39 (5) A health care provider who has actual knowledge of a disqualification may not accept a
40 health care decision from [*a*] **the disqualified [*individual*] person.**

41 (6) A person who has been disqualified from making health care decisions for a principal, and
42 who is aware of that disqualification, may not make health care decisions for the principal.

43 **SECTION 12.** ORS 127.525 is amended to read:

44 127.525. [*For an appointment under a power of attorney for health care to be effective, the*
45 *attorney-in-fact must accept the appointment in writing. Subject to the right of the attorney-in-fact to*

1 *withdraw, the acceptance imposes a duty on the attorney-in-fact to make health care decisions on behalf*
 2 *of the principal at such time as the principal becomes incapable. Until the principal becomes incapable,*
 3 *the attorney-in-fact may withdraw by giving notice to the principal. After the principal becomes inca-*
 4 *pable, the attorney-in-fact may withdraw by giving notice to the health care provider.] **For an ap-***
 5 **pointment of a health care representative or an alternate health care representative in a**
 6 **form adopted under section 3 of this 2017 Act or in the form set forth in section 5 of this 2017**
 7 **Act to be effective, the health care representative or the alternate health care representative**
 8 **must accept the appointment as described in ORS 127.510. Subject to the right of the health**
 9 **care representative or an alternate health care representative to withdraw, the acceptance**
 10 **imposes a duty on the health care representative or an alternate health care representative**
 11 **to make health care decisions on behalf of the principal as described in ORS 127.510. Until**
 12 **the principal becomes incapable, the health care representative or an alternate health care**
 13 **representative may withdraw by giving notice to the principal. After the principal becomes**
 14 **incapable, the health care representative or an alternate health care representative may**
 15 **withdraw by giving notice to the health care provider.**

16 **SECTION 13.** ORS 127.535 is amended to read:

17 127.535. (1) *[The]* A health care representative has *[all the]* authority over the principal's health
 18 care that the principal would have if **the principal were** not incapable, subject to the limitations
 19 of the appointment and ORS 127.540 and 127.580. A health care representative who is known to
 20 *[the]* a health care provider to be available to make health care decisions has priority over any
 21 person other than the principal to act for the principal *[in all]* **with respect to** health care deci-
 22 sions. A health care representative has authority to make a health care decision for a principal only
 23 when the principal is incapable.

24 (2) A health care representative is not personally responsible for the cost of health care pro-
 25 vided to the principal solely because the health care representative makes health care decisions for

8 **SECTION 14.** ORS 127.545 is amended to read:

9 127.545. (1) An advance directive or a health care decision by a health care representative may
10 be revoked:

11 (a) If the advance directive or health care decision involves the decision to withhold or with-
12 draw life-sustaining procedures or artificially administered nutrition and hydration, at any time and
13 in any manner by which the principal is able to communicate the intent to revoke; or

14 (b) At any time and in any manner by a capable principal.

15 (2) Revocation is effective upon communication by the principal to the **principal's** attending
16 physician [*or*], **attending** health care provider[, *or to the*] **or** health care representative. If the re-

10 valid [power of attorney for health care] **form appointing a health care representative**, and if the
11 directions reflected in those documents are inconsistent, the document last executed governs to the
12 extent of the inconsistency.

13 (b) If the principal has both a valid [health care instruction] **advance directive**, or a valid [power
14 of attorney for health care] **form appointing a health care representative**, and a declaration for
15 mental health treatment made in accordance with ORS 127.700 to 127.737, and if the directions re-

17 health treatment governs to the extent of the inconsistency.

SAVINGS CLAUSES AND APPLICABILITY

SECTION 32. ORS 127.658 is amended to read:

127.658. [(1) ORS 127.505 to 127.660 and 127.995 do not impair or supersede any power of attorney for health care, directive to physicians or health care instruction in effect before November 4, 1993.]

[(2) Any power of attorney for health care or directive to physicians executed before November 4, 1993, shall be governed by the provisions of ORS 127.505 to 127.660 and 127.995, except that:]

[(a) The directive to physicians or power of attorney for health care shall be valid if it complies with the provisions of either ORS 127.505 to 127.660 and 127.995 or the statutes in effect as of the date of execution;]

[(b) The terms in a directive to physicians in the form prescribed by ORS 127.610 (1991 Edition) or predecessor statute have those meanings given in ORS 127.605 (1991 Edition) or predecessor statute in effect at the time of execution; and]

[(c) The terms in a power of attorney for health care in the form prescribed by ORS 127.530 (1991 Edition) have those meanings given in ORS 127.505 in effect at the time of execution.]

[(3) A health care organization, as defined in ORS 127.646, that on November 4, 1993, has printed materials with the information and forms which were required by ORS 127.649, prior to November 4, 1993, may use such printed materials until December 1, 1993.]

(1) ORS 127.505 to 127.660 as enacted, the repeal of any statute that was a part of ORS 127.505 to 127.660 and subsequent amendments to the provisions of ORS 127.505 to 127.660 do not impair or supersede any advance directive, form appointing a health care representative or directive to physicians executed in accordance with:

(a) The provisions of ORS 127.505 to 127.660; or

(b) The provisions of ORS 127.505 to 127.660 or any other statute governing an advance directive, a form appointing a health care representative or a directive to physicians that was in effect on the date that the advance directive, the form appointing a health care representative or the directive to physicians was executed.

(2) An advance directive, a form appointing a health care representative or a directive to physicians executed before, on or after the operative date specified in section 35 of this 2017 Act shall be governed by the provisions of ORS 127.505 to 127.660 or any other statute that are in effect on the date on which:

(a) The issue giving rise to adjudication occurs; or

(b) The advance directive, the form appointing a health care representative or the directive to physicians was executed.

SECTION 33. The amendments to ORS 127.510 by section 7 of this 2017 Act apply to appointments made before, on or after the operative date specified in section 35 of this 2017 Act.

SECTION 34. (1) The amendments to ORS 127.515 by section 8 of this 2017 Act apply to advance directives and forms appointing a health care representative that are executed on or after the operative date specified in section 35 of this 2017 Act.

(2) Sections 1 to 6 of this 2017 Act, the amendments to statutes by sections 7 to 28 and

1 32 of this 2017 Act and the repeal of ORS 127.531 by section 30 of this 2017 Act do not effect
2 the validity of an advance directive executed on or after the operative date specified in sec-
