

SENATE AMENDMENTS TO A-ENGROSSED SENATE BILL 505

1 On page 1 of the printed A-engrossed bill, line 3, after “132.550” delete the rest of the line and
2 delete line 4 and insert “and 135.405; repealing ORS 132.080; and declaring an emergency.”.

3 Delete lines 6 through 17 and delete pages 2 through 22 and insert:

4 **“SECTION 1. (1)(a) The district attorney of a county comprising a judicial district with**
5 **a population between 150,000 and 300,000 or over 700,000 shall ensure that proceedings before**
6 **the grand jury are recorded in the manner described in this section and section 2 of this 2017**
7 **Act.**

8 **“(b) The Chief Justice of the Supreme Court shall designate the types of audio electronic**
9 **recording devices suitable for recording grand jury proceedings and may establish policies**
10 **and procedures by rule or order to carry out the provisions of this section and sections 2 and**
11 **3 of this 2017 Act.**

12 **“(c) The district attorney shall use to record the grand jury proceedings audio electronic**
13 **recording devices designated, provided and maintained by the Judicial Department.**

14 **“(2)(a) The district attorney shall delegate the recording of grand jury proceedings to a**
15 **grand juror and shall provide instruction to the grand juror concerning the audio electronic**
16 **recording equipment and requirements of the recording.**

17 **“(b) Notwithstanding paragraph (a) of this subsection, the court may, upon request of the**
18 **prosecuting attorney, appoint a certified shorthand reporter as defined in ORS 8.415 or a**
19 **shorthand reporter certified by a national certification association, who shall be permitted**
20 **to attend all proceedings of the grand jury for the purpose of taking accurate notes. The**
21 **shorthand reporter’s services shall be paid for by the prosecuting attorney. The shorthand**
22 **reporter shall be sworn to correctly report the proceedings of the grand jury described in**
23 **section 2 of this 2017 Act and to keep secret any information concerning the grand jury**
24 **proceedings.**

25 **“(c) The grand juror or shorthand reporter recording the proceedings is not subject to**
26 **subpoena, and may not disclose any information, concerning the grand jury proceedings**
27 **without prior court order.**

28 **“(3)(a) A failure of an audio electronic recording device to accurately record all or part**
29 **of a grand jury proceeding does not affect the validity of any prosecution or indictment.**

30 **“(b) A failure of a grand juror to operate an audio electronic recording device in a man-**
31 **ner that accurately records all or part of a grand jury proceeding, as required, does not af-**
32 **fect the validity of any prosecution or indictment.**

33 **“(c) A failure of a shorthand reporter to prepare accurate notes or an accurate report**
34 **of all or part of a grand jury proceeding, as required, does not affect the validity of any**
35 **prosecution or indictment.**

1 “(4) This section and section 2 of this 2017 Act do not apply to grand jury proceedings
2 under ORS 132.440 that inquire into the condition and management of correctional facilities
3 and youth correction facilities.

4 “SECTION 2. (1) Except as provided in subsection (2) of this section, the grand juror de-
5 scribed in section 1 (2)(a) of this 2017 Act, or the shorthand reporter described in section 1
6 (2)(b) of this 2017 Act, who is recording grand jury proceedings in a judicial district with a
7 population between 150,000 and 300,000 or over 700,000 shall record all testimony given before
8 the grand jury, including:

9 “(a) The case name and number;

10 “(b) The name of each witness appearing before the grand jury; and

11 “(c) Each question asked of, and each response provided by, a witness appearing before
12 the grand jury.

13 “(2) The grand juror operating the audio electronic recording device or the shorthand
14 reporter may not record:

15 “(a) The deliberations or voting of the grand jury.

16 “(b) A presentment made pursuant to ORS 132.370.

17 “(c) Any statements made by a grand juror who is examined as a witness as provided in
18 ORS 132.350.

19 “(d) A procedure related to the production of records, or the unsealing of records,
20 subpoenaed pursuant to ORS 136.583 and to be presented before the grand jury.

21 “(3) The district attorney shall maintain the audio recordings, or report of the shorthand
22 reporter, produced pursuant to this section and section 1 of this 2017 Act.

23 “SECTION 3. (1) Audio recordings and the notes or report of a shorthand reporter
24 produced pursuant to sections 1 and 2 of this 2017 Act in a judicial district with a population
25 between 150,000 and 300,000 or over 700,000 are confidential and may not be released except
26 as described in this section.

27 “(2) When an indictment resulting from grand jury proceedings is indorsed ‘a true bill,’
28 the audio recording or the notes or report of a shorthand reporter of the grand jury pro-
29 ceedings may be released only in the following manner:

30 “(a) The prosecuting attorney may access a copy of the audio recording or the notes or
31 report of a shorthand reporter at any time.

32 “(b) When the defendant has been arraigned on the indictment and is represented by an
33 attorney, the district attorney shall:

34 “(A) Provide a copy to the defense attorney of all audio recordings, or the notes or report
35 of a shorthand reporter, related to an indictment after 10 days have passed since the
36 defendant’s arraignment on the indictment and no motion described in subsection (4) of this
37 section has been filed; or

38 “(B) Provide a copy of the audio recordings, or the notes or report of a shorthand re-
39 porter, to the defense attorney in accordance with the court’s ruling on the motion described
40 in subsection (4) of this section, if a motion has been filed.

41 “(c) Unless the court orders otherwise for good cause shown, the prosecuting attorney
42 and the defense attorney may not copy, disseminate or republish the audio recording, the
43 notes or report of a shorthand reporter, or a transcript prepared from the audio recording,
44 notes or report, released pursuant to this subsection, except to provide a copy to an agent
45 of the prosecuting attorney or defense attorney for the limited purpose of case preparation.

1 Unless a court orders otherwise for good cause shown, in consulting with the defendant the
2 defense attorney may not disclose to the defendant:

3 “(A) Any personal identifiers of a victim, witness or grand juror obtained from the audio
4 recording, report, notes or transcript; or

5 “(B) Any portion of the audio recording, report, notes or transcript that contains any
6 personal identifiers of a victim, witness or grand juror.

7 “(d) The defense attorney may not provide a copy of the audio recording, notes or report,
8 or a transcript prepared from the audio recording, notes or report, to the defendant.

9 “(e) When the defendant has been arraigned but is not represented by an attorney, the
10 defendant may request by motion that the court issue an order allowing the defendant access
11 to review the contents of the audio recording or the notes or report of the shorthand re-
12 porter. A copy of the motion must be provided to the prosecuting attorney. The prosecuting
13 attorney may request a hearing on the motion within 10 days after receiving a copy. At the
14 hearing, or in response to receiving the motion, the court shall appoint counsel for the de-
15 fendant for the limited purpose of reviewing the audio recording, notes or report and may
16 set reasonable conditions on the review of the audio recording, notes or report.

17 “(3)(a) When a grand jury inquires into the conduct of a public servant as defined in ORS
18 162.005 for acts occurring in the performance of the public servant’s duties, and an
19 indictment resulting from the grand jury proceedings is indorsed ‘not a true bill’:

20 “(A) The public servant or the prosecuting attorney may file a motion requesting a court
21 order releasing all or a portion of a transcript of the grand jury proceedings. A copy of the
22 motion must be served on the opposing party. In deciding whether to issue such an order,
23 the court shall determine whether the public interest in disclosure outweighs the interest in
24 maintaining the secrecy of the grand jury proceedings. If the court orders disclosure, the
25 court may set reasonable conditions on copying, disseminating or republishing the transcript.

26 “(B) A member of the public may file a motion requesting a court order for production
27 and release of a transcript of the grand jury proceedings. A copy of the motion must be
28 served on the prosecuting attorney and the public servant’s attorney, or the public servant
29 if the public servant is not represented by an attorney. The person filing the motion is re-
30 sponsible for the cost of producing the transcript and a court order for production and re-
31 lease of the transcript must be conditioned on receipt of payment. In deciding whether to
32 issue such an order, the court shall determine whether the public interest in disclosure
33 outweighs the interest in maintaining the secrecy of the grand jury proceedings. If the court
34 orders disclosure, the court may set reasonable conditions on copying, disseminating or re-
35 publishing the transcript.

36 “(b) The release of any transcript under this subsection may not include:

37 “(A) The release of any personal identifiers of a victim or witness; or

38 “(B) The release of the name or any personal identifiers of a grand juror.

39 “(4)(a) A motion for a protective order concerning an audio recording, the notes or report
40 of a shorthand reporter or a transcript of grand jury proceedings may be filed as follows:

41 “(A) The prosecuting attorney may file a motion for a protective order within 10 days
42 after the defendant’s arraignment on the indictment. The motion may be filed on behalf of
43 a victim or a witness. The prosecuting attorney shall inform the victim of the ability to seek
44 a protective order.

45 “(B) The prosecuting attorney may file a motion for a protective order within 10 days

1 after receiving a motion described in subsection (2)(e) of this section.

2 “(C) The prosecuting attorney, the public servant who is the subject of an indictment
3 indorsed ‘not a true bill’ or the public servant’s attorney may file a motion for a protective
4 order within 10 days of receiving a motion described in subsection (3)(a) of this section.

5 “(b) If the motion for a protective order requests that a portion of the audio recording,
6 notes, report or transcript be redacted, the motion must be accompanied by a specific de-
7 scription, including the date and time, of the portion of the audio recording, notes, report
8 or transcript to be redacted.

9 “(c) In response to a motion filed under this subsection, the court may order that the
10 access of the person requesting release to a copy of the audio recording, notes, report or
11 transcript be denied, restricted or deferred, or may make any other order, upon a finding
12 of substantial and compelling circumstances. In deciding whether to grant the motion and
13 enter a protective order under this paragraph, the court may consider the following:

14 “(A) Protection of witnesses and others from physical harm, threats of harm, bribes,
15 economic interference, reprisal and other forms of intimidation;

16 “(B) Maintenance of secrecy regarding informants, as required for effective investigation
17 of criminal activity;

18 “(C) Confidential information recognized under law, including the protection of confiden-
19 tial relationships and privileges and the contents of confidential records unrelated to a crime
20 alleged in the indictment; and

21 “(D) Any other relevant considerations.

22 “(d) The court may permit the evidence of substantial and compelling circumstances de-
23 scribed in paragraph (c) of this subsection to be made in the form of a written statement to
24 be inspected by the court only or by oral testimony given on the record.

25 “(5)(a) Except as provided in paragraph (b) of this subsection, when grand jury pro-
26 ceedings do not result in an indictment indorsed as either ‘a true bill’ or ‘not a true bill,’ the
27 audio recording or notes or report of the shorthand reporter produced pursuant to sections
28 1 and 2 of this 2017 Act may not be disclosed or released.

29 “(b) When subsequent grand jury proceedings occur inquiring into the same criminal
30 episode as the grand jury proceedings described in paragraph (a) of this subsection, and the
31 subsequent proceedings result in an indictment indorsed as ‘a true bill,’ the prosecuting at-
32 torney shall provide notice to the person charged in the indictment of the occurrence of the
33 earlier grand jury proceedings. After the person is arraigned on the indictment and the time
34 period described in subsection (2)(b) of this section has passed, the audio recording or the
35 notes or report of the shorthand reporter produced during the earlier grand jury proceedings
36 may be obtained in the manner set forth in subsection (2) of this section.

37 “(c) As used in this subsection, ‘criminal episode’ has the meaning given that term in
38 ORS 131.505.

39 “(6) The district attorney of each county may establish a fee for the cost of providing a
40 copy of any audio recording, or the notes or report of a shorthand reporter, of a grand jury
41 proceeding to a person requesting a copy under this section.

42 “(7) An audio recording, the notes or report of a shorthand reporter or a transcript of
43 a grand jury proceeding obtained pursuant to sections 1 and 2 of this 2017 Act and this sec-
44 tion:

45 “(a) May not be used as evidence in any subsequent proceeding, except as permitted un-

1 der ORS 40.375, 40.380, 40.450, 40.460 or 40.465.

2 “(b) May not be used to challenge the indorsement of an indictment ‘a true bill’ or the
3 proceedings that led to the indorsement.

4 “(c) May be used as evidence in a prosecution for perjury or false swearing committed
5 by a witness while giving testimony during the grand jury proceeding or during trial.

6 “(d) May be used as evidence in a proceeding for contempt of court against a person al-
7 leged to have violated the terms of a court order concerning the audio recording, notes, re-
8 port or transcript.

9 “(e) May be submitted to the court and used as evidence for a hearing on a protective
10 order described in subsection (4) of this section.

11 “(8) The release of audio recordings, shorthand reporter notes or reports or transcripts
12 of grand jury proceedings under this section does not affect discovery obligations under ORS
13 135.805 to 135.873.

14 “(9) As used in this section:

15 “(a) ‘Personal identifiers’ means:

16 “(A) In relation to a witness or a grand juror, the person’s address, telephone number,
17 driver license, vehicle registration information, Social Security number, date of birth and the
18 identifying number of the person’s depository account at a financial institution, as defined
19 in ORS 706.008, or credit card account.

20 “(B) In relation to a victim, the victim’s address, electronic mail address, telephone
21 number, driver license, vehicle registration information, Social Security number, date of
22 birth, any user names or other identifying information associated with the victim’s social
23 media accounts and the identifying number of the victim’s depository account at a financial
24 institution, as defined in ORS 706.008, or credit card account.

25 “(b) ‘Social media’ has the meaning given that term in ORS 659A.330.

26 “**SECTION 4.** ORS 132.090 is amended to read:

27 “132.090. (1) Except as provided in subsections (2) and (3) of this section **and sections 1 and 2**
28 **of this 2017 Act**, no person other than the district attorney or a witness actually under examination
29 shall be present during the sittings of the grand jury.

30 “(2) Upon a motion filed by the district attorney in the circuit court, the circuit judge may ap-
31 point a reporter who shall attend the sittings of the grand jury to take and report the testimony in
32 any matters pending before the grand jury, and may appoint a parent, guardian or other appropriate
33 person 18 years of age or older to accompany any child 12 years of age or younger, or any person
34 with an intellectual disability, during an appearance before the grand jury. The circuit judge, upon
35 the district attorney’s showing to the court that it is necessary for the proper examination of a
36 witness appearing before the grand jury, may appoint a guard, medical or other special attendant
37 or nurse, who shall be present in the grand jury room and shall attend such sittings.

38 “(3) The district attorney may designate an interpreter who is certified under ORS 45.291 to
39 interpret the testimony of witnesses appearing before the grand jury. The district attorney may
40 designate a qualified interpreter, as defined in ORS 45.288, if the circuit court determines that a
41 certified interpreter is not available and that the person designated by the district attorney is a
42 qualified interpreter as defined in ORS 45.288. An interpreter designated under this subsection may
43 be present in the grand jury room and attend the sittings of the grand jury.

44 “(4) No person other than members of the grand jury shall be present when the grand jury is
45 deliberating or voting upon a matter before it.

1 “(5) As used in this section, ‘intellectual disability’ has the meaning given that term in ORS
2 427.005. Intellectual disability may be shown by attaching to the motion of the district attorney:

3 “(a) Documentary evidence of intellectual functioning; or

4 “(b) The affidavit of a qualified person familiar with the person with an intellectual disability.
5 ‘Qualified person’ includes, but is not limited to, a teacher, therapist or physician.

6 “**SECTION 5.** ORS 132.320 is amended to read:

7 “132.320. (1) Except as provided in subsections (2) to [(12)] (13) of this section, in the investi-
8 gation of a charge for the purpose of indictment, the grand jury shall receive no other evidence than
9 such as might be given on the trial of the person charged with the crime in question.

10 “(2) A report or a copy of a report made by a physicist, chemist, medical examiner, physician,
11 firearms identification expert, examiner of questioned documents, fingerprint technician, or an ex-
12 pert or technician in some comparable scientific or professional field, concerning the results of an
13 examination, comparison or test performed by such person in connection with a case which is the
14 subject of a grand jury proceeding, shall, when certified by such person as a report made by such
15 person or as a true copy thereof, be received in evidence in the grand jury proceeding.

16 “(3) An affidavit of a witness who is unable to appear before the grand jury shall be received
17 in evidence in the grand jury proceeding if, upon application by the district attorney, the presiding
18 judge for the judicial district in which the grand jury is sitting authorizes the receipt after good
19 cause has been shown for the witness’ inability to appear. An affidavit taken in another state or
20 territory of the United States, the District of Columbia or in a foreign country must be
21 authenticated as provided in ORS chapter 194 before it can be used in this state.

22 “(4) A grand jury that is investigating a charge of criminal driving while suspended or revoked
23 under ORS 811.182 may receive in evidence an affidavit of a peace officer with a report or copy of
24 a report of the peace officer concerning the peace officer’s investigation of the violation of ORS
25 811.182 by the defendant.

26 “(5) A grand jury may receive testimony of a witness by means of simultaneous television
27 transmission allowing the grand jury and district attorney to observe and communicate with the
28 witness and the witness to observe and communicate with the grand jury and the district attorney.

29 “(6) A grand jury that is investigating a charge of failure to appear under ORS 133.076, 153.992,
30 162.195 or 162.205 may receive in evidence an affidavit of a court employee certifying that the de-
31 fendant failed to appear as required by law and setting forth facts sufficient to support that con-
32 clusion.

33 “(7)(a) Except as otherwise provided in this subsection, a grand jury may receive in evidence
34 through the testimony of one peace officer involved in the criminal investigation under grand jury
35 inquiry information from an official report of another peace officer involved in the same criminal
36 investigation concerning the other peace officer’s investigation of the matter before the grand jury.
37 The statement of a person suspected of committing an offense or inadmissible hearsay of persons
38 other than the peace officer who compiled the official report may not be presented to a grand jury
39 under this paragraph.

40 “(b) If the official report contains evidence other than chain of custody, venue or the name of
41 the person suspected of committing an offense, the grand jurors must be notified that the evidence
42 is being submitted by report and that the peace officer who compiled the report will be made
43 available for testimony at the request of the grand jury. When a grand jury requests the testimony
44 of a peace officer under this paragraph, the peace officer may present sworn testimony by telephone
45 if requiring the peace officer’s presence before the grand jury would constitute an undue hardship

1 on the peace officer or the agency that employs or utilizes the peace officer.

2 “(8) A grand jury that is investigating a charge of failure to report as a sex offender under ORS
3 163A.040 may receive in evidence certified copies of the form required by ORS 163A.050 (2) and sex
4 offender registration forms and an affidavit of a representative of the Oregon State Police, as
5 keepers of the state’s sex offender registration records, certifying that the certified copies of the
6 forms constitute the complete record for the defendant.

7 “(9) The grand jury shall weigh all the evidence submitted to it; and when it believes that other
8 evidence within its reach will explain away the charge, it should order such evidence to be
9 produced, and for that purpose may require the district attorney to issue process for the witnesses.

10 “(10) A grand jury that is investigating a charge of driving while under the influence of
11 intoxicants in violation of ORS 813.010 may receive in evidence an affidavit of a peace officer re-
12 garding any or all of the following:

13 “(a) Whether the defendant was driving.

14 “(b) Whether the defendant took or refused to take tests under any provision of ORS chapter
15 813.

16 “(c) The administration of tests under any provision of ORS chapter 813 and the results of such
17 tests.

18 “(d) The officer’s observations of physical or mental impairment of the defendant.

19 “(11)(a) A grand jury may receive in evidence an affidavit of a representative of a financial in-
20 stitution for the purpose of authenticating records of the financial institution.

21 “(b) As used in this subsection, ‘financial institution’ means a financial institution as defined in
22 ORS 706.008, an entity that regularly issues, processes or services credit cards or any other com-
23 parable entity that regularly produces financial records.

24 “(12)(a) A defendant who has been arraigned on an information alleging a felony charge that is
25 the subject of a grand jury proceeding and who is represented by an attorney has a right to appear
26 before the grand jury as a witness if, prior to the filing of an indictment, the defense attorney serves
27 upon the district attorney written notice requesting the appearance. The notice shall include an
28 electronic mail address at which the defense attorney may be contacted.

29 “(b) A district attorney is not obligated to inform a defendant that a grand jury proceeding in-
30 vestigating charges against the defendant is pending, in progress or about to occur.

31 “(c) Upon receipt of the written notice described in paragraph (a) of this subsection, the district
32 attorney shall provide in writing the date, time and location of the defendant’s appearance before
33 the grand jury to the defense attorney at the indicated electronic mail address. In the event of a
34 scheduling conflict, the district attorney shall reasonably accommodate the schedules of the de-
35 fendant and the defense attorney if the accommodation does not delay the grand jury proceeding
36 beyond the time limit for holding a preliminary hearing described in ORS 135.070 (2).

37 “(d) Notwithstanding ORS 135.070 and paragraph (c) of this subsection, in order to accommodate
38 a scheduling conflict, upon the request of the defendant the time limit for holding a preliminary
39 hearing described in ORS 135.070 (2) may be extended by a maximum of an additional five judicial
40 days and the district attorney and the defendant may stipulate to an extension of greater duration.
41 During a period of delay caused by a scheduling conflict under this subsection, ORS 135.230 to
42 135.290 shall continue to apply concerning the custody status of the defendant.

43 **“(13) A grand jury in a judicial district with a population between 150,000 and 300,000 or**
44 **over 700,000, the proceedings of which are recorded pursuant to sections 1 and 2 of this 2017**
45 **Act, may receive in evidence, through the testimony of a peace officer involved in the crim-**

1 **inal investigation under grand jury inquiry, the statement of:**

2 **“(a) A person who cannot readily understand the proceedings, or who cannot communi-**
3 **cate in the proceedings, because of a physical disability or developmental disability; or**

4 **“(b) A victim under 18 years of age at the time of the proceedings.**

5 **“SECTION 6.** ORS 132.430 is amended to read:

6 “132.430. (1) When a person has been held to answer a criminal charge and the indictment in
7 relation thereto is not found ‘a true bill,’ *[it]* **the indictment** must be indorsed ‘not a true bill,’
8 which indorsement must be signed by the foreman and filed with the clerk of the court, in whose
9 office it shall remain a public record. In the case of an indictment not found ‘a true bill’ against a
10 person *[not so held, the same, together with the minutes of the evidence in relation thereto,]* **who has**
11 **not been held to answer a criminal charge, the indictment** must be destroyed by the grand jury.

12 “(2) When an indictment indorsed ‘not a true bill’ has been filed with the clerk of the court, the
13 effect *[thereof]* is to dismiss the charge[;], and the *[same]* **charge** cannot be again submitted to or
14 inquired of by the grand jury unless the court so orders.

15 **“SECTION 7.** ORS 132.550 is amended to read:

16 “132.550. The indictment shall contain substantially the following:

17 “(1) The name of the circuit court in which it is filed;

18 “(2) The title of the action;

19 “(3) A statement that the grand jury accuses the defendant or defendants of the designated of-
20 fense or offenses;

21 “(4) A separate accusation or count addressed to each offense charged, if there be more than
22 one;

23 “(5) A statement in each count that the offense charged therein was committed in a designated
24 county;

25 “(6) A statement in each count that the offense charged therein was committed on, or on or
26 about, a designated date, or during a designated period of time;

27 “(7) A statement of the acts constituting the offense in ordinary and concise language, without
28 repetition, and in such manner as to enable a person of common understanding to know what is in-
29 tended;

30 **“(8) The dates of all grand jury proceedings related to the offense or offenses charged;**

31 **“[(8)] (9) The signatures of the foreman and of the district attorney; and**

32 **“[(9)] (10) The date the indictment is filed with the clerk of the court.**

33 **“SECTION 8.** ORS 135.405 is amended to read:

34 “135.405. (1) In cases in which it appears that the interest of the public in the effective admin-
35 istration of criminal justice would thereby be served, and in accordance with the criteria set forth
36 in ORS 135.415, the district attorney may engage in plea discussions for the purpose of reaching a
37 plea agreement.

38 “(2) The district attorney shall engage in plea discussions or reach a plea agreement with the
39 defendant only through defense counsel, except when, as a matter of record, the defendant has ef-
40 fectively waived the right of the defendant to counsel or, if the defendant is not eligible for ap-
41 pointed counsel, has not retained counsel.

42 “(3) The district attorney in reaching a plea agreement may agree to, but is not limited to, one
43 or more of the following, as required by the circumstances of the individual case:

44 “(a) To make or not to oppose favorable recommendations as to the sentence which should be
45 imposed if the defendant enters a plea of guilty or no contest to the offense charged;

1 “(b) To seek or not to oppose dismissal of the offense charged if the defendant enters a plea of
2 guilty or no contest to another offense reasonably related to the defendant’s conduct; or

3 “(c) To seek or not to oppose dismissal of other charges or to refrain from bringing potential
4 charges if the defendant enters a plea of guilty or no contest to the offense charged.

5 “(4) Similarly situated defendants should be afforded equal plea agreement opportunities.

6 “(5) The district attorney may not condition a plea offer on a requirement that the defendant
7 waive:

8 “(a) The disclosure obligation of ORS 135.815 (1)(g)[.]; or

9 “(b) **The ability to receive the audio recording of grand jury proceedings as permitted
10 under section 3 of this 2017 Act, if the indictment has been indorsed ‘a true bill.’**

11 “(6)(a) A district attorney may provide a plea offer and agreed disposition recommendation to
12 the defendant at the time of arraignment or first appearance of the defendant for a crime in open
13 court under an early disposition program established under ORS 135.941.

14 “(b) Unless extended by the court, a plea offer and agreed disposition recommendation made
15 under paragraph (a) of this subsection expire upon completion of the arraignment. Except for good
16 cause, a court may not extend a plea offer and agreed disposition recommendation under this para-
17 graph for more than seven days for a misdemeanor or 21 days for a felony.

18 “**SECTION 9.** Section 1 of this 2017 Act is amended to read:

19 “**Sec. 1.** (1)(a) The district attorney of a county [*comprising a judicial district with a population*
20 *between 150,000 and 300,000 or over 700,000*] shall ensure that proceedings before the grand jury are
21 recorded in the manner described in this section and section 2 of this 2017 Act.

22 “(b) The Chief Justice of the Supreme Court shall designate the types of audio electronic re-
23 cording devices suitable for recording grand jury proceedings and may establish policies and pro-
24 cedures by rule or order to carry out the provisions of this section and sections 2 and 3 of this 2017
25 Act.

26 “(c) The district attorney shall use to record the grand jury proceedings audio electronic re-
27 cording devices designated, provided and maintained by the Judicial Department.

28 “(2)(a) The district attorney shall delegate the recording of grand jury proceedings to a grand
29 juror and shall provide instruction to the grand juror concerning the audio electronic recording
30 equipment and requirements of the recording.

31 “(b) Notwithstanding paragraph (a) of this subsection, the court may, upon request of the pros-
32 ecuting attorney, appoint a certified shorthand reporter as defined in ORS 8.415 or a shorthand re-
33 porter certified by a national certification association, who shall be permitted to attend all
34 proceedings of the grand jury for the purpose of taking accurate notes. The shorthand reporter’s
35 services shall be paid for by the prosecuting attorney. The shorthand reporter shall be sworn to
36 correctly report the proceedings of the grand jury described in section 2 of this 2017 Act and to
37 keep secret any information concerning the grand jury proceedings.

38 “(c) The grand juror or shorthand reporter recording the proceedings is not subject to subpoena,
39 and may not disclose any information, concerning the grand jury proceedings without prior court
40 order.

41 “(3)(a) A failure of an audio electronic recording device to accurately record all or part of a
42 grand jury proceeding does not affect the validity of any prosecution or indictment.

43 “(b) A failure of a grand juror to operate an audio electronic recording device in a manner that
44 accurately records all or part of a grand jury proceeding, as required, does not affect the validity
45 of any prosecution or indictment.

1 “(c) A failure of a shorthand reporter to prepare accurate notes or an accurate report of all or
2 part of a grand jury proceeding, as required, does not affect the validity of any prosecution or
3 indictment.

4 “(4) This section and section 2 of this 2017 Act do not apply to grand jury proceedings under
5 ORS 132.440 that inquire into the condition and management of correctional facilities and youth
6 correction facilities.

7 “**SECTION 10.** Section 2 of this 2017 Act is amended to read:

8 “**Sec. 2.** (1) Except as provided in subsection (2) of this section, the grand juror described in
9 section 1 (2)(a) of this 2017 Act, or the shorthand reporter described in section 1 (2)(b) of this 2017
10 Act, who is recording grand jury proceedings [*in a judicial district with a population between 150,000*
11 *and 300,000 or over 700,000*] shall record all testimony given before the grand jury, including:

12 “(a) The case name and number;

13 “(b) The name of each witness appearing before the grand jury; and

14 “(c) Each question asked of, and each response provided by, a witness appearing before the
15 grand jury.

16 “(2) The grand juror operating the audio electronic recording device or the shorthand reporter
17 may not record:

18 “(a) The deliberations or voting of the grand jury.

19 “(b) A presentment made pursuant to ORS 132.370.

20 “(c) Any statements made by a grand juror who is examined as a witness as provided in ORS
21 132.350.

22 “(d) A procedure related to the production of records, or the unsealing of records, subpoenaed
23 pursuant to ORS 136.583 and to be presented before the grand jury.

24 “(3) The district attorney shall maintain the audio recordings, or report of the shorthand re-
25 porter, produced pursuant to this section and section 1 of this 2017 Act.

26 “**SECTION 11.** Section 3 of this 2017 Act is amended to read:

27 “**Sec. 3.** (1) Audio recordings and the notes or report of a shorthand reporter produced pursuant
28 to sections 1 and 2 of this 2017 Act [*in a judicial district with a population between 150,000 and*
29 *300,000 or over 700,000*] are confidential and may not be released except as described in this section.

30 “(2) When an indictment resulting from grand jury proceedings is indorsed ‘a true bill,’ the audio
31 recording or the notes or report of a shorthand reporter of the grand jury proceedings may be re-
32 leased only in the following manner:

33 “(a) The prosecuting attorney may access a copy of the audio recording or the notes or report
34 of a shorthand reporter at any time.

35 “(b) When the defendant has been arraigned on the indictment and is represented by an attor-
36 ney, the district attorney shall:

37 “(A) Provide a copy to the defense attorney of all audio recordings, or the notes or report of a
38 shorthand reporter, related to an indictment after 10 days have passed since the defendant’s
39 arraignment on the indictment and no motion described in subsection (4) of this section has been
40 filed; or

41 “(B) Provide a copy of the audio recordings, or the notes or report of a shorthand reporter, to
42 the defense attorney in accordance with the court’s ruling on the motion described in subsection (4)
43 of this section, if a motion has been filed.

44 “(c) Unless the court orders otherwise for good cause shown, the prosecuting attorney and the
45 defense attorney may not copy, disseminate or republish the audio recording, the notes or report

1 of a shorthand reporter, or a transcript prepared from the audio recording, notes or report, released
2 pursuant to this subsection, except to provide a copy to an agent of the prosecuting attorney or
3 defense attorney for the limited purpose of case preparation. Unless a court orders otherwise for
4 good cause shown, in consulting with the defendant the defense attorney may not disclose to the
5 defendant:

6 “(A) Any personal identifiers of a victim, witness or grand juror obtained from the audio re-
7 cording, report, notes or transcript; or

8 “(B) Any portion of the audio recording, report, notes or transcript that contains any personal
9 identifiers of a victim, witness or grand juror.

10 “(d) The defense attorney may not provide a copy of the audio recording, notes or report, or a
11 transcript prepared from the audio recording, notes or report, to the defendant.

12 “(e) When the defendant has been arraigned but is not represented by an attorney, the defendant
13 may request by motion that the court issue an order allowing the defendant access to review the
14 contents of the audio recording or the notes or report of the shorthand reporter. A copy of the
15 motion must be provided to the prosecuting attorney. The prosecuting attorney may request a
16 hearing on the motion within 10 days after receiving a copy. At the hearing, or in response to re-
17 ceiving the motion, the court shall appoint counsel for the defendant for the limited purpose of re-
18 viewing the audio recording, notes or report and may set reasonable conditions on the review of the
19 audio recording, notes or report.

20 “(3)(a) When a grand jury inquires into the conduct of a public servant as defined in ORS
21 162.005 for acts occurring in the performance of the public servant’s duties, and an indictment re-
22 sulting from the grand jury proceedings is indorsed ‘not a true bill’:

23 “(A) The public servant or the prosecuting attorney may file a motion requesting a court order
24 releasing all or a portion of a transcript of the grand jury proceedings. A copy of the motion must
25 be served on the opposing party. In deciding whether to issue such an order, the court shall deter-
26 mine whether the public interest in disclosure outweighs the interest in maintaining the secrecy of
27 the grand jury proceedings. If the court orders disclosure, the court may set reasonable conditions
28 on copying, disseminating or republishing the transcript.

29 “(B) A member of the public may file a motion requesting a court order for production and re-
30 lease of a transcript of the grand jury proceedings. A copy of the motion must be served on the
31 prosecuting attorney and the public servant’s attorney, or the public servant if the public servant
32 is not represented by an attorney. The person filing the motion is responsible for the cost of
33 producing the transcript and a court order for production and release of the transcript must be
34 conditioned on receipt of payment. In deciding whether to issue such an order, the court shall de-
35 termine whether the public interest in disclosure outweighs the interest in maintaining the secrecy
36 of the grand jury proceedings. If the court orders disclosure, the court may set reasonable conditions
37 on copying, disseminating or republishing the transcript.

38 “(b) The release of any transcript under this subsection may not include:

39 “(A) The release of any personal identifiers of a victim or witness; or

40 “(B) The release of the name or any personal identifiers of a grand juror.

41 “(4)(a) A motion for a protective order concerning an audio recording, the notes or report of a
42 shorthand reporter or a transcript of grand jury proceedings may be filed as follows:

43 “(A) The prosecuting attorney may file a motion for a protective order within 10 days after the
44 defendant’s arraignment on the indictment. The motion may be filed on behalf of a victim or a wit-
45 ness. The prosecuting attorney shall inform the victim of the ability to seek a protective order.

1 “(B) The prosecuting attorney may file a motion for a protective order within 10 days after re-
2 ceiving a motion described in subsection (2)(e) of this section.

3 “(C) The prosecuting attorney, the public servant who is the subject of an indictment indorsed
4 ‘not a true bill’ or the public servant’s attorney may file a motion for a protective order within 10
5 days of receiving a motion described in subsection (3)(a) of this section.

6 “(b) If the motion for a protective order requests that a portion of the audio recording, notes,
7 report or transcript be redacted, the motion must be accompanied by a specific description, includ-
8 ing the date and time, of the portion of the audio recording, notes, report or transcript to be
9 redacted.

10 “(c) In response to a motion filed under this subsection, the court may order that the access of
11 the person requesting release to a copy of the audio recording, notes, report or transcript be denied,
12 restricted or deferred, or may make any other order, upon a finding of substantial and compelling
13 circumstances. In deciding whether to grant the motion and enter a protective order under this
14 paragraph, the court may consider the following:

15 “(A) Protection of witnesses and others from physical harm, threats of harm, bribes, economic
16 interference, reprisal and other forms of intimidation;

17 “(B) Maintenance of secrecy regarding informants, as required for effective investigation of
18 criminal activity;

19 “(C) Confidential information recognized under law, including the protection of confidential re-
20 lationships and privileges and the contents of confidential records unrelated to a crime alleged in
21 the indictment; and

22 “(D) Any other relevant considerations.

23 “(d) The court may permit the evidence of substantial and compelling circumstances described
24 in paragraph (c) of this subsection to be made in the form of a written statement to be inspected
25 by the court only or by oral testimony given on the record.

26 “(5)(a) Except as provided in paragraph (b) of this subsection, when grand jury proceedings do
27 not result in an indictment indorsed as either ‘a true bill’ or ‘not a true bill,’ the audio recording
28 or notes or report of the shorthand reporter produced pursuant to sections 1 and 2 of this 2017 Act
29 may not be disclosed or released.

30 “(b) When subsequent grand jury proceedings occur inquiring into the same criminal episode as
31 the grand jury proceedings described in paragraph (a) of this subsection, and the subsequent pro-
32 ceedings result in an indictment indorsed as ‘a true bill,’ the prosecuting attorney shall provide no-
33 tice to the person charged in the indictment of the occurrence of the earlier grand jury proceedings.
34 After the person is arraigned on the indictment and the time period described in subsection (2)(b)
35 of this section has passed, the audio recording or the notes or report of the shorthand reporter
36 produced during the earlier grand jury proceedings may be obtained in the manner set forth in
37 subsection (2) of this section.

38 “(c) As used in this subsection, ‘criminal episode’ has the meaning given that term in ORS
39 131.505.

40 “(6) The district attorney of each county may establish a fee for the cost of providing a copy
41 of any audio recording, or the notes or report of a shorthand reporter, of a grand jury proceeding
42 to a person requesting a copy under this section.

43 “(7) An audio recording, the notes or report of a shorthand reporter or a transcript of a grand
44 jury proceeding obtained pursuant to sections 1 and 2 of this 2017 Act and this section:

45 “(a) May not be used as evidence in any subsequent proceeding, except as permitted under ORS

1 40.375, 40.380, 40.450, 40.460 or 40.465.

2 “(b) May not be used to challenge the indorsement of an indictment ‘a true bill’ or the pro-
3 ceedings that led to the indorsement.

4 “(c) May be used as evidence in a prosecution for perjury or false swearing committed by a
5 witness while giving testimony during the grand jury proceeding or during trial.

6 “(d) May be used as evidence in a proceeding for contempt of court against a person alleged to
7 have violated the terms of a court order concerning the audio recording, notes, report or transcript.

8 “(e) May be submitted to the court and used as evidence for a hearing on a protective order
9 described in subsection (4) of this section.

10 “(8) The release of audio recordings, shorthand reporter notes or reports or transcripts of grand
11 jury proceedings under this section does not affect discovery obligations under ORS 135.805 to
12 135.873.

13 “(9) As used in this section:

14 “(a) ‘Personal identifiers’ means:

15 “(A) In relation to a witness or a grand juror, the person’s address, telephone number, driver
16 license, vehicle registration information, Social Security number, date of birth and the identifying
17 number of the person’s depository account at a financial institution, as defined in ORS 706.008, or
18 credit card account.

19 “(B) In relation to a victim, the victim’s address, electronic mail address, telephone number,
20 driver license, vehicle registration information, Social Security number, date of birth, any user
21 names or other identifying information associated with the victim’s social media accounts and the
22 identifying number of the victim’s depository account at a financial institution, as defined in ORS
23 706.008, or credit card account.

24 “(b) ‘Social media’ has the meaning given that term in ORS 659A.330.

25 “**SECTION 12.** ORS 132.090, as amended by section 4 of this 2017 Act, is amended to read:

26 “132.090. (1) Except as provided in subsections (2) and (3) of this section and sections 1 and 2
27 of this 2017 Act, no person other than the district attorney or a witness actually under examination
28 shall be present during the sittings of the grand jury.

29 “(2) Upon a motion filed by the district attorney in the circuit court, the circuit judge may ap-
30 point [*a reporter who shall attend the sittings of the grand jury to take and report the testimony in any*
31 *matters pending before the grand jury, and may appoint]* a parent, guardian or other appropriate
32 person 18 years of age or older to accompany any child 12 years of age or younger, or any person
33 with an intellectual disability, during an appearance before the grand jury. The circuit judge, upon
34 the district attorney’s showing to the court that it is necessary for the proper examination of a
35 witness appearing before the grand jury, may appoint a guard, medical or other special attendant
36 or nurse, who shall be present in the grand jury room and shall attend such sittings.

37 “(3) The district attorney may designate an interpreter who is certified under ORS 45.291 to
38 interpret the testimony of witnesses appearing before the grand jury. The district attorney may
39 designate a qualified interpreter, as defined in ORS 45.288, if the circuit court determines that a
40 certified interpreter is not available and that the person designated by the district attorney is a
41 qualified interpreter as defined in ORS 45.288. An interpreter designated under this subsection may
42 be present in the grand jury room and attend the sittings of the grand jury.

43 “(4) No person other than members of the grand jury shall be present when the grand jury is
44 deliberating or voting upon a matter before it.

45 “(5) As used in this section, ‘intellectual disability’ has the meaning given that term in ORS

1 427.005. Intellectual disability may be shown by attaching to the motion of the district attorney:

2 “(a) Documentary evidence of intellectual functioning; or

3 “(b) The affidavit of a qualified person familiar with the person with an intellectual disability.

4 ‘Qualified person’ includes, but is not limited to, a teacher, therapist or physician.

5 “**SECTION 13.** ORS 132.320, as amended by section 5 of this 2017 Act, is amended to read:

6 “132.320. (1) Except as provided in subsections (2) to (13) of this section, in the investigation of
7 a charge for the purpose of indictment, the grand jury shall receive no other evidence than such
8 as might be given on the trial of the person charged with the crime in question.

9 “(2) A report or a copy of a report made by a physicist, chemist, medical examiner, physician,
10 firearms identification expert, examiner of questioned documents, fingerprint technician, or an ex-
11 pert or technician in some comparable scientific or professional field, concerning the results of an
12 examination, comparison or test performed by such person in connection with a case which is the
13 subject of a grand jury proceeding, shall, when certified by such person as a report made by such
14 person or as a true copy thereof, be received in evidence in the grand jury proceeding.

15 “(3) An affidavit of a witness who is unable to appear before the grand jury shall be received
16 in evidence in the grand jury proceeding if, upon application by the district attorney, the presiding
17 judge for the judicial district in which the grand jury is sitting authorizes the receipt after good
18 cause has been shown for the witness’ inability to appear. An affidavit taken in another state or
19 territory of the United States, the District of Columbia or in a foreign country must be
20 authenticated as provided in ORS chapter 194 before it can be used in this state.

21 “(4) A grand jury that is investigating a charge of criminal driving while suspended or revoked
22 under ORS 811.182 may receive in evidence an affidavit of a peace officer with a report or copy of
23 a report of the peace officer concerning the peace officer’s investigation of the violation of ORS
24 811.182 by the defendant.

25 “(5) A grand jury may receive testimony of a witness by means of simultaneous television
26 transmission allowing the grand jury and district attorney to observe and communicate with the
27 witness and the witness to observe and communicate with the grand jury and the district attorney.

28 “(6) A grand jury that is investigating a charge of failure to appear under ORS 133.076, 153.992,
29 162.195 or 162.205 may receive in evidence an affidavit of a court employee certifying that the de-
30 fendant failed to appear as required by law and setting forth facts sufficient to support that con-
31 clusion.

32 “(7)(a) Except as otherwise provided in this subsection, a grand jury may receive in evidence
33 through the testimony of one peace officer involved in the criminal investigation under grand jury
34 inquiry information from an official report of another peace officer involved in the same criminal
35 investigation concerning the other peace officer’s investigation of the matter before the grand jury.
36 The statement of a person suspected of committing an offense or inadmissible hearsay of persons
37 other than the peace officer who compiled the official report may not be presented to a grand jury
38 under this paragraph.

39 “(b) If the official report contains evidence other than chain of custody, venue or the name of
40 the person suspected of committing an offense, the grand jurors must be notified that the evidence
41 is being submitted by report and that the peace officer who compiled the report will be made
42 available for testimony at the request of the grand jury. When a grand jury requests the testimony
43 of a peace officer under this paragraph, the peace officer may present sworn testimony by telephone
44 if requiring the peace officer’s presence before the grand jury would constitute an undue hardship
45 on the peace officer or the agency that employs or utilizes the peace officer.

1 “(8) A grand jury that is investigating a charge of failure to report as a sex offender under ORS
2 163A.040 may receive in evidence certified copies of the form required by ORS 163A.050 (2) and sex
3 offender registration forms and an affidavit of a representative of the Oregon State Police, as
4 keepers of the state’s sex offender registration records, certifying that the certified copies of the
5 forms constitute the complete record for the defendant.

6 “(9) The grand jury shall weigh all the evidence submitted to it; and when it believes that other
7 evidence within its reach will explain away the charge, it should order such evidence to be
8 produced, and for that purpose may require the district attorney to issue process for the witnesses.

9 “(10) A grand jury that is investigating a charge of driving while under the influence of
10 intoxicants in violation of ORS 813.010 may receive in evidence an affidavit of a peace officer re-
11 garding any or all of the following:

12 “(a) Whether the defendant was driving.

13 “(b) Whether the defendant took or refused to take tests under any provision of ORS chapter
14 813.

15 “(c) The administration of tests under any provision of ORS chapter 813 and the results of such
16 tests.

17 “(d) The officer’s observations of physical or mental impairment of the defendant.

18 “(11)(a) A grand jury may receive in evidence an affidavit of a representative of a financial in-
19 stitution for the purpose of authenticating records of the financial institution.

20 “(b) As used in this subsection, ‘financial institution’ means a financial institution as defined in
21 ORS 706.008, an entity that regularly issues, processes or services credit cards or any other com-
22 parable entity that regularly produces financial records.

23 “(12)(a) A defendant who has been arraigned on an information alleging a felony charge that is
24 the subject of a grand jury proceeding and who is represented by an attorney has a right to appear
25 before the grand jury as a witness if, prior to the filing of an indictment, the defense attorney serves
26 upon the district attorney written notice requesting the appearance. The notice shall include an
27 electronic mail address at which the defense attorney may be contacted.

28 “(b) A district attorney is not obligated to inform a defendant that a grand jury proceeding in-
29 vestigating charges against the defendant is pending, in progress or about to occur.

30 “(c) Upon receipt of the written notice described in paragraph (a) of this subsection, the district
31 attorney shall provide in writing the date, time and location of the defendant’s appearance before
32 the grand jury to the defense attorney at the indicated electronic mail address. In the event of a
33 scheduling conflict, the district attorney shall reasonably accommodate the schedules of the de-
34 fendant and the defense attorney if the accommodation does not delay the grand jury proceeding
35 beyond the time limit for holding a preliminary hearing described in ORS 135.070 (2).

36 “(d) Notwithstanding ORS 135.070 and paragraph (c) of this subsection, in order to accommodate
37 a scheduling conflict, upon the request of the defendant the time limit for holding a preliminary
38 hearing described in ORS 135.070 (2) may be extended by a maximum of an additional five judicial
39 days and the district attorney and the defendant may stipulate to an extension of greater duration.
40 During a period of delay caused by a scheduling conflict under this subsection, ORS 135.230 to
41 135.290 shall continue to apply concerning the custody status of the defendant.

42 “(13) A grand jury [*in a judicial district with a population between 150,000 and 300,000 or over*
43 *700,000*], the proceedings of which are recorded pursuant to sections 1 and 2 of this 2017 Act, may
44 receive in evidence, through the testimony of a peace officer involved in the criminal investigation
45 under grand jury inquiry, the statement of:

1 “(a) A person who cannot readily understand the proceedings, or who cannot communicate in
2 the proceedings, because of a physical disability or developmental disability; or

3 “(b) A victim under 18 years of age at the time of the proceedings.

4 “**SECTION 14. ORS 132.080 is repealed.**

5 “**SECTION 15. The Public Defense Services Commission, the Judicial Department and**
6 **each county that begins recording grand jury proceedings under sections 1 and 2 of this 2017**
7 **Act on March 1, 2018, shall:**

8 “(1) Provide a preliminary report on the implementation of the recording requirement to
9 the Emergency Board and the interim committees of the Legislative Assembly related to the
10 judiciary, in the manner provided in ORS 192.245, no later than December 1, 2018.

11 “(2) Provide a final report on the implementation of the recording requirement to the
12 Joint Committee on Ways and Means and the committees of the Legislative Assembly related
13 to the judiciary, in the manner provided in ORS 192.245, no later than February 1, 2019.

14 “**SECTION 16. In addition to and not in lieu of any other appropriation, there is appro-**
15 **propriated to the Judicial Department, for the biennium beginning July 1, 2017, out of the Gen-**
16 **eral Fund, the amount of \$1,500,000, for the purchase of equipment and services and for other**
17 **expenses necessary to carry out the provisions of this 2017 Act.**

18 “**SECTION 17. (1) In addition to and not in lieu of any other appropriation, there is ap-**
19 **propriated to the Emergency Board, for the biennium beginning July 1, 2017, out of the**
20 **General Fund, the amount of \$8,500,000, to be allocated for expenses necessary to carry out**
21 **the provisions of this 2017 Act.**

22 “(2) If any of the moneys appropriated by subsection (1) of this section are not allocated
23 by the Emergency Board prior to December 1, 2018, the moneys remaining on that date be-
24 come available for any purpose for which the Emergency Board lawfully may allocate funds.

25 “**SECTION 18. (1) Sections 1, 2 and 3 of this 2017 Act and the amendments to ORS 132.090,**
26 **132.320, 132.550 and 135.405 by sections 4, 5, 7 and 8 of this 2017 Act become operative on**
27 **March 1, 2018.**

28 “(2) The amendments to sections 1, 2 and 3 of this 2017 Act and ORS 132.090, 132.320 and
29 132.430 by sections 6, 9, 10, 11, 12 and 13 of this 2017 Act and the repeal of ORS 132.080 by
30 section 14 of this 2017 Act become operative on July 1, 2019.

31 “(3) The Judicial Department may take any action before the operative dates specified in
32 subsections (1) and (2) of this section that is necessary to enable the department to exercise
33 the duties, functions and powers conferred on the department by this 2017 Act.

34 “**SECTION 19. This 2017 Act being necessary for the immediate preservation of the public**
35 **peace, health and safety, an emergency is declared to exist, and this 2017 Act takes effect**
36 **on its passage.”.**

37
