SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Eliminates probationary driver permits. Standardizes requirements for hardship permits.
Eliminates certain driving privilege suspensions.

Expands list of persons granted driving privileges in this state to include members of commissioned corps of National Oceanic and Atmospheric Administration and members' spouses under certain conditions.

A BILL FOR AN ACT

Be It Enacted by the People of the State of Oregon:

PROBATIONARY PERMITS AND HARDSHIP PERMITS

SECTION 1. ORS 807.250, 807.252, 807.260, 807.270, 809.650, 809.660, 813.500 and 813.510 are repealed.

SECTION 2. ORS 807.240 is amended to read:

807.240. The Department of Transportation shall provide for issuance of hardship driver permits in a manner consistent with this section. A hardship driver permit grants the driving privileges provided in this section or under the permit. Except as otherwise provided in this section, a hardship driver permit is subject to the fees, provisions, conditions, prohibitions and penalties applicable to a license. The following apply to a hardship driver permit:

(1) The department may only issue a permit to a person whose driving privileges under the vehicle code have been suspended, **or revoked under ORS 809.600 as a habitual offender.**

(2) Except as provided in **this section and** ORS 813.520, the department may reinstate the privilege to operate a motor vehicle of any person whose license to operate a motor vehicle has been suspended, **or revoked under ORS 809.600 as a habitual offender,** by issuing the person a hardship permit. *[described under this section if such person qualifies under this section, ORS 807.250, 807.252 and 813.500. However, the department may not issue a hardship permit authorizing a person*

NOTE: Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 *to drive a commercial motor vehicle.]*

2 (3) To qualify for a hardship permit, a person must do all of the following [*in addition to any*
3 *applicable provisions under ORS 807.250, 807.252 and 813.500*]:

4 (a) The person must submit to the department an application for the permit that demonstrates
5 the person's need for the permit.

6 (b) The person must present satisfactory evidence, as determined by the department by rule:

7 (A) That the person must operate a motor vehicle as a requisite of the person's occupation or
8 employment;

9 (B) That the person must operate a motor vehicle to seek employment or to get to or from a
10 place of employment;

11 (C) That the person must operate a motor vehicle to get to or from an alcohol or drug treatment
12 or rehabilitation program;

13 (D) That the person or a member of the person's immediate family requires medical treatment
14 on a regular basis and that the person must operate a motor vehicle in order that the treatment
15 may be obtained; or

16 **(E) That the person's driving privileges are suspended for driving in violation of ORS**
17 **471.430 and are not suspended for any other reason and that the person must operate a mo-**
18 **tor vehicle in order to provide necessary services to the person or to a member of the**
19 **person's family. The department shall determine by rule what constitutes necessary services**
20 **for purposes of this subparagraph. The rule shall include as necessary services, but need not**
21 **be limited to, grocery shopping, driving the person or the person's children to school, driving**
22 **to medical appointments and caring for elderly family members.**

23 [*(E) That the person's driving privileges are suspended for driving uninsured in violation of ORS*
24 *806.010 or for violation of ORS 165.805 or 471.430 and are not suspended for any other reason and that*
25 *the person must operate a motor vehicle in order to provide necessary services to the person or to a*
26 *member of the person's family. The department shall determine by rule what constitutes necessary ser-*
27 *vices for purposes of this subparagraph. The rule shall include as necessary services, but need not be*
28 *limited to, grocery shopping, driving the person or the person's children to school, driving to medical*
29 *appointments and caring for elderly family members.]*

30 (c) If the person is applying for a permit because the person or a member of the person's im-
31 mediate family requires medical treatment on a regular basis, the person must present, in addition
32 to any evidence required by the department under paragraph (b) of this subsection, a statement
33 signed by a licensed physician or certified nurse practitioner that indicates that the person or a
34 member of the person's immediate family requires medical treatment on a regular basis.

35 (d) The person must show that the person is not incompetent to drive nor a habitual incompe-
36 tent, reckless or criminally negligent driver as established by the person's driving record in this or
37 any other jurisdiction.

38 (e) The person must make a future responsibility filing.

39 (f) The person must submit any other information the department may require for purposes of
40 determining whether the person qualifies under this section[, *ORS 807.250, 807.252, 813.500*] and
41 **ORS 813.520.**

42 (4) If the department finds that the person meets the requirements of this section and any ap-
43 plicable requirements under ORS [*807.250, 807.252, 813.500 and*] 813.520, the department may issue
44 the person a hardship permit, valid for the duration of the suspension **or revocation** or for a shorter
45 period of time established by the department unless sooner suspended or revoked under this section.

1 If the department issues the permit for a period shorter than the suspension **or revocation** period,
2 renewal of the permit shall be on such terms and conditions as the department may require. The
3 permit:

4 (a) Shall limit the holder to operation of a motor vehicle only during specified times.

5 (b) May bear other reasonable limitations relating to the hardship permit or the operation of a
6 motor vehicle that the department deems proper or necessary. The limitations may include any
7 limitation, condition or requirement. Violation of a limitation is punishable as provided by ORS
8 811.175 or 811.182.

9 (5) The department, upon receiving satisfactory evidence of any violation of the limitations of
10 a permit issued under this section [*or limitations placed on a hardship permit under ORS 807.252 or*
11 *813.510*], may suspend or revoke the hardship permit.

12 (6) The fee charged for application or issuance of a hardship driver permit is the hardship driver
13 permit application fee under ORS 807.370. The department may not refund the fee if the application
14 is denied or if the driver permit is suspended or revoked. The fee upon renewal of the driver permit
15 is the same fee as that charged for renewal of a license. The application fee charged under this
16 subsection is in addition to any fee charged for reinstatement of driving privileges under ORS
17 807.370.

18 (7) The department may issue a permit granting the same driving privileges as those suspended
19 **or revoked** or may issue a permit granting fewer driving privileges, as the department determines
20 necessary to assure safe operation of motor vehicles by the permit holder.

21 **(8) The department may not issue a hardship permit to a person:**

22 **(a) Whose driver license or driver permit is suspended pursuant to ORS 25.750 to 25.783;**

23 **(b) Whose driving privileges are suspended pursuant to ORS 809.280 (1);**

24 **(c) That authorizes the person to operate a commercial motor vehicle;**

25 **(d) Whose suspension of driving privileges is based on a second or subsequent conviction**
26 **of driving while under the influence of intoxicants in violation of ORS 813.010 or the statu-**
27 **tory counterpart to ORS 813.010 in another jurisdiction;**

28 **(e) Whose driving privileges are suspended for conviction of assault in the second, third**
29 **or fourth degree if the person, within 10 years preceding application for the permit, has been**
30 **convicted of:**

31 **(A) Any degree of murder, manslaughter, criminally negligent homicide or assault re-**
32 **sulting from the operation of a motor vehicle;**

33 **(B) Reckless driving, as defined in ORS 811.140;**

34 **(C) Driving while under the influence of intoxicants, as defined in ORS 813.010;**

35 **(D) Failure to perform the duties of a driver involved in an accident or collision, as de-**
36 **scribed in ORS 811.700 or 811.705;**

37 **(E) Criminal driving while suspended or revoked, as defined in ORS 811.182;**

38 **(F) Fleeing or attempting to elude a police officer, as defined in ORS 811.540; or**

39 **(G) Aggravated vehicular homicide, as defined in ORS 163.149, or aggravated driving while**
40 **suspended or revoked, as defined in ORS 163.196; or**

41 **(f) Whose driving privileges are suspended for a conviction of assault in the second, third**
42 **or fourth degree:**

43 **(A) For a period of four years from the date the department suspends driving privileges**
44 **if the person's driving privileges are suspended for conviction of assault in the second degree**
45 **and the person was not incarcerated for that conviction.**

1 **(B) For a period of four years from the date the person is released from incarceration**
2 **for the conviction if the person’s driving privileges are suspended for conviction of assault**
3 **in the second degree and the person was incarcerated for that conviction.**

4 **(C) For a period of two years from the date the department suspends driving privileges**
5 **if the person’s driving privileges are suspended for conviction of assault in the third degree**
6 **and the person was not incarcerated for that conviction.**

7 **(D) For a period of two years from the date the person is released from incarceration for**
8 **the conviction if the person’s driving privileges are suspended for conviction of assault in the**
9 **third degree and the person was incarcerated for that conviction.**

10 **(E) For a period of six months from the date the department suspends driving privileges**
11 **if the person’s driving privileges are suspended for conviction of assault in the fourth degree**
12 **and the person is not incarcerated for that conviction.**

13 **(F) For a period of six months from the date the person is released from incarceration**
14 **for the conviction if the person’s driving privileges are suspended for conviction of assault**
15 **in the fourth degree and the person was incarcerated for that conviction.**

16 **(9) A conviction arising out of the same episode as the current suspension is not con-**
17 **sidered a conviction for purposes of subsection (8)(e) of this section.**

18 **(10) A person’s driving privileges under a hardship permit are subject to suspension or**
19 **revocation if the person does not maintain a good driving record, as defined by the adminis-**
20 **trative rules of the department, during the term of the permit.**

21 **SECTION 3.** ORS 163.196 is amended to read:

22 163.196. (1) A person commits the crime of aggravated driving while suspended or revoked if the
23 person operates a motor vehicle that causes serious physical injury to, or the death of, another
24 person while knowingly violating ORS 811.175 or 811.182, if the suspension or revocation resulted
25 from, or if the hardship [*or probationary*] permit violated is based upon a suspension or revocation
26 that resulted from, a conviction for a criminal offense involving the use of a motor vehicle.

27 (2) Aggravated driving while suspended or revoked is a Class C felony.

28 (3) The Oregon Criminal Justice Commission shall classify aggravated driving while suspended
29 or revoked as crime category 7 of the sentencing guidelines grid of the commission.

30 **SECTION 4.** ORS 430.165 is amended to read:

31 430.165. The Oregon Health Authority may prescribe fee schedules for any of the programs that
32 it establishes and operates under ORS 430.265, 430.306 to 430.375, 430.405, 430.415[,] **and** 430.850 to
33 430.880[, *813.500 and 813.510*]. The fees shall be charged and collected by the authority in the same
34 manner as charges are collected under ORS 179.610 to 179.770. When the authority acts under this
35 section, “person in a state institution” or “person at a state institution” or any similar phrase, as
36 defined in ORS 179.610, includes a person who receives services from a program for which fee
37 schedules are established under this section.

39 430.197. The Mental Health Services Fund is established in the State Treasury, separate and
40 distinct from the General Fund. The Mental Health Services Fund comprises moneys collected or

42 of Corrections under ORS 179.640, 426.241 and 430.165. The moneys in the fund are continuously

10 limited circumstances. The term may also refer to a document issued as evidence of a grant of
11 driving privileges under a driver permit. Driver permits issued by this state include the following:

12 (1) Applicant temporary driver permit described under ORS 807.310.

13 (2) Court issued temporary driver permit described under ORS 807.320.

14 (3) Disability golf cart driver permit described under ORS 807.210.

18 809.312. (1) A person whose driving privileges or right to apply for driving privileges or whose
19 identification card or right to apply for an identification card has been suspended for one of the
20 reasons specified in subsection (2) of this section may request that the person's driving privileges
21 or right to apply for driving privileges or identification card or right to apply for an identification
22 card be reinstated after the Department of Transportation determines the criteria are met under
23 subsection (4) of this section.

24 (2) This section applies to suspensions imposed under:

25 (a) ORS 809.310 (3)(a);

26 (b) ORS 809.310 (3)(b); and

27 (c) ORS 809.415 [(5)] **(4)** for committing an act that constitutes an offense described in ORS
28 809.310 (3)(a) or (b).

29 (3) To make a request under subsection (1) of this section, the person must provide sufficient
30 proof for the department to make the determinations required in subsection (4) of this section. The
31 department shall provide an administrative review to determine if the person's driving privileges or
32 right to apply for driving privileges or identification card or right to apply for an identification card
33 should be reinstated and may reinstate the person's suspended driving privileges or right to apply

36 (4) The granting of an administrative review under this section does not stay the suspension.

8 (7) To reinstate an identification card or the right to apply for an identification card after the
9 department determines that the person meets the objective criteria under subsection (4) of this sec-
10 tion, the person shall pay the fee for reinstatement of an identification card as described in ORS
11 807.410 (4).

12 (8) The department's authority to reinstate a suspension of a person's driving privileges or right
13 to apply for driving privileges under this section does not impinge on a court's authority to impose
14 a suspension under ORS [165.805 or] 471.430.

15 **SECTION 10.** ORS 809.390 is amended to read:

16 809.390. All of the following apply to a person whose driving privileges have been revoked:

17 (1) The period of revocation shall last as long as required for the revocation by law.

18 (2) During the period of revocation, the person is not entitled to exercise any driving privileges
19 in this state or to apply for or receive any driving privileges in this state except when a person who
20 has been determined to be a habitual offender is permitted to obtain driving privileges [*under a*
21 *probationary driving permit as described under ORS 807.270 and 809.650. This subsection prohibits the*
22 *issuance of any driver permit, including a hardship permit described]* under ORS 807.240[, *to a person*
23 *whose driving privileges or right to apply for driving privileges are revoked except as provided for the*
24 *probationary driving permit under ORS 807.270].*

25 (3) Upon expiration of the revocation period, the person must reapply for driving privileges in
26 the manner established by law and must reestablish the person's eligibility for issuance of driving
27 privileges. [*If driving privileges are revoked because the person is a habitual offender, the person must*
28 *meet the additional eligibility requirements for reinstatement of driving privileges under ORS 809.650*
29 *and 809.660.]*

30 (4) The Department of Transportation may issue new driving privileges to a person before the
31 expiration of the revocation period if the person is otherwise entitled to be issued driving privileges
32 and when, with reference to a conviction upon which the revocation was based, the Governor has
33 pardoned the person of the crime.

34 (5) The department shall not issue any driving privileges in contradiction to this section.

35 (6) If the person fails to surrender to the department any license or driver permit issued as ev-
36 idence of driving privileges that are revoked, the person is subject to the penalty under ORS 809.500.

37 (7) No reinstatement of revoked driving privileges will be made by the department until the fee
38 for reinstatement of revoked driving privileges established under ORS 807.370 is paid to or waived
39 by the department. The department may waive the reinstatement fee if the department committed
40 an error in issuing the revocation.

41 **SECTION 11.** ORS 809.600 is amended to read:

42 809.600. This section establishes the kinds of offenses and the number of convictions necessary
43 to revoke the driving privileges of a person as a habitual offender under ORS 809.640. The kinds
44 of offenses and the number of convictions necessary to revoke driving privileges as a habitual
45 offender are as follows:

1 (1) A person's driving privileges shall be revoked as a habitual offender if the person, within a
2 five-year period, has been convicted of three or more of any one or more of the following offenses
3 as evidenced by the records maintained by the Department of Transportation or by the records of
4 a similar agency of another state:

19 (b) Any offense specified in the rules of the department adopted under ORS 809.605.

43 **SECTION 17.** ORS 339.254, 339.257, 807.066, 809.265, 809.320 and 809.423 are repealed.

45 164.775. (1) It is unlawful for any person to discard any glass, cans or other trash, rubbish, de-

1 bris or litter on land within 100 yards of any of the waters of the state, as defined in ORS 468B.005,
2 other than in receptacles provided for the purpose of holding such trash, rubbish, debris or litter.

3 (2) It is unlawful for any person to discard any glass, cans or other similar refuse in any waters
4 of the state, as defined in ORS 468B.005.

5 (3) In addition to or in lieu of the penalties provided for violation of any provision of this sec-
6 tion, the court in which any individual is convicted of a violation of this section may order suspen-
7 sion of certain permits or licenses for a period not to exceed 90 days if the court finds that the

8 in this state except as provided under this subsection. Unless otherwise specifically provided by law,
9 a person whose driving privileges are suspended may obtain, if the person qualifies, a hardship
10 driver permit under ORS 807.240, and exercise driving privileges under the driver permit.

11 (3) Upon expiration of the suspension, the Department of Transportation shall reissue, upon re-
12 quest of the person, the suspended driving privileges and any license or driver permit that evidences
13 the driving privileges. The reissuance shall be without requalification by the person except that the
14 department may require the person to furnish evidence satisfactory to the department that the per-
15 son is qualified to continue to exercise driving privileges in this state before the department reissues
16 the driving privileges.

17 (4) The department may not issue any driving privileges in contradiction to this section.

18 (5) If the person fails to surrender to the department any license or driver permit issued as ev-
19 idence of driving privileges that are suspended, the person is subject to the penalties under ORS
20 809.500.

21 (6) No reinstatement of suspended driving privileges will be made by the department until the
22 fee for reinstatement of suspended driving privileges established under ORS 807.370 is paid to or
23 waived by the department. The department may waive the reinstatement fee for any of the following
24 reasons:

25 (a) The suspension occurred under ORS 809.419 for failure to take an examination upon request
26 of the department under ORS 807.340.

27 (b) The suspension occurred under ORS 809.419 for failure to obtain required medical clearance
28 upon request of the department under ORS 807.070 or 807.090.

29 (c) The suspension occurred under ORS 809.419 for incompetence to drive a motor vehicle or
30 having a mental or physical condition or impairment that affects the person's ability to safely op-
31 erate a motor vehicle.

32 (d) The suspension occurred under ORS 809.419 upon notification by the superintendent of a
33 hospital under ORS 807.700 that a person should not drive.

34 (e) The suspension occurred under ORS 809.419 upon notification by a court under ORS 810.375
35 that a person charged with a traffic offense has been found guilty except for insanity.

36 (f) The department committed an error in issuing the suspension.

37 (g) The suspension was the result of an error committed by an insurance company in issuing or
38 failing to issue a certification of insurance or in canceling a certification of insurance filed with the
39 department under ORS 806.270.

40 (h) The department issued the suspension without error because the person failed to respond as
41 required under ORS 806.160 or to furnish proof of exemption under ORS 806.210 from the filing re-
42 quirement of ORS 806.200, but the department later determines that the person in fact was in com-
43 pliance with financial responsibility requirements as of the date of the department's letter of
44 verification under ORS 806.150 or at the time of an accident described in ORS 806.200.

45 (i) The department issued the suspension without error because the person was not in compli-

1 ance with financial responsibility requirements as of the date of the department's letter of verifica-
2 tion under ORS 806.150 or at the time of an accident described in ORS 806.200, but the department
3 later determines that the person reasonably and in good faith believed that the person was in com-
4 pliance with financial responsibility requirements on the date of the department's letter of verifica-
5 tion or at the time of the accident.

6 (j) The suspension was the result of an error committed by an insurance company in notifying
7 the department regarding the correctness of a certification under ORS 806.150.

8 (k) The suspension occurred because the person failed to make future responsibility filings but
9 the department later determines that the reason for the failure was that the person was a military
10 reservist or a member of a national guard unit that was ordered to active military duty to a location
11 outside of the United States. The effective date of the military orders must be prior to the effective
12 date of a suspension issued by the department for failure to make a future responsibility filing.

13 (L) The department issued the suspension without error because the department received a no-
14 tice to suspend from a court under ORS 809.210 or 809.220, but the department later determines that
15 the person in fact was in compliance with the requirements of the court prior to the effective date
16 of the suspension.

17 *[(7) The department shall waive the reinstatement fee for a person whose driving privileges were*
18 *suspended under ORS 809.423 (3) if the person:]*

19 *[(a) Has graduated from high school and provides the department with proof of graduation satis-*
20 *factory to the department; or]*

21 *[(b) Has received a General Educational Development (GED) certificate from a community college*
22 *and provides the department with proof of the certificate satisfactory to the department.]*

23 **SECTION 36.** ORS 809.409 is amended to read:

24 809.409. (1)(a) Upon receipt of a record of conviction of an offense described in this section, the
25 Department of Transportation shall revoke the driving privileges of the person convicted.

26 (b) A person is entitled to administrative review under ORS 809.440 of a revocation under this
27 section.

28 (c) Except as otherwise provided in subsections (2) and (3) of this section, the revocation shall
29 be for a period of one year from the date of revocation, except that the department may not rein-
30 state driving privileges of any person whose privileges are revoked under this section until the
31 person complies with future responsibility filings.

32 (2) The department shall take action under subsection (1) of this section upon receipt of a record
33 of conviction of aggravated vehicular homicide or aggravated driving while suspended or revoked
34 or any degree of murder, manslaughter or criminally negligent homicide resulting from the operation
35 of a motor vehicle or assault in the first degree resulting from the operation of a motor vehicle,
36 except that the provisions of this subsection do not apply to a person whose driving privileges are
37 ordered revoked under ORS 809.235. A person whose driving privileges are revoked under this sub-

2 action under subsection (1) of this section upon receipt of a record of conviction of failure to per-
3 form the duties of a driver to injured persons under ORS 811.705.

4 (b) The department shall revoke driving privileges under this subsection for a period of three
5 years if the court indicates on the record of conviction that a person sustained serious physical in-
6 jury, as defined in ORS 161.015, as a result of the accident. The person may apply for reinstatement

41 same as other driving privileges granted under the vehicle code. This section is in addition to any
42 exemptions from the vehicle code under ORS 801.026. The following persons are granted the de-

3 To qualify under this subsection, the person must have the out-of-state license or driver permit in
4 the person's possession. A person is not granted driving privileges under this subsection:

5 (a) If the person is under the minimum age required to be eligible for driving privileges under
6 ORS 807.060;

7 (b) During a period of suspension or revocation by this state or any other jurisdiction of driving
8 privileges or of the right to apply for a license or driver permit issued by this state or any other
9 jurisdiction; or

10 (c) That exceed the driving privileges granted to the person by the out-of-state license or driver
11 permit.

12 (2) A [*person in*] **member of the Armed Forces of the United States or the commissioned**
13 **corps of the National Oceanic and Atmospheric Administration** may operate a motor vehicle
14 without an Oregon license or driver permit if the person is operating a motor vehicle in the course
15 of the person's duties in the Armed Forces **or the National Oceanic and Atmospheric Adminis-**
16 **tration.**

17 (3) A person without a license or driver permit may operate a road roller or road machinery
18 that is not required to be registered under the laws of this state.

28 821.172.

29 (9) Driving privileges for Class IV all-terrain vehicles are exclusively as provided in ORS
30 821.176.

31 (10) A person without a license or driver permit may operate a golf cart in accordance with an
32 ordinance adopted under ORS 810.070.

33 (11) The spouse of a member of the Armed Forces of the United States on active duty **or the**
34 **spouse of a member of the commissioned corps of the National Oceanic and Atmospheric**
35 **Administration** who is accompanying the member on assignment in this state may operate a motor
36 vehicle if the spouse has a current out-of-state license or driver permit issued to the spouse by an-
37 other state in the spouse's possession.

38 (12) A person who is a member of the Armed Forces of the United States on active duty **or a**
39 **member of the commissioned corps of the National Oceanic and Atmospheric Administration**
40 may operate a motor vehicle if the person has a current out-of-state license or driver permit in the
41 person's possession that is issued to the person by the person's state of domicile or by the Armed
42 Forces of the United States in a foreign country. Driving privileges described under this subsection
43 that are granted by the Armed Forces apply only for a period of 45 days from the time the person
44 returns to the United States.

45 (13) A person who does not hold a motorcycle endorsement may operate a motorcycle if the

1 person is:

2 (a) Within an enclosed cab; or

3 (b) Operating a vehicle designed to travel with three wheels in contact with the ground at
4 speeds of less than 15 miles per hour.

5 (14) A person may operate a bicycle that is not an electric assisted bicycle without any grant
6 of driving privileges.

7 (15) A person may operate an electric assisted bicycle without a driver license or driver permit
8 if the person is 16 years of age or older.

9 (16) A person may operate a motor assisted scooter without a driver license or driver permit if
10 the person is 16 years of age or older.

11 (17) A person who is not a resident of this state or who has been a resident of this state for less
12 than 30 days may operate a motor vehicle without an Oregon license or driver permit if the person
13 is at least 15 years of age and has in the person's possession a current out-of-state equivalent of a
14 Class C instruction driver permit issued to the person. For the purpose of this subsection, a person
15 is a resident of this state if the person meets the residency requirements described in ORS 807.062.
16 A person operating a motor vehicle under authority of this subsection has the same privileges and
17 is subject to the same restrictions as a person operating under the authority of a Class C instruction
18 driver permit issued as provided in ORS 807.280.

19 (18) A person may operate an electric personal assistive mobility device without any grant of
20 driving privileges if the person is 16 years of age or older.
