**PROPOSED AMENDMENTS TO  
SENATE BILL 56**

1 On page 1 of the printed bill, line 2, delete “declaring an emergency” and  
2 insert “prescribing an effective date”.

3 Delete lines 4 through 29 and delete page 2 and insert:

4 **“SECTION 1. Section 2 of this 2017 Act is added to and made a part**  
5 **of ORS 475B.400 to 475B.525.**

6 **“SECTION 2. (1) Notwithstanding section 40 (8), chapter \_\_\_\_\_,**  
7 **Oregon Laws 2017 (Enrolled Senate Bill 1057), the additional fee im-**  
8 **posed by the Oregon Health Authority under section 40 (8), chapter**  
9 **\_\_\_\_\_, Oregon Laws 2017 (Enrolled Senate Bill 1057), may not:**

10 **“(a) Be greater than the fee imposed under ORS 475B.420 for**  
11 **marijuana grow sites, ORS 475B.435 for marijuana processing sites and**  
12 **ORS 475B.450 for medical marijuana dispensaries;**

13 **“(b) Be imposed on a marijuana grow site other than the marijuana**  
14 **grow site of a person designated to produce marijuana by a registry**  
15 **identification cardholder; and**

16 **“(c) Be imposed on a marijuana grow site, until January 1, 2020,**  
17 **that produces marijuana for a registry identification cardholder who**  
18 **is eligible for reduced registry identification cardholder fees under**  
19 **ORS 475B.415.**

20 **“(2) Pursuant to ORS 475B.025 (2)(d)(G), the Oregon Liquor Control**  
21 **Commission shall impose a fee on licensees, as defined in ORS**

1 475B.015, that is calculated to pay costs incurred under section 40,  
2 chapter \_\_\_\_\_, Oregon Laws 2017 (Enrolled Senate Bill 1057), other  
3 than costs paid pursuant to section 40 (7) and (8), chapter \_\_\_\_\_,  
4 Oregon Laws 2017 (Enrolled Senate Bill 1057). Moneys collected pur-  
5 suant to this subsection shall be deposited into the Marijuana Control  
6 and Regulation Fund established under ORS 475B.240 and are contin-  
7 uously appropriated to the commission for purposes of this subsection.

8 **“SECTION 3.** If Senate Bill 1057 does not become law, section 2 of  
9 this 2017 Act is repealed.

10 **“SECTION 4.** This 2017 Act takes effect on the 91st day after the  
11 date on which the 2017 regular session of the Seventy-ninth Legislative  
12 Assembly adjourns sine die.”.
