SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Requires Environmental Quality Commission to adopt by rule program that places cap on greenhouse gas emissions and that provides market-based mechanism for covered entities to demonstrate compliance. Establishes program advisory committee. Declares legislative purposes of program and related investments of moneys received as proceeds under market-based compliance mechanism.

Establishes certain statutory funds in State Treasury. Requires certain moneys received as proceeds under market-based compliance mechanism to be deposited in certain funds. Requires certain uses of moneys deposited in funds. Requires program advisory committee to submit biennial report to Governor, **Oregon Transportation Commission** and Legislative Assembly each even-numbered year. **Requires Oregon Transportation Commission to prepare and submit biennial transportation decarbonization investment proposal to Joint Legislative Committee on Climate and Oregon Department of Administrative Services.** Requires Governor to consider investment and expenditures recommendations in biennial report during preparation of Governor's budget.

Makes all provisions related to program adopted by commission and distribution of proceeds operative January 1, 2021. Authorizes commission and certain other agencies to adopt rules prior to operative date.

Repeals greenhouse gas emissions goals and requires commission to adopt by rule statewide greenhouse gas emissions goal for 2025 and limits for years 2035 and 2050.

Defines "greenhouse gas" for air pollution laws.

Establishes Joint Legislative Committee on Climate.

Modifies registration and greenhouse gas reporting requirements for certain persons.

Makes provisions related to Joint Legislative Committee on Climate, "greenhouse gas" definition, emissions limits and registration and reporting operative January 1, 2019.

Requires certain persons to pay annual program development fee to Department of Environmental Quality. Becomes operative July 1, [2019] **2018**. Sunsets January 2, 2021.

Provides for expedited review of Act by Supreme Court upon petition by adversely affected party.

[Declares emergency, effective on passage.]

Takes effect on 91st day following adjournment sine die.

2 Relating to greenhouse gas emissions; creating new provisions; amending ORS 184.617, 468A.005,
3 468A.210, 468A.235, 468A.240, 468A.250, 468A.260, 468A.265, 468A.279, 468A.280, 757.357 and
4 757.528 and section 9, chapter 751, Oregon Laws 2009; repealing ORS 468A.205; and prescribing
5 an effective date.

6 Whereas climate change and ocean acidification caused by greenhouse gas emissions threaten
7 to have significant detrimental effects on public health and the economic vitality, natural resources
8 and environment of this state; and

9 Whereas the diverse impacts of climate change and ocean acidification include the exacerbation
10 of air quality problems, a reduction in the quantity and quality of water available to this state from

1 mountain snowpack, a rise in sea levels resulting in the displacement of thousands of coastal busi-
2 nesses and residences, damage to marine ecosystems and food sources, the degradation of the na-
3 tural environment from increased severity of forest fires and pest infestations of stressed land-based
4 ecosystems, extreme weather events and an increase in the incidences of infectious diseases, asthma
5 and other human health-related problems; and

6 Whereas climate change has a disproportionate effect on fish and wildlife populations, many of
7 which require specific habitat conditions and are therefore particularly vulnerable to warmer tem-
8 peratures, modified precipitation patterns, diminished snowpack, ocean acidification and other ef-
9 fects of climate change; and

10 Whereas climate change and ocean acidification will have detrimental effects on some of this
11 state's most important industries, including agriculture, forestry, commercial fishing, recreation and
12 tourism; and

13 Whereas this state's forests and other natural and working lands are among the most productive
14 carbon sinks globally and provide many other important ecological, social and economic benefits
15 while the conversion of forests and other natural and working lands causes the emission of signif-
16 icant stored carbon dioxide and eliminates the potential for future sequestration; and

17 Whereas climate change will strain the electricity and domestic water supplies that are neces-
18 sary for economic stability and the most basic levels of human well-being and survival in this state;
19 and

20 Whereas national and international actions are necessary to fully address climate change and
21 ocean acidification; and

22 Whereas national actions in the United States are emerging too slowly to address the scope,
23 magnitude and urgency of climate change and ocean acidification; and

24 Whereas many greenhouse gases persist in the atmosphere for millennia, meaning that the costs
25 of early policy inaction will be severe; and

26 Whereas in the absence of effective national engagement, it is the responsibility of the individ-
27 ual states, deemed to be the laboratories of progress, to take immediate leadership actions to ad-
28 dress climate change and ocean acidification; and

29 Whereas by exercising a leadership role in addressing climate change and ocean acidification,
30 the State of Oregon will position its economy, technology centers, financial institutions and busi-
31 nesses to benefit from the national and international efforts that must occur to reduce greenhouse
32 gas emissions; and

33 Whereas by joining together with other leadership jurisdictions similarly resolved to address
34 climate change and ocean acidification, Oregon will help encourage more states, the federal gov-
35 ernment and the international community to act; and

36 Whereas global climate change has a disproportionate effect on impacted communities and In-
37 dian tribes, which typically have fewer resources for adapting to climate change and are therefore
38 the most vulnerable to displacement, adverse health effects, job loss, property damage and other
39 effects of climate change; and

40 Whereas climate change policies can be designed to protect impacted communities, Indian tribes,
41 rural communities and workers, including low-income households and people of color, from economic
42 costs and can provide cobenefits to and within these communities that include, but are not limited
43 to, opportunities for job creation and training, investments in infrastructure, affordable housing in-
44 vestment, economic development, air quality improvements, energy savings and conservation and
45 increased utilization of clean energy technologies; and

1 Whereas a key strategy in promoting net reductions of atmospheric carbon dioxide and adapting
2 to climate change is preserving and maintaining the resilient, healthy function of this state's forests
3 and other natural and working lands; and

4 Whereas any climate policy should address leakage to ensure a level playing field between in-
5 state and out-of-state companies to prevent jobs from leaving this state; and

6 Whereas the climate crisis is pressing; and

7 Whereas it is the intent of the Legislative Assembly to obtain reductions in greenhouse gas
8 emissions through legally binding market-based mechanisms; now, therefore,

9 **Be It Enacted by the People of the State of Oregon:**

10
11 **“GREENHOUSE GAS” DEFINED FOR PURPOSES OF**
12 **AIR QUALITY LAWS**

13
14 **SECTION 1.** ORS 468A.005 is amended to read:

15 468A.005. As used in ORS chapters 468, 468A and 468B, unless the context requires otherwise:

16 (1) “Air-cleaning device” means any method, process or equipment which removes, reduces or
17 renders less noxious air contaminants prior to their discharge in the atmosphere.

18 (2) “Air contaminant” means a dust, fume, gas, mist, odor, smoke, vapor, pollen, soot, carbon,
19 acid or particulate matter or any combination thereof.

20 (3) “Air contamination” means the presence in the outdoor atmosphere of one or more air con-
21 taminants which contribute to a condition of air pollution.

22 (4) “Air contamination source” means any source at, from, or by reason of which there is emit-
23 ted into the atmosphere any air contaminant, regardless of who the person may be who owns or
24 operates the building, premises or other property in, at or on which such source is located, or the
25 facility, equipment or other property by which the emission is caused or from which the emission
26 comes.

27 (5) “Air pollution” means the presence in the outdoor atmosphere of one or more air contam-
28 inants, or any combination thereof, in sufficient quantities and of such characteristics and of a du-
29 ration as are or are likely to be injurious to public welfare, to the health of human, plant or animal
30 life or to property or to interfere unreasonably with enjoyment of life and property throughout such
31 area of the state as shall be affected thereby.

32 (6) “Area of the state” means any city or county or portion thereof or other geographical area
33 of the state as may be designated by the Environmental Quality Commission.

34 (7) **“Greenhouse gas” includes, but is not limited to, carbon dioxide, methane, nitrous**
35 **oxide, hydrofluorocarbons, perfluorocarbons, sulfur hexafluoride and nitrogen trifluoride.**

36
37 **STATEWIDE GREENHOUSE GAS EMISSION LIMITS**

38
39 **SECTION 2.** ORS 468A.205 is repealed.

40 **SECTION 3.** Section 4 of this 2018 Act is added to and made a part of ORS chapter 468A.

41 **SECTION 4.** (1) As used in this section, “statewide greenhouse gas emissions” means:

42 (a) **The total annual emissions of greenhouse gases in this state; and**

43 (b) **All emissions of greenhouse gases from outside this state that are attributable to the**
44 **generation of electricity that is delivered to and consumed in this state, accounting for**
45 **transmission and distribution line losses.**

1 **(2) The Environmental Quality Commission shall adopt by rule:**

2 **(a) A statewide greenhouse gas emissions reduction goal to, by the year 2025, achieve**
3 **greenhouse gas levels that are at least 20 percent below 1990 levels;**

4 **(b) A statewide greenhouse gas emissions limit that, for the year 2035, requires**
5 **greenhouse gas emissions to be reduced to levels that are at least 45 percent below 1990**
6 **levels; and**

7 **(c) A statewide greenhouse gas emissions limit that, for the year 2050, requires**
8 **greenhouse gas emissions to be reduced to levels that are at least 80 percent below 1990**
9 **levels.**

10 **(3) This section does not create any additional regulatory authority for an agency of the**
11 **executive department as defined in ORS 174.112.**

12
13 **JOINT LEGISLATIVE COMMITTEE ON CLIMATE**
14

15 **SECTION 5.** **(1) There is established the Joint Legislative Committee on Climate.**

16 **(2) The joint committee consists of members of the Senate appointed by the President**
17 **of the Senate and members of the House of Representatives appointed by the Speaker of the**
18 **House of Representatives.**

19 **(3) The President of the Senate and the Speaker of the House of Representatives shall**
20 **each appoint one cochair for the joint committee with the duties and powers necessary for**
21 **the performance of the functions of the offices as the President and the Speaker determine.**

22 **(4) The joint committee has a continuing existence and may meet, act and conduct its**
23 **business during sessions of the Legislative Assembly or any recess thereof and in the interim**
24 **between sessions.**

25 **(5) The term of a member shall expire upon the date of the convening of the odd-**
26 **numbered year regular session of the Legislative Assembly next following the commence-**
27 **ment of the member's term.**

28 **(6)(a) If there is a vacancy for any cause, the appointing authority shall make an ap-**
29 **pointment to become immediately effective.**

30 **(b) When a vacancy occurs in the membership of the joint committee in the interim be-**
31 **tween odd-numbered year regular sessions, until the vacancy is filled:**

32 **(A) The membership of the joint committee shall be considered not to include the vacant**
33 **position for the purpose of determining whether a quorum is present; and**

34 **(B) A majority of the remaining members constitutes a quorum.**

35 **(7)(a) Members of the joint committee shall receive an amount equal to that authorized**
36 **under ORS 171.072 from funds appropriated to the Legislative Assembly for each day spent**
37 **in the performance of their duties as members of the joint committee or any subcommittee**
38 **of the joint committee in lieu of reimbursement for in-state travel expenses.**

39 **(b) Notwithstanding paragraph (a) of this subsection, when engaged in out-of-state travel,**
40 **members shall be entitled to receive their actual and necessary expenses in lieu of the**
41 **amount authorized by this subsection. Payment shall be made from funds appropriated to the**
42 **Legislative Assembly.**

43 **(8) The joint committee may not transact business unless a quorum is present. Except**
44 **as provided in subsection (6)(b)(B) of this section, a quorum consists of a majority of joint**
45 **committee members from the House of Representatives and a majority of joint committee**

1 members from the Senate.

2 (9) Action by the joint committee requires the affirmative vote of a majority of joint
3 committee members from the House of Representatives and a majority of joint committee
4 members from the Senate.

5 (10) The joint committee may adopt rules necessary for the operation of the joint com-
6 mittee.

7 (11) The Legislative Policy and Research Director may employ persons necessary for the
8 performance of the functions of the joint committee. The director shall fix the duties and
9 amounts of compensation of the employees. The joint committee shall use the services of
10 continuing legislative staff, without employing additional persons, to the greatest extent
11 practicable.

12 (12) All agencies of state government, as defined in ORS 174.111, are directed to assist
13 the joint committee in the performance of the duties of the joint committee and, to the ex-
14 tent permitted by laws relating to confidentiality, to furnish information and advice the
15 members of the joint committee consider necessary to perform their duties.

16 **SECTION 6.** (1) The Joint Legislative Committee on Climate shall:

17 (a) Provide general legislative oversight of policy related to climate, including but not
18 limited to the program established under sections 12 to 19 of this 2018 Act;

19 (b) Examine expenditures and investments of state proceeds from auctions conducted
20 under section 18 of this 2018 Act; and

21 (c) Make recommendations related to the expenditures and investments of state proceeds
22 from auctions conducted under section 18 of this 2018 Act to the Joint Committee on Ways
23 and Means.

24 (2) In developing recommendations under subsection (1)(c) of this section, the Joint
25 Legislative Committee on Climate shall consider the recommendations of the program advi-
26 sory committee established under section 8 of this 2018 Act and shall solicit and consider the
27 recommendations of the Oregon Global Warming Commission, the Oregon Climate Change
28 Research Institute and the Environmental Justice Task Force.

29
30 **GREENHOUSE GAS CAP AND INVESTMENT PROGRAM**
31 **(Program Advisory Committee)**
32

33 **SECTION 7.** Sections 8 to 20 of this 2018 Act and ORS 468A.200 to 468A.260 are added to
34 and made a part of ORS chapter 468A.

35 **SECTION 8.** (1) There is established in the Department of Environmental Quality a pro-
36 gram advisory committee consisting of 21 members appointed by the Governor as follows:

37 (a) Five members who are recommended to the Governor by the Environmental Justice
38 Task Force;

39 (b) Two members who represent Indian tribes;

40 (c) Three members with expertise in the economic drivers in rural communities in this
41 state, including one with expertise in agriculture, one with expertise in forestry and one with
42 expertise in fisheries;

43 (d) Three members who represent the interests of business and industry, including one
44 who represents covered entities, one who represents small businesses and one who repres-
45 ents business sectors affected by climate change;

1 (e) Two members who represent local governments, including one who represents the
2 interests of cities and one who represents the interests of counties;

3 (f) Two members who represent labor unions;

4 (g) Two members who represent environmental organizations, including one with exper-
5 tise in climate mitigation and one with expertise in climate resiliency;

6 (h) One member with expertise in climate science; and

7 (i) One member with expertise in public health equity.

8 (2) In making appointments to the committee, the Governor shall seek to:

9 (a) Reflect the geographic and demographic diversity of this state's population; and

10 (b) To the extent feasible, appoint individuals who have additional expertise or experience
11 in program development, budgeting, management and oversight, or climate planning or other
12 disciplines of particular value relevant to the duties of the committee.

13 (3)(a) The term of office of each member is four years, but a member serves at the
14 pleasure of the Governor.

15 (b) Before the expiration of the term of a member, the Governor shall appoint a succes-
16 sor whose term begins on January 1 next following.

17 (c) A member is eligible for reappointment.

18 (d) If there is a vacancy for any cause, the Governor shall make an appointment to be-
19 come immediately effective for the unexpired term.

20 (4) A majority of the members of the committee constitutes a quorum for the transaction
21 of business.

22 (5) The Governor shall appoint one of the members of the committee to serve as chair-
23 person.

24 (6) A member of the committee is entitled to actual and necessary travel and other ex-
25 penses as provided in ORS 292.495.

26 (7) The department shall provide the committee with necessary staff support.

27 (8) All agencies of the executive department as defined in ORS 174.112 are directed to
28 assist the committee in the performance of its duties and, to the extent permitted by laws
29 relating to confidentiality, to furnish such information and advice as the members of the
30 committee consider necessary to perform their duties.

31 **SECTION 9.** Notwithstanding the term of office specified by section 8 of this 2018 Act,
32 of the members first appointed to the program advisory committee established under section
33 8 of this 2018 Act:

34 (1) Five shall serve for a term ending January 1, 2020.

35 (2) Five shall serve for a term ending January 1, 2021.

36 (3) Five shall serve for a term ending January 1, 2022.

37 (4) Six shall serve for a term ending January 1, 2023.

38 **SECTION 10.** (1) The program advisory committee established under section 8 of this 2018
39 Act shall advise the Governor, the Environmental Quality Commission, the Department of
40 Environmental Quality, the Oregon Department of Administrative Services, the Oregon
41 Transportation Commission, the Department of Transportation, the Public Utility Commis-
42 sion, the Higher Education Coordinating Commission and other relevant state agencies on:

43 (a) The development and implementation of rules under sections 12 to 19, 25, 30a and 32
44 of this 2018 Act;

45 (b) The implementation of sections 31 and 34 of this 2018 Act; and

1 (c) The expenditures and investments of state proceeds from auctions conducted under
2 section 18 of this 2018 Act pursuant to sections 27 to 32, 33, 34 and 34a of this 2018 Act.

3 (2) The program advisory committee may conduct studies, request information and pro-
4 vide other advice related to the program established under sections 12 to 19 of this 2018 Act
5 and the expenditures and investments of state proceeds from auctions conducted under sec-
6 tion 18 of this 2018 Act as necessary to provide advice as described in subsection (1) of this
7 section.

8 (3)(a) The program advisory committee shall prepare a biennial report in each even-
9 numbered year that includes:

10 (A) The recommendations of the committee for the expenditures and investments of
11 state proceeds from auctions conducted under section 18 of this 2018 Act that are deposited
12 in the Climate Investments Fund established under section 28 of this 2018 Act and in the
13 Transportation Decarbonization Investments Account established under section 29 of this
14 2018 Act; and

15 (B) The recommendations of the committee, which may include recommendations for
16 legislation, regarding the effectiveness of implementation of sections 12 to 19, 27 to 32, 33,
17 34 and 34a of this 2018 Act.

18 (b) The committee shall submit the report required by this subsection to:

19 (A) The Oregon Transportation Commission for consideration in developing the trans-
20 portation decarbonization investment proposal required under section 29a of this 2018 Act;

21 (B) The Governor; and

22 (C) The interim committees of the Legislative Assembly related to climate, in the manner
23 provided by ORS 192.245.

24
25 (Statement of Purposes)

26
27 **SECTION 11.** (1) The Legislative Assembly finds and declares that the purposes of the
28 program established under sections 12 to 19 of this 2018 Act and the investments provided
29 for in sections 27 to 32, 33, 34 and 34a of this 2018 Act are to reduce greenhouse gas emis-
30 sions consistent with the statewide greenhouse gas emissions limits established under sec-
31 tion 4 of this 2018 Act and to promote carbon sequestration and adaptation and resilience
32 by this state's natural and working lands, fish and wildlife resources, communities and
33 economy in the face of climate change and ocean acidification.

34 (2) Sections 12 to 19 of this 2018 Act and the rules adopted pursuant to sections 12 to 19
35 of this 2018 Act:

36 (a) May not be interpreted to limit the authority of any state agency to adopt and im-
37 plement measures to reduce greenhouse gas emissions; and

38 (b) Shall be interpreted in a manner consistent with federal law.

39
40 (Greenhouse Gas Cap and Market-Based Compliance Mechanism)

41
42 **SECTION 12. Definitions.** As used in ORS 468A.200 to 468A.260 and sections 8 to 19 of this
43 2018 Act:

44 (1) "Aggregation" means an approach for qualifying and quantifying offset projects that
45 allows for the grouping together of two or more geographically or temporally separate ac-

1 **tivities that result in reductions or removals of greenhouse gases in a similar manner.**

2 **(2) “Allocation of electricity” has the meaning given that term in ORS 757.518.**

3 **(3) “Allowance” means a tradable authorization to emit one metric ton of carbon dioxide**
4 **equivalent.**

5 **(4) “Annual allowance budget” means the number of allowances available to be allocated**
6 **during one year of the program established under sections 12 to 19 of this 2018 Act.**

7 **(5) “Carbon dioxide equivalent” means the amount of carbon dioxide by weight that would**
8 **produce the same global warming impact as a given weight of another greenhouse gas, based**
9 **on considerations including but not limited to the best available science, including informa-**
10 **tion from the Intergovernmental Panel on Climate Change.**

11 **(6) “Coal-fired resource” has the meaning given that term in ORS 757.518.**

12 **(7) “Compliance instrument” means one allowance or one offset credit that may be used**
13 **to fulfill a compliance obligation.**

14 **(8) “Compliance obligation” means the quantity of regulated emissions for which a cov-**
15 **ered entity must submit compliance instruments to the Department of Environmental**
16 **Quality during a compliance period.**

17 **(9) “Consumer-owned utility” has the meaning given that term in ORS 757.270.**

18 **(10) “Covered entity” means a person that is designated by the Environmental Quality**
19 **Commission as subject to the program established under sections 12 to 19 of this 2018 Act.**

20 **(11) “Direct environmental benefits in this state” means:**

21 **(a) A reduction in or avoidance of emissions of any air contaminant in this state other**
22 **than a greenhouse gas;**

23 **(b) A reduction in or avoidance of pollution of any of the waters of the state, as the**
24 **terms “pollution” and “the waters of the state” are defined in ORS 468B.005; or**

25 **(c) An improvement in the health of natural and working lands in this state.**

26 **(12) “Electric company” has the meaning given that term in ORS 757.600.**

27 **(13) “Electricity service supplier” has the meaning given that term in ORS 757.600.**

28 **(14) “General market participant” means a person that:**

29 **(a) Is a registered entity;**

30 **(b) Is not a covered entity or an opt-in entity; and**

31 **(c) Intends to purchase, hold, sell or voluntarily surrender compliance instruments.**

32 **(15) “Impacted communities” means communities most at risk of being disproportion-**
33 **ately impacted by climate change as designated by the Environmental Quality Commission**
34 **under section 20 of this 2018 Act.**

35 **(16) “Leakage” means a reduction in greenhouse gas emissions within this state that is**
36 **counteracted by an increase in greenhouse gas emissions outside this state.**

37 **(17) “Natural and working lands” means:**

38 **(a) Land that is actively used by an agricultural owner or operator for an agricultural**
39 **operation that includes, but need not be limited to, active engagement in farming or ranch-**
40 **ing;**

41 **(b) Land producing forest products;**

42 **(c) Lands consisting of forests, grasslands, deserts, freshwater and riparian systems,**
43 **wetlands, coastal and estuarine areas, watersheds, wildlands or wildlife habitat; or**

44 **(d) Lands used for recreational purposes such as parks, urban and community forests,**
45 **trails, greenbelts and other similar open space land.**

1 (18) “Natural gas utility” means a natural gas utility regulated by the Public Utility
2 Commission under ORS chapter 757.

3 (19) “Offset credit” means a tradable credit generated through an offset project that re-
4 presents a greenhouse gas emissions reduction or removal of one metric ton of carbon
5 dioxide equivalent.

6 (20) “Offset project” means a project that reduces or removes greenhouse gas emissions
7 that are not regulated emissions.

8 (21) “Opt-in entity” means a person that is not designated as a covered entity by the
9 Environmental Quality Commission and that voluntarily chooses to participate in the pro-
10 gram established under sections 12 to 19 of this 2018 Act as if the entity were a covered en-
11 tity.

12 (22) “Registered entity” means a covered entity, opt-in entity or general market partic-
13 ipant that has successfully registered to participate in the program established under
14 sections 12 to 19 of this 2018 Act.

15 (23) “Regulated emissions” means the verified greenhouse gas emissions reported by or
16 assigned to a covered entity or opt-in entity under ORS 468A.280 that the commission de-
17 termines by rule are greenhouse gas emissions regulated under sections 12 to 19 of this 2018
18 Act.

19 (24) “Surrender” means to transfer a compliance instrument to the Department of En-
20 vironmental Quality:

21 (a) To satisfy a compliance obligation or an adjusted compliance obligation; or

22 (b) On a voluntary basis.

23 **SECTION 13. Adoption of program; general provisions.** (1) The Environmental Quality
24 Commission shall, by rule, adopt a program that places a cap on the total anthropogenic
25 greenhouse gas emissions by all covered entities through setting annual allowance budgets
26 and that provides a market-based mechanism for covered entities to demonstrate compliance
27 with the program. In adopting the program required by this section, the commission shall
28 set an annual allowance budget for the calendar year 2021, and a schedule of annual allow-
29 ance budgets that decline by a predetermined rate each calendar year until 2050. The sched-
30 ule of annual allowance budgets must reflect the total anthropogenic greenhouse gas
31 emissions from all covered entities as a proportionate share of anthropogenic statewide
32 greenhouse gas emissions, as defined in section 4 of this 2018 Act, that must be reduced to
33 prevent exceedance of the statewide greenhouse gas emissions limits established under sec-
34 tion 4 of this 2018 Act.

35 (2) The commission shall designate persons as covered entities as follows:

36 (a) The commission shall designate a person in control of one or more air contamination
37 sources for which a permit is issued pursuant to ORS 468.065, 468A.040 or 468A.155 as a
38 covered entity if the annual regulated emissions attributable to the air contamination
39 sources meet or exceed 25,000 metric tons of carbon dioxide equivalent. The commission shall
40 exempt from regulation under sections 12 to 19 of this 2018 Act:

41 (A) The methane emissions from a landfill that are demonstrated to have been recap-
42 tured and used for the generation of renewable energy, including but not limited to elec-
43 tricity, transportation fuels or heat.

44 (B) A land disposal site if the land disposal site was closed before the effective date of
45 this 2018 Act and is closed and maintained in compliance with ORS 459.268.

1 (C) A cogeneration facility, as defined in ORS 758.505, that is owned or operated by a
2 public university listed in ORS 352.002 or by a hospital as defined in ORS 442.015. An owner
3 or operator of a cogeneration facility exempted under this paragraph shall biennially submit
4 a report to the Department of Environmental Quality and, in the manner provided by ORS
5 192.245, to the Joint Legislative Committee on Climate. The report must detail the actions
6 taken by the owner or operator to achieve demonstrable greenhouse gas emissions re-
7 ductions at the public university or hospital served by the cogeneration facility.

8 (b) For the purpose of regulating persons that import, sell, allocate or distribute for use
9 in this state electricity generated outside this state, and unless the commission determines
10 that a method exists for regulating persons described in this paragraph that is more accu-
11 rate or efficient or that better enables the state to pursue linkage agreements under section
12 19 of this 2018 Act, the commission shall:

13 (A) Designate an electric company or a consumer-owned utility as a covered entity if the
14 regulated emissions that are attributable to the generation of electricity for which the elec-
15 tric company or consumer-owned utility is the load serving entity meet or exceed 25,000
16 metric tons of carbon dioxide equivalent.

17 (B) Designate an electricity service supplier as a covered entity for the purpose of ad-
18 dressing regulated emissions attributable to the electricity service supplier.

19 (c) The commission shall, for the purpose of regulating persons that import, sell or dis-
20 tribute for use in this state fuel that emits greenhouse gases when combusted:

21 (A) Designate a natural gas marketer as a covered entity for the purpose of addressing
22 annual regulated emissions that are attributable to the combustion of natural gas that is
23 sold by the natural gas marketer for use in this state by air contamination sources that are
24 not designated as covered entities under paragraph (a) of this subsection.

25 (B) Designate a natural gas utility as a covered entity for the purpose of addressing an-
26 nual regulated emissions that are attributable to the combustion of natural gas that the
27 natural gas utility imports, sells or distributes for use in this state and that are not emis-
28 sions accounted for through the regulation of air contamination sources under paragraph (a)
29 of this subsection or natural gas marketers under subparagraph (A) of this paragraph.

30 (C) Designate as covered entities persons not described in subparagraphs (A) and (B) of
31 this paragraph as necessary to address regulated emissions that are attributable to the
32 combustion of fuel that is imported, sold or distributed for use in this state. For purposes
33 of this subparagraph, the commission:

34 (i) May exclude from designation as a covered entity any person that imports in a cal-
35 endar year less than a de minimis amount of gasoline and diesel fuel, in total, as determined
36 by the commission by rule. Gasoline and diesel fuel imported by persons that are related or
37 share common ownership or control shall be aggregated in determining whether a person
38 may be excluded under this sub-subparagraph.

39 (ii) Shall exclude from regulated emissions the greenhouse gas emissions from the com-
40 bustion of fuel that is demonstrated to have been used as watercraft or aviation fuel.

41 (3) The commission shall adopt rules for the market-based compliance mechanism re-
42 quired by subsection (1) of this section that include, but need not be limited to:

43 (a) Criteria for the allocation of allowances pursuant to section 16 of this 2018 Act;

44 (b) Standards, pursuant to section 17 of this 2018 Act, for offset projects and for covered
45 entities to use offset credits;

1 (c) Rules for the administration of auctions of allowances pursuant to section 18 of this
2 2018 Act;

3 (d) Rules allowing for the trading of compliance instruments;

4 (e) Rules allowing opt-in entities and general market participants to participate in the
5 market-based compliance mechanism; and

6 (f) Compliance periods, standards for calculating compliance obligations and procedures
7 for covered entities to demonstrate compliance with the compliance obligations.

8 (4) The commission shall require a covered entity or opt-in entity to surrender to the
9 department a quantity of compliance instruments equal to the covered entity's or opt-in
10 entity's compliance obligation no later than the surrender date specified by the commission
11 by rule or order. In addition to any penalty provided by law, rules adopted by the commission
12 shall require a covered entity or opt-in entity that fails to timely surrender to the depart-
13 ment a sufficient quantity of compliance instruments to meet a compliance obligation to
14 surrender to the department a number of compliance instruments that is in addition to the
15 entity's compliance obligation.

16 (5)(a) All covered entities, opt-in entities and general market participants must register
17 as registered entities to participate in the program established under sections 12 to 19 of this
18 2018 Act.

19 (b) The commission shall adopt by rule registration requirements and any additional re-
20 quirements necessary for registered entities to participate in auctions administered pursuant
21 to section 18 of this 2018 Act.

22 (c) The commission may adopt a schedule of fees for registration under this subsection.
23 Fees must be reasonably calculated not to exceed the costs to the department in adminis-
24 tering sections 8 to 20 of this 2018 Act.

25 SECTION 14. Temporary exemption for certain emissions. (1) Annual verified greenhouse
26 gas emissions reported or assigned under ORS 468A.280 that are emissions of
27 hydrofluorocarbons, perfluorocarbons, sulfur hexafluoride, nitrogen trifluoride or other
28 fluorinated greenhouse gases generated during semiconductor and related device manufac-
29 turing are exempt from regulation under sections 12 to 19 of this 2018 Act and rules adopted
30 under sections 12 to 19 of this 2018 Act.

31 (2) This section applies to annual verified greenhouse gas emissions reported or assigned
32 under ORS 468A.280 for the period beginning January 1, 2021, and ending December 31, 2025.

33 SECTION 15. Section 14 of this 2018 Act is repealed on January 2, 2026.

34 SECTION 16. Allocation of allowances. (1) The Department of Environmental Quality
35 shall allocate a percentage of allowances from each annual allowance budget to be distributed
36 directly into an allowance price containment reserve designed to assist in containing com-
37 pliance costs for covered entities.

38 (2) The Environmental Quality Commission shall, in consultation with the Public Utility
39 Commission, adopt rules for distributing allowances to covered entities that are electric
40 companies and natural gas utilities. Rules adopted under this subsection must:

41 (a) Require the department to allocate allowances for direct distribution at no cost to
42 electric companies and, except as provided for in paragraph (b) of this subsection, require
43 the electric companies to consign all directly distributed allowances to the state to be auc-
44 tioned pursuant to section 18 of this 2018 Act;

45 (b) Taking into consideration the interaction of sections 12 to 19 of this 2018 Act with the

1 provisions of ORS 469A.005 to 469A.210 and 757.518, allow an electric company to surrender
2 as compliance instruments a portion of the allowances directly distributed to the electric
3 company under paragraph (a) of this subsection that reflects greenhouse gas emissions from
4 coal-fired resources in the electric company's allocation of electricity;

5 (c) Require the department to allocate allowances for direct distribution at no cost to a
6 natural gas utility and require the natural gas utility to consign the directly distributed al-
7 lowances to the state to be auctioned pursuant to section 18 of this 2018 Act; and

8 (d) Include a methodology for determining the allocation for distribution directly to cov-
9 ered entities described in this subsection that, to the extent feasible, is based on the follow-
10 ing principles:

11 (A) The direct distribution to a covered entity during the calendar year 2021 should rep-
12 resent an amount equal to 100 percent of the covered entity's proportionate share of regu-
13 lated emissions during representative calendar years prior to 2018; and

14 (B) The direct distribution received by a covered entity under this subsection during
15 calendar years subsequent to 2021 should decline annually at a rate equal to the predeter-
16 mined rate of decline for annual allowance budgets adopted under section 13 of this 2018 Act.

17 (3)(a) The department shall allocate allowances for direct distribution at no cost to a
18 covered entity that is a consumer-owned utility. The Environmental Quality Commission may
19 adopt rules allowing for a consumer-owned utility to consign directly distributed allowances
20 to the state to be auctioned pursuant to section 18 of this 2018 Act. Auction proceeds from
21 the sale of allowances consigned to the state for auction under this subsection must be used
22 by the consumer-owned utility for the benefit of ratepayers, consistent with the purposes
23 stated in section 11 of this 2018 Act and as further required by the governing body of the
24 consumer-owned utility.

25 (b) In determining the allocation for a consumer-owned utility, the department shall
26 employ a methodology based on the principles set forth in subsection (2)(d) of this section.

27 (c) The governing body of a consumer-owned utility that receives directly distributed al-
28 lowances under this subsection shall, no later than September 15 of each even-numbered
29 year, submit a report to the Joint Legislative Committee on Climate on the uses by the
30 consumer-owned utility of the directly distributed allowances. The report must include, but
31 not be limited to, a description of the uses by the consumer-owned utility of auction proceeds
32 from the sale of allowances consigned to the state for auction under this subsection.

33 (4)(a) In order to mitigate leakage, the commission shall adopt rules for allocating al-
34 lowances for direct distribution at no cost to covered entities that are engaged in
35 emissions-intensive, trade-exposed processes. The department shall hire or contract with a
36 third-party organization to assist the commission and the department in gathering data and
37 conducting analysis as necessary to implement the provisions of this subsection.

38 (b) Rules adopted under this subsection must utilize an output-based benchmarking
39 methodology for determining the allocation for a covered entity. The methodology must:

40 (A) Apply, for each emissions-intensive, trade-exposed process, an emissions efficiency
41 benchmark that equals up to 90 percent of the average regional emissions intensity per unit
42 of output from that process, based on greenhouse gas emissions data from representative
43 years prior to 2018; and

44 (B) Require the allocation to a covered entity to decline annually at a rate equal to the
45 predetermined rate of decline for annual allowance budgets adopted under section 13 of this

1 **2018 Act.**

2 (c) A covered entity shall receive an allocation under this subsection if the covered entity
3 is classified as being engaged in one or more of the processes described by the following in-
4 dustry descriptions and codes in the North American Industry Classification System:

5 (A) Cement Manufacturing, code 327310.

6 (B) Other Crushed and Broken Stone Mining and Quarrying, code 212319.

7 (C) Frozen Fruit, Juice and Vegetable Manufacturing, code 311411.

8 (D) Frozen Specialty Food Manufacturing, code 311412.

9 (E) Dried and Dehydrated Food Manufacturing, code 311423.

10 (F) Iron and Steel Mills and Ferroalloy Manufacturing, code 331110.

11 (G) Other Basic Inorganic Chemical Manufacturing, code 325180.

12 (H) All Other Plastics Product Manufacturing, code 326199.

13 (I) Mineral Wool Manufacturing, code 327993.

14 (J) Polystyrene Foam Product Manufacturing, code 326140.

15 (K) Glass Container Manufacturing, code 327213.

16 (L) Ethyl Alcohol Manufacturing, code 325193.

17 (M) Reconstituted Wood Product Manufacturing, code 321219.

18 (N) Gypsum Product Manufacturing, code 327420.

19 (O) Pulp Mills, code 322110.

20 (P) Paper (except Newsprint) Mills, code 322121.

21 (Q) Paperboard Mills, code 322130.

22 (d) The commission shall, by the year 2024 and once every three years thereafter, con-
23 duct a review of rules adopted under this subsection and any updated data and analysis to
24 determine whether updates to the rules are necessary to:

25 (A) Mitigate leakage by covered entities engaged in emissions-intensive, trade-exposed
26 processes;

27 (B) Prevent allocation to covered entities of allowances under this section that are in
28 excess of the allocation necessary to mitigate leakage; or

29 (C) Notwithstanding paragraph (b)(A) of this subsection, update the applicable emissions
30 efficiency benchmarks for any emissions-intensive, trade-exposed processes.

31 (e) In addition to and not in lieu of the review required by paragraph (d) of this sub-
32 section, the commission may update the list of processes in paragraph (c) of this subsection
33 by rule if a covered entity makes a proposal to the commission that an update to the list is
34 necessary to mitigate leakage.

35 (f) A covered entity that is a fossil fuel distribution and storage facility or infrastructure,
36 or an electric generating unit, may not receive an allocation under this subsection.

37 (5) The department shall allocate a percentage of allowances from each annual allowance
38 budget to be retired each year for eligible voluntary renewable electricity generated in the
39 previous year.

40 (6) After making all allocations provided for in subsections (1) to (5) of this section, the
41 department shall allocate all remaining allowances in the annual allowance budget to be
42 distributed to an auction holding account for auction pursuant to section 18 of this 2018 Act.

43 **SECTION 17. Offset projects.** (1) Offset projects:

44 (a) Must be located in the United States or in a jurisdiction with which the Environ-
45 mental Quality Commission has entered into a linkage agreement pursuant to section 19 of

1 this 2018 Act;

2 (b) Must not be otherwise required by law; and

3 (c) Must result in greenhouse gas emissions reductions or removals that:

4 (A) Are real, permanent, quantifiable, verifiable and enforceable; and

5 (B) Are in addition to greenhouse gas emissions reductions or removals otherwise re-
6 quired by law and any other greenhouse gas emissions reductions or removals that would
7 otherwise occur.

8 (2)(a) A total of no more than eight percent of a covered entity's compliance obligation
9 may be met by surrendering offset credits. A total of no more than four percent of a covered
10 entity's compliance obligation may be met by surrendering offset credits that are sourced
11 from offset projects that do not provide direct environmental benefits in this state.

12 (b) The commission may by rule adopt additional restrictions on the number of offset
13 credits that may be surrendered by a covered entity that is an air contamination source that
14 is geographically located in an impacted community if:

15 (A) The geographic area within which the air contamination source is located is also a
16 nonattainment area or an attainment area projected by the Department of Environmental
17 Quality to exceed air quality standards within five years and the air contamination source
18 substantially contributes to or causes the nonattainment or projected nonattainment of air
19 quality standards; or

20 (B) The air contamination source is in violation of the terms or conditions of any permit
21 required or authorized under ORS chapter 468A and issued by the department or a regional
22 air quality control authority.

23 (3) In adopting rules governing offset projects and covered entities' use of offset credits,
24 the commission shall:

25 (a) Take into consideration standards, rules or protocols for offset projects and offset
26 credits established by other states, provinces and countries with programs comparable to the
27 program established under sections 12 to 19 of this 2018 Act;

28 (b) Encourage opportunities for the development of offset projects in this state by
29 adopting offset protocols that may include, but need not be limited to, protocols that make
30 use of aggregation or other mechanisms to reduce transaction costs related to the develop-
31 ment of offset projects;

32 (c) Consult with and consider the recommendations of the advisory committee required
33 by subsection (4) of this section, the State Department of Agriculture, the State Board of
34 Forestry, the Environmental Justice Task Force and other relevant state agencies; and

35 (d) Adopt by rule a process for the Department of Environmental Quality to investigate
36 and invalidate issued offset credits as necessary to uphold the environmental integrity of the
37 program established under sections 12 to 19 of this 2018 Act.

38 (4) The Director of the Department of Environmental Quality shall appoint a compliance
39 offsets protocol advisory committee to aid and advise the commission in adopting and up-
40 dating rules governing offset projects and covered entities' use of offset credits. The advisory
41 committee shall provide guidance to the commission in developing and updating offset pro-
42 tocols for the purposes of increasing offset projects with direct environmental benefits in
43 this state while prioritizing offset projects that benefit impacted communities, Indian tribes
44 and natural and working lands. The director shall appoint at least one member to the advi-
45 sory committee from each of the following groups:

- 1 (a) Scientists;
- 2 (b) Public health experts;
- 3 (c) Carbon market experts;
- 4 (d) Representatives of Indian tribes;
- 5 (e) Environmental justice advocates;
- 6 (f) Labor and workforce representatives;
- 7 (g) Forestry experts;
- 8 (h) Agriculture experts;
- 9 (i) Environmental advocates;
- 10 (j) Conservation advocates; and
- 11 (k) Dairy experts.

12 **SECTION 18. Auctions.** (1) Except as provided in subsection (6) of this section, auctions
13 of allowances are open to registered entities.

14 (2) The Department of Environmental Quality shall hold auctions at least annually.

15 (3) The department may engage:

- 16 (a) A qualified, independent auction administrator to administer auctions; or
- 17 (b) A qualified financial services administrator to conduct financial transactions related
18 to the auction.

19 (4) The department shall issue notice for an upcoming auction prior to the auction.

20 (5) The Environmental Quality Commission shall:

21 (a) Set an auction floor price for the year 2021 and a schedule for the floor price to in-
22 crease by a predetermined amount each calendar year; and

23 (b) Take actions to minimize the potential for market manipulation and to guard against
24 bidder collusion, including but not limited to specifying as holding limits the maximum
25 number of allowances that may be held for use or trade by a registered entity at any time.

26 (6) Reserve auctions of allowances from the allowance price containment reserve shall
27 be conducted separately from the auction of other allowances for the purpose of addressing
28 high costs of compliance instruments. Allowances unsold at a reserve auction must be made
29 available again at future reserve auctions. Only covered entities may participate in reserve
30 auctions.

31 (7) The proceeds of an auction shall be transferred as follows:

32 (a) Auction proceeds from the sale of allowances consigned to the state for auction shall
33 be transferred to the electric company, natural gas utility or consumer-owned utility that
34 consigned the allowances.

35 (b) Auction proceeds payable to the state shall be transferred to the State Treasurer to
36 be deposited in the Auction Proceeds Distribution Fund established under section 26 of this
37 2018 Act.

38 **SECTION 19. Linkage with market-based compliance mechanisms in other jurisdictions.**

39 (1) In adopting and implementing rules under sections 12 to 19 of this 2018 Act, the Envi-
40 ronmental Quality Commission and the Department of Environmental Quality shall:

41 (a) Consider market-based compliance mechanisms designed to reduce greenhouse gas
42 emissions in other jurisdictions; and

43 (b) Implement the program established under sections 12 to 19 of this 2018 Act in a
44 manner that:

45 (A) Avoids double counting of emissions or emissions reductions; and

1 (B) Enables the state to pursue linkage agreements pursuant to this section with other
2 jurisdictions.

3 (2) The commission may not link the market-based compliance mechanism established
4 pursuant to sections 12 to 19 of this 2018 Act and rules adopted under sections 12 to 19 of
5 this 2018 Act with the market-based compliance mechanism of any other jurisdiction unless
6 the commission notifies the Governor that the commission intends to link the market-based
7 compliance mechanism and the Governor makes the following findings:

8 (a) The jurisdiction with which the commission proposes to link has adopted program
9 requirements for greenhouse gas reductions that are equivalent to or stricter than those
10 required by sections 12 to 19 of this 2018 Act;

11 (b) Under the proposed linkage, the State of Oregon is able to enforce sections 12 to 19
12 of this 2018 Act against any entity subject to regulation under sections 12 to 19 of this 2018
13 Act and against any entity located within the linking jurisdiction to the maximum extent
14 permitted under the United States and Oregon Constitutions;

15 (c) The proposed linkage provides for enforcement of applicable laws by the commission
16 or by the linking jurisdiction of program requirements that are equivalent to or stricter than
17 those required by sections 12 to 19 of this 2018 Act; and

18 (d) The proposed linkage and any related engagement by the State of Oregon of an inde-
19 pendent organization to provide administrative or technical services to support implementa-
20 tion of sections 12 to 19 of this 2018 Act shall not impose any significant liability on the state
21 or any state agency for any failure associated with the linkage.

22 (3) The Governor shall issue findings pursuant to subsection (2) of this section within 45
23 days of receiving a notice from the commission that the commission intends to link the
24 market-based compliance mechanism and shall provide the findings to the Legislative As-
25 sembly. The Governor, in making the findings, shall consider the advice of the Attorney
26 General. Findings issued pursuant to subsection (2) of this section are not subject to judicial
27 review.

28
29 (Methodology for Designating Impacted Communities)

30
31 **SECTION 20.** (1) The Environmental Quality Commission, by rule and after consultation
32 with the Portland State University Population Research Center, the Oregon Health Author-
33 ity, the program advisory committee established under section 8 of this 2018 Act and other
34 relevant state agencies and local agencies and officials, shall designate impacted communi-
35 ties, as defined in section 12 of this 2018 Act, by census tract. The commission shall designate
36 impacted communities based on a methodology that takes into consideration geographic,
37 socioeconomic, historic disadvantage, public health and environmental hazard criteria. The
38 commission may designate as impacted communities areas that include, but are not limited
39 to:

40 (a) Areas with above average concentrations of low income households, historically dis-
41 advantaged households, high unemployment, high linguistic isolation, low levels of
42 homeownership, high rent burden, sensitive populations or residents with low levels of edu-
43 cational attainment.

44 (b) Areas disproportionately affected by environmental pollution and other hazards that
45 can lead to negative public health effects, exposure or environmental degradation.

1 (2) The methodology required by this section must give greater weight to those criteria
2 that the commission determines are the most accurate predictors of vulnerability to the
3 impacts of climate change and ocean acidification.

4 (3) The commission shall review and update the methodology required by this section and
5 the designation of impacted communities a minimum of once every five years.

6
7 (Department of Environmental Quality Program Development Fee)

8
9 **SECTION 21.** Section 22 of this 2018 Act is added to and made a part of ORS chapter
10 468A.

11 **SECTION 22.** (1) In addition to and not in lieu of any other fee required by law, and
12 subject to subsection (3) of this section, a person required to register and report greenhouse
13 gas emissions to the Department of Environmental Quality under ORS 468A.280 shall pay to
14 the department an annual program development fee of \$_____ if, for the year prior
15 to the year in which the annual program development fee is assessed, the person reported
16 annual greenhouse gas emissions attributable to the person that equal or exceed 25,000
17 metric tons of carbon dioxide equivalent.

18 (2) Fees collected under this section shall be deposited into the State Treasury to the
19 credit of an account of the department. Moneys deposited under this subsection are con-
20 tinuously appropriated to the department for the payment of expenses of the department and
21 the Environmental Quality Commission in developing and preparing for implementation of
22 sections 8 to 20 of this 2018 Act.

23 (3) A person described in subsection (1) of this section shall pay to the department the
24 fee required under this section no later than 30 days after the date of the invoice issued by
25 the department for the fee.

26 (4) The commission may adopt rules necessary to implement the provisions of this sec-
27 tion, including but not limited to rules imposing a penalty for failure to pay, substantial
28 underpayment of or late payment of the fee required by this section.

29 **SECTION 23.** Section 22 of this 2018 Act is repealed on January 2, 2021.

30
31 (Auction Proceeds Investment)

32
33 **SECTION 24.** Section 25 of this 2018 Act is added to and made a part of ORS chapter 757.

34 **SECTION 25.** (1) As used in this section:

35 (a) "Auction proceeds" means revenue transferred to an electric company or natural gas
36 utility under section 18 of this 2018 Act from the sale of allowances that the electric company
37 or natural gas utility consigned to the state for auction, pursuant to the program established
38 by the Environmental Quality Commission under sections 12 to 19 of this 2018 Act.

39 (b) "Electric company" has the meaning given that term in ORS 757.600.

40 (c) "Natural gas utility" means a natural gas utility regulated by the Public Utility
41 Commission under this chapter.

42 (2) Auction proceeds received by an electric company or natural gas utility must be spent
43 within the service territory of the electric company or natural gas utility and must be used
44 only for activities that serve to reduce greenhouse gas emissions, as defined in ORS 468A.005,
45 or to stabilize or reduce energy bills for customers.

1 **(3) An electric company or natural gas utility shall use the auction proceeds for activities**
2 **that benefit the following customers, in the following order:**

3 **(a) Low-income residential customers, including but not limited to low-income residential**
4 **customers that are tenants.**

5 **(b) All other customers, including residential customers, small commercial customers**
6 **and energy intensive industrial customers that are not covered entities receiving allowances**
7 **directly allocated at no cost under section 16 of this 2018 Act.**

8 **(4)(a) An electric company or natural gas utility shall prioritize the use of auction pro-**
9 **ceeds for bill assistance, weatherization and energy efficiency measures. Except as provided**
10 **in paragraph (b) of this subsection, auction proceeds returned to customers as bill assistance**
11 **must be returned in a nonvolumetric manner.**

12 **(b) An electric company or natural gas utility shall expend a portion of the auction pro-**
13 **ceeds received by the electric company or natural gas utility each year to fund volumetric**
14 **bill assistance to low-income residential customers.**

15 **(5) The Public Utility Commission shall, pursuant to ORS 756.040 and after consultation**
16 **with the Housing and Community Services Department and the program advisory committee**
17 **established under section 8 of this 2018 Act, adopt rules for the implementation and**
18 **enforcement of this section.**

19 **SECTION 26. (1) The Auction Proceeds Distribution Fund is established in the State**
20 **Treasury, separate and distinct from the General Fund.**

21 **(2) The Auction Proceeds Distribution Fund shall consist of moneys transferred to the**
22 **fund under section 18 of this 2018 Act. Interest earned by the fund shall be credited to the**
23 **fund.**

24 **(3) Subject to subsection (4) of this section, the Department of Environmental Quality**
25 **shall certify the amount of moneys available for distribution in the Auction Proceeds Dis-**
26 **tribution Fund and distribute the moneys as follows:**

27 **(a) All moneys that constitute revenues described in Article IX, section 3a, of the Oregon**
28 **Constitution, must be transferred to the Transportation Decarbonization Investments Ac-**
29 **count;**

30 **(b) All moneys that constitute revenues described in Article VIII, section 2 (1)(g), of the**
31 **Oregon Constitution, must be transferred to the Common School Fund; and**

32 **(c) Of the moneys remaining after the transfer under paragraphs (a) and (b) of this**
33 **subsection:**

34 **(A) Eighty-five percent must be transferred to the Oregon Climate Investments Fund;**
35 **and**

36 **(B) Fifteen percent must be transferred to the Just Transition Fund.**

37 **(4) The Department of Environmental Quality shall consult with the Department of**
38 **Transportation in determining the amount of moneys to be transferred under subsection**
39 **(3)(a) of this section.**

40 **SECTION 27. As used in sections 27 to 32 of this 2018 Act:**

41 **(1) “Impacted communities” has the meaning given that term in section 12 of this 2018**
42 **Act.**

43 **(2) “Metropolitan planning organization” has the meaning given that term in ORS 197.629.**

44 **(3) “Natural and working lands” has the meaning given that term in section 12 of this**
45 **2018 Act.**

1 (4) “Regional transportation plan” has the meaning given that term in ORS 184.899.

2 **SECTION 28.** (1) The Climate Investments Fund is established in the State Treasury,
3 separate and distinct from the General Fund. Moneys in the Climate Investments Fund are
4 continuously appropriated to the Oregon Department of Administrative Services to be dis-
5 tributed by the department as provided in this section. The fund shall consist of moneys
6 deposited in the fund under section 26 of this 2018 Act. Interest earned by the fund shall be
7 credited to the fund.

8 (2) Moneys in the Climate Investments Fund may be used only for projects, programs and
9 activities that further the purposes stated in section 11 of this 2018 Act.

10 (3) The Legislative Assembly shall allocate the moneys deposited in the fund subject to
11 section 30 of this 2018 Act. Of the moneys deposited in the fund each biennium:

12 (a) Fifty percent must be allocated for projects, programs or activities that are to the
13 benefit of or geographically located in and to the benefit of impacted communities;

14 (b) Ten percent must be allocated for projects, programs or activities that are to the
15 benefit of Indian tribes;

16 (c) Twenty percent must be allocated for projects, programs or activities that represent
17 investments in natural and working lands; and

18 (d) Twenty percent may be allocated for any projects, programs or activities that meet
19 the requirements of subsection (2) of this section, as further described in section 30 of this
20 2018 Act, regardless of whether a program, project or activity funded under this paragraph
21 is described in paragraphs (a) to (c) of this subsection.

22 (4) Of the moneys allocated by the Legislative Assembly under subsection (3)(a) of this
23 section, at least 33 percent must be allocated for activities that benefit rural areas that are
24 designated as impacted communities. For purposes of this subsection, “rural area” means
25 an area located entirely outside of the acknowledged Portland Metropolitan Area Regional
26 Urban Growth Boundary and the acknowledged urban growth boundaries of cities with pop-
27 ulations of 30,000 or more.

28 (5) The department may perform activities necessary to ensure that recipients of moneys
29 distributed from the Climate Investments Fund comply with applicable requirements. If the
30 department determines that a recipient has not complied with applicable requirements, the
31 department may order the recipient to refund all moneys distributed from the fund. Moneys
32 refunded pursuant to this subsection shall be credited to the fund.

33 **SECTION 29.** (1) The Transportation Decarbonization Investments Account is established
34 as a separate account within the State Highway Fund. Interest earned by the Transportation
35 Decarbonization Investments Account shall be credited to the account. Moneys in the ac-
36 count are continuously appropriated to the Department of Transportation to be distributed
37 by the department as provided in this section.

38 (2) The account shall consist of moneys deposited in the account under section 26 of this
39 2018 Act.

40 (3) Moneys deposited in the account may be used only for:

41 (a) The uses stated in Article IX, section 3a, of the Oregon Constitution; and

42 (b) Activities that further the purposes stated in section 11 of this 2018 Act.

43 (4) The Legislative Assembly shall allocate the moneys deposited in the account subject
44 to section 30 of this 2018 Act. At least 60 percent of the moneys deposited in the account
45 each biennium must be allocated for purposes that benefit impacted communities.

1 (5) The department may perform activities necessary to ensure that recipients of moneys
2 distributed from the account comply with applicable requirements. If the department deter-
3 mines that a recipient has not complied with applicable requirements, the department may
4 order the recipient to refund all moneys distributed from the account. Moneys refunded
5 pursuant to this subsection shall be credited to the account.

6 **SECTION 29a.** (1) The Oregon Transportation Commission shall prepare, for each
7 biennium, a transportation decarbonization investment proposal that sets forth:

8 (a) A list of recommended transportation projects to be funded with moneys in the
9 Transportation Decarbonization Investments Account established under section 29 of this
10 2018 Act; and

11 (b) Any additional recommendations for the Legislative Assembly to consider in deter-
12 mining how to best allocate moneys deposited in the account.

13 (2) Prior to selecting transportation projects for inclusion in the proposal, the commis-
14 sion shall consider the recommendations contained in the biennial report submitted to the
15 commission under section 10 of this 2018 Act, and shall seek additional input from the pro-
16 gram advisory committee established under section 8 of this 2018 Act.

17 (3) In selecting transportation projects for inclusion in the proposal, the commission
18 shall consider:

19 (a) Whether proposed transportation projects meet the requirements of sections 29 (3)
20 and 30 of this 2018 Act;

21 (b) How selection of projects to be funded through moneys deposited in the account may
22 affect the state's ability to carry out the purposes of Article IX, section 3a (3), of the Oregon
23 Constitution; and

24 (c) How much of the cost of a proposed transportation project can be funded from any
25 source other than the account.

26 (4) The commission shall submit the proposal required under this section to:

27 (a) The interim Joint Legislative Committee on Climate in the manner provided by ORS
28 192.245; and

29 (b) The Oregon Department of Administrative Services, to be included and submitted to
30 the Legislative Assembly as part of the Governor's recommended budget.

31 **SECTION 30.** (1) Moneys deposited in the Climate Investments Fund and moneys depos-
32 ited in the Transportation Decarbonization Investments Account shall be allocated, to the
33 extent feasible, cost-effective and consistent with law, to maximize greenhouse gas emissions
34 reductions, to support the purposes stated in section 11 of this 2018 Act and to:

35 (a) Complement efforts to achieve and maintain local air quality;

36 (b) Provide opportunities for Indian tribes, members of impacted communities and busi-
37 nesses owned by women or members of minority groups to participate in and benefit from
38 statewide efforts to reduce greenhouse gas emissions, including technical assistance for mi-
39 nority or women owned businesses, nonprofit organizations and other community insti-
40 tutions that serve or represent most impacted communities or low-income households;

41 (c) Make use of domestically produced products to the maximum extent feasible; or

42 (d) Promote low carbon economic development opportunities and creation of jobs that
43 sustain living wages.

44 (2) Moneys may be allocated from the Climate Investments Fund for investments that
45 may include, but need not be limited to, any of the following:

1 (a) Funding to reduce greenhouse gas emissions or promote adaptation or resiliency
2 through energy efficiency and energy conservation in buildings, low-income weatherization
3 and support of affordable housing that is transit oriented or located near employment cen-
4 ters.

5 (b) Funding to reduce greenhouse gas emissions through electrical grid decarbonization
6 efforts, including but not limited to investments in energy generation from renewable re-
7 sources, distributed energy resources, transmission and storage projects for renewable en-
8 ergy, demand response, community solar projects and other community-scale renewable
9 energy projects.

10 (c) Funding to reduce greenhouse gas emissions associated with transportation, including
11 but not limited to investments in transportation electrification, transit, fuel and energy ef-
12 ficiency in vessels powered by marine engines and roadside landscape management efforts
13 that promote carbon sequestration.

14 (d) Funding to support planning or implementation of planning by local governments and
15 metropolitan planning organizations for reducing greenhouse gas emissions or promoting
16 carbon sequestration, adaptation or resilience.

17 (e) Funding to reduce greenhouse gas emissions or support adaptation or resiliency
18 through investments in natural and working lands, including but not limited to investments
19 in agricultural or forestry practices that reduce greenhouse gas emissions or promote carbon
20 sequestration, restoration of tidal marsh or intertidal areas of estuaries, irrigation efficiency
21 projects, riparian zone restoration projects and methane recovery.

22 (f) Funding to facilitate the development in Oregon of clean energy infrastructure or
23 technologies, low carbon infrastructure or technologies, carbon capture and storage or
24 carbon-free infrastructure and technologies.

25 (g) Funding to strengthen the resilience of fish, wildlife and ecosystems in the face of
26 climate change through investments in projects, including but not limited to projects in-
27 volving instream flow acquisition and protection, fish barrier removal, habitat restoration
28 and enhancement and protection of wildlife corridors, coldwater refugia areas and species
29 strongholds.

30 (3)(a) In allocating moneys from the Transportation Decarbonization Investments Ac-
31 count, the Legislative Assembly shall, to the extent feasible and consistent with law, seek
32 to invest in:

33 (A) Programs, projects or activities that are consistent with, or that complement, in-
34 vestments described in subsection (2) of this section;

35 (B) The implementation of land use and transportation scenarios required to be adopted
36 by metropolitan service districts under section 37, chapter 865, Oregon Laws 2009, and that
37 have been approved by the Land Conservation and Development Commission; and

38 (C) The development and implementation of land use and transportation scenarios by lo-
39 cal governments and metropolitan planning organizations in accordance with the guidelines
40 established by the Department of Transportation and the Department of Land Conservation
41 and Development under ORS 184.893.

42 (b) A project, program or activity that is eligible to be funded by moneys deposited in the
43 Transportation Decarbonization Investments Account may also be eligible to be funded by
44 moneys deposited in the Climate Investments Fund for those portions of the project, pro-
45 gram or activity that may not be constitutionally funded by revenues described in Article IX,

1 section 3a (1), of the Oregon Constitution.

2 (4) Agencies of the executive department as defined in ORS 174.112, counties, cities and
3 all other public and private entities receiving moneys under sections 27 to 32 of this 2018 Act
4 shall report annually to the Oregon Department of Administrative Services on the expen-
5 ditures of the moneys.

6 (5) The Oregon Department of Administrative Services shall make an annual report to
7 the Legislative Assembly presenting the information required by subsection (4) of this sec-
8 tion. The report must be made to the Joint Legislative Committee on Climate.

9 (6) If an allocation of moneys for a particular purpose by the Legislative Assembly under
10 sections 27 to 32 of this 2018 Act is determined by a court to be inconsistent with law, the
11 allocation is hereby declared independent and severable and the invalidity, if any, of any part
12 or feature of the allocation shall not affect or render the remainder of the allocations by the
13 Legislative Assembly under sections 27 to 32 of this 2018 Act invalid or inoperative.

14 **SECTION 30a.** (1) If a construction project is funded in whole or in part by moneys allo-
15 cated by the Legislative Assembly from the Climate Investments Fund or the Transportation
16 Decarbonization Investments Account, the primary contractor participating in the con-
17 struction project:

18 (a) Shall participate in an apprenticeship program registered with the State Apprentice-
19 ship and Training Council;

20 (b) May not be a contractor listed by the Commissioner of the Bureau of Labor and In-
21 dustries under ORS 279C.860 as ineligible to receive a contract or subcontract for public
22 works;

23 (c) Must demonstrate a history of compliance with the rules and other requirements of
24 the Construction Contractors Board and of the Workers' Compensation Division, the Build-
25 ing Codes Division and the Occupational Safety and Health Division of the Department of
26 Consumer and Business Services; and

27 (d) Must demonstrate a history of compliance with federal and state wage and hour laws.

28 (2) A farm labor contractor, as defined in ORS 658.405, may not receive moneys allocated
29 by the Legislative Assembly from the Climate Investments Fund or the Transportation
30 Decarbonization Investments Account unless the farm labor contractor is in compliance with
31 all licensing and any other requirements or regulations imposed upon farm labor contractors
32 pursuant to ORS 658.405 to 658.503.

33 (3)(a) The Oregon Department of Administrative Services shall adopt model rules that
34 specify labor, workforce and contracting procedures for all state agencies to use in admin-
35 istering funds for projects that are funded in whole or in part by moneys allocated by the
36 Legislative Assembly from the Climate Investments Fund or the Transportation
37 Decarbonization Investments Account. The department shall adopt the rules in accordance
38 with ORS chapter 183.

39 (b) Model rules adopted under this subsection shall require the use of a project labor
40 agreement for large construction projects funded as described in paragraph (a) of this sub-
41 section. For all other construction projects funded as described in paragraph (a) of this
42 subsection, the model rules shall establish measurable, enforceable goals for the training and
43 hiring of persons who are members of impacted communities and for contracting with busi-
44 nesses that are owned or operated by members of impacted communities.

45 (c) The model rules shall promote best practices in procurement and contracting.

1 (d)(A) The model rules shall require that, in each contract awarded for a construction
2 project funded as described in paragraph (a) of this subsection, steel, iron, coatings for steel
3 and iron and manufactured products that the contractor purchases for the project and that
4 become part of a permanent structure be produced in the United States.

5 (B) The requirement in subparagraph (A) of this paragraph shall not apply if the admin-
6 istering agency finds that:

7 (i) The requirement is inconsistent with the public interest;

8 (ii) Steel, iron, coatings for steel and iron and manufactured products required for the
9 project are not produced in the United States in sufficient and reasonably available quantities
10 and with satisfactory quality; or

11 (iii) The requirement set forth in subparagraph (A) of this paragraph will increase the
12 costs of the project, exclusive of labor costs involved in final assembly for manufactured
13 products, by 25 percent or more.

14 (C) Notwithstanding a finding by the administering agency under paragraph (d)(B) of this
15 subsection, a contractor shall spend at least 75 percent of the total amount the contractor
16 spends in connection with the construction project on steel, iron, coatings for steel and iron
17 and manufactured products that become part of a permanent structure to purchase steel,
18 iron, coatings for steel and iron and manufactured products that are produced in the United
19 States.

20 (e) Before adopting or amending a rule under this subsection, the department shall con-
21 sult with the program advisory committee established under section 8 of this 2018 Act, rep-
22 resentatives of labor and workforce equity and contractor equity, and other knowledgeable
23 persons.

24 (4) A state agency charged with administering funds for construction projects that are
25 funded in whole or in part by moneys deposited in the Climate Investments Fund or the
26 Transportation Decarbonization Investments Account may not adopt the administering
27 agency's own rules for labor, workforce and contracting procedures related to administering
28 funds allocated from the Climate Investments Fund or the Transportation Decarbonization
29 Investments Account.

30 SECTION 31. In preparing the Governor's budget as required under ORS 291.202, the
31 Governor shall consider the recommendations for the expenditures and investments of state
32 proceeds from auctions conducted under section 18 of this 2018 Act that are contained in the
33 biennial report prepared by the program advisory committee under section 10 of this 2018
34 Act.

35 SECTION 32. (1) The Oregon Department of Administrative Services, after consultation
36 with the program advisory committee established under section 8 of this 2018 Act, the De-
37 partment of Transportation and other interested state agencies, shall adopt rules as neces-
38 sary to implement sections 27 to 32 of this 2018 Act.

39 (2) Rules adopted under this section must include guidelines for agencies that receive
40 allocations of funds under sections 27 to 32 of this 2018 Act for ensuring that expenditures
41 of funds allocated under sections 27 to 32 of this 2018 Act comply with all applicable laws.

42 SECTION 33. (1) The Just Transition Fund is established in the State Treasury, separate
43 and distinct from the General Fund. Interest earned by the Just Transition Fund shall be
44 credited to the fund. Moneys in the fund are continuously appropriated to the Higher Edu-
45 cation Coordinating Commission to be distributed pursuant to the Just Transition Program

1 established under section 34 of this 2018 Act.

2 (2) The Just Transition Fund shall consist of moneys deposited in the fund under section
3 26 of this 2018 Act.

4 (3)(a) Of the moneys deposited in the fund each biennium, the commission shall set aside
5 50 percent of the funds in a reserve account.

6 (b) The commission shall continue to credit the reserve account in the manner required
7 under this subsection until the balance in the reserve account is the lesser of:

8 (A) An amount that, in the commission's determination, is adequate for the purposes
9 specified in paragraph (c) of this subsection; or

10 (B) \$2.5 million.

11 (c) The reserve account shall be maintained and used by the commission only to fund
12 programs or activities that provide financial support for workers dislocated or adversely af-
13 fected by climate change or climate change policies.

14 **SECTION 34.** (1) The Higher Education Coordinating Commission, after consultation with
15 the program advisory committee established under section 8 of this 2018 Act, the Employ-
16 ment Department and other interested state agencies, shall establish a Just Transition Pro-
17 gram for the purpose of distributing moneys deposited in the Just Transition Fund.

18 (2) Moneys distributed through the Just Transition Program shall be distributed to:

19 (a) Support economic diversification, job creation, job training and other employment
20 services;

21 (b) Provide financial support for workers dislocated or adversely affected by climate
22 change or climate change policies;

23 (c) Provide mental health services for workers dislocated or adversely affected by climate
24 change or climate change policies; or

25 (d) Consistent with the purposes stated in section 11 of this 2018 Act, provide other re-
26 lated workforce support to communities in this state that are adversely affected by climate
27 change or climate change policies.

28 (3) The commission shall seek to develop and implement the Just Transition Program in
29 a manner that is consistent with and complementary to other local, state and federal pro-
30 grams, policies and incentives that serve to carry out the activities described in subsection
31 (2) of this section, including but not limited to activities undertaken by the commission un-
32 der ORS 660.318. The Just Transition Program may include, but need not be limited to, a
33 competitive grant program.

34 (4) The commission may adopt rules necessary for the administration of the Just Tran-
35 sition Program, including but not limited to rules that set standards for awarding grants.

36 (5) A grant program adopted under this section may:

37 (a) Encourage, but not require, a grant applicant to provide matching funds for com-
38 pletion of the project, program or activity for which a grant is awarded; and

39 (b) Allow a grant applicant to appeal to the office for reevaluation of any determination
40 of grant funding.

41 (6) The commission may perform activities necessary to ensure that recipients of moneys
42 distributed from the Just Transition Fund comply with applicable requirements. If the com-
43 mission determines that a recipient has not complied with applicable requirements, the
44 commission may order the recipient to refund all moneys distributed from the fund. Moneys
45 refunded pursuant to this subsection shall be credited to the fund.

1 **SECTION 34a.** Moneys deposited in the Common School Fund under section 26 of this
2 2018 Act are continuously appropriated to the Department of State Lands to be used for
3 purposes:

- 4 (1) For which other moneys in the Common School Fund may be used; and
5 (2) That are consistent with the purposes stated in section 11 of this 2018 Act.

7 **GREENHOUSE GAS EMISSIONS REGISTRATION AND REPORTING**

8
9 **SECTION 35.** ORS 468A.280 is amended to read:

10 468A.280. (1) *[In addition to any registration and reporting that may be required under ORS*
11 *468A.050,]* The Environmental Quality Commission by rule may require registration and reporting
12 **of information necessary to determine greenhouse gas emissions** by:

13 **(a) A person in control of an air contamination source of any class for which registration**
14 **and reporting is required under ORS 468A.050.**

15 [(a)] **(b)** *[Any]* A person who imports, sells, allocates or distributes **electricity** for use in this
16 state *[electricity, the generation of which emits greenhouse gases].*

17 [(b)] **(c)** *[Any]* A person who imports, sells or distributes for use in this state *[fossil]* fuel that
18 *[generates]* **emits** greenhouse gases when combusted.

19 **(2) A person required to register and report under subsection (1) of this section shall**
20 **register with the Department of Environmental Quality and make reports containing infor-**
21 **mation that the commission by rule may require that is relevant to determining and verify-**
22 **ing greenhouse gas emissions. The commission may by rule require the person to provide an**
23 **audit by an independent and disinterested party to verify that the greenhouse gas emissions**
24 **information reported by the person is true and accurate.**

25 [(2)] **(3)** Rules adopted by the commission under this section for electricity that is imported, sold,
26 allocated or distributed for use in this state may require reporting of information necessary to de-
27 termine greenhouse gas emissions from generating facilities used to produce the electricity and re-
28 lated electricity transmission line losses.

29 [(3)(a)] **(4)(a)** The commission shall allow consumer-owned utilities, as defined in ORS 757.270,
30 to comply with reporting requirements imposed under this section by the submission of a report
31 prepared by a third party. A report submitted under this paragraph may include information for
32 more than one consumer-owned utility, but must include all information required by the commission
33 for each individual utility.

34 (b) For the purpose of determining greenhouse gas emissions related to electricity purchased
35 from the Bonneville Power Administration by a consumer-owned utility, as defined in ORS 757.270,
36 the commission may require only that the utility report:

37 (A) The number of megawatt-hours of electricity purchased by the utility from the Bonneville
38 Power Administration, segregated by the types of contracts entered into by the utility with the
39 Bonneville Power Administration; and

40 (B) The percentage of each fuel or energy type used to produce electricity purchased under each
41 type of contract.

42 [(4)(a)] **(5)(a)** Rules adopted by the commission pursuant to this section for electricity that is
43 purchased, imported, sold, allocated or distributed for use in this state by an electric company, as
44 defined in ORS 757.600, must be limited to the reporting of:

45 **(A) The generating facility fuel type and** greenhouse gas emissions emitted from generating

1 facilities owned or operated by the electric company;

2 **(B) The megawatt-hours of electricity generated by the electric company for use in this**
3 **state;**

4 [(B)] (C) Greenhouse gas emissions emitted from transmission equipment owned or operated by
5 the electric company;

6 [(C)] (D) The number of megawatt-hours of electricity purchased by the electric company for use
7 in this state, including information, if known, on:

8 (i) The seller of the electricity to the electric company; and

9 (ii) The original generating facility fuel type or types; and

10 [(D)] (E) An estimate of the amount of greenhouse gas emissions[, *using default greenhouse gas*
11 *emissions factors established by the commission by rule,*] attributable to:

12 (i) Electricity purchases made by a particular seller to the electric company;

13 (ii) Electricity purchases from an unknown origin or from a seller who is unable to identify the
14 original generating facility fuel type or types;

15 (iii) Electricity purchases for which a renewable energy certificate under ORS 469A.130 has
16 been issued but subsequently transferred or sold to a person other than the electric company;

17 (iv) Electricity transmitted for others by the electric company; and

18 (v) Total energy losses from electricity transmission and distribution equipment owned or oper-
19 ated by the electric company.

20 (b) Pursuant to paragraph (a) of this subsection, a multijurisdictional electric company may rely
21 upon a cost allocation methodology approved by the Public Utility Commission for reporting emis-
22 sions allocated in this state.

23 [(5)] (6) Rules adopted by the commission under this section for [*fossil*] fuel that is imported, sold
24 or distributed for use in this state may require reporting of the type and quantity of the fuel and
25 any additional information necessary to determine the [*carbon content*] **greenhouse gas emissions**
26 **associated with the use or combustion** of the fuel. [*For the purpose of determining greenhouse gas*
27 *emissions related to liquefied petroleum gas, the commission shall allow reporting using publications*
28 *or submission of data by the American Petroleum Institute but may require reporting of such other*
29 *information necessary to achieve the purposes of the rules adopted by the commission under this sec-*
30 *tion.*]

31 [(6)] (7) To an extent that is consistent with the purposes of the rules adopted by the commission
32 under this section, the commission shall minimize the burden of the reporting required under this
33 section by:

34 (a) Allowing concurrent reporting of information that is also reported to another state agency;

35 (b) Allowing electronic reporting;

36 (c) Allowing use of good engineering practice calculations in reports, or of emission factors
37 published by the United States Environmental Protection Agency;

38 (d) Establishing thresholds for the amount of specific greenhouse gases that may be emitted or
39 generated without reporting;

38 **subject to the provisions of Article IV, sections 18 and 25 (2), of the Oregon Constitution.**

39 (2) **Jurisdiction is conferred on the Supreme Court to determine whether this 2018 Act**

13 petition, the Supreme Court may appoint a special master to hear evidence and to prepare
14 recommended findings of fact.

15
16 **APPROPRIATION FOR ENVIRONMENTAL JUSTICE TASK FORCE**

17
18 **SECTION 48.** In addition to and not in lieu of any other appropriation, there is appropri-
19 ated to the Environmental Justice Task Force, for the biennium beginning July 1, 2017,
20 out of the General Fund, the amount of \$_____, which may be expended for compensation
21 and expenses incurred by members of the task force who are not members of the Legislative
22 Assembly in the manner and amounts provided for in ORS 292.495, and for provision by the
23 Governor of clerical and administrative staff support to the task force.

24
25 **OPERATIVE DATES**

26
27 **SECTION 49.** (1)(a) Sections 21 to 23 of this 2018 Act become operative on July 1, 2018.

28 (b) The Environmental Quality Commission may adopt rules or take any actions before
29 the operative date specified in paragraph (a) of this subsection that are necessary to enable
30 the commission, on and after the operative date specified in paragraph (a) of this subsection,
31 to carry out the provisions of sections 21 to 23 of this 2018 Act.

32 (2)(a) Sections 3 to 10 of this 2018 Act, the amendments to statutes and uncodified law
33 by sections 1 and 35 to 46 of this 2018 Act and the repeal of ORS 468A.205 by section 2 of this
34 2018 Act become operative on January 1, 2019.

35 (b) The Environmental Quality Commission may adopt rules or take any actions before
36 the operative date specified in paragraph (a) of this subsection that are necessary to enable
37 the commission, on and after the operative date specified in paragraph (a) of this subsection,
38 to carry out the provisions of sections 3 to 10 of this 2018 Act, the amendments to statutes
39 and uncodified law by sections 1 and 35 to 46 of this 2018 Act and the repeal of ORS 468A.205
40 by section 2 of this 2018 Act. Any rules adopted under this paragraph may not become op-
41 erative until January 1, 2019.

42 (3)(a) Sections 11 to 20 and 24 to 34a of this 2018 Act become operative on January 1, 2021.

43 (b) The Environmental Quality Commission, the Public Utility Commission, the Depart-
44 ment of Transportation, the Oregon Department of Administrative Services, the Governor
45 and the Higher Education Coordinating Commission may adopt rules or take any actions

1 before the operative date specified in paragraph (a) of this subsection that are necessary to
2 enable the Governor, the commissions and the departments, on and after the operative date
3 specified in paragraph (a) of this subsection, to carry out the provisions of sections 11 to 20
4 and 24 to 34a of this 2018 Act. Any rules adopted under this paragraph may not become
5 operative until January 1, 2021.

7 **REPORTS AND REVIEWS**

8
9 **SECTION 50.** On or before September 15, 2020, the Department of Environmental Quality
10 shall report on the actions being taken by the Environmental Quality Commission and the
11 department to prepare for implementation of sections 11 to 20 and 24 to 34a of this 2018 Act
12 to the interim legislative committees on the environment and natural resources.

13 **SECTION 51.** On or before September 15, 2031, the Department of Environmental Quality
14 shall conduct a review and provide a report to the Legislative Assembly in the manner pro-
15 vided by ORS 192.245 on the implementation of section 17 of this 2018 Act and rules adopted
16 under section 17 of this 2018 Act. The report may include recommendations for legislation.
17 The review and report must:

18 (1) Assess the implementation of laws, policies and protocols for offset projects and the
19 use of offset credits by covered entities; and

20 (2) Make determinations and recommendations regarding whether changes to laws, poli-
21 cies or protocols are necessary or advisable to address any negative impacts or to best align
22 the laws, policies or protocols with the purposes set forth in section 11 of this 2018 Act.

23
24 **CAPTIONS**

26 **SECTION 52.** The unit and section captions used in this 2018 Act are provided only for
27 the convenience of the reader and do not become part of the statutory law of this state or
28 express any legislative intent in the enactment of this 2018 Act.

30 **EFFECTIVE DATE**

31
32 **SECTION 53.** This 2018 Act takes effect on the 91st day after the date on which the 2018
33 regular session of the Seventy-ninth Legislative Assembly adjourns sine die.
