

Hi, My name is Courtney,

I'm a constituent, mother, wife and I own my own business here in Oregon. I'm reaching out to you today to urge you to oppose HB 3063, which would further burden people who assert a philosophical or religious objection to vaccination.

All over our country hundreds of thousands of parents are speaking out about vaccines and the injuries they have caused their children. The US Supreme Court itself recognizes that vaccines are "unavoidably unsafe" and that they cause injury and death in some cases. Yet these same parents are having their right to medical freedom stripped from them in many states. They are being bullied in social and professional situations and their injured children are being humiliated by not being allowed to attend public schools. As I speak this my heart is breaking for the parents who have lost their voice in this country. Who is standing up to the vaccine producers to demand safe vaccines and more research? Who really has these children's best interest at heart? Who will hold the medical community responsible for the the lack of research that has injured so many lives? Will it be you?

To date, there have been numerous independent studies that prove a relationship between the very scary Autism epidemic, immunodeficiencies, debilitating allergies, seizures, encephalopathy, and the aggressive vaccine schedule. The ingredients in vaccines have not been thoroughly studied and yet they are administered without abandon (69 total doses!) to our most precious and vulnerable assets, our children. I hope that this personal account reaches you. I hope that you can see the very dire and scary predicament that has been created by the current stance on widespread one-size-fits-all vaccination. I hope that you will look into ALL the information available about the safety of vaccines. I hope that you will listen to the hundreds of thousands of parents who are frantically trying to get anyone to listen before it is too late for another child.

Under the current law the Oregon un-vaccination rate is currently at approximately 2.6%. There is no need to make it harder for people to assert philosophical or religious exemptions to vaccination.

I urge you to oppose HB 3063.
