

Hi! I'm reaching out to share my concerns over HB3063 being heard in the healthcare committee today! I have four kids and each of them have a different level of vaccination. Some we choose to get and some we don't, please do not put us all in a one-size-fits-all-box! We are all created differently, with different genetic make-up and therefore all react differently to injected toxins. My kids who have more vaccines have much worse digestive systems, more food sensitivities, more hyper activity and more health issues to manage. My kids with less vaccines are generally much more healthy. But please read on.....

I strongly oppose this bill for several reasons, the 2 foremost being its gross over reach on our religious freedoms and its extreme discrimination against students who are "unvaccinated" (especially because they are lumping those with no vaccines at all in with those only missing 1 or 2, those choosing a delayed schedule, or those who only object to flu shots/std shots/etc.)

When Oregon changed it's vaccine exemption options to include only medical and non-medical exemptions in 2015, we were assured that religious reasons were included under the non-medical option. This bill removes the philosophical exemption and all vestiges of religious freedom with it.

The first amendment to the constitution states that "Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof." The Supreme Court has interpreted religion to mean a sincere and meaningful belief that occupies in the life of its possessor a place parallel to the place held by God in the lives of other persons.

If infringing upon the First amendment of the US constitution isn't enough to give you pause, perhaps the the UNESCO Universal Declaration on Bioethics and Human Rights will. This declaration was signed in 2005 by 193 countries including the US, and it states "“Any preventive, diagnostic and therapeutic medical intervention is only to be carried out with the prior, free and informed consent of the person concerned, based on adequate information....The interests and welfare of the individual should have priority over the sole interest of science or society.” Free and informed consent cannot be given under duress, coercion, or compulsion.

And if political justification isn't enough, perhaps the ethical violations of the Nuremburg Code, specifically points 1 and 5, are?

1. The voluntary consent of the human subject is absolutely essential.

This means that the person involved should have legal capacity to give consent; should be so situated as to be able to exercise free power of choice, without the intervention of any element of force, fraud, deceit, duress, over-reaching, or other ulterior form of constraint or coercion; and should have sufficient knowledge and comprehension of the elements of the subject matter involved as to enable him to make an understanding and enlightened decision. This latter element requires that before the acceptance of an affirmative decision by the experimental subject there should be made known to him the nature, duration, and purpose of the experiment; the method and means by which it is to be conducted; all inconveniences and hazards reasonably to be expected; and the effects upon his health or person which may possibly come from his participation in the experiment. The duty and responsibility for ascertaining

the quality of the consent rests upon each individual who initiates, directs or engages in the experiment. It is a personal duty and responsibility which may not be delegated to another with impunity.

5. No experiment should be conducted where there is an a priori reason to believe that death or disabling injury will occur; except, perhaps, in those experiments where the experimental physicians also serve as subjects.

Many of these vaccines the proponents of this bill wish to require list in their vaccine inserts, directly from the "mouths of" the vaccine manufacturers, the risk of DEATH. Off the top of my head, I know specifically that the MMR is one of them. Both Congress, in the National Childhood Vaccine Injury Act of 1986, and the US Supreme Court, in *Bruesewitz v. Wyeth*, concluded that vaccines are "unavoidably unsafe." I would say that requiring these vaccines across the board, with no regard for genetic makeup, pre-disposition, previous vaccine injuries or reactions, family history, etc.... as a precursor to any educational allowance falls pretty close to "experimental" and smack dab into "duress, over-reaching, or other ulterior form of constraint or coercion."

I don't want to belabor the point and I won't further argue vaccine science. I firmly believe each of us has the right and responsibility to choose for themselves. As I tell my kids, "stay in your own lane." This is what is right for me, I only ask for the freedom to continue to choose for myself and the tiny, precious humans God entrusted to my care. And that this freedom doesn't come at the expense of the educational rights they are \*supposed to\* have!

This brings me to my second complaint. Denying a child a free and appropriate education (which is guaranteed under the rehabilitation act of 1973) unless they comply with an unwanted medical procedure is not free and informed consent.

Should this bill pass, my children's right to a "free" public education would be removed, (but not my tax burden to pay for it, of course...) and to add insult to that and injury, my access to the home education co-ops I currently choose for them will also possibly be removed as well. Surely online charter education? They are at home and not in contact with other students! Nope, Same rules.... So hopefully we can afford be a one income family and to homeschool, because this bill also bans them from daycare! It boggles my mind that this is going on in the United States of America.

I appreciate you taking the time to read and consider my concerns. I hope you will join me in opposition after considering all aspects and possible ramifications of HB3063.
