On this first day of March, 2019, let my statement regarding Mandatory Vaccination Bill HB 3063 be entered on the record: **VOTE NO!**

I am Kathleen Berryman, a lawful citizen of Oregon, and am outraged that you are fast-tracking this bill without adequate time for public comment. I am violently opposed to any bill that takes away my rights to make medical decisions for myself or my family or removes all nonmedical exemptions in Oregon. What you are trying to ram through is medical tyranny and outright socialism/communistic. Either you are ignorant of the current information out there, or you are a pawn of the Deep State, or perhaps both. What matters is that you represent the citizens of Oregon, **which you are not doing.**

I stand with the Association of American Physicians and Surgeons on their position, as follows:
