

My esteemed fellow Americans, I urge you to vote no on HB 3063.

We are not California. Our Constitution Matters.

And where there is risk...there must always be freedom of choice.

I am a Dad, a Licensed Doctor, an Ordained Minister, and I am also Vaccine Injured. For the last 3 years, I have taught a class on vaccines to healthcare professionals and parents alike that covers

- *Manufacturer Product Inserts & Info Statements*
- *the Vaccine Adverse Events Reporting Database (VAERS)*
- *the 1986 National Childhood Vaccine Injury Act*
- *the Vaccine Injury Compensation Program (VICP)*
- *CDC Surveillance Reporting*
- *& How to use Safe, Therapeutic Amount of Nutrients to help improve common vaccine injuries like Neurologic, Cognitive & Digestive Disorder caused by vaccines.*

I began having seizures at the age of 13 following a series of vaccinations to be eligible to play football in high school and the effects I still deal with to this day some 32 years later.

My father found me lying unconscious in a pool of my own blood one morning after having my first seizure and falling unconscious to the bathroom floor after hitting my head on the sink.

No doctor was able to connect the dots that the seizure was related to vaccines just days earlier.

Instead they did a battery of tests and put me on 3 different anti-seizure medications that caused me to break out in full body rashes and lose the energy and enthusiasm I had for school.

After another series of vaccinations the next year, I would develop a fever of 108 degrees that lasted for 10 days, lose over 25 pounds I didn't have to lose, and have to deal with my kidneys shutting down.

Doctors had no idea what the cause was and it took me 2 decades to finally put the pieces together after I learned what few doctors know...that vaccines have a long list of potential adverse events due in large part to the more than questionable list of adjuvants and preservatives they contain.

I was lucky. I made it through by the grace of God so I could speak these words to you. 😊

Fortunately, I'm not here to change anyone's mind.

For a person who believes in vaccination I say I want to fight alongside you to ensure Vaccine Manufacturers put out a much safer product free of known carcinogens, neurotoxins, allergens, animal organs, and aborted human fetal tissue.

As of today the Vaccine Adverse Events Reporting Database shows the following:

At least 619,181 Reports of Vaccine Injury

At least 2,561 Deaths due to Vaccine Injury

And the Vaccine Injury Compensation Program has paid out over \$4 Billion Dollars to 6,358 families of Vaccine Injured Americans

And that's with an estimated less than 5% of Licensed Doctors & Nurses and less than 1% of Emergency Medical Technicians even knowing how to properly assess a vaccine injury. So these numbers are systematically deflated and don't give us anywhere near a true indication of the depth of this problem in my professional opinion which spans 2 decades of experience.

This is clear evidence of risk. And one of the major breakdowns in this entire process is that Vaccine Risk, Vaccine Adverse Events, and how to assess for Vaccine Injury is not taught in any of our nation's medical schools. Whether that is by design or not, you will have to decide for yourself...but nevertheless it is a significant problem that we must address before we even consider removing religious/personal belief exemptions and violating the 1st and 14th Amendments of our Constitution.

Where there is risk...there must always be freedom of choice.

According to the FDA Vaccines contain Fetal Bovine Serum (Baby Cow Blood), Green Monkey Kidney Cells, Canine Kidney Cells, Formaldehyde (Known Carcinogen), MSG (Known Neurotoxin), Nail Polish Remover,

Polysorbate 80 (Known to push toxins across the blood brain barrier), Aluminum and Mercury (Known Neurotoxins), which can be added post-production without being listed as an ingredient according to the CDC and FDA. Vaccines have known allergens like Milk, Eggs and Yeast, which can increase the risk of an adverse event particularly in an infant under 24 months of age that has not yet reached Immunocompetence and therefore relies on his Mother's milk for immunity. And Vaccines also contain MRC-5 and WI-38...aka Aborted Human Fetal Tissue that has been cloned.

If I poured those ingredients on a spoon and told you to make your child swallow them or they can't go to school even though they're currently healthy...would you feel free?

I mean, all this hysteria, all this fear, and the media who are paid by Vaccine Manufacturer's advertising dollars continue to stoke the fires of fear giving no time or consideration to the product, the risks, and the Constitutional violations of what they are recommending. All this hysteria over 4 reported cases of measles, with a vaccination rate for measles in our K-12 population of 96.7%, and with no deaths or injuries.

And do you want to hear the comical part, if there is one? When you review the Vaccine Insert for MMR...measles and mumps are both listed as possible adverse events.

Now for a person who believes in our Constitution and Medical Freedom, I say I want to fight alongside you to ensure that Vaccine Manufacturers lose their legal immunity to civil litigation so that civil

litigation for vaccine injuries can encourage Vaccine Manufacturers to improve and properly test their product to safeguard all children just as it's done for products like car seats.

In Montana in 2007 Evenflo, a car seat maker, was forced to pay \$10.4 Million because 1 car seat killed 1 baby. The result was that they recalled their product and made it better. This is exactly what Americans need to hold Vaccine Manufacturers accountable and ensure a checks and balances that leads to safer products that are properly tested. This is exactly what the 14th Amendment Section 1 was intended for.

I have a student who lost their little girl, Holly, to a vaccine injury. After 3 tortuous years she was paid the maximum compensation by the VICP...\$250,000 which essentially comes from our tax dollars. The vaccine maker paid \$0 and my student had no legal path to take the vaccine maker to court which could have helped make the product safer for all children.

This system is broken from education, to civil liberty and Constitutional violations, to product safety testing, to a vaccine schedule which continues to grow in spite of in never having been independently tested for safety. Our children have been and are being used in what is referred to as a Phase 4 Clinical Trial...and almost always without informed consent as doctors and nurses alike continue to bully mom's into vaccination with fear mongering that is worthy of a State Bill to prevent them from doing so.

Go and talk to the moms that have to live with a vaccine injured child and listen to the stories of what really goes on in the doctor's offices on this topic.

Go and ask doctors who advocate for vaccines how much they make in restitution from vaccine manufacturers when they can demonstrate what percentage of their pediatric population has been vaccinated.

This is a corrupt system.

The side effect of a corrupt law.

Paid for by corrupt companies that will do just about anything to make us believe we live in a United States they own.

Don't follow in California's footsteps and make Oregon just another California.

I left that corrupt place filled with greedy bureaucrats who listen to corporate donors more than the people that pay their salaries.

Lets talk the 1986 National Childhood Vaccine **Injury** Act authored by California Senator Henry Waxman in 1986 with the help of his interests in Pharmaceutical Companies...

Were you aware that §300aa–11. Petitions for compensation of the 1986 National Childhood Vaccine Injury Act states...

(a) General rule

(1) A proceeding for compensation under the Program for a vaccine-related injury or death shall be initiated by service upon the Secretary and the filing of a petition containing the matter prescribed by subsection (c) with the United States Court of Federal Claims. The clerk of the United States Court of Federal Claims shall immediately forward the filed petition to the chief special master for assignment to a special master under section 300aa–12(d)(1) of this title.

(2)(A) No person may bring a civil action for damages in an amount greater than \$1,000 or in an unspecified amount against a vaccine administrator or manufacturer in a State or Federal court for damages arising from a vaccine-related injury or death associated with the administration of a vaccine after October 1, 1988, and no such court may award damages in an amount greater than \$1,000 in a civil action for damages for such a vaccine-related injury or death, unless a petition has been filed, in accordance with section 300aa–16 of this title, for compensation under the Program for such injury or death and—

(i)(I) the United States Court of Federal Claims has issued a judgment under section 300aa–12 of this title on such petition, and

(II) such person elects under section 300aa–21(a) of this title to file such an action, or

(ii) such person elects to withdraw such petition under section 300aa–21(b) of this title or such petition is considered withdrawn under such section.

(B) If a civil action which is barred under subparagraph (A) is filed in a State or Federal court, the court shall dismiss the action. If a petition is filed under this section with respect to the injury or death for which such civil action was brought, the date such dismissed action was filed shall, for purposes of the limitations of actions prescribed by section 300aa-16 of this title, be considered the date the petition was filed if the petition was filed within one year of the date of the dismissal of the civil action.

(3) No vaccine administrator or manufacturer may be made a party to a civil action (other than a civil action which may be brought under paragraph (2)) for damages for a vaccine-related injury or death associated with the administration of a vaccine after October 1, 1988.

This level of legal immunity is a direct violation of Section 1 of the 14th Amendment of our sacred Constitution when sanctioned at the state level as corrupt California has done.

“All persons born or naturalized in the United States and subject to the jurisdiction thereof, are citizens of the United States and of the State wherein they reside. **No State shall make or enforce any law which shall abridge the privileges or immunities of citizens of the United States; nor shall any State deprive any person of life, liberty, or property**, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws.

California’s Mandatory Vaccine Law also violates of the 1st Amendment of our Sacred Constitution.

“Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances.”

And if you remove an Oregonian’s right to religious/person belief exemptions you do exactly what corrupt California has done in violating our Constitution.

You make us New California. And that would be hard for me to accept because I was born and raised in California. I lived there more than 30 years. I know how much their government has sold their collective souls to companies in the name of unbridled profit.
