

To Oregon State Legislature, Senate Committee on Health Care

Regarding: Opposition for HB 3063

I am a resident of Jackson County. I am in opposition to House Bill 3063, which would end non-medical vaccination exemptions for children in Oregon. This bill, if passed, will remove freedom and personal choice.

As a Registered Nurse, the only education I received regarding vaccines was where to give a vaccine and how to administer. I did not receive education regarding side effects, risk, etc. Medical Doctors receive very little education as well. This is why the choice of whether a child receives all, none, or some of the vaccines should not be in the hands of a medical doctor.

As a Registered Nurse, the concern for me is when I hear “the science is settled.” Science is never settled, it is forever evolving. Vaccines do have adverse reactions, we can see this online with VAERS. Every year in the United States between 3,000 and 4,500 severe vaccine reactions are reported to the CDC. When a family experiences this, they are unable to sue the pharmaceutical company, due to the National Childhood Vaccine Injury Act passed in 1986. This act states that no vaccine manufacturer shall be liable in a civil action for damages arising from a vaccine-related injury or death associated with the administration of a vaccine.

We need transparency from the CDC and vaccine manufacturers. The National Institute of Health’s “Gold Standard” for medication safety is through a randomized double blind placebo study, but vaccine clinical trials do not use a placebo due to ethical standards according to NIH. Vaccines inserts do not match up with CDC claims. Vaccines are a pharmaceutical drug, and it is not black and white as they would like it to appear. With risk, there MUST be choice!

Vaccines do not go through the same “Gold Standard” that medications go through- a randomized double blind placebo study, due to ethical standards according to the National Institute of Health. We need transparency from the CDC and vaccine manufacturers. We feel ignored and betrayed and WE WANT ANSWERS!

I am not a “Pro-Vaxxer” or an “Anti-Vaxxer.” I am Pro Science, Pro Choice, and Pro Truth. The government should not be involved in making decisions regarding personal medical choices, as this infringes upon our constitutional right for choice.


