RE: Please Oppose HB 3063

I am the mother of two vaccine damaged/injured girls, who have side effects and learning disabilities due to vaccines, and informed my children could not attend school without these shots. I have seen them become ill with fevers, headaches, and listlessness after these shots.

Then around the age of 14 and 16 Human Papillomavirus (HPV) Gardasil vaccine came out and the media, CDC, and our Doctors urged us to give this shot to my girls. My daughters had severe adverse reactions directly after the HPV shot was administered; they became ill with fevers, headaches, and listlessness, joint pain, and dizziness after the shots. They had little to no energy, which was not like my daughters.

Let us make the CDC accountable again for their products and have liability and accurate studies which reflect the safety of these vaccines. We need to repeal the
