SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

[Directs Legislative Revenue Officer to report to Legislative Assembly on options for tax reform including recommendations for legislation intended to reform current tax system.]

Establishes refundable credit against personal income taxes for contributions to higher education savings network account or ABLE account. Applies to tax years beginning on or after January 1, 2020, and before January 1, 2026. Eliminates subtraction for contribution to ABLE account or higher education savings network account. Applies to tax years beginning on or after January 1, 2020.

Establishes tax credit for short line railroad rehabilitation projects. Applies to tax years beginning on or after January 1, 2020, and before January 1, 2026.

Extends sunsets for certain income and excise tax credits and property tax exemptions, and for historic property special assessment program. Makes modifications to provisions governing certain tax credits and property tax exemptions.

Creates sunset for tax exemption for vehicle used in emissions testing.

Makes modifications to corporate activity tax provisions. Applies to tax years beginning on or after January 1, 2020.

Establishes exclusion from taxable commercial activity for certain payments for single-family residential construction labor costs paid by general contractor to subcontractor. Applies to tax years beginning on or after January 1, 2020, and before January 1, 2026.

Takes effect on 91st day following adjournment sine die.

Be It Enacted by the People of the State of Oregon:

TAX CREDIT FOR HIGHER EDUCATION SAVINGS OR ABLE ACCOUNT CONTRIBUTIONS

SECTION 1. Sections 2 and 3 of this 2019 Act are added to and made a part of ORS chapter 315.

SECTION 2. (1) A credit against taxes otherwise imposed under ORS chapter 316 shall

1 be allowed for amounts contributed by the taxpayer during the tax year to a savings network
2 account for higher education established under ORS 178.300 to 178.355 or an ABLE account
3 established under ORS 178.380. A taxpayer who makes contributions to both types of account
4 may claim the credit for the amounts listed in subsection (2) of this section for each type
5 of account.

6 (2) The amount of the credit allowed under this section shall be limited based on the
7 taxpayer's adjusted gross income and shall be the lesser of \$300, if reported on a joint return,
8 or \$150, if reported on any other type of return, or the following:

9 (a) The amount contributed, if the taxpayer's adjusted gross income does not exceed
10 \$30,000;

11 (b) 50 percent of the amount contributed, if the taxpayer's adjusted gross income exceeds
12 \$30,000 but does not exceed \$70,000;

13 (c) 25 percent of the amount contributed, if the taxpayer's adjusted gross income exceeds
14 \$70,000 but does not exceed \$100,000;

15 (d) 10 percent of the amount contributed, if the taxpayer's adjusted gross income exceeds
16 \$100,000 but does not exceed \$250,000; or

17 (e) 5 percent of the amount contributed, if the taxpayer's adjusted gross income exceeds
18 \$250,000.

19 (3)(a) The Department of Revenue shall annually adjust the maximum credit amounts
20 allowable under this section according to the cost-of-living adjustment for the calendar year.
21 The department shall first make this adjustment for a joint return by multiplying the maxi-
22 mum credit amount in subsection (2) of this section by the percentage (if any) by which the
23 monthly averaged U.S. City Average Consumer Price Index for the 12 consecutive months
24 ending August 31 of the prior calendar year exceeds the monthly averaged U.S. City Average
25 Consumer Price Index for the 12 consecutive months ending August 31, 2018.

26 (b) As used in this subsection, "U.S. City Average Consumer Price Index" means the U.S.
27 City Average Consumer Price Index for All Urban Consumers (All Items) as published by the
28 Bureau of Labor Statistics of the United States Department of Labor.

29 (c) If any adjustment to the maximum credit amount for a joint return, as determined
30 under paragraph (a) of this subsection, is not a multiple of \$20, the adjustment shall be
31 rounded to the next lower multiple of \$20. The department shall then adjust the maximum
32 credit amount for all other types of returns so that it is half the maximum credit amount
33 for a joint return.

34 (4) A credit under this section is allowed for a preceding tax year for amounts contrib-
35 uted to a savings network account for higher education or to an ABLE account if the con-
36 tribution is made before the taxpayer files a return or before the 15th day of the fourth
37 month following the closing of the taxpayer's tax year, whichever is earlier.

38 (5) A credit is not allowed under this section for any amount that has been transferred
39 into a savings network account for higher education from an individual development account,
40 through a rollover, as provided in ORS 458.685 (4)(a)(A).

41 (6) If the amount allowable as a credit under this section, when added to the sum of the
42 amounts allowable as payment of tax under ORS 316.187 (withholding), ORS 316.583 (esti-
43 mated tax), other tax prepayment amounts and other refundable credit amounts, exceeds the
44 taxes imposed by ORS chapters 314 and 316 for the tax year (reduced by any nonrefundable
45 credits allowable for purposes of ORS chapter 316 for the tax year), the amount of the excess

1 shall be refunded to the taxpayer as provided in ORS 316.502.

2 (7) The credit shall be claimed on a form prescribed by the Department of Revenue that
3 contains the information required by the department.

4 (8) Spouses in a marriage who file separate returns for a taxable year may each claim a
5 share of the tax credit that would have been allowed on a joint return in proportion to the
6 adjusted gross income of each.

7 (9) In the case of a credit allowed under this section:

8 (a) A nonresident shall be allowed the credit in the proportion provided in ORS 316.117.

9 (b) If a change in the status of the taxpayer from resident to nonresident or from non-
10 resident to resident occurs, the credit shall be determined in a manner consistent with ORS
11 316.117.

12 (c) If a change in the taxable year of the taxpayer occurs as described in ORS 314.085,
13 or if the department terminates the taxpayer's taxable year under ORS 314.440, the credit
14 shall be prorated or computed in a manner consistent with ORS 314.085.

15 **SECTION 3.** (1) As provided in subsection (2) of this section, prior tax relief afforded a
16 taxpayer by virtue of the credit allowed under section 2 of this 2019 Act shall be forfeited if
17 any of the following are taken:

18 (a) A nonqualified withdrawal from an account, as defined in ORS 178.300;

19 (b) A withdrawal from a savings network account for higher education established under
20 ORS 178.300 to 178.355 to pay expenses in connection with enrollment or attendance at an
21 elementary or secondary school; or

22 (c) A distribution from an ABLE account that is not a qualified disability expense of the
23 designated beneficiary as provided in ORS 178.375 and 178.380 and rules adopted by the
24 Oregon 529 Savings Board.

25 (2) A taxpayer shall report the amount of a disallowed withdrawal or distribution in the
26 tax year in which it is taken, and shall remit the taxes due as a result of the forfeited credit.
27 The Department of Revenue shall by rule determine the calculation of forfeited credit
28 amounts.

29 (3) If a taxpayer does not report a disallowed withdrawal or distribution in the tax year
30 that it is taken, and notwithstanding ORS 314.410, the department shall proceed to collect
31 those taxes, including penalties and interest, not paid by the taxpayer as a result of the tax
32 credit allowed the taxpayer.

33 **SECTION 4.** Except as provided in ORS 316.699 (4), a taxpayer:

34 (1) May use a subtraction under ORS 316.699 only for contributions made in tax years
35 beginning before January 1, 2020; and

36 (2) May carry forward and use a subtraction under ORS 316.699 (4) only in tax years be-
37 ginning before January 1, 2025.

38 **SECTION 5.** Sections 2 and 3 of this 2019 Act apply to tax years beginning on or after
39 January 1, 2020, and before January 1, 2026.

41 **TAX CREDIT FOR SHORT LINE RAILROAD REHABILITATION**

42
43 **SECTION 6.** Sections 7 to 14 of this 2019 Act are added to and made a part of ORS
44 chapter 315.

45 **SECTION 7.** As used in sections 7 to 14 of this 2019 Act:

1 (1) "Infrastructure" includes tracks, switches, sidings, roadbeds, railroad bridges and in-
2 dustrial leads owned by a short line railroad.

3 (2) "Short line railroad" means a class II or class III railroad as defined in 49 C.F.R. 1201.

4 (3) "Short line railroad rehabilitation project" means a project that involves the mainte-
5 nance, reconstruction or replacement of infrastructure.

6 (4) "Short line railroad rehabilitation project costs" means costs that are directly related
7 to the work necessary to maintain, reconstruct or replace infrastructure. "Short line rail-
8 road rehabilitation project costs" does not include costs that are funded by or used to qualify
9 for any state or federal grants, or costs that are used to claim a federal tax credit.

10 (5) "Tier I short line railroad" means a short line railroad owned or leased by a person
11 for whom the total length of short line railroad track owned or leased in Oregon is equal to
12 or greater than 200 miles. The total amount of short line railroad track in Oregon calculated
13 under this subsection includes any short line railroad track owned or leased by the person,
14 or if the person is a corporation, by the person's parent corporation or subsidiaries, regard-
15 less of whether the track is owned or leased by one or more railroads.

16 (6) "Tier II short line railroad" means a short line railroad that is not a tier I short line
17 railroad or is a short line railroad owned or leased by the state, a city, a county, a port or
18 any other public or municipal corporation.

19 **SECTION 8.** (1) A credit against taxes imposed by ORS chapter 316 (or, if the taxpayer
20 is a corporation, under ORS chapter 317 or 318) is allowed to a taxpayer, based upon short
21 line railroad rehabilitation project costs actually paid or incurred by the taxpayer during the
22 tax year for which the credit is claimed.

23 (2) The credit allowed under this section shall be the least of:

24 (a) In the case of a tier I short line railroad, \$1,000 multiplied by the number of miles
25 of short line railroad track the taxpayer owns or leases in this state on the day the short line
26 railroad rehabilitation project is completed;

27 (b) In the case of a tier II short line railroad, \$3,500 multiplied by the number of miles
28 of short line railroad track the taxpayer owns or leases in this state on the day the short line
29 railroad rehabilitation project is completed; or

30 (c) Fifty percent of the short line railroad rehabilitation project costs paid or incurred
31 by the taxpayer during the tax year in which the credit is claimed.

32 (3) For the credit to be allowed under this section:

33 (a) The infrastructure must be located in Oregon; and

34 (b) The taxpayer must:

35 (A) Own or lease the infrastructure;

36 (B) Be a short line railroad; and

37 (C) Receive a final written certification from the Department of Transportation before
38 claiming the credit.

39 (4) The amount of the credit claimed under this section for any one tax year may not
40 exceed the tax liability of the taxpayer.

41 (5) Any tax credit otherwise allowable under this section that is not used by the taxpayer
42 in a particular tax year may be carried forward and offset against the taxpayer's tax liability
43 for the next succeeding tax year. Any credit remaining unused in that next succeeding tax
44 year may be carried forward and used in the second succeeding tax year, and likewise, any
45 credit not used in that second succeeding tax year may be carried forward and used in the

1 third succeeding tax year, and likewise, any credit not used in that third succeeding tax year
2 may be carried forward and used in the fourth succeeding tax year, and likewise, any credit
3 not used in that fourth succeeding tax year may be carried forward and used in the fifth
4 succeeding tax year but may not be carried forward for any tax year thereafter.

5 (6) The credit allowed under this section is not in lieu of any depreciation or amortization
6 deduction for the short line railroad rehabilitation project to which the taxpayer otherwise
7 may be entitled for purposes of ORS chapter 316, 317 or 318 for the tax year.

8 (7) The taxpayer's adjusted basis for determining gain or loss may not be decreased by
9 any tax credit allowed under this section.

10 (8)(a) The Department of Revenue may by rule require that the Department of Trans-
11 portation provide information about a certification issued under section 9 of this 2019 Act,
12 including the name and taxpayer identification number of the taxpayer or other person re-
13 ceiving certification, the date the certification was issued in its final form, the approved
14 amount of credit and the first tax year for which the credit may be claimed.

15 (b) A taxpayer that is a pass-through entity that has received certification under section
16 9 of this 2019 Act shall provide to the Department of Revenue, within two months after the
17 close of the tax year in which the certification was issued, the name, taxpayer identification
18 number and any other information required by the department of each owner receiving a
19 distributive share of the credit, in a manner prescribed by the department.

20 (9) The Department of Revenue shall prescribe by rule the manner and the timing of
21 submission of the information described in subsection (8) of this section to the department.

22 (10) The credit shall be claimed on a form prescribed by the Department of Revenue that
23 contains the information required by the department.

24 (11) In the case of a credit allowed under this section:

25 (a) A nonresident shall be allowed the credit under this section in the proportion provided
26 in ORS 316.117.

27 (b) If a change in the status of a taxpayer from resident to nonresident or from nonres-
28 ident to resident occurs, the credit allowed by this section shall be determined in a manner
29 consistent with ORS 316.117.

30 (c) If a change in the taxable year of a taxpayer occurs as described in ORS 314.085, or
31 if the Department of Revenue terminates a taxpayer's taxable year under ORS 314.440, the
32 credit allowed under this section shall be prorated or computed in a manner consistent with
33 ORS 314.085.

34 **SECTION 9.** (1) Prior to construction of a short line railroad rehabilitation project, a
35 taxpayer may apply to the Department of Transportation for preliminary certification of the
36 project in the manner prescribed by rules adopted under this section, which must include:

37 (a) Timelines and deadlines for submission of application materials;

38 (b) A description of the information required by the department to determine that the
39 taxpayer qualifies for the credit allowed under section 8 of this 2019 Act;

40 (c) Criteria for determining the amount of the tax credit allowed under section 8 of this
41 2019 Act, including standards for what constitutes completion of a short line railroad reha-
42 bilitation project;

43 (d) The process by which an applicant will be notified of an incomplete application and
44 the time allowed for the applicant to provide the missing information; and

45 (e) The month and date by which the department must notify an applicant of the pre-

1 liminary certification decision and the potential amount of the tax credit for which the ap-
2 plicant has received preliminary certification.

3 (2) If the total amount of potential tax credits allowed under section 8 of this 2019 Act
4 for all taxpayers that have applied for preliminary certification exceeds the limit in section
5 8 of this 2019 Act, the department shall allocate the tax credits allowed under section 8 of
6 this 2019 Act as follows:

7 (a) By giving first priority to all tier II short line railroads that own or lease less than
8 75 miles of short line railroad track in this state; and

9 (b) By giving second priority to all tier II short line railroads not described in paragraph
10 (a) of this subsection.

11 (3) If the department must allocate tax credits to a group of taxpayers in an amount that
12 is less than the amount the taxpayers would otherwise receive under section 8 of this 2019
13 Act, the department shall divide the available tax credits among the group proportionally,
14 based on the amount each taxpayer would have otherwise received under section 8 of this
15 2019 Act.

16 SECTION 10. (1) A taxpayer may apply to the Department of Transportation for final
17 certification of a short line railroad rehabilitation project if:

18 (a) The taxpayer received preliminary certification for the project under section 9 of this
19 2019 Act; and

20 (b) The project is completed.

21 (2) After approving the application, the department shall certify the project, including the
22 amount of the tax credit for which the taxpayer has received final certification. The depart-
23 ment may not certify an amount that is more than the amount approved in the preliminary
24 certification for the project.

25 (3) The department may establish by rule a process for accepting applications and issuing
26 final certifications under this section.

27 SECTION 11. (1) The Department of Transportation may charge and collect a fee from
28 taxpayers for preliminary or final certification of short line rehabilitation projects under
29 sections 9 and 10 of this 2019 Act. The fee may not exceed the cost to the department of is-
30 suing certifications.

31 (2) All fees collected under this section shall be deposited in the State Treasury to the
32 credit of the Railroad Fund established under ORS 824.014. Moneys deposited under this
33 section are continuously appropriated to the Department of Transportation for the purpose
34 of administering and enforcing the provisions of sections 7 to 14 of this 2019 Act.

35 SECTION 12. (1) A person that has obtained a tax credit under section 8 of this 2019 Act
36 may transfer the credit to a taxpayer under ORS chapter 316, 317 or 318. A transfer that
37 occurs on or after January 1, 2020, is conditioned upon compliance with this section and ORS
38 315.052 and 315.053.

39 (2) The Department of Revenue may require that the person that has earned the credit
40 and the taxpayer that intends to claim the credit jointly file a notice of tax credit transfer
41 with the department on or before the earliest of the following dates:

42 (a) A date 30 days after the transfer of the credit;

43 (b) The date on which the transferee files a return; or

44 (c) The due date, including extensions, of the transferee's return.

45 (3) The notice shall be given on a form prescribed by the department that contains:

1 (a) The name and address of the transferor and of the transferee;

2 (b) The taxpayer identification number of the transferor and of the transferee;

3 (c) The dates on which the person earning the credit received certifications for the
4 credit;

5 (d) The amount of the credit that is certified, the amount that is being transferred and
6 the amount that is being retained by the transferor; and

7 (e) Any other information required by the department.

8 (4)(a) A transferor may separately transfer the entirety of that portion corresponding to
9 the tax year to one or more transferees, subject to subsection (5) of this section.

10 (b) Any amount of credit that would be allowed due only to a carryforward provision may
11 not be transferred.

12 (5) Any transfer of a tax credit or a portion of a tax credit must be completed no later
13 than the earliest of the following dates in relation to the tax return on which the credit is
14 claimed:

15 (a) The original due date, including extensions, of the transferor's return;

16 (b) The date on which the transferor's return is actually filed;

17 (c) The original due date, including extensions, of the transferee's return; or

18 (d) The date on which the transferee's return is actually filed.

19 (6) Notwithstanding subsection (5) of this section, if the transferor is a tax-exempt entity,
20 the transfer must be completed on or before a date one year after the close of the tax year
21 for which the credit was certified. As used in this subsection, "tax-exempt entity" means a
22 government agency or an organization that is recognized as exempt under section 501(c)(3)
23 of the Internal Revenue Code.

24 (7) The transferee shall claim the credit in accordance with the credit provisions for the
25 tax years in which the credit is allowed.

26 (8) The department by rule may establish policies and procedures for the implementation
27 of this section.

28 **SECTION 13.** The total amount of potential tax credits allowed under section 8 of this
29 2019 Act at the time of preliminary certification under section 9 of this 2019 Act may not
30 exceed \$4 million for any biennium.

31 **SECTION 14.** (1) Under the procedures for a contested case under ORS chapter 183, the
32 Director of Transportation may order the suspension, revocation or forfeiture of a tax credit
33 certification under section 9 or 10 of this 2019 Act, or of a portion thereof, if the director
34 finds that:

35 (a) The certification was obtained by fraud or misrepresentation;

36 (b) The certification was obtained by mistake or miscalculation; or

37 (c) The taxpayer otherwise violates or has violated a condition or requirement for eligi-
38 bility for the tax credit.

39 (2) As soon as an order of revocation under this section becomes final, the director shall
40 notify the Department of Revenue and the person that received the tax credit certification
41 of the order of revocation. Upon notification, the Department of Revenue immediately shall
42 proceed to collect:

43 (a) If no portion of a credit has been transferred, those taxes not paid by the holder of
44 the certification as a result of the tax credits provided to the holder under the revoked ap-
45 proval, from the holder or a successor in interest to the business interests of the holder.

1 **All tax credits provided to the holder and attributable to the fraudulently or mistakenly ob-**
2 **tained certification or portion of the certification shall be forfeited.**

3 **(b) If all of a credit has been transferred, an amount equal to the amount of the tax**
4 **credits allowable to the transferee under the revoked certification, from the transferor.**

5 **(c) If a portion of a tax credit has been transferred, those taxes not paid by the**
6 **transferor as a result of the tax credits provided to the transferor pursuant to the revoked**
7 **certification, from the transferor or a successor in interest to the business interests of the**
8 **transferor, and an amount equal to the amount of the tax credits allowable to the transferee**
9 **pursuant to the revoked certification, from the transferor.**

10 **(3)(a) The Department of Revenue shall have the benefit of all laws of the state pertain-**
11 **ing to the collection of income and excise taxes and may proceed to collect the amounts de-**
12 **scribed in subsection (2) of this section from the person that obtained certification or a**
13 **successor in interest to the business interests of that person. An assessment of tax is not**
14 **necessary and the collection of taxes described in this subsection is not precluded by any**
15 **statute of limitations.**

16 **(b) For purposes of this subsection, a lender, bankruptcy trustee or other person that**
17 **acquires an interest through bankruptcy or through foreclosure of a security interest is not**
18 **considered to be a successor in interest to the business interests of the person that obtained**
19 **certification.**

20 **(4) If the certification is ordered revoked pursuant to this section, the holder of the**
21 **certification shall be denied any further relief in connection with the credit from and after**
22 **the date that the order of revocation becomes final.**

23 **(5) Notwithstanding subsections (1) to (4) of this section, a certification or portion of a**
24 **certification held by a transferee may not be considered revoked for purposes of the**
25 **transferee, the tax credit allowable to the transferee may not be reduced and a transferee**
26 **is not liable under this section.**

27 **(6) Interest under this section shall accrue at the rate established in ORS 305.220 begin-**
28 **ning the day after the due date of the return on which the credit may first be claimed.**

29 **(7) The Department of Revenue may collect amounts owed under this section by a part-**
30 **nership from the partnership.**

31 **SECTION 15. ORS 314.752, as amended by section 7, chapter 108, Oregon Laws 2018, is**
32 **amended to read:**

33 314.752. (1) Except as provided in ORS 314.740 (5)(b), the tax credits allowed or allowable to a
34 C corporation for purposes of ORS chapter 317 or 318 shall not be allowed to an S corporation. The
35 business tax credits allowed or allowable for purposes of ORS chapter 316 shall be allowed or are
36 allowable to the shareholders of the S corporation.

37 (2) In determining the tax imposed under ORS chapter 316, as provided under ORS 314.734, on
38 income of the shareholder of an S corporation, there shall be taken into account the shareholder's
39 pro rata share of business tax credit (or item thereof) that would be allowed to the corporation (but
40 for subsection (1) of this section) or recapture or recovery thereof. The credit (or item thereof), re-
41 capture or recovery shall be passed through to shareholders in pro rata shares as determined in the
42 manner prescribed under section 1377(a) of the Internal Revenue Code.

43 (3) The character of any item included in a shareholder's pro rata share under subsection (2)
44 of this section shall be determined as if such item were realized directly from the source from which
45 realized by the corporation, or incurred in the same manner as incurred by the corporation.

1 (4) If the shareholder is a nonresident and there is a requirement applicable for the business tax
2 credit that in the case of a nonresident the credit be allowed in the proportion provided in ORS
3 316.117, then that provision shall apply to the nonresident shareholder.

4 (5) As used in this section, “business tax credit” means the following credits: ORS 315.104
5 (forestation and reforestation), ORS 315.138 (fish screening, by-pass devices, fishways), ORS 315.141
6 (biomass production for biofuel), ORS 315.156 (crop gleanings), ORS 315.164 and 315.169 (agriculture
7 workforce housing), ORS 315.176 (bovine manure), ORS 315.204 (dependent care assistance), ORS
8 315.208 (dependent care facilities), ORS 315.213 (contributions for child care), ORS 315.237 (employee
9 and dependent scholarships), ORS 315.271 (individual development accounts), ORS 315.304 (pollution
10 control facility), ORS 315.326 (renewable energy development contributions), ORS 315.331 (energy
11 conservation projects), ORS 315.336 (transportation projects), ORS 315.341 (renewable energy re-
12 source equipment manufacturing facilities), ORS 315.354 and 469B.151 (energy conservation facili-
13 ties), ORS 315.506 (tribal taxes on reservation enterprise zones and reservation partnership zones),
14 ORS 315.507 (electronic commerce), ORS 315.514 (film production development contributions), ORS
15 315.521 (university venture development funds), ORS 315.523 (employee training programs), ORS

(B) Renders the exemption granted under ORS 307.455 inoperative.

(b) An ordinance or resolution adopted pursuant to this subsection by the governing body of a city shall apply:

(A) Only within the corporate boundaries of the city;

(B) To all qualified machinery and equipment taxable within the corporate boundaries; and

(C) To the tax levies of the city and all other taxing districts having jurisdiction within the corporate boundaries.

(c) An ordinance or resolution adopted pursuant to this subsection by the governing body of a county shall apply:

(A) Only within the unincorporated territory of the county;

(B) To all qualified machinery and equipment taxable within the unincorporated territory; and

(C) To the tax levies of the county and all other taxing districts having jurisdiction within the unincorporated territory.

17 [(5) (3) “Doing business” means engaging in any activity, whether legal or illegal, that is con-
18 ducted for, or results in, the receipt of commercial activity at any time during a calendar year.

19 [(6) (4) “Excluded person” means any of the following:

20 (a) Organizations described in sections 501(c) and 501(j) of the Internal Revenue Code, unless the
21 exemption is denied under section 501(h), (i) or (m) or under section 502, 503 or 505 of the Internal
22 Revenue Code.

23 (b) Organizations described in section 501(d) of the Internal Revenue Code, unless the exemption
24 is denied under section 502 or 503 of the Internal Revenue Code.

25 (c) Organizations described in section 501(e) of the Internal Revenue Code.

26 (d) Organizations described in section 501(f) of the Internal Revenue Code.

27 (e) Charitable risk pools described in section 501(n) of the Internal Revenue Code.

28 (f) Organizations described in section 521 of the Internal Revenue Code.

29 (g) Qualified state tuition programs described in section 529 of the Internal Revenue Code.

30 (h) Foreign or alien insurance companies, but only with respect to the underwriting profit de-
31 rived from writing wet marine and transportation insurance subject to tax under ORS 731.824 and
32 731.828.

33 (i) Governmental entities.

34 (j) Any person with commercial activity that does not exceed [*\$1 million*] **\$750,000** for the cal-
35 endar year, other than a person that is part of a unitary group as provided in section 60, **chapter**
36 **122, Oregon Laws 2019 (Enrolled House Bill 3427)**, [*of this 2019 Act*] with commercial activity in
37 excess of [*\$1 million*] **\$750,000**.

38 (k) Hospitals subject to assessment under section 2, chapter 736, Oregon Laws 2003, long term
39 care facilities subject to assessment under section 16, chapter 736, Oregon Laws 2003, or any entity
40 subject to assessment under section 3, 5 or 9, chapter 538, Oregon Laws 2017.

41 [(7) (5) “Financial institution” has the meaning given that term in ORS 314.610, except that
42 “financial institution” does not include a credit union.

43 [(8)(a) (6)(a) “FR Y-9” means the consolidated or parent-only financial statements that a holding
44 company is required to file with the Federal Reserve Board pursuant to 12 U.S.C. 1844.

45 (b) In the case of a holding company required to file both consolidated and parent-only financial

1 statements, “FR Y-9” means the consolidated financial statements that the holding company is re-
2 quired to file.

3 [(9)] (7) “Governmental entity” means:

4 (a) The United States and any of its unincorporated agencies and instrumentalities.

5 (b) Any incorporated agency or instrumentality of the United States wholly owned by the United
6 States or by a corporation wholly owned by the United States.

7 (c) The State of Oregon and any of its unincorporated agencies and instrumentalities.

8 (d) Any county, city, district or other political subdivision of the state.

9 (e) [*Any public corporation*] **A special government body as defined in ORS 174.117.**

10 (f) A federally recognized Indian tribe.

11 [(10)] (8) “Groceries” means food as defined in 7 U.S.C. 2012(k), **but does not include**
12 **cannabinoid edibles or marijuana seeds.**

13 **(9)(a) “Hedging transaction” means a hedging transaction as defined in section 1221 of**
14 **the Internal Revenue Code or a transaction accorded hedge accounting treatment under Fi-**
15 **nancial Accounting Standards Board Statement No. 133.**

16 **(b) “Hedging transaction” does not include a transaction in which an actual transfer of**
17 **title of real or tangible property to another entity occurs.**

18 [(11)] (10) “Insurer” has the meaning given that term in ORS 317.010.

19 [(12)] (11) “Internal Revenue Code,” except where the Legislative Assembly has provided other-
20 wise, refers to the laws of the United States or to the Internal Revenue Code as they are amended
21 and in effect on December 31, 2018.

22 [(13)] (12) “Labor costs” means total compensation of all employees, not to include compensation
23 paid to any single employee in excess of \$500,000.

24 [(14)(a)] (13)(a) “Motor vehicle fuel or any other product used for the propulsion of motor ve-
25 hicles” means:

26 (A) Motor vehicle fuel as defined in ORS 319.010; and

27 (B) Fuel the use of which in a motor vehicle is subject to taxation under ORS 319.530.

28 (b) “Motor vehicle fuel or any other product used for the propulsion of motor vehicles” does not
29 mean:

30 (A) Electricity; or

31 (B) Electric batteries or any other mechanical or physical component or accessory of a motor
32 vehicle.

33 [(15)] (14) “Person” includes individuals, combinations of individuals of any form, receivers,
34 assignees, trustees in bankruptcy, firms, companies, joint-stock companies, business trusts, estates,
35 partnerships, limited liability partnerships, limited liability companies, associations, joint ventures,
36 clubs, societies, entities organized as for-profit corporations under ORS chapter 60, C corporations,
37 S corporations, qualified subchapter S subsidiaries, qualified subchapter S trusts, trusts, entities that
38 are disregarded for federal income tax purposes and any other entities.

39 [(16)] (15) “Retailer” means a person doing business by selling tangible personal property to a
40 purchaser for a purpose other than:

41 (a) Resale by the purchaser of the property as tangible personal property in the regular course
42 of business;

43 (b) Incorporation by the purchaser of the property in the course of regular business as an in-
44 gredient or component of real or personal property; or

45 (c) Consumption by the purchaser of the property in the production for sale of a new article of

1 tangible personal property.

2 [(17)] (16) "Taxable commercial activity" means commercial activity sourced to this state under
3 section 66, **chapter 122, Oregon Laws 2019 (Enrolled House Bill 3427)** [of this 2019 Act], less any
4 subtraction pursuant to section 64, **chapter 122, Oregon Laws 2019 (Enrolled House Bill 3427)**
5 [of this 2019 Act].

6 [(18)(a)] (17)(a) "Taxpayer" means any person or unitary group required to register, file or pay
7 tax under sections 58 to 76, **chapter 122, Oregon Laws 2019 (Enrolled House Bill 3427)** [of this
8 2019 Act].

9 (b) "Taxpayer" does not include excluded persons, **except to the extent that a tax-exempt**
10 **entity has unrelated business income that is taxable under the Internal Revenue Code.**

11 [(19)(a)] (18)(a) "Unitary business" means a business enterprise in which there exists directly
12 or indirectly between the members or parts of the enterprise a sharing or exchange of value as
13 demonstrated by:

- 14 (A) Centralized management or a common executive force;
- 15 (B) Centralized administrative services or functions resulting in economies of scale; or
- 16 (C) Flow of goods, capital resources or services demonstrating functional integration.

17 (b) "Unitary business" may include a business enterprise the activities of which:

- 18 (A) Are in the same general line of business, such as manufacturing, wholesaling or retailing;

19 or

20 (B) Constitute steps in a vertically integrated process, such as the steps involved in the pro-
21 duction of natural resources, which might include exploration, mining, refining and marketing.

22 [(20)] (19) "Unitary group" means a group of persons with more than 50 percent common own-
23 ership, either direct or indirect, that is engaged in business activities that constitute a unitary
24 business.

25 [(21)] (20) "Wholesaler" means a person primarily doing business by merchant distribution of
26 tangible personal property to retailers or to other wholesalers.

27 **SECTION 51.** Section 61, chapter 122, Oregon Laws 2019 (Enrolled House Bill 3427), is amended
28 to read:

29 **Sec. 61.** (1) Except as provided in subsection (2) of this section:

30 (a) A person shall include as taxable commercial activity the value of property the person
31 transfers into this state for the person's own use in the course of a trade or business within one year
32 after the person receives the property outside this state; and

33 (b) In the case of a unitary group, the taxpayer shall include as taxable commercial activity the
34 value of property that any of the taxpayer's members transferred into this state for the use in the
35 course of a trade or business by any of the taxpayer's members within one year after the taxpayer
36 receives the property outside this state.

37 (2) Property brought into this state within one year after it is received outside this state by a
38 person or unitary group described in subsection (1) of this section may not be included as taxable
39 commercial activity as required under subsection (1) of this section if **the person or unitary group**
40 **can show or if** the Department of Revenue ascertains that the property's receipt outside this state
41 by the person or unitary group followed by its transfer into this state within one year was not in-
42 tended in whole or in part to avoid in whole or in part the tax imposed under sections 58 to 76,
43 **chapter 122, Oregon Laws 2019 (Enrolled House Bill 3427)** [of this 2019 Act].

44 (3) The department may adopt rules necessary to administer this section.

45 **SECTION 52.** Section 63, chapter 122, Oregon Laws 2019 (Enrolled House Bill 3427), is amended

1 to read:

2 **Sec. 63.** (1) A corporate activity tax is imposed on each person with taxable commercial activity
3 for the privilege of doing business in this state. The tax is imposed upon persons with substantial
4 nexus with this state. The tax imposed under this section is not a transactional tax and is not sub-
5 ject to the Interstate Income Act of 1959 (P.L. 86-272). The tax imposed under this section is in ad-
6 dition to any other taxes or fees imposed under the tax laws of this state. The tax imposed under
7 this section is imposed on the person [*receiving*] **with** the commercial activity and is not a tax im-
8 posed directly on a purchaser. The tax imposed under this section is an annual privilege tax for the
9 calendar year and shall be remitted quarterly to the Department of Revenue. A taxpayer is subject
10 to the annual corporate activity tax for doing business during any portion of such calendar year.

11 (2) A person has substantial nexus with this state if any of the following applies. The person:

12 (a) Owns or uses a part or all of its capital in this state.

13 (b) Holds a certificate of existence or authorization issued by the Secretary of State authorizing
14 the person to do business in this state.

15 (c) Has bright-line presence in this state.

16 (d) Otherwise has nexus with this state to an extent that the person can be required to remit
17 the tax imposed under sections 58 to 76, **chapter 122, Oregon Laws 2019 (Enrolled House Bill**
18 **3427)**, [*of this 2019 Act*] under the United States Constitution.

19 (3) A person has bright-line presence in this state for the calendar year if any of the following
20 applies. The person:

21 (a) Owns at any time during the calendar year property in this state with an aggregate value
22 of at least \$50,000. For purposes of this paragraph, owned property is valued at original cost and
23 rented property is valued at eight times the net annual rental charge.

24 (b) Has during the calendar year payroll in this state of at least \$50,000. Payroll in this state
25 includes the following:

26 (A) Any amount subject to withholding by the person under ORS 316.167 and 316.172;

27 (B) Any other amount the person pays as compensation to an individual under the supervision
28 or control of the person for work done in this state; and

29 (C) Any amount the person pays for services performed in this state on the person's behalf by
30 another.

31 (c) Has during the calendar year commercial activity, sourced to this state under section 66,
32 **chapter 122, Oregon Laws 2019 (Enrolled House Bill 3427)** [*of this 2019 Act*], of at least \$750,000.

33 (d) Has at any time during the calendar year within this state at least 25 percent of the person's
34 total property, total payroll or total commercial activity.

35 (e) Is a resident of this state or is domiciled in this state for corporate, commercial or other
36 business purposes.

37 **(4) Notwithstanding subsection (1) of this section, a vehicle dealer may collect from the**
38 **purchaser of a motor vehicle the estimated portion of the tax imposed under this section**
39 **that is attributable to commercial activity from the sale of the vehicle.**

40 **SECTION 53.** Section 64, chapter 122, Oregon Laws 2019 (Enrolled House Bill 3427), is amended
41 to read:

42 **Sec. 64.** (1) A taxpayer shall subtract from commercial activity sourced to this state 35 percent
43 of the greater of the following amounts paid or incurred by the taxpayer in the tax year:

44 (a) The amount of cost inputs; or

45 (b) The taxpayer's labor costs.

1 (2) The amounts in subsection (1)(a) or (b) of this section shall be apportioned to this state in
2 the manner required for apportionment of income under ORS 314.605 to 314.675.

3 **(3) A subtraction under this section is not allowed for any amount of:**

4 **(a) Expenses from transactions among members of a group, as excluded under section**
5 **60, chapter 122, Oregon Laws 2019 (Enrolled House Bill 3427); or**

6 **(b) Cost inputs or labor costs that are attributable to a person's receipts from an item**
7 **that is not commercial activity.**

8 [(3)] (4) Notwithstanding subsection (1) of this section, the subtraction under this section may
9 not exceed 95 percent of the taxpayer's commercial activity in this state.

10 **SECTION 54.** Section 66, chapter 122, Oregon Laws 2019 (Enrolled House Bill 3427), is amended
11 to read:

12 **Sec. 66.** (1) For purposes of sections 58 to 76, **chapter 122, Oregon Laws 2019 (Enrolled**
13 **House Bill 3427)** [of this 2019 Act], commercial activity [other than commercial activity of financial
14 institutions or insurers] shall be sourced to this state as follows:

15 (a) In the case of the sale, rental, lease or license of real property, if and to the extent the
16 property is located in this state.

17 (b) In the case of the rental, lease or license of tangible personal property, if and to the extent
18 the property is located in this state.

19 (c) In the case of the sale of tangible personal property, if and to the extent the property is
20 delivered to a purchaser in this state.

21 (d) In the case of the sale of a service, if and to the extent the service is delivered to a location
22 in this state.

23 (e) In the case of the sale, rental, lease or license of intangible property, if and to the extent
24 the property is used in this state. If the receipts are not based on the amount of use of the property,
25 but rather on the right to use the property, and the payor has the right to use the property in this
26 state, the receipts shall be sourced to this state to the extent the receipts are based on the right
27 to use the property in this state.

28 **(f) In the case of a financial institution or an insurer, commercial activity not otherwise**
29 **described in this section is sourced to this state if it is from business conducted in this state.**

30 (2) If the sourcing provisions of subsection (1) of this section do not fairly represent the extent
31 of a person's commercial activity attributable to this state, the person may request, or the Depart-
32 ment of Revenue may require or permit, an alternative method. A request under this subsection by
33 a person must be made within the statute of limitations applicable to sections 58 to 76, **chapter 122,**
34 **Oregon Laws 2019 (Enrolled House Bill 3427)** [of this 2019 Act].

35 (3) The department may adopt rules to provide additional guidance to the application of this
36 section, and to provide alternative methods of sourcing commercial activity that apply to financial
37 institutions and to insurers, and to any other persons, or a subset of persons, that are engaged in
38 similar business or trade activities.

39 **SECTION 55.** Section 67, chapter 122, Oregon Laws 2019 (Enrolled House Bill 3427), is amended
40 to read:

41 **Sec. 67.** (1) Except as expressly authorized by this section, the authority to impose, in this state,
42 a tax upon the commercial activity of an entity is vested solely in the Legislative Assembly. A city,
43 county, district or other political subdivision or municipal corporation of this state may not impose,
44 by ordinance or other law, a tax upon commercial activity or upon receipts from grocery sales.

45 (2) Subsection (1) of this section does not apply:

1 (a) To any tax, or to subsequent amendments of the provisions of any tax, if the ordinance or
2 other law imposing the tax is in effect and operative on April 1, 2019, or is adopted by initiative or
3 referendum petition at an election held prior to March 1, 2019; or

4 (b) To the imposition of **privilege taxes not measured by commercial activity**, franchise fees
5 [or franchise taxes] or **right-of-way fees**.

6 **SECTION 56.** Section 70, chapter 122, Oregon Laws 2019 (Enrolled House Bill 3427), is amended
7 to read:

8 **Sec. 70.** (1) For purposes of the corporate activity tax imposed under section 63, **chapter 122,**
9 **Oregon Laws 2019 (Enrolled House Bill 3427)** [of this 2019 Act], every person doing business in
10 this state with commercial activity for the tax year in excess of \$1 million shall file not later than
11 April 15 of the following year an annual return. The return must be filed with the Department of
12 Revenue in a form prescribed by the department.

13 (2) The corporate activity tax imposed under section 63, **chapter 122, Oregon Laws 2019 (En-**
14 **rolled House Bill 3427)**, [of this 2019 Act] is due and **estimated tax payments are** payable to the
15 department on or before the last day of January, April, July and October of each year for the pre-
16 vious calendar quarter.

17 (3) The department may by rule extend the time for making any return for good cause. If the
18 time for filing a return is extended at the request of a taxpayer, interest on any unpaid tax at the
19 rate established under ORS 305.220 from the time the return was originally required to be filed to
20 the time of payment, shall be added and paid.

21 **SECTION 57.** Section 58 of this 2019 Act is added to and made a part of sections 58 to 76,
22 chapter 122, Oregon Laws 2019 (Enrolled House Bill 3427).

23 **SECTION 58.** An exclusion from taxable commercial activity shall be allowed for sub-
24 contracting payments for labor costs that are made by a general contractor, as defined in
25 ORS 701.005, to a subcontractor, as defined in ORS 701.410, pursuant to a contract for resi-
26 dential real estate construction. The exclusion under this section:

- 27 (1) Shall be allowed only for single-family residential construction located in Oregon;
28 (2) Is not allowed for payment for materials, land or permits;
29 (3) Is not allowed for payments between subcontractors; and
30 (4) Shall be 15 percent of payments for labor by the general contractor.

31 **SECTION 59.** Section 58 of this 2019 Act applies to tax years beginning on or after Jan-
32 uary 1, 2020, and before January 1, 2026.

33 **SECTION 60.** The amendments to sections 58, 61, 63, 64, 66 and 70, chapter 122, Oregon
34 Laws 2019 (Enrolled House Bill 3427), by sections 50 to 54 and 56 of this 2019 Act apply to tax
35 years beginning on or after January 1, 2020.
