SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Modifies provisions relating to small estates.
Clarifies that execution of bargain and sale deed does not place personal representative of estate in chain of title to property conveyed, except under certain circumstances.
Clarifies procedure for opening and examination of contents of safe deposit box of decedent.

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1.** ORS 114.505 is amended to read:

7 114.505. As used in ORS 114.505 to 114.560:

8 (1) "Affiant" means the person or persons signing [*an*] **a small estate** affidavit [*filed under ORS*
9 *114.515*].

10 (2) "Claiming successors" means:

11 (a) If the decedent died intestate, the heir or heirs of the decedent, or if there is no heir, an
12 estate administrator of the Department of State Lands appointed under ORS 113.235;

13 (b) If the decedent died testate, the devisee or devisees of the decedent; and

14 (c) Any creditor of the estate entitled to payment or reimbursement from the estate under ORS
15 114.545 [(1)(d)] **(1)(f)** who has not been paid or reimbursed the full amount owed such creditor within
16 60 days after the date of the decedent's death.

17 [(3) "*Estate*" means decedent's property subject to administration in Oregon.]

18 **(3) "Small estate affidavit" means an affidavit or amended affidavit filed under ORS**
19 **114.515.**

20 **SECTION 2.** Section 3 of this 2019 Act is added to and made a part of ORS 114.505 to
21 **114.560.**

22 **SECTION 3. Value limitations for small estate.** (1) **A person who meets the requirements**
23 **of ORS 114.515 may file a small estate affidavit only with regard to an estate in which:**

24 (a) **Not more than \$75,000 of the fair market value of the estate is attributable to per-**
25 **sonal property; and**

26 (b) **Not more than \$200,000 of the fair market value of the estate is attributable to real**

2 **(2) The fair market value of the estate shall be determined under this section:**

3 **(a) As of the date of death; or**

4 **(b) If the date of death is more than one year before the date of filing of the affidavit,**
5 **as of a date within 45 days before the filing of the affidavit.**

6 **(3) In determining fair market value under this section, the fair market value of the**
7 **entire interest in the property included in the estate shall be used without reduction for liens**
8 **or other debts.**

9 **SECTION 4.** ORS 114.515 is amended to read:

10 114.515. (1) If the estate of a decedent meets the requirements of [*subsection (2) of this section*]
11 **section 3 of this 2019 Act**, any of the following persons may file [*an*] **a small estate** affidavit with
12 the clerk of the probate court in any county where there is venue for a proceeding seeking the ap-
13 pointment of a personal representative for the estate:

14 (a) One or more of the claiming successors of the decedent.

15 (b) If the decedent died testate, any person named as personal representative in the decedent's
16 will.

17 (c) The Director of Human Services, the Director of the Oregon Health Authority or an attorney
18 approved under ORS 114.517, if the decedent received public assistance as defined in ORS 411.010,
19 received medical assistance as defined in ORS 414.025 or received care at an institution as defined
20 in ORS 179.010, and it appears that the assistance or the cost of care may be recovered from the
21 estate of the decedent.

22 [*(2) An affidavit under this section may be filed only if:*]

23 [*(a) The fair market value of the estate is \$275,000 or less;*]

24 [*(b) Not more than \$75,000 of the fair market value of the estate is attributable to personal prop-*
25 *erty; and*]

26 [*(c) Not more than \$200,000 of the fair market value of the estate is attributable to real property.*]

27 **(2) A person may not file a small estate affidavit if:**

28 **(a) The person would be disqualified from acting as a personal representative under ORS**
29 **113.095; or**

30 **(b) The person has been convicted of a felony in Oregon or in another jurisdiction.**

31 (3) [*An*] **A small estate** affidavit [*under this section*] may not be filed until 30 days after the
32 death of the decedent.

33 (4) [*An*] **A small estate** affidavit [*filed under the provisions of this section*] must contain the in-
34 formation required in ORS 114.525 and shall be made a part of the probate records. If the affiant is
35 an attorney approved by the Director of Human Services or the Director of the Oregon Health Au-
36 thority, a copy of the document approving the attorney must be attached to the affidavit.

37 [*(5) In determining fair market value under this section, the fair market value of the entire interest*
38 *in the property included in the estate shall be used without reduction for liens or other debts.*]

39 [(6)] **(5)** The clerk of the probate court shall charge and collect the fee established under ORS
40 21.145 for the filing of [*any*] **a small estate** affidavit [*under this section*].

41 **(6)(a) Except as provided in subsection (7) of this section, the affiant shall file an**
42 **amended small estate affidavit in the following circumstances:**

43 **(A) To correct a material error or omission in a previous affidavit.**

44 **(B) To include property not described in a previous affidavit.**

45 **(b) The amended affidavit must include all information required under ORS 114.525 and**

1 state the value of the property as of the date used to prepare the original affidavit.

2 (7) If the fair market value of the property of the estate exceeds the value limitations for
3 a small estate under section 3 of this 2019 Act, an affiant may not file an amended small
4 estate affidavit under subsection (6) of this section and the affiant's authority with regard
5 to the estate is terminated, except that the affiant shall deliver assets of the estate in the
6 affiant's possession upon request by a personal representative appointed under ORS 113.085.
7 The affiant shall promptly file notice with the court that the estate of the decedent is not
8 subject to ORS 114.505 to 114.560 and shall serve a copy of the notice on each person who
9 received a copy of the previous affidavit.

10 (8) The clerk of the probate court may acknowledge a small estate affidavit upon pres-
11 entation of the identification of the affiant and the affiant's statement under penalty of
12 perjury.

13 *[(7) Any error or omission in an affidavit filed under this section may be corrected by filing an*
14 *amended affidavit within four months after the filing of the affidavit.]*

15 *[(8) One or more supplemental affidavits may be filed at any time after the filing of an affidavit*
16 *under this section for the purpose of including property not described in the original affidavit. Copies*
17 *of all previously filed affidavits must be attached to the supplemental affidavit and all information re-*
18 *quired in ORS 114.525 must be reflected in the supplemental affidavit. A supplemental affidavit may*
19 *not be filed if by reason of the additional property described in the supplemental affidavit any limita-*
20 *tion imposed by subsection (2) of this section is exceeded.]*

21 **SECTION 5.** ORS 114.517 is amended to read:

22 114.517. The Director of Human Services, or the director's designated representative, or the
23 Director of the Oregon Health Authority, or the director's designated representative, may approve
24 in writing attorneys who are eligible to file *[an]* a **small estate** affidavit *[under ORS 114.515]* if the
25 decedent received public assistance as defined in ORS 411.010, received medical assistance as de-
26 fined in ORS 414.025 or received care at an institution as defined in ORS 179.010, and it appears that
27 the assistance or the cost of care may be recovered from the estate of the decedent. An attorney
28 approved under this section does not represent the Director of Human Services or the Director of
29 the Oregon Health Authority when the attorney files *[an]* a **small estate** affidavit *[under ORS*
30 *114.515]*.

31 **SECTION 6.** ORS 114.520 is amended to read:

32 114.520. (1) If a decedent dies intestate and without heirs, a creditor of an estate who is a
33 claiming successor may not file *[an]* a **small estate** affidavit *[under ORS 114.515]* unless the creditor
34 has received written authorization from *[an estate administrator of]* the Department of State Lands
35 *[appointed under ORS 113.235]*. Except as provided by rule adopted by the Director of the Depart-
36 ment of State Lands, *[an estate administrator]* **the department** shall consent to the filing of *[an]* a
37 **small estate** affidavit *[under ORS 114.515]* by a creditor only if it appears after investigation that
38 the estate is insolvent.

39 (2) A creditor of an estate who is subject to subsection (1) of this section may give written no-
40 tice to *[an estate administrator of]* the Department of State Lands informing the *[estate*
41 *administrator]* **department** that the creditor intends to file *[an]* a **small estate** affidavit *[under ORS*
42 *114.515]*. Upon receiving the notice permitted by this subsection, the *[estate administrator]* **depart-**
43 **ment** shall investigate the assets and liabilities of the estate. Within 30 days after receiving the
44 notice required by this subsection, the *[estate administrator]* **department** shall either:

45 (a) Give written authorization to the creditor for the filing of *[an]* a **small estate** affidavit by

1 the creditor [*under ORS 114.515*]; or

2 (b) Inform the creditor that the Department of State Lands will file [*an*] a **small estate** affidavit
3 as claiming successor [*under ORS 114.515*].

4 (3) If a decedent dies intestate and without heirs, a creditor of an estate who is a claiming
5 successor and who files [*an*] a **small estate** affidavit [*under ORS 114.515*] must notate at the top
6 of the affidavit that the affidavit is being filed by a creditor of the estate. If the affidavit contains
7 the notation required by this subsection, the clerk of the probate court may not accept the affidavit
8 for filing unless there is attached to the affidavit written authorization for the filing of the affidavit
9 by the creditor from [*an estate administrator of*] the Department of State Lands. The written au-
10 thorization may be a copy of a memorandum of an interagency agreement between the Department
11 of State Lands and another state agency.

12 **SECTION 7.** ORS 114.525 is amended to read:

13 114.525. (1) [*An*] **A small estate** affidavit [*filed under ORS 114.515*] must:

14 (a) **Contain a notice in substantially the following form, printed in at least 14-point bold**
15 **type immediately below the caption on the first page of the small estate affidavit:**

18 **NOTICE OF DUTY TO PAY DEBT OR TURN OVER PROPERTY**
19

20 **To: Any person to whom a copy of this small estate affidavit is mailed or delivered.**

21 **Under ORS 114.535, if you owe a debt to the decedent or have personal property of the**
22 **decedent, you must pay the debt or turn over the property to the affiant. If you refuse, the**
23 **affiant may ask the court to compel you to pay the debt or turn over the property and you**
24 **could be responsible for the affiant's attorney fees.**

25
26
27 (b) **State the name and post-office address of the affiant.**

28 (c) **State the authority under which the affiant is filing the small estate affidavit, as**
29 **provided in ORS 114.515.**

30 (d) **State that the small estate affidavit is made under ORS 114.505 to 114.560.**

31 [(1)] (e) State the name, age, domicile[,] and post-office address and **last four digits of the So-**
32 **cial Security number of the decedent[;].**

33 [(2)] (f) State the date and place of the decedent's death. [*A certified copy of the death record*
34 *must be attached to the affidavit;*]

35 [(3)] (g) Describe and state the fair market value of all property in the estate, **valued as pro-**
36 **vided in section 3 of this 2019 Act**, including a legal description of any real property[;].

37 [(4)] *State that no application or petition for the appointment of a personal representative has been*
38 *granted in Oregon;*]

39 (h) **State that no personal representative of the estate has been appointed in Oregon, that**
40 **there is no pending petition for appointment of a personal representative of the estate in**
41 **Oregon and that the estate is not currently being administered in Oregon.**

42 [(5)] (i) State whether the decedent died testate or intestate[, *and if the decedent died testate, the*
43 *will must be attached to the affidavit;*].

44 [(6)] (j) List the heirs of the decedent and the last address of each heir as known to the affiant,
45 and state that a copy of the affidavit showing the date of filing and a copy of the will, if the

1 decedent died testate, will be delivered to each heir or mailed to the heir at the last-known
2 address[;].

3 [(7)] **(k)** If the decedent died testate, list the devisees of the decedent and the last address of
4 each devisee as known to the affiant and state that a copy of the will and a copy of the affidavit
5 showing the date of filing will be delivered to each devisee or mailed to the devisee at the last-
6 known address[;].

7 [(8)] **(L)** State the interest in the property described in the affidavit to which each heir or
8 devisee is entitled and the interest, if any, that will escheat[;].

9 [(9)] **(m)** State that reasonable efforts have been made to ascertain creditors of the estate[;].

10 [(10)] **(n)** List the [*expenses of and*] claims against the estate [*remaining*] **that are undisputed**
11 **by the affiant and that remain** unpaid or on account of which the affiant or any other person is
12 entitled to reimbursement from the estate, including the known or estimated amounts of the [*ex-*
13 *penses and*] claims and the names and addresses of the creditors as known to the affiant, and state
14 that a copy of the affidavit showing the date of filing will be delivered to each creditor who has not
15 been paid in full or mailed to the creditor at the last-known address[;].

16 [(11)] **(o)** Separately list the name and address of each person known to the affiant to assert a
17 claim against the estate that the affiant disputes and the known or estimated amount of the [*claim*]
18 **claims disputed by the affiant** and state that a copy of the affidavit showing the date of filing will
19 be delivered to each such person or mailed to the person at the last-known address[;].

20 **(p)(A) State the mailing address for presentment of claims; and**

21 **(B) If the affiant wishes to authorize creditors to present claims by electronic mail or**
22 **facsimile communication, state the electronic mail address or facsimile number for**
23 **presentment of claims.**

24 **(q) List anticipated administrative expenses and attorney fees, if any.**

25 **(r) State that the affiant is not disqualified from acting as an affiant under ORS 114.515**
26 **(2).**

27 [(12)] **(s)** State that a copy of the affidavit showing the date of filing **and a copy of the death**
28 **record** will be mailed or delivered to the Department of Human Services or to the Oregon Health
29 Authority, as prescribed by rule by the department or authority[;].

30 **(t) State, to the best of the affiant's knowledge, whether the decedent was incarcerated**
31 **in a correctional facility in this state at any time in the 15 years before the decedent's death**
32 **and, if the decedent was incarcerated in a correctional facility in this state at any time in**
33 **the 15 years before the decedent's death, state that a copy of the affidavit showing the date**
34 **of filing and a copy of the death record will be mailed or delivered to the Department of**
35 **Corrections.**

36 **(u) State that undisputed claims against the estate will be paid as provided in ORS**
37 **114.545.**

38 [(13)] **(v)** State that claims against the estate not listed in the affidavit or in amounts larger than
39 those listed in the affidavit may be barred unless:

40 [(a)] **(A)** A claim is presented to the affiant within four months of the filing of the affidavit **or**
41 **amended affidavit** at the address, **electronic mail address or facsimile number** stated in the af-
42 fidavit for presentation of claims; or

43 [(b)] **(B)** [*A personal representative of the estate is appointed*] **A petition for appointment of a**
44 **personal representative of the estate is filed** within the time allowed under ORS 114.555[; and].

45 [(14)] **(w)** If the affidavit lists one or more claims that the affiant disputes, state that any such

1 claim may be barred unless:

2 [(a)] **(A)** A petition for summary determination is filed within four months of the filing of the
3 affidavit; or

4 [(b)] **(B)** *[A personal representative of the estate is appointed]* **A petition for appointment of a**
5 **personal representative of the estate is filed** within the time allowed under ORS 114.555.

6 **(2) The affiant shall file a certified copy of the death record of the decedent as a confi-**
7 **dential document.**

8 **(3) If the decedent died testate, the affiant shall file simultaneously with the small estate**
9 **affidavit:**

10 **(a)(A) The original will; or**

11 **(B) If the original will is filed in an estate proceeding in another jurisdiction, a certified**
12 **copy of the original will; and**

13 **(b) Proof of the will meeting the requirements of ORS 113.055.**

14 **SECTION 8.** ORS 114.535 is amended to read:

15 114.535. (1) *[Not sooner than 10 days after the filing of an affidavit under ORS 114.515, the affiant*
16 *may deliver a certified copy of the affidavit to any person who was indebted to the decedent or]* **The**
17 **affiant may deliver a certified copy of a small estate affidavit to any person** who has pos-
18 session of personal property belonging to the estate **or who was indebted to the decedent.** Except
19 as provided in this section, upon receipt of the **certified** copy, the person shall pay[,] **the debt or**
20 transfer, deliver, provide access to and allow possession of the personal property to the affiant.

21 (2) Subject to ORS 114.537, if a **certified** copy of *[an]* **a small estate** affidavit is delivered under
22 subsection (1) of this section to a person that controls access to personal property belonging to the
23 estate of the decedent, including personal property held in a safe deposit box for which the decedent
24 was the sole lessee or the last surviving lessee, the person shall:

25 (a) Provide the affiant with access to the decedent's personal property; and

26 (b) Allow the affiant to take possession of the personal property.

27 (3) Subject to ORS 114.537, if a **certified** copy of *[an]* **a small estate** affidavit is delivered under
28 subsection (1) of this section to a person who **owes a debt to the decedent or** has received prop-
29 erty of the decedent under ORS 446.616, 708A.430, 723.466 or 803.094, or a similar statute providing
30 for the transfer of property of an estate that is not being probated, the person shall pay[,] **the debt**
31 **or** transfer, deliver, provide access to or allow possession of the property to the affiant if the person
32 would be required to pay[,] **the debt or** transfer, deliver, provide access to or allow possession of
33 the property to a personal representative of the estate.

34 (4) Any person that pays[,] **a debt owing to the decedent or** transfers, delivers, provides access
35 to or allows possession of property of a decedent in the manner provided by this section is dis-
36 charged and released from any liability or responsibility for the **debt or** property in the same man-
37 ner and with the same effect as if the **debt had been paid or the** property had been transferred[,]
38 **or** delivered *[or paid]* to a personal representative of the estate of the decedent.

39 (5) **The affiant may deliver a certified copy of a small estate affidavit to** a transfer agent
40 of any corporate security registered in the name of the decedent. **The transfer agent** shall change
41 the registered ownership on the books of the corporation to the *[person entitled thereto on presenta-*
42 *tion of a certified copy of the affidavit filed under ORS 114.515]* **affiant or the person named in the**
43 **affidavit entitled to it, as directed by the affiant.**

44 *[(6) If a person to whom an affidavit is delivered refuses to pay, deliver, transfer, provide access*
45 *to or allow possession of any personal property as required by this section, the property may be re-*

1 covered or payment, delivery, transfer of or access to the property may be compelled upon proof of the
2 transferee's entitlement in a proceeding brought for the purpose by or on behalf of the transferee.]

3 **(6)(a) If a person to whom a certified copy of a small estate affidavit is delivered under**
4 **this section refuses to pay a debt or deliver, transfer, provide access to or allow possession**
5 **of personal property as required by this section, the affiant may serve a written demand by**
6 **certified mail on the person to pay the debt or deliver, transfer, provide access to or allow**
7 **possession of the personal property. The demand must state that, if the person fails to pay**
8 **the debt or deliver, transfer, provide access to or allow possession of the personal property,**
9 **the affiant may file a motion to compel payment of the debt or delivery of, transfer of or**
10 **access to the personal property.**

11 **(b) If the person fails to pay the debt or deliver, transfer, provide access to or allow**
12 **possession of the personal property within 30 days after service of a demand under paragraph**
13 **(a) of this subsection, the affiant may file a motion to compel payment of the debt or delivery**
14 **of, transfer of or access to the personal property. The court may enter a judgment awarding**
15 **reasonable attorney fees to the prevailing party if the court finds that the affiant filed the**
16 **motion without an objectively reasonable basis or the person refused to pay the debt or de-**
17 **liver, transfer, provide access to or allow possession of any personal property without an**
18 **objectively reasonable basis.**

19 (7) If *[the]* a **small estate** affidavit was signed by the Director of Human Services, the Director
20 of the Oregon Health Authority or an attorney approved under ORS 114.517, the Director of Human
21 Services, the Director of the Oregon Health Authority or the attorney may certify a copy of the
22 affidavit for the purposes described in this section.

23 **SECTION 9.** ORS 114.537 is amended to read:

24 114.537. (1) If a *[claiming successor or other]* person who is eligible to file *[an]* a **small estate**
25 affidavit *[under ORS 114.515]* is aware that the decedent was the sole lessee or the last surviving
26 lessee of a safe deposit box **or was the owner of the contents of a safe deposit box** at the time
27 of the decedent's death, the claiming successor or other person may not file *[an]* a **small estate**
28 affidavit *[under ORS 114.515]* until the person requests an inventory of the box under ORS 708A.655,
29 if the lessor of the box is an Oregon operating institution as defined in ORS 706.008, or under ORS
30 723.844, if the lessor of the box is a credit union as defined in ORS 723.008. Upon receiving the re-
31 quest, the lessor of the box shall cause an inventory of the contents of the box to be made. The
32 lessor shall retain the original inventory in the box and shall provide a copy of the inventory to the
33 person requesting the inventory. The person requesting the inventory shall take the contents of the
34 box into consideration in determining whether the estate of the decedent is within the limits pre-
35 scribed by *[ORS 114.515 (2)]* **section 3 of this 2019 Act**. If *[an]* **the person files a small estate**
36 affidavit *[under ORS 114.515 is filed by the person]*, the **affidavit must contain a statement of the**
37 value of the contents of the box *[shall be stated in the affidavit]*.

38 (2) If *[a person who has filed an affidavit under ORS 114.515]* **an affiant** becomes aware after
39 the filing of *[the]* a **small estate** affidavit that the decedent was the sole lessee or the last surviving
40 lessee of a safe deposit box **or was the owner of the contents of a safe deposit box** at the time
41 of the decedent's death, the *[person]* **affiant** shall promptly request an inventory of the box under
42 ORS 708A.655, if the lessor of the box is an Oregon operating institution as defined in ORS 706.008,
43 or under ORS 723.844, if the lessor of the box is a credit union as defined in ORS 723.008. Upon
44 receiving the request, the lessor of the box shall cause an inventory of the contents of the box to
45 be made. The lessor shall retain the original inventory in the box and shall provide a copy of the

1 inventory to the [person requesting the inventory] **affiant**. If the estate of the decedent remains
 2 within the limits prescribed by [ORS 114.515 (2)] **section 3 of this 2019 Act** after consideration of
 3 the value of the contents of the box, the [person] **affiant** shall file an amended **small estate** affidavit
 4 under ORS 114.515 (6). Upon [providing the lessor of the box with] **receiving** a certified copy of the
 5 amended affidavit, the lessor shall allow the [person] **affiant** to take possession of the contents of
 6 the box. If the estate of the decedent exceeds the limits prescribed by [ORS 114.515 (2)] **section 3**
 7 **of this 2019 Act** after consideration of the value of the contents of the box, the [person] **affiant**
 8 may not file an amended **small estate** affidavit [under ORS 114.515] and shall file notice with the
 9 court that the estate of the decedent is not subject to ORS 114.505 to 114.560 and shall serve a copy
 10 of the notice on the lessor of the box. The lessor of the box shall [thereafter] deliver the contents
 11 of the box to the personal representative for the decedent, or to such other person as may be pro-
 12 vided for under the terms of the lease of the box.

13 **SECTION 10.** ORS 114.540 is amended to read:

14 114.540. (1)(a) A claim against an estate with respect to which [an] **a small estate** affidavit is
 15 filed [under ORS 114.515] may be presented to the affiant within four months after the affidavit was
 16 filed. If an amended **small estate** affidavit is filed under ORS 114.515 [(7)] (6), claims against the
 17 estate [must be filed] **may be presented** within four months after the filing of the amended affidavit.
 18 [If a supplemental affidavit is filed under ORS 114.515 (8), claims against the estate must be filed
 19 within four months after the filing of the supplemental affidavit.]

20 **(b) Except as provided in ORS 114.550, a claim presented after the limitations described**
 21 **in paragraph (a) of this subsection is barred.**

22 **(c) Filing a claim with the court does not constitute presentation to the affiant.**

23 **(d)(A) Except as provided in subparagraph (B) of this paragraph, a claim is presented to**
 24 **the affiant when the claim is mailed or personally delivered to the affiant at the mailing ad-**
 25 **dress for presentment of claims included in the small estate affidavit under ORS 114.525.**

26 **(B) If the affiant authorized creditors to present claims by electronic mail or facsimile**
 27 **communication in the small estate affidavit as provided in ORS 114.525, a claim is presented**
 28 **to the affiant when it is sent to the electronic mail address or the facsimile number desig-**
 29 **nated by the affiant for presentment of claims, unless the sender receives a notice that the**
 30 **electronic mail was not delivered or the facsimile communication was not successful. If the**

36 (2)(a) A claim presented to the affiant **that was not listed in the small estate affidavit** shall
 37 be considered allowed as presented unless within 60 days after the date of presentment of the claim
 38 the affiant mails or delivers a notice of disallowance of the claim in whole or in part to the claimant
 39 and any attorney for the claimant. A notice of disallowance of a claim [shall] **must state the rea-**
 40 **son for the disallowance and** inform the claimant that the claim has been disallowed in whole or
 41 in part and, to the extent disallowed, will be barred unless:

42 [(a)] **(A) The claimant [proceeds] files a petition for summary determination** as provided in

8 drafts or negotiable orders of withdrawal or otherwise for the payment of claims and expenses de-
9 scribed in paragraph [(d)] **(f)** of this subsection.

10 [(d)] **(f)** From and to the extent of the property of the estate, shall pay or reimburse any person
11 who has paid:

12 (A) Expenses described in ORS 115.125 (1)(b) and (c) and listed in the **small estate** affidavit;

13 (B) Claims listed in the **small estate** affidavit as undisputed;

16 (b) Neglect in paying over money or delivering property of the estate.

19 (d) Embezzlement or commingling of the assets of the estate with other property.

20 (e) Unauthorized self-dealing.

21 (f) Any other negligent or willful act or nonfeasance in the administration of the estate
22 by which loss to the estate arises.

24 114.550. (1)(a) The affiant or any claiming successor of the estate who has not been paid the full
25 amount owed [*such*] **the** claiming successor may, within two years after the filing of [*an*] **a small**

27 (c) Death benefits received by the trustee are not subject to the debts of the designator or to
28 inheritance or estate taxes to any greater extent than if the death benefits were payable to the
29 beneficiaries named in the trust and not to the estate of the designator.

30 (d) Death benefits held in trust may be commingled with any other assets that may properly
31 become a part of the trust.

32 (3) As used in this section:

33 (a) "Death benefits" means death benefits of any kind, including proceeds of life insurance policies,
34 payments under annuity or endowment contracts, and funds payable in connection with pension,
35 retirement, stock bonus or profit-sharing plans, or any trust administered in connection with

37 (b) "Designator" means the person entitled to designate the beneficiary of death benefits upon

15 or complete revocation of the decedent's will, or an addition to or an alteration of the decedent's
16 will. The proponent shall give notice of the filing to any personal representative appointed by the
17 court, the devisees named in any will admitted to probate and those persons identified in ORS
18 113.035 (5). Persons receiving notice under this subsection shall have 20 days after the notice was
19 given to file written objections to the petition. The court may make a determination regarding the
20 decedent's intent after a hearing or on the basis of affidavits.

21 (4)(a) If the court determines that clear and convincing evidence exists showing that a writing
22 described in subsection (1) of this section was intended by the decedent to accomplish one of the
23 purposes set forth in subsection (1) of this section, the court shall:

24 (A) Prepare written findings of fact in support of the determination; and

25 (B) Enter a limited judgment that admits the writing for probate as the decedent's will or oth-
26 erwise acknowledges the validity and intent of the writing.

27 (b) A determination under this subsection does not preclude the filing of a will contest under
28 ORS 113.075, except that the will may not be contested on the grounds that the will was not exe-
29 cuted in compliance with ORS 112.235.

30 (5) The fee imposed and collected by the court for the filing of a petition under this section shall
31 be in accordance with ORS 21.135.

39 **SECTION 34. The section captions used in this 2019 Act are provided only for the con-**
40 **venience of the reader and do not become part of the statutory law of this state or express**
41 **any legislative intent in the enactment of this 2019 Act.**
