

# Senate Bill 141

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Senate Interim Committee on Health Care)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Requires Oregon Health Authority to establish or contract for establishment of statewide mental health crisis support access line to facilitate specified services for individuals experiencing behavioral health crises.

Declares emergency, effective on passage.

## A BILL FOR AN ACT

2 Relating to individuals experiencing behavioral health crises; and declaring an emergency.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. (1) As used in this section:**

5 (a) **"Behavioral health clinician" has the meaning given that term in ORS 414.025.**

6 (b) **"Behavioral health crisis" means a disruption in an individual's mental or emotional**  
7 **stability or functioning resulting in an urgent need for immediate treatment to prevent a**  
8 **serious deterioration in the individual's mental or physical health.**

9 (c) **"Caring contacts" means brief communications with an individual that begin when the**  
10 **individual transitions from one level of care or care setting to another level of care or care**  
11 **setting, or when an individual misses an appointment or withdraws from treatment, and**  
12 **continue as long as a provider deems necessary.**

13 (d) **"Patient" means an individual admitted to a hospital, or presenting to an emergency**  
14 **department of a hospital, for behavioral health treatment.**

15 (e) **"Provider" means a behavioral health clinician or any of the following individuals, as**  
16 **defined in ORS 414.025:**

17 (A) **Peer support specialist.**

18 (B) **Peer wellness specialist.**

19 (C) **Family support specialist.**

20 (D) **Youth support specialist.**

21 (2) **The Oregon Health Authority shall establish or contract for the establishment of a**  
22 **statewide mental health crisis support access line to provide to hospital staff the following**  
23 **services:**

24 (a) **Facilitating caring contacts for a patient who presented with a behavioral health cri-**  
25 **sis to transition to a provider in the community; and**

26 (b) **Follow-up services for a patient who presented with a behavioral health crisis to en-**  
27 **sure a successful transition to outpatient services.**

28 (3) **If a behavioral health clinician determines that a patient attempted suicide or expe-**  
29 **rienced suicidal ideation, the statewide mental health crisis support access line must attempt**

1 to initiate caring contacts within 48 hours of the patient's release from the hospital.

2 **SECTION 2.** The Oregon Health Authority shall report to the regular session of the  
3 Eighty-first Legislative Assembly, in the manner provided in ORS 192.245, on the barriers  
4 within each community in this state that limit the availability of appropriate follow-up care  
5 for a patient released or discharged from a hospital following treatment for a behavioral  
6 health crisis, as defined in section 1 of this 2019 Act.

7 **SECTION 3.** No later than September 15, 2020, the Oregon Health Authority shall report  
8 to the interim committees of the Legislative Assembly related to health, in the manner  
9 provided in ORS 192.245, recommendations for increasing access to providers in each com-  
10 munity in this state to meet the needs of each patient who is released from an emergency  
11 department following treatment for a behavioral health crisis, as defined in section 1 of this  
12 2019 Act.

13 **SECTION 4.** In addition to and not in lieu of any other appropriation, there is appropri-  
14 ated to the Oregon Health Authority, for the biennium beginning July 1, 2019, out of the  
15 General Fund, the amount of \$1,000, which may be expended for carrying out the provisions  
16 of section 1 of this 2019 Act.

17 **SECTION 5.** Section 1 of this 2019 Act becomes operative on July 1, 2019.

18 **SECTION 6.** This 2019 Act being necessary for the immediate preservation of the public  
19 peace, health and safety, an emergency is declared to exist, and this 2019 Act takes effect  
20 on its passage.
