**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Provides that Oregon Military Department may select any available payment method for cooperative agreements with federal National Guard Bureau. If department selects advance payment method, prohibits department from incurring funding obligation payable or reimbursable from federal moneys under cooperative agreement unless department has available moneys sufficient to meet obligation. **Authorizes department to adopt rules as necessary to maintain eligibility of state to receive advance payments under cooperative agreements.**

*[Authorizes State Treasurer to create accounts or subaccounts and adopt rules to maintain eligibility to receive advance funding under cooperative agreement with federal bureau.]*

**Authorizes State Treasurer, at request of department, to create accounts in State Treasury pursuant to cooperative agreement or related federal law. Continuously appropriates moneys in such accounts to department.**

**A BILL FOR AN ACT**

2 Relating to federal moneys received by the Oregon Military Department.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. (1) The Oregon Military Department may enter into cooperative agreements**  
5 **with the federal National Guard Bureau.**

6 **(2) The department may select any available payment method option for a cooperative**  
7 **agreement, including the advance payment method.**

8 **(3) If the department selects the advance payment method for a cooperative agreement,**  
9 **the department may not incur a funding obligation that is payable or reimbursable from**  
10 **federal moneys under the cooperative agreement unless moneys sufficient to meet the obli-**  
11 **gation are available in the State Treasury and:**

12 **(a) Are available for expenditure by the department; and**

13 **(b) Are not committed or encumbered for any other purpose.**

14 **(4) The department may adopt rules as necessary to maintain the eligibility of the state**  
15 **to receive advance payments under cooperative agreements with the federal National Guard**  
16 **Bureau.**

17 **SECTION 2. The State Treasurer, at the request of the Oregon Military Department, may**  
18 **create accounts in the State Treasury, separate and distinct from the General Fund, pursu-**  
19 **ant to a cooperative agreement described in section 1 of this 2019 Act or federal statutes or**  
20 **regulations governing the cooperative agreement. Interest earned by such an account must**  
21 **be credited to the account. Moneys in accounts created under this section are continuously**
