Public Hearing and Work Session

- HB 4016 ** **Subsequent Referral(s) to Ways and Means
Directs Oregon Health Authority to study health care.
- HB 4161 ** **Subsequent Referral(s) to Ways and Means
Defines "Regional Health Equity Coalition" and "Regional Health Equity Coalition model." Requires Oregon Health Authority to provide grants to Regional Health Equity Coalitions and groups utilizing Regional Health Equity Coalition model throughout state.
- HB 4101 ** **Subsequent Referral(s) to Ways and Means
Requires Oregon Health Authority to ensure reimbursement of health services delivered using telemedicine.
- HB 4081
Removes requirement that physician assistant practice under supervising physician.
- HB 4074
Authorizes Health Licensing Office to issue license to practice genetic counseling to qualified applicant.
- HB 4116
Requires health insurance policies that have prescription drug benefit to cover cost of drugs prescribed for urgent medical conditions and cost of drugs prescribed and dispensed by pharmacists within their scope of practice, including cost of pharmacists' consultation fees associated with prescribing and dispensing drugs.
- HB 4109
Prohibits aerial pesticide applicator from spraying or otherwise applying by aircraft pesticide product containing chlorpyrifos.

Work Session

- HB 4102
Requires coordinated care organizations to report specified information to Oregon Health Authority regarding requests for prior authorization.
- HB 4030
Modifies and delays implementation of requirements for pharmacy benefit managers.

- HJR 202 ** **Subsequent Referral(s) to Rules
Proposes amendment to Oregon Constitution establishing obligation of state to ensure every resident of state access to cost-effective, clinically appropriate and affordable health care.
- HB 4110
Prescribes grace periods for payment of premiums on certain types of health insurance.
- HB 4029
Prohibits nonprofit hospital from requiring patient to apply for medical assistance before screening for or providing financial assistance.
- HB 4115
Requires health care providers, including coordinated care organizations, and companies providing health care interpreters to health care providers to use health care interpreters who are qualified or certified by Oregon Health Authority.
- HB 4073
Limits cost-sharing for health benefit plan coverage of insulin prescribed for treatment of diabetes.
- HB 4089
Allows person employed by health care facility to practice surgical technology if person is enrolled in or has completed specified apprenticeship program.
- HB 4032 ** **Subsequent Referral(s) to Ways and Means
Appropriates moneys from General Fund to Oregon Health Authority for expenses related to hospital nurse staffing program.
- HB 4114
Requires medical assistance and health benefit plan coverage of renal dialysis.
