SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Requires coordinated care organizations to report specified information to Oregon Health Authority regarding requests for prior authorization.

Requires insurers offering health benefit plans to report specified information to Department of Consumer and Business Services regarding requests for prior authorization.

Creates new requirements and modifies existing requirements applicable to utilization review by insurers offering health benefit plans. Creates new requirements applicable to step therapy requirements imposed by entities providing health insurance, medical services contracts or health care service contracts, multiple employer welfare arrangements and pharmacy benefit managers. **Ex-empts from certain new or modified requirements health benefit plans offered to public employees by Public Employees' Benefit Board and Oregon Educators Benefit Board.**

A BILL FOR AN ACT

Relating to managing the utilization of health care; creating new provisions; and amending ORS 743.035, 743B.001, 743B.250, 743B.256, 743B.420, 743B.423 and 743B.602.

Be It Enacted by the People of the State of Oregon:

SECTION 1. (1) As used in this section, "coordinated care organization" has the meaning given that term in ORS 414.025.

(2) A coordinated care organization must report annually to the Oregon Health Authority, in the form and manner prescribed by the authority, the following information regarding requests for prior authorization received by the coordinated care organization or a risk-bearing entity acting for or in concert with the coordinated care organization:

(a) The number of requests received;

(b) The number of requests that were initially denied and the reasons for the denials, including, but not limited to, lack of medical necessity or incomplete requests; and

(c) The number of denials that were reversed in response to an appeal.

SECTION 2. ORS 743B.250 is amended to read:

743B.250. All insurers offering a health benefit plan in this state shall:

(1) Provide to all enrollees directly or in the case of a group policy to the employer or other policyholder for distribution to enrollees, to all applicants, and to prospective applicants upon request, the following information:

(a) The insurer's written policy on the rights of enrollees, including the right:

(A) To participate in decision making regarding the enrollee's health care.

(B) To be treated with respect and with recognition of the enrollee's dignity and need for pri-

1 vacy.

2 (C) To have grievances handled in accordance with this section.

3 (D) To be provided with the information described in this section.

4 (b) An explanation of the procedures described in subsection (2) of this section for making cov-
5 erage determinations and resolving grievances. The explanation must be culturally and linguistically
6 appropriate, as prescribed by the department by rule, and must include:

7 (A) The procedures for requesting an expedited response to an internal appeal under subsection
8 (2)(d) of this section or for requesting an expedited external review of an adverse benefit determi-
9 nation;

10 (B) A statement that if an insurer does not comply with the decision of an independent review
11 organization under ORS 743B.256, the enrollee may sue the insurer under ORS 743B.258;

12 (C) The procedure to obtain assistance available from the insurer, if any, and from the Depart-
13 ment of Consumer and Business Services in filing grievances; and

14 (D) A description of the process for filing a complaint with the department.

15 (c) A summary of benefits and an explanation of coverage in a form and manner prescribed by
16 the department by rule.

17 (d) A summary of the insurer's policies on prescription drugs, including:

18 (A) Cost-sharing differentials;

19 (B) Restrictions on coverage;

20 (C) Prescription drug formularies;

21 (D) Procedures by which a provider with prescribing authority may prescribe clinically appro-
22 priate drugs not included on the formulary;

23 (E) Procedures for the coverage of clinically appropriate prescription drugs not included on the
24 formulary; and

25 (F) A summary of the criteria for determining whether a drug is experimental or investigational.

26 (e) A list of network providers and how the enrollee can obtain current information about the
27 availability of providers and how to access and schedule services with providers, including clinic
28 and hospital networks. The list must be available online and upon request in printed format.

29 (f) Notice of the enrollee's right to select a primary care provider and specialty care providers.

30 (g) How to obtain referrals for specialty care in accordance with ORS 743B.227.

31 (h) Restrictions on services obtained outside of the insurer's network or service area.

32 (i) The availability of continuity of care as required by ORS 743B.225.

33 (j) Procedures for accessing after-hours care and emergency services as required by ORS
34 743A.012.

35 (k) Cost-sharing requirements and other charges to enrollees.

36 (L) Procedures, if any, for changing providers.

37 (m) Procedures, if any, by which enrollees may participate in the development of the insurer's
38 corporate policies.

39 (n) A summary of how the insurer makes decisions regarding coverage and payment for treat-
40 ment or services, including a general description of any prior authorization and utilization review
41 requirements that affect coverage or payment.

42 (o) Disclosure of any risk-sharing arrangement the insurer has with physicians or other provid-
43 ers.

44 (p) A summary of the insurer's procedures for protecting the confidentiality of medical records
45 and other enrollee information and the requirement under ORS 743B.555 that a carrier or third

1 party administrator send communications containing protected health information only to the
2 enrollee who is the subject of the protected health information.

3 (q) An explanation of assistance provided to non-English-speaking enrollees.

4 (r) Notice of the information available from the department that is filed by insurers as required
5 under ORS 743B.200, 743B.202 and 743B.423.

6 (2) Establish procedures, in accordance with requirements adopted by the department, for mak-
7 ing coverage determinations and resolving grievances that provide for all of the following:

8 (a) Timely notice of adverse benefit determinations.

9 (b) A method for recording all grievances, including the nature of the grievance and significant
10 action taken.

11 (c) Written decisions.

12 (d) An expedited response to a request for an internal appeal that accommodates the clinical
13 urgency of the situation.

14 (e) At least one but not more than two levels of internal appeal for group health benefit plans
15 and one level of internal appeal for individual health benefit plans and for any denial of an exception
16 to a prescription drug formulary. If an insurer provides:

17 (A) Two levels of internal appeal, a person who was involved in the consideration of the initial
18 denial or the first level of internal appeal may not be involved in the second level of internal appeal;
19 and

20 (B) No more than one level of internal appeal, a person who was involved in the consideration
21 of the initial denial may not be involved in the internal appeal.

22 (f)(A) An external review that meets the requirements of ORS 743B.252, 743B.254 and 743B.255,
23 after the enrollee has exhausted internal appeals or after the enrollee has been deemed to have
24 exhausted internal appeals.

25 (B) An enrollee shall be deemed to have exhausted internal appeals if an insurer fails to strictly
26 comply with this section and federal requirements for internal appeals.

27 (g) The opportunity for the enrollee to receive continued coverage of an approved and ongoing
28 course of treatment under the health benefit plan pending the conclusion of the internal appeal
29 process.

30 (h) The opportunity for the enrollee or any authorized representative chosen by the enrollee to:

31 (A) Submit for consideration by the insurer any written comments, documents, records and other
32 materials relating to the adverse benefit determination; and

33 (B) Receive from the insurer, upon request and free of charge, reasonable access to and copies
34 of all documents, records and other information relevant to the adverse benefit determination.

35 (3) Establish procedures for notifying affected enrollees of:

36 (a) A change in or termination of any benefit; and

37 (b)(A) The termination of a primary care delivery office or site; and

38 (B) Assistance available to enrollees in selecting a new primary care delivery office or site.

39 (4) Provide the information described in subsection (2) of this section and ORS 743B.254 at each
40 level of internal appeal to an enrollee who is notified of an adverse benefit determination or to an
41 enrollee who files a grievance.

42 (5) Upon the request of an enrollee, applicant or prospective applicant, provide:

43 (a) The insurer's annual report on grievances and internal appeals submitted to the department
44 under subsection (8) of this section.

45 (b) A description of the insurer's efforts, if any, to monitor and improve the quality of health

1 services.

2 (c) Information about the insurer's procedures for credentialing network providers.

3 (6) **In addition to the requirements in ORS 743B.423 and 743B.602**, provide, upon the request
4 of an enrollee, a written summary of information that the insurer may consider in its utilization
5 review of a particular condition or disease, to the extent the insurer maintains such criteria.
6 *[Nothing in]* This subsection *[requires]* **does not require** an insurer to advise an enrollee how the
7 insurer would cover or treat that particular enrollee's disease or condition. Utilization review cri-
8 teria that are proprietary shall be subject to oral disclosure only.

9 (7) Maintain for a period of at least six years written records that document all grievances de-
10 scribed in ORS 743B.001 *[(7)(a)]* **(8)(a)** and make the written records available for examination by
11 the department or by an enrollee or authorized representative of an enrollee with respect to a
12 grievance made by the enrollee. The written records must include but are not limited to the fol-
13 lowing:

14 (a) Notices and claims associated with each grievance.

15 (b) A general description of the reason for the grievance.

16 (c) The date the grievance was received by the insurer.

17 (d) The date of the internal appeal or the date of any internal appeal meeting held concerning
18 the appeal.

19 (e) The result of the internal appeal at each level of appeal.

20 (f) The name of the covered person for whom the grievance was submitted.

21 (8) Provide *[an annual summary]* to the department, **in the format prescribed by the depart-**
22 **ment, an annual summary** of the insurer's aggregate data regarding:

23 (a) Grievances[.];

24 (b) Internal appeals *[and]*;

25 (c) Requests for external review *[in a format prescribed by the department to ensure consistent*
26 *reporting on the number, nature and disposition of grievances, internal appeals and requests for ex-*
27 *ternal review]*; **and**

28 **(d) The following information about requests for prior authorization received by the**
29 **insurer:**

30 **(A) The number of requests received;**

31 **(B) The number of requests that were initially denied and the reasons for the denials,**
32 **including, but not limited to, lack of medical necessity or failure to provide additional clinical**
33 **information requested by the insurer;**

34 **(C) The number of requests that were initially approved; and**

35 **(D) The number of denials that were reversed by internal appeals or external reviews.**

36 (9) Allow the exercise of any rights described in this section by an authorized representative.

37 **SECTION 3.** ORS 743B.256 is amended to read:

38 743B.256. (1) An independent review organization shall perform the following duties when ap-
39 pointed under ORS 743B.252 to review a dispute under a health benefit plan between an insurer and
40 an enrollee:

41 (a) Decide whether the dispute pertains to an adverse benefit determination and notify the
42 enrollee and insurer in writing of the decision. If the decision is against the enrollee, the inde-
43 pendent review organization shall notify the enrollee of the right to file a complaint with or seek
44 other assistance from the Department of Consumer and Business Services and the availability of
45 other assistance as specified by the department.

1 (b) Appoint a reviewer or reviewers as determined appropriate by the independent review or-
2 ganization. **At least one reviewer must be a clinician in the same or a similar specialty as the**
3 **provider who prescribed the treatment that is under review.**

4 (c) Notify the enrollee of information that the enrollee is required to provide and any additional
5 information the enrollee may provide, and when the information must be submitted as provided in
6 ORS 743B.252.

7 (d) Notify the insurer of additional information the independent review organization requires and
8 when the information must be submitted as provided in ORS 743B.252.

9 (e) Decide the dispute relating to the adverse benefit determination of the insurer and issue the
10 decision in writing.

11 (2) A decision by an independent review organization shall be based on expert medical judgment
12 after consideration of the enrollee's medical record, the recommendations of each of the enrollee's
13 providers, relevant medical, scientific and cost-effectiveness evidence and standards of medical
14 practice in the United States. An independent review organization must make its decision in ac-
15 cordance with the coverage described in the health benefit plan, except that the independent review
16 organization may override the insurer's standards for medically necessary or experimental or
17 investigational treatment if the independent review organization determines that the standards of
18 the insurer are unreasonable or are inconsistent with sound medical practice.

19 (3) When review is expedited, the independent review organization shall issue a decision not
20 later than the third day after the date on which the enrollee applies to the insurer for an expedited
21 review or the Director of the Department of Consumer and Business Services orders an expedited
22 review.

23 (4) When a review is not expedited, the independent review organization shall issue a decision
24 not later than the 30th day after the enrollee applies to the insurer for a review or the director
25 orders a review.

26 (5) An independent review organization shall file synopses of its decisions with the director ac-
27 cording to the format and other requirements established by the director. The synopses shall exclude
28 information that is confidential, that is otherwise exempt from disclosure under ORS 192.345 and
29 192.355 or that may otherwise allow identification of an enrollee. The director shall make the syn-
30 opsos public.

31 **SECTION 4.** ORS 743B.420 is amended to read:

32 743B.420. Except in the case of misrepresentation, prior authorization determinations shall be
33 subject to the following requirements:

34 (1) Prior authorization determinations relating to benefit coverage and medical necessity shall
35 be binding on the insurer if obtained no more than [30] **60** days prior to the date the service is
36 provided.

37 (2) Prior authorization determinations relating to enrollee eligibility shall be binding on the
38 insurer if obtained no more than five business days prior to the date the service is provided.

39 **SECTION 5.** ORS 743B.423 is amended to read:

40 743B.423. (1) All insurers offering a health benefit plan in this state that provide utilization re-
41 view or have utilization review provided on their behalf shall file an annual summary with the De-
42 partment of Consumer and Business Services that describes all utilization review policies, including
43 delegated utilization review functions, and documents the insurer's procedures for monitoring of
44 utilization review activities.

45 (2) All utilization review activities conducted pursuant to subsection (1) of this section shall

1 comply with the following:

2 (a) **In addition to the requirements of ORS 743B.602, in establishing utilization review, the**
3 **insurer must use clinical review criteria that are evidence-based and continuously updated**
4 **based on new evidence and research, and take into account new developments in treatment.**

5 (b) **The insurer must adjudicate claims for reimbursement in accordance with ORS**
6 **743B.450 based on the information submitted by the provider and may not require the pro-**
7 **vider to resubmit the information.**

8 [(a)] (c) **The criteria and the process** used in the utilization review [*process*] and the method
9 of development of the criteria [*shall*] **must** be made available for review to contracting providers
10 [*upon request*].

11 (d) **The insurer must have a website where:**

12 (A) **The following information is clearly posted:**

13 (i) **All requirements for requesting coverage of a treatment, drug or device that is subject**
14 **to utilization review, including the specific documentation required for a request to be con-**
15 **sidered complete.**

16 (ii) **A list of the specific treatments, drugs or devices that are subject to utilization re-**
17 **view.**

18 (B) **A provider can make a secure electronic submission, meeting industry standards for**
19 **privacy, of a request for coverage of a treatment, drug or device that is subject to utilization**
20 **review, along with needed forms and documents, and receive an electronic acknowledgement**
21 **of receipt of the request.**

22 (e) **If the insurer deems as incomplete a request made for coverage of a treatment, drug**
23 **or device that is subject to utilization review, the insurer must inform the provider of the**
24 **specific information needed for the request to be considered complete.**

25 [(b)] (f) **The insurer must use** a physician licensed under ORS 677.100 to 677.228 [*shall be re-*
26 *sponsible for*] **to make** all final recommendations regarding [*the necessity or appropriateness of ser-*
27 *vices or the site at which the services are provided and shall consult as appropriate with medical and*
28 *mental health specialists in making such recommendations*] **coverage of a treatment, drug or device**
29 **that is subject to utilization review and to consult as needed.**

30 (g) **The insurer must give a provider notice in writing of a denial of a request for cover-**
31 **age of a treatment, drug or device that is subject to utilization review. The notice must be**
32 **written in plain language, be understandable to providers and patients, and include the spe-**
33 **specific reason for the denial based on evidence-based, peer-reviewed literature. If the denial is**
34 **based on terms in a policy or certificate of insurance, the denial must cite the specific lan-**
35 **guage in the policy or certificate.**

36 [(c)] (h) **The insurer must make available to** any provider who has had a request for [*treat-*
37 *ment or payment for services*] **coverage** denied as not medically necessary or as experimental [*shall*
38 *be provided*] an opportunity for a timely appeal before an appropriate medical consultant or peer
39 review committee.

40 [(d)] (i) Except as provided in paragraph [(e)] (j) of this subsection, [*an*] **the** insurer must issue
41 a determination on a provider's or an enrollee's request for [*prior authorization of a nonemergency*
42 *service*] **coverage of a nonemergency treatment, drug or device that is subject to utilization**
43 **review** within a reasonable period of time appropriate to the medical circumstances but no later
44 than two business days after receipt of the request, and qualified health care personnel must be
45 available for same-day telephone responses to inquiries concerning certification of continued length

1 of stay.

2 [(e)] (j) If [an] **the insurer** requires additional information from an enrollee or a provider to
3 make a determination on a request for [prior authorization] **coverage of a treatment, drug or**
4 **device that is subject to utilization review**, no later than two business days after receipt of the
5 request, the insurer shall notify the enrollee and the provider in writing of the additional informa-
6 tion needed to make the determination. The insurer shall issue the determination by the later of:

7 (A) Two business days after receipt of a response **from the provider or enrollee** to the request
8 for additional information; or

9 (B) Fifteen days after the date of the request for additional information[.], **unless otherwise**
10 **provided by federal law.**

11 (k) **If a change in a drug formulary or other change in coverage impacts the coverage**
12 **of an enrollee's treatment plan and the enrollee has been stabilized on the treatment plan**
13 **for at least 90 days, the insurer must continue to provide coverage of the treatment until**
14 **utilization review and all internal appeals and external reviews are completed.**

15 (L) **The insurer may not alter utilization review requirements, or initiate or implement**
16 **new utilization review requirements, without giving a 60-day advance notice to all partic-**
17 **ipating providers.**

18 (m) **In addition to the requirements of ORS 743B.420, an approved request for coverage**
19 **of a treatment, other than a prescription drug, shall be binding on the insurer for a period**
20 **ending on the later of the following:**

21 (A) **The reasonable duration of the treatment based on clinical standards; or**

22 (B) **Sixty days after the date that the treatment begins following approval of prior au-**
23 **thorization.**

24 (n) **Except as provided in paragraph (o) of this subsection, an approved request for cov-**
25 **erage of a prescription drug shall be binding on the insurer for one year from the date that**
26 **the treatment begins following approval of the request if the drug:**

27 (A) **Is prescribed as a maintenance therapy that is expected to last at least 12 months**
28 **based on medical or scientific evidence;**

29 (B) **Continues to be prescribed throughout the 12-month period; and**

30 (C)(i) **Is prescribed for a condition that is within the scope of use for the drug as ap-**
31 **proved by the United States Food and Drug Administration; or**

32 (ii) **Has been proven to be a safe and effective form of treatment for the enrollee's med-**
33 **ical condition based on clinical practice guidelines developed from peer-reviewed medical lit-**
34 **erature.**

35 (o) **Paragraph (n) of this subsection does not apply if:**

36 (A) **A therapeutic equivalent of the prescription drug or a generic alternative to the**
37 **prescription drug is or becomes available as a substitute for the drug for which prior au-**
38 **thorization is requested or was approved; or**

39 (B) **A biologic product is or becomes available that is determined by the United States**
40 **Food and Drug Administration to be interchangeable with the drug for which prior authori-**
41 **zation is requested or approved.**

42 (p) **Paragraphs (k), (m) and (n) of this subsection do not require an insurer to reimburse**
43 **the cost of care for a patient who is no longer enrolled in the health benefit plan offered by**
44 **the insurer.**

45 **SECTION 6.** ORS 743B.602 is amended to read:

1 743B.602. (1) As used in this section:

2 (a) **“Beneficiary” means an individual receiving health care that is provided or reim-**
3 **bursed by an entity that provides health care coverage.**

4 [(a)] (b) **“Health care coverage [plan]” includes any of the following that reimburse the cost**
5 **of prescription drugs:**

6 (A) A health benefit plan[, *as defined in ORS 743B.005*];

7 (B) An insurance policy or certificate covering the cost of prescription drugs, hospital expenses,
8 health care services and medical expenses, equipment and supplies;

9 (C) A medical services contract[, *as defined in ORS 743B.001*];

10 (D) A multiple employer welfare arrangement, as defined in ORS 750.301;

11 (E) A contract or agreement with a health care service contractor, as defined in ORS 750.005,
12 or a preferred provider organization;

13 (F) **Claims payments by** a pharmacy benefit manager, as defined in ORS 735.530, or other third
14 party administrator [*that pays prescription drug claims*]; and

15 (G) An accident insurance policy or any other insurance contract [*providing reimbursement for*
16 *the cost of prescription drugs, hospital expenses, health care services and medical expenses, equipment*
17 *and supplies*].

18 [(b)] **“Step therapy” means a drug protocol in which a health care coverage plan will reimburse the**
19 **cost of a prescribed drug only if the patient has first tried a specified drug or series of drugs.]**

20 [(2)] **A health care coverage plan that requires step therapy shall make easily accessible to pre-**
21 **scribing practitioners, clear explanations of:]**

22 (2) **An entity that provides health care coverage that requires step therapy shall:**

23 (a) **Post to the entity’s website clear explanations that are easily accessible to prescribing**
24 **practitioners and beneficiaries of the coverage, written in plain language and understandable**
25 **to practitioners and beneficiaries, of:**

26 [(a)] (A) The clinical criteria for each step therapy protocol **and the criteria for approving**
27 **an exception to step therapy;**

28 [(b)] (B) The procedure by which a practitioner may submit to the [plan] **entity** the
29 practitioner’s medical rationale for determining that a particular step therapy [protocol] is not ap-
30 propriate for a particular [patient] **beneficiary** based on the [patient’s] **beneficiary’s** medical condi-
31 tion and history; and

32 [(c)] (C) The documentation, if any, that a practitioner must submit to the [plan] **entity** for the
33 [plan] **entity** to determine the appropriateness of step therapy for a specific [patient] **beneficiary**.

34 (b) **Provide a clear, readily accessible and convenient process for a prescribing practi-**
35 **tioner to request an exception to the step therapy, which may be the same process used to**
36 **request exceptions to other coverage restrictions or limitations.**

37 (c) **Approve a request for an exception to step therapy if the entity determines that the**
38 **evidence submitted by the prescribing practitioner is sufficient to establish that:**

39 (A) **The prescription drug required by the step therapy is contraindicated or will cause**
40 **the beneficiary to experience a clinically predictable adverse reaction;**

41 (B) **The prescription drug required by the step therapy is expected to be ineffective based**
42 **on the known clinical characteristics of the beneficiary and the known characteristics of the**
43 **prescription drug regimen;**

44 (C) **While covered under the beneficiary’s current or prior health care coverage, the**
45 **beneficiary has tried the drug required by the step therapy, a drug in the same**

1 **pharmacologic class as the drug required by the step therapy or a drug with the same**
2 **mechanism of action as the drug required by the step therapy, and the beneficiary's use of**
3 **the drug required by the step therapy was discontinued due to the lack of efficacy or effec-**
4 **tiveness, a diminished effect or an adverse reaction; or**

5 **(D) For a period of at least 90 days the beneficiary has experienced a positive therapeutic**
6 **outcome from the drug for which the exception is requested while enrolled in the current**
7 **or immediately preceding health care coverage and changing to the drug required by the step**
8 **therapy may cause a clinically predictable adverse reaction or physical or mental harm to**
9 **the beneficiary.**

10 **(3) A prescribing practitioner may not use a pharmaceutical sample for the sole purpose**
11 **of qualifying for an exception to step therapy under subsection (2)(c)(C) or (D) of this section.**

12 **(4) This section does not prevent:**

13 **(a) An entity that provides health care coverage from requiring a beneficiary to try an**
14 **AB-rated generic equivalent or a biological product that is a biosimilar agent approved by the**
15 **United States Food and Drug Administration prior to covering the equivalent brand name**
16 **prescription drug;**

17 **(b) An entity that provides health care coverage from denying a request for an exception**
18 **to allow coverage of a drug that has been removed from the market due to the safety con-**
19 **cerns of the United States Food and Drug Administration; or**

20 **(c) A practitioner from prescribing a prescription drug that is medically appropriate re-**
21 **gardless of coverage.**

22 **SECTION 7.** ORS 743B.001 is amended to read:

23 743B.001. As used in this section and ORS 743.008, 743.029, 743.035, 743A.190, 743B.195,
24 743B.197, 743B.200, 743B.202, 743B.204, 743B.220, 743B.225, 743B.227, 743B.250, 743B.252, 743B.253,
25 743B.254, 743B.255, 743B.256, 743B.257, 743B.258, 743B.310, 743B.400, 743B.403, 743B.405, 743B.420,
