SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Changes name of Early Learning Division to Department of Early Learning and Care. Establishes Department of Early Learning and Care as state agency that is separate from Department of Education and that functions under, and is coordinated by, Early Learning Council.

Prescribes expanded duties, functions and powers of Department of Early Learning and Care, including administration of Employment Related Day Care. Modifies requirements of Employment Related Day Care.

Directs Early Learning Division, Department of Education and Department of Human Services to develop and implement plans for seamless transfer of relevant duties, functions and powers, and to report on plans to appropriate interim committees of Legislative Assembly.

Revises goals of statewide early learning system.

Modifies membership and duties of State Interagency Coordinating Council.

Declares emergency, effective on passage.

10 Whereas a child's brain makes one million new neural connections every second before the age
11 of five years, with early experiences shaping brain architecture; and

12 Whereas complex neural, social and emotional development occurs before the age of five years,
13 making early childhood a critical window in which to eliminate disparities; and

14 Whereas for children who are six weeks of age to 12 years of age and for children through 17
15 years of age who have disabilities or safety concerns, access to continuous, high quality child care,
16 early care and education and out-of-school programs is critical to a child's success in school and life;
17 and

18 Whereas both early care and education and out-of-school programs during elementary school
19 predict higher academic achievement at 15 years of age; and

20 Whereas all children are born full of potential, yet their family's zip code, income and race and
21 ethnicity are powerful predictors of a child's and family's access to high quality child care and early

1 education; and

2 Whereas child caring disproportionately impacts women, particularly women of color, through
3 child care shortages, lower wages as child care providers and staff and systemic discrimination; and

4 Whereas an affordable, accessible system of high quality child care is necessary for the health
5 of Oregon’s economy because employers benefit when parents have safe, stable, culturally responsive
6 and developmentally appropriate care for their children that meets their needs; and

7 Whereas families deserve to have centralized, coordinated access to a variety of eligible services
8 that build upon the single enrollment and eligibility ONE system; and

9 Whereas the Oregon Early Learning System should provide developmentally appropriate, cul-
10 turally responsive, relevant and inclusive child care and early care and education for children and
11 families across race, ethnicity, language, geography, ability and income levels, as recommended by
12 Raise Up Oregon; and

13 Whereas the health and stability of Oregon’s child care and early care and education workforce
14 is pivotal to any expansion of child care in Oregon and this workforce, predominately composed of
15 women of color, is structurally afflicted by low wages, limited or no health care and a severe lack
16 of retirement benefits; and

17 Whereas Oregon must value the work of caregivers, especially Black and indigenous women,
18 women of color and immigrant women, and ensure that they receive the equitable pay and benefits
19 they deserve for their work, training and services that support workforce development and supports
20 offered to all provider types; and

21 Whereas Oregon’s child care sector supports all providers, which are essential to offering a
22 mixed-delivery child care system and that include family, friend and neighbor child care, regulated
23 subsidy child care, registered family child care, certified family child care, certified child care cen-
24 ters, out-of-school programs, Oregon Prekindergarten, Head Start, Early Head Start, relief nurseries,
25 Healthy Families Oregon programs, privately subsidized child care programs and publicly funded
26 child care programs; and

27 Whereas the Oregon Early Learning System must be informed by and accountable to the parents
28 and providers who most need it and who know the most about the system; and

29 Whereas the partnership and collaboration between the Oregon Early Learning System, the
30 kindergarten through grade 12 system, the health system, the human services system and the hous-
31 ing system are critical to the success of every child; now, therefore,

32 **Be It Enacted by the People of the State of Oregon:**

33
34 **STATEWIDE EARLY LEARNING SYSTEM**

35
36 **SECTION 1.** ORS 417.728 is amended to read:

37 417.728. (1) The Early Learning Council [*shall lead a joint effort with other state and local early*
38 *childhood partners to establish the policies necessary for a voluntary*] **is responsible for leading**
39 **cross-sector strategic planning that establishes the goals, objectives and strategies necessary**
40 **for a statewide early learning system.**

41 [*(2) The voluntary statewide early learning system shall be designed to achieve:*]

42 [*(a) The appropriate outcomes identified by the Early Learning Council with input from early*
43 *childhood partners; and*]

44 [*(b) Any other early childhood benchmark or outcome that demonstrates progress toward meeting*
45 *a target and that is identified by the Early Learning Council with input from early childhood*]

1 *partners.]*

2 **(2) The purpose of the statewide early learning system is to make progress toward en-**
3 **suring that:**

4 **(a) Children enter school ready to learn;**

5 **(b) Children are raised in families that are healthy, stable and attached; and**

6 **(c) Early learning is available and provided in a manner that is aligned, coordinated and**
7 **family centered.**

8 (3) The *[voluntary]* statewide early learning system shall include the following components:

9 (a) A process to identify as early as possible children and families who would benefit from early
10 learning services, including the required use of standardized screening and referral procedures used
11 throughout the *[voluntary]* statewide early learning system;

12 (b) A plan to support the identified needs of the child and family that coordinates case man-
13 agement personnel and the delivery of services to the child and family; and

14 (c) Services to support children who are zero through six years of age and their families who
15 give their express written consent, including:

16 (A) Screening, assessment and home visiting services pursuant to ORS 417.795;

17 (B) Specialized or targeted home visiting services;

18 (C) Community-based services such as relief nurseries, family support programs and parent ed-
19 ucation programs;

20 (D) Affordable, quality child care, as defined by the Early Learning Council;

21 (E) Preschool and other early education services;

22 (F) Health services for children and pregnant women;

23 (G) Mental health services;

24 (H) Alcohol and drug treatment programs that meet the standards promulgated by the Oregon
25 Health Authority pursuant to ORS 430.357;

26 (I) Developmental disability services; and

27 (J) Other state and local services.

28 (4) In establishing the definition of affordable, quality child care under subsection (3)(c)(D) of
29 this section, the Early Learning Council shall consult with child care providers and early childhood
30 educators. The definition established by the council shall support parental choice of child care pro-
31 vider and shall consider differences in settings and services, including but not limited to child care
32 for school-aged children, part-time care, odd-hour and respite care and factors of cultural appropri-
33 ateness and competence.

34 *[(5) No later than July 1, 2016, for the purpose of ensuring that affordable, quality home-based*
35 *child care is available through a subsidy program administered by the Department of Human Services,*
36 *the Early Learning Division, in consultation with the department, shall develop and implement a system*
37 *of quality supports for exempt family child care providers as defined in ORS 329A.430. The system*
38 *may use evidence-based practices or best practices that are consistent with state policies for child*
39 *well-being and development and that are subject to collective bargaining. The system must include*
40 *professional development opportunities for exempt family child care providers that are available for*
41 *attendance in person and through the Internet.]*

42 **[(6)] (5) The Early Learning Council shall:**

43 (a) Consolidate administrative functions relating to the *[voluntary]* statewide early learning
44 system, to the extent practicable, including but not limited to training and technical assistance,
45 planning and budgeting.

1 (b) Adopt policies to establish training and technical assistance programs to ensure that per-
2 sonnel have skills in appropriate areas, including screening, family assessment, competency-based
3 home visiting skills, cultural and gender differences and other areas as needed.

4 (c) Identify research-based age-appropriate and culturally and gender appropriate screening and
5 assessment tools that would be used as appropriate in programs and services of the [voluntary]
6 statewide early learning system.

7 (d) Develop a plan for the implementation of a common data system for voluntary early child-
8 hood programs.

9 (e) Coordinate existing and new early childhood programs to provide a range of community-
10 based supports.

11 (f) Establish a common set of quality assurance standards to guide local implementation of all
12 elements of the [voluntary] statewide early learning system, including voluntary universal screening
13 and assessment, home visiting, staffing, evaluation and community-based services.

14 (g) Ensure that all plans for voluntary early childhood services are coordinated and consistent
15 with federal and state law, including but not limited to plans for Oregon prekindergarten programs,
16 federal Head Start programs, early childhood special education services, early intervention services
17 and public health services.

18 (h) Identify how the [voluntary] statewide early learning system for children who are zero
19 through six years of age will link with systems of support for older children and their families.

20 (i) During January of each odd-numbered year, report to the Governor and the Legislative As-
21 sembly on the [voluntary] statewide early learning system.

22 [(7)] (6) The State Board of Education, the Employment Department, the Department of Human
23 Services and the Oregon Health Authority when adopting rules to administer voluntary early
24 childhood programs under their individual authority shall adopt rules:

25 (a) That are consistent with the requirements of the [voluntary] statewide early learning system
26 created under this section; and

27 (b) With the direction of the Early Learning Council.

28 [(8)] (7) Information gathered in conjunction with the voluntary comprehensive screening and
29 assessment of children and their families may be used only for the following purposes:

30 (a) Providing services to children and families who give their express written consent;

31 (b) Providing statistical data that are not personally identifiable;

32 (c) Accomplishing other purposes for which the family has given express written consent; and

33 (d) Meeting the requirements of mandatory state and federal disclosure laws.

34 **SECTION 2.** ORS 417.723 is amended to read:

35 417.723. The Oregon Health Authority and the Early Learning Council shall establish a grant
36 program to provide funding to support effective and scalable strategies that align [voluntary] state-
37 wide early learning systems and health systems for the purpose of improving the developmental
38 outcomes for children from zero through three years of age.

39 **SECTION 3.** ORS 417.727 is amended to read:

40 417.727. Based on the findings expressed in ORS 417.708, there is created the Oregon Early
41 Learning System. The goals of the system are to:

42 (1) Prevent child abuse and neglect;

43 (2) Improve the health and development of young children;

44 (3) Promote bonding and attachment in the early years of a child's life;

45 (4) Support parents in providing the optimum environment for their young children;

1 (5) Link and integrate services and supports in the [voluntary] statewide early learning system
2 pursuant to ORS 417.728;

3 (6) Ensure that children are entering school ready to learn; and

4 (7) Ensure that parents have access to affordable, quality child care.

5 **SECTION 4.** ORS 417.795 is amended to read:

6 417.795. (1) The Early Learning Division shall establish Healthy Families Oregon programs in
7 all counties of this state as funding becomes available.

8 (2) These programs shall be nonstigmatizing, voluntary and designed to achieve the appropriate
9 early childhood benchmarks and shall:

10 (a) Ensure that express written consent is obtained from the family prior to any release of in-
11 formation that is protected by federal or state law and before the family receives any services;

12 (b) Ensure that services are voluntary and that, if a family chooses not to accept services or
13 ends services, there are no adverse consequences for those decisions;

14 (c) Offer a voluntary comprehensive risk assessment of all children, from zero through three
15 years of age, and their families in coordination with [voluntary] statewide early learning system
16 screening and referral efforts;

17 (d) Ensure that the disclosure of information gathered in conjunction with the voluntary com-
18 prehensive risk assessment of children and their families is limited pursuant to ORS 417.728 [(8)] (7)
19 to the following purposes:

20 (A) Providing services under the programs to children and families who give their express
21 written consent;

22 (B) Providing statistical data that are not personally identifiable;

23 (C) Accomplishing other purposes for which the family has given express written consent; and

24 (D) Meeting the requirements of mandatory state and federal disclosure laws;

25 (e) Ensure that risk factors used in the risk screen are limited to those risk factors that have
26 been shown by research to be associated with poor outcomes for children and families;

27 (f) Identify, as early as possible, families that would benefit most from the programs;

28 (g) Provide parenting education and support services, including but not limited to community-
29 based home visiting services;

30 (h) Provide other supports, including but not limited to referral to and linking of community and
31 public services for children and families such as mental health services, alcohol and drug treatment
32 programs that meet the standards promulgated by the Oregon Health Authority under ORS 430.357,
33 child care, food, housing and transportation;

34 (i) Coordinate services for children consistent with other services provided through the Oregon
35 Early Learning System;

36 (j) Integrate data with any common data system for early childhood programs;

37 (k) Be included in a statewide independent evaluation to document:

38 (A) Level of screening and assessment;

39 (B) Incidence of child abuse and neglect;

40 (C) Change in parenting skills; and

41 (D) Rate of child development;

42 (L) Be included in a statewide training program in the dynamics of the skills needed to provide
43 early childhood services, such as assessment and home visiting; and

44 (m) Meet statewide quality assurance and quality improvement standards.

45 (3) The Healthy Families Oregon programs, in coordination with statewide home visiting part-

1 ners, shall:

2 (a) Identify existing services and describe and prioritize additional services necessary for a
3 voluntary home visit system;

4 (b) Build on existing programs;

5 (c) Maximize the use of volunteers and other community resources that support all families;

6 (d) Target, at a minimum, all prenatal families and families with children less than three months
7 of age and provide services through at least the child's third birthday; and

8 (e) Ensure that home visiting services provided by local home visiting partners for children and
9 pregnant women support and are coordinated with local Healthy Families Oregon programs.

10 (4) Through a Healthy Families Oregon program, a trained home visitor shall be assigned to
11 each family assessed as at risk that consents to receive services through the trained home visitor.
12 The trained home visitor shall conduct home visits and assist the family in gaining access to needed
13 services.

14 (5) The services required by this section shall be provided by hospitals, public or private entities
15 or organizations, or any combination thereof, capable of providing all or part of the family risk as-
16 sessment and the follow-up services. In granting a contract, collaborative contracting or requests for
17 proposals may be used and must include the most effective and consistent service delivery system.

18 (6) The family risk assessment and follow-up services for families at risk shall be provided by
19 trained home visitors organized in teams supervised by a manager.

20 (7) Each Healthy Families Oregon program shall adopt disciplinary procedures for trained home
21 visitors and other employees of the program. The procedures shall provide appropriate disciplinary
22 actions for trained home visitors and other employees who violate federal or state law or the poli-
23 cies of the program.

24 **SECTION 5.** ORS 417.788 is amended to read:

25 417.788. (1) The Early Learning Division shall support Relief Nursery programs statewide as
26 funding becomes available. Funding to support Relief Nursery programs may include, but is not
27 limited to:

28 (a) Administrative costs;

29 (b) Costs for direct service personnel, equipment, supplies and operating expenses;

30 (c) Start-up costs;

31 (d) Classroom furniture and materials;

32 (e) Playground equipment;

33 (f) Computers; and

34 (g) Transportation vehicles.

35 (2) The division may encourage communities to establish Relief Nursery programs for young
36 children who are at risk and their families. Communities may choose to establish regional Relief
37 Nursery programs. The Relief Nursery programs shall be consistent with the [*voluntary*] **statewide**
38 early learning system coordinated by the Early Learning Council.

39 (3) Relief Nursery programs shall participate in a statewide independent evaluation conducted
40 by the Oregon Association of Relief Nurseries to document improved child safety, reduction in foster
41 care placements, progress in healthy child development and improvement in family functioning and
42 support.

43 (4) Each Relief Nursery program that receives state funding shall have financial support from
44 the community that, excluding any amounts distributed to the Relief Nursery program pursuant to
45 ORS 131A.360 (4)(d) and 131A.365 (3)(d), is at least equal to 25 percent of any state allocation.

1 (5) The division shall adopt rules necessary for the administration of this section, including rules
2 requiring that any public funds received by Relief Nursery programs be used to achieve the out-
3 comes identified in subsection (3) of this section.

4 **SECTION 6.** ORS 417.793 is amended to read:

5 417.793. The Early Learning Division shall support parents-as-teachers programs statewide as
6 funding becomes available. If a program is offered, the program shall be part of a comprehensive,
7 research-based approach to parent education and support. The program shall be consistent with the
8 [voluntary] **statewide** early learning system plan coordinated by the Early Learning Council.

10 **STATE INTERAGENCY COORDINATING COUNCIL**

11
12 **SECTION 7.** ORS 343.499 is amended to read:

13 343.499. (1)(a) There is created the State Interagency Coordinating Council.

14 (b) The Governor shall appoint members of the council from a list of eligible appointees **from**
15 **this state that is** provided by the council and agencies described in subsection (2) of this section
16 and shall ensure that the membership of the council reasonably represents the **racial, ethnic, lin-**
17 **guistic and geographic** population of this state.

18 (c) The Governor shall designate one member of the council to serve as the chairperson, or if
19 the Governor chooses not to name a chairperson, the council may elect one of its members to serve
20 as chairperson.

21 **(d) [However] Notwithstanding paragraph (c) of this subsection,** any member of the council
22 who represents the Department of Education may not serve as the chairperson of the council.

23 *[(2) The membership of the council shall be composed as follows:]*

24 *[(a) At least 20 percent of the council members shall be parents, including minority parents, of*
25 *preschool children with disabilities or of children with disabilities who are 12 years of age or younger*
26 *who have knowledge of or experience with programs for infants and toddlers with disabilities. At least*
27 *one council member shall be a parent of an infant or toddler with a disability or of a child with a*
28 *disability who is six years of age or younger.]*

29 *[(b) At least 20 percent of the council members shall be public or private providers of early inter-*
30 *vention and early childhood special education services.]*

31 *[(c) At least one council member shall be a member of the Legislative Assembly.]*

32 *[(d) At least one council member shall be involved in personnel preparation.]*

33 *[(e) At least one council member shall represent the Department of Human Services.]*

34 *[(f) At least one council member shall represent the federal Head Start program.]*

35 *[(g) At least one council member shall represent the Office of Child Care.]*

36 *[(h) At least one council member shall represent the Department of Education.]*

37 *[(i) At least one council member shall represent the Department of Consumer and Business Ser-*
38 *vices.]*

39 *[(j) At least one council member shall represent the Early Learning Division.]*

40 *[(k) At least one council member shall represent the Child Development and Rehabilitation Center*
41 *of the Oregon Health and Science University.]*

42 *[(L) At least one council member shall be a member of the State Advisory Council for Special Ed-*
43 *ucation created under ORS 343.287.]*

44 *[(m) At least one council member shall be a representative designated by the state coordinator for*
45 *homeless education.]*

1 *[(n) At least one council member shall represent the state child welfare agency responsible for foster*
2 *care.]*

3 *[(o) At least one council member shall represent the state agency responsible for children's mental*
4 *health.]*

5 *[(p) At least one council member shall be from the Oregon Health Authority.]*

6 *[(q) The council may include other members appointed by the Governor, including but not limited*
7 *to one representative from the United States Bureau of Indian Affairs or, where there is no school*
8 *operated or funded by the bureau, from the Indian Health Service or the tribe or tribal council.]*

9 **(2) The membership of the council shall be composed as follows:**

10 **(a) At least 20 percent of the council members shall be parents of children with a disa-**
11 **bility who are 12 years of age or younger at the time the council member is appointed. When**
12 **appointing council members under this paragraph, the Governor shall ensure that:**

13 **(A) At least 50 percent of the council members are parents of a child with a disability**
14 **who is five years of age or younger at the time the council member is appointed;**

15 **(B) At least 20 percent of the council members:**

16 **(i) Are parents of a child with a disability who is three years of age or younger at the**
17 **time the council member is appointed; and**

18 **(ii) Have knowledge of, or experience with, programs or services for infants or toddlers**
19 **with a disability; and**

20 **(C) The council members represent the racial, ethnic and linguistic diversity of children**
21 **in this state who are five years of age or younger.**

22 **(b) At least 20 percent of the council members shall be public or private providers of**
23 **early intervention and early childhood special education services.**

24 **(c) At least one council member shall be from a program responsible for preparing early**
25 **intervention and early childhood special education educators.**

26 **(d) At least one council member shall be from a Head Start or Early Head Start program.**

27 **(e) At least one council member shall be from a home-based child care program.**

28 **(f) At least one council member shall be from a center-based child care program.**

29 **(g) At least one council member shall be from the committee that serves as the state**
30 **advisory council, as described in ORS 326.425 (3).**

31 **(h) At least one council member shall be a member of the State Advisory Council for**
32 **Special Education created under ORS 343.287.**

33 **(i) At least one council member shall be from each state agency involved in the provision**
34 **of, or payment for, early intervention and early childhood special education services to in-**
35 **fant and toddlers with a disability and their families.**

36 **(j) At least one council member shall be from each state agency responsible for providing**
37 **preschool services to children with a disability.**

38 **(k) At least one council member shall be from each state agency responsible for**
39 **children's mental health.**

40 **(L) At least two council members shall be from the Department of Human Services with**
41 **expertise in foster care or self-sufficiency programs.**

42 **(m) At least one council member shall be from the Office of Child Care with expertise in**
43 **the Child Care and Development Fund.**

44 **(n) At least one council member shall be a representative of the Department of Educa-**
45 **tion with expertise in the coordination of education of homeless children and youth.**

1 (o) At least one council member shall be from the Department of Consumer and Business
2 Services with expertise in state regulation of private health insurance.

3 (p) At least one council member shall be from the Oregon Health Authority with exper-
4 tise in Medicaid and the Children's Health Insurance Program.

5 (q) At least one council member shall be a representative from a tribal agency responsi-
6 ble for supporting young children with developmental delays and disabilities, from a tribal
7 council or otherwise representing one or more tribes.

8 (3) An individual appointed to represent a state agency *[that is involved in the provision of or*
9 *payment for services for preschool children with disabilities under subsection (2)(e) and (h) to (k) of this*
10 *section shall]* **under subsection (2) of this section must** have sufficient authority to engage in
11 making and implementing policy on behalf of the agency. **The Governor may appoint a council**
12 **member to represent more than one program or specialty listed in subsection (2) of this**
13 **section.**

14 (4) In addition to the council members appointed under subsection (2) of this section:

15 (a) The Governor may appoint any other council members not listed in subsection (2) of
16 this section.

17 (b) The President of the Senate shall appoint one member from among members of the
18 Senate to serve as a nonvoting council member.

19 (c) The Speaker of the House of Representatives shall appoint one member from among
20 members of the House of Representatives to serve as a nonvoting council member.

21 [(4)] (5) The State Interagency Coordinating Council shall:

22 (a) Advise the Superintendent of Public Instruction, the State Board of Education, **the Early**
23 **Learning System Director** and the Early Learning Council on unmet needs in the early childhood
24 special education and early intervention programs for *[preschool]* children with *[disabilities]* **a disa-**
25 **bility**, review and comment publicly on any rules proposed by the State Board of Education and the
26 distribution of funds for the programs and assist the state in developing and reporting data on and
27 evaluations of the programs and services.

28 (b) Advise and assist the represented public agencies regarding the services and programs they
29 provide to *[preschool]* children with *[disabilities]* **a disability** and their families, including public
30 comments on any proposed rules affecting the target population and the distribution of funds for
31 such services, and assist each agency in developing services that reflect the overall goals for the
32 target population as adopted by the council.

33 (c) Advise *[and assist]* the Department of Education, **the Early Learning Division** and other
34 state agencies *[in]* **on** the development and implementation of the policies that constitute the state-
35 wide system.

36 (d) *[Assist]* **Advise** all appropriate public agencies *[in]* **on** achieving the full participation, coordi-
37 nation and cooperation for implementation of a statewide system that includes but is not limited
38 to:

39 (A) Seeking information from service providers, service coordinators, parents and others about
40 any federal, state or local policies that impede timely service delivery; and

41 (B) Taking steps to ensure that any policy problems identified under subparagraph (A) of this
42 paragraph are resolved.

43 (e) Advise *[and assist the Department of Education in]* **the Superintendent of Public Instruc-**

7 *[(g) To the extent appropriate, assist the Department of Education in the resolution of disputes.]*

8 *[(h) (g) Advise [and assist] the Department of Education **and the Early Learning Division on***
9 *[in] the preparation of applications and amendments thereto.*

10 *[(i) (h) Advise [and assist the Department of Education regarding the transition of preschool*
11 *children with disabilities] **the Superintendent of Public Instruction and the Early Learning***
12 ***System Director regarding transitions of children with a disability, including transitions to***
13 ***kindergarten.***

14 *[(j) (i) Prepare and submit an annual report to the Governor, **the Deputy Superintendent of***
15 ***Public Instruction,** the Early Learning System Director, the Early Learning Council, **the State***
16 ***Board of Education,** the Legislative Assembly and the United States Secretary of Education on the*
17 *status of early intervention *[programs operated]* **and early childhood special education services***
18 ***provided** within this state.*

19 *[(5) (6) The council may advise appropriate agencies about integration of services for preschool*
20 *children with *[disabilities]* **a disability** and at-risk preschool children.*

21 *[(6) (7) Terms of office for council members shall be three years, except that:*

EMPLOYMENT RELATED DAY CARE

SECTION 8. ORS 329A.500 is amended to read:

329A.500. *[(1) The Department of Human Services, in consultation with the Early Learning Division and the Office of Child Care, shall adopt rules for the operation of subsidy programs for employment-related child care administered by the department. At a minimum, and taking into account the availability of funds, the rules must provide the following:]*

[(a) Subsidy recipients may be entitled to receive the subsidy for at least one year, regardless of changes in employment. Rules adopted by the department may provide for termination of subsidy eligibility for reasons other than changes in employment during the one-year period. Exit eligibility and copays must be structured to mitigate the financial impact of reduced subsidy support due to increased income.]

[(b) Subsidy recipients who are enrolled in coursework, as defined by the department by rule, may be entitled to receive the subsidy to enable the subsidy recipient to attend and participate in the coursework provided all other eligibility requirements are met.]

[(c) Persons who are self-employed may qualify for subsidy programs provided all other eligibility requirements are met.]

[(d) Subsidy recipients who voluntarily choose child care providers that meet minimum standards established under the tiered quality rating and improvement system implemented under ORS 329A.261 may qualify for lower copayments. A fair representation of the subsidy recipients who qualify for lower copayments must be persons with children who are from underserved racial, ethnic or minority populations. In addition, child care providers that meet specified minimum standards established under the tiered quality rating and improvement system may receive an enhanced reimbursement under the subsidy programs.]

[(e) Subsidy recipients must report a change of child care provider to the department during the period a subsidy is being received.]

(1) As used in this section, “family” means any individual who is responsible for the care, control and supervision of a child.

(2) The Department of Human Services and the Early Learning Council shall adopt rules for the operation of the Employment Related Day Care subsidy program administered by the department.

(3) The rules adopted under this section must support equitable access to a supply of diverse child care providers that meet the needs of families, as those needs are defined by the department by rule, including:

- (a) Cultural diversity;**
- (b) Linguistic diversity;**
- (c) Racial and ethnic diversity; and**
- (d) Diversity of provider types.**

(4) The rules adopted under this section must provide that:

(a) A child’s eligibility to participate in the Employment Related Day Care subsidy program must be based on:

- (A) The household income of a child’s family; and**
- (B) Any other criteria established by the department.**
- (b) A child must be able to receive care that:**
 - (A) Meets the child’s developmental needs; and**

1 (B) Enables the child's family to complete activities that relate to family well-being,
2 which may include the family's work hours, education hours, commute time, study time and
3 other activities that support family well-being.

4 (c) Payment to child care providers must be based on enrollment instead of attendance.

5 (5) Taking into account the availability of funds, the rules adopted under this section
6 must establish a sliding scale for copayment, with the requirement that a copayment may
7 not exceed seven percent of the household income of the child's family.

8 (6) In developing rules under this section, the department shall consider policies for in-
9 creasing the stability and continuity of a child's access to a family's preferred child care
10 provider.

11 (7) Rules adopted by the department under this section establish minimum requirements
12 pertaining to the Employment Related Day Care subsidy program and may not be construed
13 to preempt, limit or otherwise diminish the applicability of any policy, standard or collective
14 bargaining agreement that provides for an increased subsidy or a child care provider re-
15 imbursement amount under state or federal law.

16 [(2)] (8)(a) The department shall work to meet federal recommendations for income eligibility
17 and market access in regard to [*employment-related child care*] the **Employment Related Day Care**
18 **subsidy program** administered by the department.

19 (b) **Notwithstanding any provision of this section or any rule adopted by the department**
20 **pursuant to this section, the laws and regulations applicable to any federal funds shall govern**
21 **when any aspect of child care is funded by federal funds.**

22 **SECTION 8a.** ORS 329A.505 is amended to read:

23 329A.505. (1) At any reasonable time, an authorized representative of the Office of Child Care
24 may conduct an inspection or investigation of a regulated subsidy facility, as defined by the Early
25 Learning Council by rule.

26 (2) When conducting an investigation under this section, the Office of Child Care may:

27 (a) Take evidence;

28 (b) Take the depositions of witnesses, including the person under investigation, in the manner
29 prescribed by law for depositions in civil actions;

30 (c) Compel the appearance of witnesses, including the person under investigation, in the manner
31 prescribed by law for appearances in civil actions;

32 (d) Require answers to interrogatories;

33 (e) Compel the production of books, papers, accounts, documents or testimony that pertains to
34 the matter under investigation;

37 (3) The Office of Child Care may, as a condition of finalizing an inspection, require improve-

41 **329A.500**, the Early Learning Council, in consultation with the Department of Human Services, may

16 326.430. (1) The **Department of Early Learning [Division] and Care** is established. [*in the De-*
17 *partment of Education. The purpose of the division is to ensure that children enter school ready to*

20 (a) **Ensure that every child in this state is given the best opportunity to succeed in**

25 **other specialized care from birth through 17 years of age;**

27 **children enter school ready to learn and families are healthy, stable and attached; and**

28 (c) **Administer programs in a manner that supports parents' and providers' needs and**
29 **considers the economic security and well-being of parents and providers.**

30 [(2)] (3) The [division] **department** shall function under [*the direction and control of*] **and be**
31 **coordinated by** the Early Learning Council [*with*].

32 (4) The Early Learning System Director [*serving*] **appointed under section 12 of this 2021 Act**
33 **shall serve** as the administrative officer **of the department.**

34 **SECTION 12.** (1) **The Department of Early Learning and Care is under the supervision**
35 **and control of the Early Learning System Director, who is responsible for the performance**
36 **of the duties, functions and powers of the department.**

37 (2) **The director shall be appointed by the Governor and serves at the pleasure of the**
38 **Governor.**

39 (3) **The director shall receive such salary as may be provided by law or, if not so provided,**

19 **garding the expenditures of the funds received by the State of Oregon pursuant to the federal**
20 **Child Care and Development Block Grant Act of 2014 and the most recent estimate of the**
21 **balance of the funds.**

22 **SECTION 14. ORS 131A.360 is amended to read:**

1 the **Department of** Early Learning [*Division*] **and Care** Fund established under ORS 326.435 for
2 disbursement to Relief Nursery programs as defined in ORS 417.786; and

3 (e) Deduct an amount equal to 10 percent of the forfeiture proceeds and deposit that amount in
4 an account established or designated by the State Treasurer in the higher education qualified tuition
5 savings program of the Oregon 529 Savings Network for disbursement to the scholarship program
6 for children of public safety officers established under ORS 348.270.

7 (5) If the forfeiting agency has entered into an agreement with a county under subsection (2)
8 of this section, after paying costs under subsection (3) of this section and making the deductions
9 required by subsection (4) of this section, the forfeiting agency shall pay the county the amounts
10 required by the agreement.

11 (6) After making all payments and deductions required by subsections (3), (4) and (5) of this
12 section, the forfeiting agency may use the remaining forfeiture proceeds, including amounts received
13 by a county under subsection (5) of this section or by any other public body under an intergovern-
14 mental agreement entered into under ORS 131A.355, only for:

15 (a) The purchase of equipment necessary for the enforcement of laws relating to the unlawful
16 delivery, distribution, manufacture or possession of controlled substances;

24 (4) Except as otherwise provided in the Public Contracting Code, the Secretary of State has all
25 the authority to procure or supervise the procurement of goods, services and personal services re-
26 lated to programs under the authority of the Secretary of State.

28 authority to procure or supervise the procurement of goods, services and personal services related

40 terials, equipment and supplies for constructing, demolishing, exchanging, maintaining, operating
41 and equipping housing for individuals with chronic mental illness, subject to applicable provisions
42 of ORS 426.504;

43 (c) The State Department of Fish and Wildlife to procure or supervise the procurement of con-
44 struction materials, equipment, supplies, services and personal services for public improvements,
45 public works or ordinary construction described in ORS 279C.320 that is subject to the authority

1 of the State Department of Fish and Wildlife;

2 (d) The State Parks and Recreation Department to procure or supervise the procurement of all
3 goods, services, public improvements and personal services related to state parks;

4 (e) The Oregon Department of Aviation to procure or supervise the procurement of construction
5 materials, equipment, supplies, services and personal services for public improvements, public works
6 or ordinary construction described in ORS 279C.320 that is subject to the authority of the Oregon
7 Department of Aviation;

8 (f) The Oregon Business Development Department to procure or supervise the procurement of
9 all goods, services, personal services and public improvements related to its foreign trade offices
10 operating outside the state;

11 (g) The Housing and Community Services Department to procure or supervise the procurement
12 of goods, services and personal services as provided in ORS 279A.025 (2)(o);

13 (h) The Department of Corrections to procure or supervise the procurement of construction
14 materials, equipment, supplies, services and personal services for public improvements, public works
15 or ordinary construction described in ORS 279C.320 that is subject to the authority of the Depart-
16 ment of Corrections;

17 (i) The Department of Corrections, subject to any applicable provisions of ORS 279A.120,
18 279A.125, 279A.145 and 283.110 to 283.395, to procure or supervise the procurement of goods, ser-
19 vices and personal services under ORS 179.040 for its institutions;

20 (j) The Department of Veterans' Affairs to procure or supervise the procurement of real estate
21 broker and principal real estate broker services related to programs under the department's au-
22 thority;

23 (k) The Oregon Military Department to procure or supervise the procurement of construction
24 materials, equipment, supplies, services and personal services for public improvements, public works
25 or ordinary construction described in ORS 279C.320 that is subject to the authority of the Oregon
26 Military Department;

27 (L) The Department of Education, subject to any applicable provisions of ORS 329.075, 329.085
28 and 329.485 and the federal Every Student Succeeds Act (P.L. 114-95, 129 Stat. 1802), to procure or

31 **(m) The Department of Early Learning and Care to procure or supervise the procure-**

2 Learning Hub region that shall be responsible for awarding grants and contracts to providers who

4 (b) Before a provider may be awarded a grant or contract under this section, the provider must
5 agree to participate in any quality improvement and professional development activities necessary
6 to meet the standards established by the [*Early Learning Division*] **department**.

10 and prescribe the form used to claim a credit and the information required on the form.

11 (8) A nonresident individual shall be allowed the credit computed in the same manner and sub-
12 ject to the same limitations as the credit allowed a resident by subsection (1) of this section.
13 However, the credit shall be prorated using the proportion provided in ORS 316.117.

14 (9) If a change in the taxable year of a taxpayer occurs as described in ORS 314.085, or if the
15 Department of Revenue terminates the taxpayer's taxable year under ORS 314.440, the credit al-
16 lowed by this section shall be prorated or computed in a manner consistent with ORS 314.085.

17 (10) If a change in the status of a taxpayer from resident to nonresident or from nonresident to
18 resident occurs, the credit allowed by this section shall be determined in a manner consistent with
19 ORS 316.117.

20 (11) If the amount allowable as a credit under this section, when added to the sum of the
21 amounts allowable as payment of tax under ORS 316.187 or 316.583, other tax prepayment amounts
22 and other refundable credit amounts, exceeds the taxes imposed by ORS chapters 314 and 316 for
23 the tax year after application of any nonrefundable credits allowable for purposes of ORS chapter
24 316 for the tax year, the amount of the excess shall be refunded to the taxpayer as provided in ORS
25 316.502.

26 (12) Any amount that is refunded to the taxpayer under this section and that is in excess of the
27 tax liability of the taxpayer does not bear interest.

28 **SECTION 76.** ORS 406.072 is amended to read:

29 406.072. (1) As used in this section:

30 (a) "Uniformed service" means the Armed Forces of the United States, the Army National Guard
31 or the Air National Guard when the member is engaged in active duty for training, inactive duty
32 for training or full-time National Guard duty, the commissioned corps of the United States Public
33 Health Service and any other category of persons designated by the President of the United States
34 in time of war or national emergency.

35 (b) "Written information" means information that is in written form and includes but is not
36 limited to information obtained by electronic means, electronic mail, facsimile or other form of
37 electronic communication.

38 (2)(a) Subject to subsection (3) of this section and upon implementation or upgrade of an elec-
39 tronic delivery system that will enable the Department of Human Services to provide the notice
40 required by this subsection in a cost-effective and efficient manner, the Director of Human Services
41 shall notify the Director of Veterans' Affairs within 30 days of receipt of written information from
42 a member or veteran of a uniformed service who has applied for benefits or services under the fol-
43 lowing:

44 (A) Temporary assistance for needy families program under ORS 412.001 to 412.069;

45 (B) Assistance funded under Title IV-A of the Social Security Act as administered in this state

1 by the Department of Human Services;

2 (C) Supplemental Nutrition Assistance Program under ORS 411.806 to 411.845;

4 [(E) *Employment Related Day Care program administered by the Department of Human Services;*]

5 [(F)] (E) Programs and services for seniors and persons with disabilities administered by the
6 Department of Human Services; and

7 [(G)] (F) Vocational rehabilitation services and programs administered by the Department of
8 Human Services.

9 (b) **Subject to subsection (3) of this section, the Early Learning System Director shall**
10 **notify the Director of Veterans' Affairs within 30 days of receipt of written information from**
11 **a member or veteran of a uniformed service who has applied for benefits or services under**
12 **the Employment Related Day Care subsidy program administered by the Department of Early**
13 **Learning and Care.**

14 [(b)] (c) The notification required under this subsection is limited to notifying the Director of
15 Veterans' Affairs of the name and residence address or mailing address of the member or veteran.

16 [(c)] (d) The authorization of a member or veteran as required by subsection (3) of this section
17 may be contained in the written information at the time it is received by the Department of Human
18 Services **or the Department of Early Learning and Care** or separately at another time but the
19 authorization must specifically authorize the notification to be made under this subsection.

20 (3) The Director of Human Services **or the Early Learning System Director** shall notify the
21 Director of Veterans' Affairs as required by subsection (2) of this section only when authorized to
22 do so by the member or veteran of a uniformed service who submitted the written information.

23 (4) The Department of Human Services **and the Early Learning Council**, in consultation with
24 the Department of Veterans' Affairs, shall adopt rules to implement the provisions of this section,
25 including but not limited to the method of notification required under subsection (2) of this section.

27 411.882. In administering the JOBS Plus Program and to the extent permitted by federal law, the
28 Department of Human Services shall maximize the use of federal grants and apportionments of the
29 temporary assistance for needy families program[,] **and** the Supplemental Nutrition Assistance Pro-

31 **SECTION 78.** (1) **The amendments to ORS 315.264, 329A.500, 329A.505, 406.072 and 411.882**
32 **by sections 73 to 77 of this 2021 Act become operative on June 30, 2023.**

33 (2) **Notwithstanding the operative date set forth in subsection (1) of this section, the**
34 **Early Learning Division and the Department of Human Services may take any action before**
35 **the operative date set forth in subsection (1) of this section that is necessary for the De-**
36 **partment of Early Learning and Care to exercise, on and after the operative date set forth**
37 **in subsection (1) of this section, all of the duties, functions and powers conferred on the**
38 **Department of Early Learning and Care by the amendments to ORS 315.264, 329A.500,**
39 **329A.505, 406.072 and 411.882 by sections 73 to 77 of this 2021 Act.**

40 (3) **For the purpose of ensuring that the Department of Early Learning and Care may**
41 **exercise, on and after the operative date set forth in subsection (1) of this section, all of the**
42 **duties, functions and powers conferred on the Department of Early Learning and Care by the**
43 **amendments to ORS 315.264, 329A.500, 329A.505, 406.072 and 411.882 by sections 73 to 77 of**
44 **this 2021 Act, the Early Learning Division and the Department of Human Services shall de-**
45 **velop and implement a plan that provides for a seamless transfer of duties, functions and**

2 (4) The Governor shall resolve any disputes related to the plan developed and imple-
3 mented under subsection (3) of this section, and the Governor's decision is final.

4 **SECTION 79.** (1) The amendments to ORS 329A.500 by section 73 of this 2021 Act are in-
5 tended to transfer the Employment Related Day Care subsidy program from the Department
6 of Human Services to the Department of Early Learning and Care.

7 (2) For the purpose of the transfer described in subsection (1) of this section, the Direc-
8 tor of Human Services shall:

9 (a) Deliver to the Department of Early Learning and Care all records and property within
10 the jurisdiction of the director that relate to the duties, functions and powers transferred

28 Act are transferred to and are available for expenditure by the Department of Early Learn-

30 enforcing the duties, functions and powers transferred to the Department of Early Learning

32 (2) The expenditure classifications, if any, established by Acts authorizing or limiting
33 expenditures by the Department of Human Services remain applicable to expenditures by the

35 **SECTION 81.** The transfer of duties, functions and powers to the Department of Early
36 Learning and Care by the amendments to ORS 329A.500 by section 73 of this 2021 Act does
37 not affect any action, proceeding or prosecution involving or with respect to such duties,
38 functions and powers begun before and pending at the time of the transfer, except that the
39 Department of Early Learning and Care is substituted for the Department of Human Ser-
40 vices in the action, proceeding or prosecution.

41 **SECTION 82.** (1) Nothing in the amendments to ORS 315.264, 329A.500, 329A.505, 406.072
42 and 411.882 by sections 73 to 77 of this 2021 Act relieves a person of a liability, duty or obli-
43 gation accruing under or with respect to the duties, functions and powers transferred by the
44 amendments to ORS 329A.500 by section 73 of this 2021 Act. The Department of Early
45 Learning and Care may undertake the collection or enforcement of any such liability, duty

1 or obligation.

2 (2) The rights and obligations of the Department of Human Services legally incurred un-
3 der contracts, leases and business transactions executed, entered into or begun before the
4 operative date of the amendments to ORS 329A.500 by section 73 of this 2021 Act are trans-
5 ferred to the Department of Early Learning and Care. For the purpose of succession to
6 these rights and obligations, the Department of Early Learning and Care is a continuation
7 of the Department of Human Services and not a new authority.

8 SECTION 83. Notwithstanding the transfer of duties, functions and powers by the
9 amendments to ORS 329A.500 by section 73 of this 2021 Act, the rules of the Department of
10 Human Services in effect on the operative date of the amendments to ORS 329A.500 by sec-
11 tion 73 of this 2021 Act continue in effect until superseded or repealed by rules of the Early
12 Learning Council. References in rules of the Department of Human Services to the Depart-
13 ment of Human Services in relation to the Employment Related Day Care subsidy program
14 or an officer or employee of the Department of Human Services in relation to the Employ-
15 ment Related Day Care subsidy program are considered to be references to the Department
16 of Early Learning and Care or an officer or employee of the Department of Early Learning
17 and Care.

18 SECTION 84. Whenever, in any statutory law or resolution of the Legislative Assembly
19 or in any rule, document, record or proceeding authorized by the Legislative Assembly, ref-
20 erence is made to the Department of Human Services or an officer or employee of the De-
21 partment of Human Services in relation to the Employment Related Day Care subsidy
22 program, the reference is considered to be a reference to the Department of Early Learning
23 and Care or an officer or employee of the Department of Early Learning and Care.

29 report to the appropriate interim committees of the Legislative Assembly. The report shall

31 sections 64 and 78 of this 2021 Act, including:

32 (a) Progress on the transfer of background checks inspections for the Employment Re-
33 lated Day Care subsidy program to the Early Learning Division, including any recommen-
34 dations for legislation or other authority necessary for the collection of subsidy
35 overpayments made under the program.

36 (b) Recommendations for and progress on the transfer of child care assistance programs,
37 including the Employment Related Day Care subsidy program, to the Early Learning Divi-
38 sion.

39 (c) Recommendations to strengthen the alignment of the early childhood special educa-
40 tion and early intervention services within the statewide early learning system, including any
41 recommended changes to governance, policymaking or other oversight of the system.

42 (d) Progress on the adoption of rules related to school-age child care.

43 (e) Any fiscal impacts of the plan and any conflicts of the plan with federal statute that
44 must be resolved.

45 (f) Any budgetary impacts or recommendations for legislation related to the plan.
